

Four Lincoln men arrested south of Salem on Saturday

Four Lincoln men were arrested the morning of Saturday, Aug. 5, south of Salem.

The men were detained for hunting without permission on private property. Three rifles were seized as part of the investigation.

A Honda Civic was located hidden in tall weeds located several hundred yards off the nearest roadway and had Lincoln plates. The men were believed to be in the field over night.

Nebraska Game Wardens have reported that for the last year they have been observing Asian groups from the Lincoln area illegally hunting non-game song birds along with other animals.

The public is reminded to be observant and report suspicious activity to the local Sheriff's Office or the Nebraska Game and Parks.

FC Schools closed Aug. 21 for eclipse

The Falls City Public Schools and Falls City Sacred Heart School will not have school on August 21, the day of the solar eclipse.

The decision comes after safety concerns as the event presents potential dangers to students if viewed without proper eye protection.

Another concern is traffic, as a major influx of visitors are expected to travel to the Falls City area to watch the eclipse. And while schools in the district will be closed August 21, solar eclipse informational material will be sent home with every student on August 18 and all students will receive solar viewing glasses as well.

School will resume as scheduled on August 22.

Painted Lady Butterfly, not Monarch making an entrance in Nebraska

The painted lady butterfly has really made its mark in southeast Nebraska the past couple of weeks. It seems everywhere you go, pecially on country roads, you see thousands of these orange and dark colbutterored flies.

Why are we seeing so many of these butterflies? There is really no explanation, much of it depends on environmental conditions. The painted lady butterflies tend to

move northward through the summer months. They are even seeing several in Alberta, Canada this summer. They look something like small monarch butterflies, but they are

not. Will they cause problems with crops this year? That is a good question. Actually a few people have treated fields or areas of fields where the painted lady caterpillars has defoliated soybeans a great

First let's look at the life cycle of the painted lady butterfly. The adult female butterflies lay their eggs, which are the size of a pin head on plants the painted lady caterpillars

like to eat. These include thistles and holly-

hock, although they have been in soybean fields, defoliating soybeans earlier this summer. The eggs will hatch in three to five days and the caterpillars will eat continuously, growing rapidly and shed-

The caterpillars are around five to ten days and the caterpillars are hairy, black and yellow in color and almost two inches long. The caterpillar will then spin a silk pad to attach to. The caterpillar then forms a chrysalis or pupa. The butterfly will come out of this case in seven to ten days.

ding its skin four times.

When the butterfly emerges, it has a two week life span. During this period, its main goal is to reproduce and lay eggs so the cycle can begin again.

Should we be concerned about when the eggs hatching that the caterpillars will infest the soybeans, defoliating them, causing a reduc-

The first one came at the David von Behren hymn sing at the Presbyterian church. There really was a hymn sing, and David von Behren really did play several numbers. But the whole thing was mainly a ruse for a 90-minute love fest for Mrs. Appleoff's 90th birthday—a morning celebration that featured many of her favorite hymns. Doug Kirkendall, Jennifer James and Mildred's daughter, Sandy Appleoff, had planned the whole thing with David, and Sandy had compiled the list of hymns after garnering information from her mom.

"I think Mom thought I was planning her funeral," Sandy joked.

The church sanctuary was packed with people, some who knew about the ruse, and some who had come to hear David play. All were treated to the incredible talents of the 23-year-old organist who also played the piano, violin, and trumpet during the hymn sing. For one song, he awed the crowd on the violin while playing the bass part on the organ pedals. In addition, he sang his own personal arrangement of "You Raise Me Up" and Amazing Grace (My Chains are Gone)," and dedicated the performance to Mrs. A.

"When I think of the influence that she has had on my life and the lives of countless others," he said, "Words cannot express our gratitude for the gift that Mrs. A has given to us – the gift of music. And in the words of Heinrich Heine, 'where words leave off, music speaks.""

Although David was the main performer, he shared the limelight with several other people. His mom, Glenda, played the piano or organ for various num-





Yin-Yang: Stories that didn't make the obituaries

In journalism school we had to write obituaries as "punishment" for having misspelled words in our stories.

Today, while I don't relish death, I do look forward to reading the obits of people I knew and saying some things about the deceased that would never make the obituaries. I was recently afforded the opportunity by the deaths of two prominent Nebraskans.

Warren Urbom was 91. John DeCamp was 76. Both attorneys. Both veterans. One was a judge, the other was judged.

Yin and Yang. One was the dark swirl who operated in the shadows. The other was light, brightness. But, while seemingly the opposite, they were actually complementary and both played important roles in the tapestry of government and justice that often landed on this reporter's plate.

DeCamp, a Vietnam veteran, spent 16 years in the Nebraska Unicameral. He also ran for the Republican Party nomination for the U.S. Senate and for Governor. Urbom was drafted into the Army in 1944. He became a United States District Court Judge in 1970 and spent more

than 40 years on the bench. Descriptions of DeCamp ranged from colorful to iconoclastic to lecherous. Depending on who you asked, there were also words that couldn't be printed. He was a master of the rules of the Legislature and used them to his advantage, often changing his mind – and the game – at the last minute. He had a full-size ping-pong table in his Capitol office and a lot of business was conducted one-on-one from opposite ends of that table. DeCamp, with or without a ping-pong paddle, was a competitor.

Urbom was lauded as fair and innovative. He survived the Dust Bowl, the loss of his left eye at age 3, and a stint in the Army during World War II. He spent a year in seminary and summers working for his dad's earth-moving business in South Central Nebraska, before deciding he was going to be an attorney. Among the innovations he brought to the court was allowing jurors to take notes during trial and allowing them to ask questions of witnesses.

DeCamp and his close colleague Senator Loran Schmit of Bellwood (he sat behind Schmit in the George W. Norris Legislative Chamber) often teamed up on issues. One of their collaborations was a proposed pipeline from the coalfields of Wyoming to the steel mills of the eastern United States. It called for crushing the coal into a powder, mixing it with water and pumping the slurry through the pipes across several states. Opposition from the railroads and lack of a plan to return the water to the valuable Ogallala Aquifer effectively killed that measure.

Urbom signed on in 1974 for what he thought would be a weeklong trial of Native Americans who had been arrested during the second battle of Wounded Knee in South Dakota. He stayed on the multiple cases for

a year. Early in the trials, federal marshals told Urbom that some of the Native Americans in the courtroom didn't stand when he entered the room. One of the Natives explained that they didn't mean disrespect, but simply didn't want to act as if they did respect the prosecution. Urbom told the bailiffs to leave out the words "all rise" when he entered the court. He said no one ever explained the reason for the "allrise" to him anyway.

I don't know that DeCamp ever appeared in Urbom's courtroom. I don't know if they ever met. As DeCamp was overcome with conspiracy theories in the case of the failed Franklin Credit Union - he wrote a book about it – it could have happened. But those matters, including several deaths, which DeCamp blamed on the subsequent probe, never made it to Urbom's court.

That leaves an unwritten chapter in the lives of these two prominent Nebraskans. So alike, yet so different.



Three Indiana men were arrested for killing a Lincoln cop. One of the convicts was wounded and two others were captured after a five hour search.

The city asked the State Department of Roads to delay the tearing up of Harlan Street until spring. Plans called for the conversion of a narrow bumpy Harlan into a four lane roadway from 19th North to the City limits.

A total of 582 jobs were filled by the local Falls City employment office for the month of July. Eighty-three persons were directed to non-farm opportunities. The labor supply was 33 men and 43 women.


The Dawson-Verdon board of Education met to hear proposals for the sale of the Verdon school property.

Some of them graduated in the early to mid-70's!" But she knew the song verbatim as well, and she was turning 90! "I guess when you practice a song so much, you sing it on autopilot," she said.

Several other people participated in the hymn sing, too. Doug Kirkendall conducted the choir, and also served as emcee. The Giles sisters—Jen-

nifer (James), Julie (Hopp), and Janine (McClintock) sang "Be Thou My Vision" with their mother, Jeanne Giles. Dwight Mullins, a native of Reserve, added extra flair throughout the program on the guitar and trombone. And yours truly performed American Sign Language as the congregation sang "Here I Am, Lord."

Mildred's daughter, Connie, placed a crown on her mom's head, and the queen for the day reigned over her party.

'My three kids have been with me every inch of the way on my musical journey,"

Mildred said. "My husband Bob, was, too." (She and Bob were married for 54 years when he passed away in 2001. She later married Gale Marsh, who has since passed, also.)

"Music brings people together," Mildred said. "It's not mechanical. It's music. It breathes. It lives." What a beautiful quote from Falls City's matriarch of music. And the fact that it came from Mildred is truly no surprise at all.



Southeast Nebraska Community Action Partnership, Inc. (SENCA) Head Start annual report to the public

Head Start is an early childhood development program that provides comprehensive services to children age three to five and their families. Families served are primarily at or below the 100 percent poverty level. Head start can serve up to 35 percent of children that are at or below the 130percent level and up to 10 percent of children above the poverty guideline.

Head Start is a federally funded program receiving its federal dollars via the Department of Health and Human Services, Administration for Children and Families, and Office of Head Start. The federal government requires Head Start programs to obtain a 25 percent non-federal match on every federal dollar expended within their program.

The in-kind match is meant to have communities show support and have a stake in the Head Start program. Without the tremendous support of volunteers this program would not be possible. Southeast Nebraska Community Action Partnership, Inc. (SENCA) is a grantee for the Head Start program that currently serves the southeast Nebraska counties of Nemaha, Otoe, Pawnee, and Richardson. SENCA has been the grantee agency for the Head Start program in southeast Nebraska since 1968. SENCA Head Start is funded to serve 151 children with 32 slots in Nemaha County, 53 slots in Otoe County, 18 slots in Pawnee County, and 48 slots in Richardson County. The SENCA Head Start centers are located in Auburn, Nebraska City, Table Rock, and Falls City. Collaboration sites include Bulldog Beginnings at Auburn Public Schools, HTRS Early Education Center at HTRS Public Schools, and Parent Child Center at Falls City Public Schools. With a fleet of seven buses, one being handicap accessible, every effort is made to provide transportation to all children who

attend school at SENCA Head Start sites. SENCA Head Start operates Monday through Friday with classes held Monday through Thursday in part-day and full-day programs.

SENCA Head Start utilizes the Creative Curriculum 5th edition for Preschool in our classrooms. We also implement Positive Behavior Instructional Support, a systematic approach to preventing or reducing challenging behaviors and, eventually, enhancing the quality of life for individuals and support providers. All activities in the Head Start classrooms are based on learning through play, allowing for the educational opportunity to be given to every child. The program starts by teaching children school readiness and self-sufficiency skills of: listening, following directions, letters, names, numbers, cutting, sharing, snapping, zipping, pouring, setting the tables, as well as cleaning up. Individualization is done with every child, making it a fun and safe atmosphere on a daily basis. Our goal is to have every child ready for kindergarten when that time arrives.

Good health and wellness are essential components of the SENCA Head Start program. These components consist of physical health, dental health, social and emotional health, and nutrition. The objective of the health component is to ensure all child health and development concerns are identified and children and families are linked to ongoing sources of continuous, accessible care to meet their health needs. A registered dietician reviews nutritional information for each child allowing the dietician to make suggestions for families on how to improve or maintain their child's nutritional needs for growth and development.

Parent and family engagement is a critical component of the Head Start program. Parents are encouraged to work at home with their own children. Home visits by teaching and social service staff are another way we involve and reinforce parents in their role as prime educators of their children. SENCA Head Start guides and assists parents in encouraging their children's development. This kind of parent participation reinforces and supports the child's total Head Start experience.





Police Department preparing for influx of tourists ahead of eclipse

Some people have been preparing nearly ten years for the Great American Eclipse, others may wait until the week before to prepare for the show, but local law enforcement has been thinking and preparing for the public's safety for quite a while now.

With the population of Falls City and several neighboring communities expected to swell, local law enforcement anticipates a busy weekend ahead of the eclipse. The Falls City Police Department plans to have extra officers on duty, and a lot of those officers will specifically be out doing traffic enforcement. The high volume of people expected to flock to Falls City due to its speculator eclipse viewing location could cause several issues. The Falls City Police Department hopes that working on traffic enforcement will prevent people from breaking traffic laws and in turn keep other drivers and pedestrians out of danger as well.

Prior to the eclipse, starting on August 18, law enforcement will be participating in the "You Drink and Drive, You Lose" campaign. This enforcement campaign will put extra officers on the streets in hopes of deterring drunk drivers. There will be zero tolerance for drunk driving.

The Falls City Police Department assured the Journal that they are prepared for the potential of several calls. They also would like to assure the public that there will be a significant law enforcement presence in Falls City on Monday, Aug.

Law enforcement agencies around the United States have announced their plan to step up law enforcement in smaller communities within the prime viewing area. Other tips to follow: Don't drive and try to look at the eclipse. Please pull to the shoulder if you plan to watch the event. Be aware of distracted drivers. Keep an eye on others who may not follow the law. Officials are more concerned with driving safety during the eclipse than anything. Be aware of your surroundings; Falls City may be inundated with several strangers from all over. Play it safe and use common sense.

For everyone keeping track at home, and I know I'm not the only one, the Husker football season is less than a month away. Nebraska started practice a week ago, and so far there are no major injuries to report, so that's good news. Also, there has not been anything substantial to report on quite yet. The offense looks ok according to reports, don't look for major changes out of the offense. With a pro style quarterback running the show we will see more progressions on pass plays, tighter spirals, and sharper passes. Not to worry though Husker nation we will still see plenty of opportunities from our stable of running backs. I don't foresee us going to a strictly passing attack while abandoning the run.

What I fully expect to see is far better execution, not only from the quarterback but also from our offensive line. I feel in the past Tommy Armstrong Jr. made up his mind in the huddle whom he was going to throw the ball to, whether covered or not. You will not see that out of any of our quarterbacks this season. If a receiver is not open, they will continue to check down until they find an open man, you will even see the running backs catching more

passes if that's what the defense is giving us.

I'm not too worried about the offense. However, the defense with Bob Diaco's new scheme may give us some trouble. The Blackshirts will do an excellent job. However, it will take some time for the defense to get completely comfortable in the new 3-4. We will see some guys out of position early on and maybe guys looking a little lost at times, there is always a learning curve, but once things start to gel, the Blackshirts will once again be a force to be reckoned with.

This past week the Huskers also added Gary Darnell as a defensive consultant to help install the new defense. Darnell will add considerable expertise on the defensive side of the ball this fall. Previously, Darnell was a defensive coordinator at Kansas St., Wake Forrest, Notre Dame, Florida, Texas and Texas A&M. He was also a head coach at Florida (interim), Western Michigan and Texas A&M (interim). Darnell was hired after the passing Coach Bob Elliott last month.

Also in the news last week, according to a report by the Lincoln Journal Star, the Husker athletic department is close to a new licensing agreement with Adidas. If the report is correct the new deal would significantly increase the money Adidas already pays Nebraska.

Reports indicate the deal could be worth as much as 128 million over 11 years. Roughly half of the estimated dollars would come in the form of shoes and apparel for the athletes and coaches. Adidas and Nebraska have been partners since 1995, and with the new deal, they will remain partners for many years to come.

Has anyone else seen the alternate uniforms they were unveiled last week. Usually, I'm not a fan of this; I prefer to keep things the same when it comes to uniforms and helmets. This year's jerseys to be worn against Wisconsin are amazing. They are a tribute to the 1997 team, our last national title team. The jerseys will have mesh on the numbers and stripes on the arms as a nod to the jerseys worn by the '97 team. I have a feeling these will be quite popular with the fan base.

Finally, the preseason Amway Coaches Poll was released last week with Alabama garnering the top spot. Four Big Ten schools were represented in the top 10 with Ohio St. at #2, Penn S. at #6, Michigan at #9 and Wisconsin coming in at #10. Nebraska received votes to come in at the equivalent at #36. I will now go on record and make my predictions for this fall. Nebraska will over-achieve and finish the regular season at 9-3. The Huskers will lose early at Oregon but will bounce back with a home win against Wisconsin on October 7.

Nebraska will then fall the following week to Ohio St. but will bounce back two weeks later with a win against Northwestern. The final loss will come at the hands of Penn St. before beating Iowa to bring the season to a close. With wins against the Badgers, Northwestern, and Iowa, the Huskers will win the Big Ten West division and will travel to Indianapolis to take on the Michigan Wolverines.

Look for the Huskers to give the Wolverines a good game but they will fall just short but will be rewarded with a top tier bowl game and finish the season with a victory and a 10-4 record. I know wishful thinking right?





PHYSICAL EXAMINATION/IMMUNIZATIONS

Nebraska Law requires evidence of physical examination by a qualified physician, physician's assistant or a nurse practitioner for children entering Kindergarten, the seventh grade and for students who have resided in another state during the past year. Students are required to be immunized against measles, mumps, rubella, poliomyelitis, diphtheria, pertussis, varicella and tetanus prior to enrollment and any student not in compliance shall not be permitted to continue in school. Two (2) doses of MMR (measles, mumps, rubella) are required for all K-12 students. Hepatitis B is also required for students entering school for the first time and all transfer students from outside the State of Nebraska. All 7th grade students are required to have had one dose of Tdap (must contain pertussis booster) after 10 or 11 years of age. Exemptions shall be granted for: 1) medical exceptions for health reasons substantiated by a signed statement from a physician, physician's assistant or nurse practitioner; or 2) religious conflict substantiated by a signed affidavit from the student or the student's legal guardian, if the student is a minor. Students may be provisionally enrolled in a Nebraska school if they have begun the required immunizations and continue to receive the necessary immunizations as rapidly as is medically feasible. The law will apply to all students enrolled in Nebraska schools. All students participating in athletics must have a current physical on file.

WEATHER DISMISSAL PROCEDURE

If it is determined to dismiss school for any type of weather conditions, the following procedure will be followed:

1. The radio stations, KTNC and KLZA, will be notified to inform parents and students of an early dismissal, late start, or no school may be announced. These stations are the first to be notified. Additional media are: KOLN 10-11, KFAB, Channel 7-Omaha, KQTV, WOWT 6.2. In addition, we will continue to use the Black Connect automated phone calling message system for emergency announcements. 3. If the weather condition continues, school may be called off for the following day.

ASBESTOS NOTIFICATION

Asbestos is an issue we have been dealing with for many years. The Asbestos Hazard Emergency Response Act of 1986 (referred to as AHERA), was enacted recently by Congress. AHERA was enacted to determine the extent of and develop solutions for any problems schools may have with asbestos.

To give you some background, asbestos has been used as a building material for many years. It is a naturally occurring mineral that is mined primarily in Canada, South Africa, and the U.S.S.R. Asbestos properties made it an ideal building material for insulation, sound absorption, decorative plasters, fireproofing and a variety of miscellaneous uses. There have been over 36,000 different products made using asbestos materials. EPA began action to limit uses of asbestos products in

1973 and most uses of asbestos products as building materials were banned in 1978.

We have had our facilities inspected by a certified asbestos inspector, as required by AHERA.

The inspector located, sampled and rated the condition and hazard potential of all material in our facilities suspected of containing asbestos. The inspection and laboratory analysis records were turned over to a professional certified firm to develop asbestos management plans.

An asbestos management plan was developed for our facilities which includes: this notification

An asbestos management plan was developed for our facilities which includes: this notification letter, education and training of our employees, a set of plans and procedures designed to minimize the disturbance of the asbestos containing materials (ACM) and plans for regular surveillance of

Falls City Public School, complying with this plan, removed all of the friable asbestos from its buildings. Some floor tile containing asbestos still remain.

A copy of the asbestos management plan is available for your inspection in our administrative offices during regular office hours. Mike Kafer is our asbestos program coordinator and all inquiries regarding the plan should be directed to him.

We have implemented the asbestos management plan. We are intent on not only complying with, but exceeding federal, state and local regulations in this area. We plan on taking whatever steps are necessary to insure your children and our employees have a healthy, safe environment in which to learn and work.

MISSING CHILDREN IDENTIFICATION ACT

The law requires all new enrolling students to provide; 1) a certified birth certificate, or 2) other reliable proof of the student's identity and age accompanied by an affidavit explaining the inability to produce a birth certificate.

-tion in yield? This is a possibility. In speaking with UNL Extension Entomologist, Robert Wright, his recommendation is to continually scout soybean fields for the painted lady caterpillars.

If defoliation reaches 20 percent during the reproductive stage, treatment with an insecticide may be warranted. So it would be a good idea to check your fields the next few weeks in August to watch out for the painted lady caterpillar. You may have other pests in your soybeans as well, i.e bean leaf beetle and/or the soybean aphid, which may show up with the cool weather we are having.

If you recall a few years ago we had an infestation of the spotted skipper butterflies in the early summer and then in August, some people had an infestation of the spotted skipper caterpillars in their soybeans with a few people treating fields. The Missouri Department of Transportation's employs a program of inspection, repair and maintenance of the more than 10,000 bridges across the state.

This program ensures the bridges are kept in the best possible condition for as long as possible for all those that travel across Missouri's roadways.

The Missouri River Bridge on U.S. Route 159 connecting Missouri and Rulo, was rebuilt beginning in September 2010 and reopened to the public in September

Bridges along Missouri's border are the shared responsibility of Missouri and the neighboring states. The Nebraska Department of Transportation maintains the Rulo bridge and has scheduled an inspection of this bridge with lane closures Tuesday, Aug. 15 through Friday, Aug. 18.

The lane closure will remain in place each day from approximately 7:30 a.m. to 6:00 p.m. During the work a flagger and pilot car will direct traffic across the bridge. All work is weather permitting and

schedules are subject to change. Motorists are advised to be alert for work zone signs and extra equipment on the roadways during the inspection. Please put down your phone and other distractions so you can give driving your full attention and give the crew plenty of room to safely do their work.
