Inheritance taxes help lower levy

The Richardson County Commissioners, meeting in regular session Tuesday, Sept. 25, adopted a resolution to set the county tax levy for the 2012 tax year at .389684.

Included in the resolution was the following: "If it were not for the use of inheritance tax dollars, the county rate would be increased to .413194 in order to maintain the current level of services that are both mandated under state law and that our county taxpayers deserve and expect."

Action on the levy was preceded by a public hearing at which no one spoke.

Attending the session were Commissioner Chairman Dave Sickel and Vice Chairman Bill Ely. Jim Davidson was unable to attend.

During the meeting, a letter was drafted and signed by board members and sent to Congressman Jeff Fortenberry regarding the extension of the wind energy production tax credit. A letter was also submitted to the Nebraska State Auditor responding to the findings of the fiscal year end, June 30, 2012, draft audit report as prepared by the Nebraska State Auditor.

In other developments, the Commissioners:

—Met with EMA Director Jim Gerweck, who reported that the documents for the grant funding through the Emergency Management Program Grant, EMPG, had not yet been received from the State of Nebraska Emergency Management Agency. Gerweck reviewed with the board a report and listing of the items that are ongoing within the Richardson County EMA. The EMA Director requested an executive session, which was postponed until this week when Commissioner Davidson would be in attendance.

-Were presented an update from Sandy Morrissey of Region V on Region V Systems activity with the Youth Prevention Coalition, which receives Federal Block Grant funding.

-Met with Highway Supt. Scott Huppert. The board moved to approve the annual report to be submitted to the Nebraska Board of Classifications and Standards.


-Voted to enter into agreement with Great Plains Communications for the use of county road right-of-way in Franklin, Humboldt and Speiser Townships, and approved the August 2012 Richardson County Transit report as submitted by SENCA.

After some 89 years, switchboard goes silent

Mitch Glaeser, owner of the Grand Weaver Hotel, was looking for a rather lengthy guarantee but just couldn't arrange one. The number he had in mind was 89 years.

That's how long the hotel's switchboard, located at the first floor front desk, had been in service. And it still worked, as guests called the desk with requests for information or service or to place an outgoing call. Imagine the number of calls that had gone through that switchboard in almost nine decades.

But the first floor lobby area is in its final stages in the remodeling and refurbishing process. The new, attractive and expanded front desk has been moved to the southeast lobby area. The switchboard that had served for so long had to go.

Southeast Nebraska Communications was not confident that the old system could be moved and still work. So a new system had to be installed. It came with a warranty, but not one that was a year short of 90. "We called the manufacturer of the new phone system and asked if we could get an 89-year guarantee," Glaeser said. "We are still waiting for a call back."

Glaeser said the "retired" switchboard will be displayed on the first floor for guests to see.

Not all has changed, though. Of the rooms and suites in the hotel include the original phones from 1923. They are a very real part of the hotel, it's history and ambiance. They work like a charm.

Nebraska congressmen caught in Farm Bill limbo

For nearly 80 years – most recently in 5-year-chunks – the United States has provided support to farmers and rural residents through a variety

of programs and initiatives bundled into what has traditionally been called the "Farm Bill."

The package, which sets national policy in agriculture, nutrition, conservation and forestry, was last passed in 2008 and was to have been passed by the Congress, which just left Washington for its "Presidential Break."

Several agricultural groups have voiced their displeasure with Congress for its inability to overcome partisan deadlock and pass the bill, which cleared the House Agriculture Committee on a 35-11 vote in July. House Speaker John Boehner, R-OH, confirms that the bill will not be dealt with until after the election. Farm groups and some members of Congress say the measure is too important to leave to a lame duck Congress.

John Crabtree of the Center for Rural Affairs says expiration of the Farm Bill on September 30 won't be the end of the world, but it will make it much more difficult to restart many of the programs that are crucial to rural areas. Among those is the Rural Micro Entrepreneur Assistance Program, which provides loans, and technical assistance for rural small business development.

Experts say most of the farm and nutrition programs (including food stamps) covered by the bill won't be affected until January 1, 2013. Others are concerned that this particular version of the Farm Bill (The Agriculture Reform, Food and Jobs Act of 2012 [S. 3240]) represents the most significant reforms in agricultural policy in decades. The bill ends direct payments, streamlines and consolidates programs and reduces the budget deficit by \$23 billion.

The Economic Research Service of the U.S. Department of Agriculture said the agriculture sector has experienced unprecedented strength and growth with

a record net farm income in 2011 and 2012 exceeding \$90 billion each year. In addition, USDA says that in three decades the five years of highest earnings for farmers have occurred since 2004.

Two of Nebraska's three Congressional Districts represent the majority of the state's farmers. Even though both representatives are Republicans, they are being painted almost as polar opposites on the issue. First District Rep. Jeff Fortenberry of Lincoln is among a handful of Republicans who have signed a "discharge petition" to push for action, sooner than later.

Rep. Adrian Smith of Ger-

ing, who represents Nebraska's sprawling Third District, said he is frustrated and disappointed with the lack of agreement on the measure but feels major reforms need to be ironed out and can be without a major lapse in policy. Most of the programs authorized by the Farm Bill have been funded through next March by a Housepassed Continuing Resolution that includes crop insurance and commodity programs, which are tabbed to cover the 2012 harvest.

Smith and Fortenberry agree on one thing. In the midst of a heated national election, politics has hijacked the Farm Bill.

The future of the Farm Bill

This summer I sat down with a farmer on the front porch of his farmhouse in the heart of Nebraska's cattle country. This farmer has seen it all. We talked about the current drought and those of the past, cattle prices, input costs, biofuels, and all the complex things that make up modern agriculture. Overlooking cornfields and blue sky, our discussion was far removed from the halls of Congress, but we in Nebraska understand the importance of agriculture – one of our economy's few bright spots - to our nation's well-being.

Last week, Congress left Washington without reauthorizing a new "Farm Bill," the overarching policy that directs the administration of our nation's farm, conservation, and nutrition programs. Enacted in 2008, the current Farm Bill expires this Sunday (farm legislation typically spans over a five-year period).

The U.S. Senate passed its version of new farm policy back in June. The House Agriculture Committee, on which I serve, advanced its own Farm Bill proposal in July. Though the bill wasn't perfect, I supported it as an opportunity to chart a new way forward for America's farmers and ranchers while still respecting the federal government's severe budgetary





constraints. I was hopeful our proposal would receive a vote before the entire House of Representatives so we could move forward in sending a five-year Farm Bill to the President. Unfortunately, a House vote did not take place and Congress left town with the current Farm Bill set to expire.

Many Nebraskans are now asking about the consequences of this inaction and what it means for farmers and rural communities. You may have heard that if we do not enact new farm policy by the end of this year, the United States will revert back to "Permanent Law," which is the 1938 and 1949 statutes—clearly written for another era. The most immediate impacts would be on dairy and certain conservation management programs, which are based on the calendar year. Commodity programs are covered under the expiring Farm Bill until the next harvest. The next winter wheat crop will be the first affected. Current Conservation Reserve Program (CRP) contracts will not be affected, nor will crop insurance coverage for farmers.

Although the current uncertainty about the bill is not preferable for planning purposes, Congress has a few more months to pass a new Farm Bill. Clearly, it is better to act on a five-year bill. Congress may also choose to extend the current Farm Bill, but then the reforms and budget savings achieved in the new proposal will be lost.

Agriculture is critical to America's economic security, energy security, and national security. Farm policy goes beyond farms, farmers, and rural America – it benefits all of America. We have the lowest food prices in the world, we export and provide food to others, we create clean energy from homegrown sources, and we encourage environmentally responsible management practices that protect and conserve natural resources. A reasonable long-term Farm Bill plays an important role in these efforts, helping farmers manage risks, plan for productive harvests, and uphold the strong outcomes and traditions of the American agriculture community.


NDEQ awards to Nemaha NRD

Nebraska Dept. of Environmental Quality Director Mike Linder announced the awarding of \$1,692,426 in grants for waste reduction and recycling projects.

Among the awards were two to Nemaha Natural Resource and Development, which serves Richardson, Nemaha, Pawnee, Johnson, Jefferson, Otoe and Saline counties.

The Nemaha NRD will receive \$35,568 to host nine household hazardous waste collection events and \$26,900 to purchase a brush chipper for use with invasive woody vegetation.

The grants are available through the Waste Reduction and Recycling Incentive Grant Fund. This fund is generated by a fee on solid waste disposed of in landfills, an annual retail business sales fee and a fee assessed on the sale of new tires for motor vehicles. Tire fee grants totaling \$1.86 million for projects related to tire recycling were announced in May.



When I asked for ideas for my column, this was the most requested topic I heard. What really happened to Brian last year? The stories people tell us make us sound a little crazy and very adventurous. Some examples are, Brian dove head first into shallow water and rocks, Brian and I were swimming during hurricane Irene, and the weirdest, Brian fell off of a boat into the Potomac River. Talking about it is hard for Brian, but he insisted that maybe if we share what really happened, maybe everyone will stop asking him how and why he dove into shallow water and rocks during a hurricane.

Brian and I were invited to join some of our closest friends on a trip to D.C. and Delaware last September. We were beyond thrilled that we could go celebrate our anniversary in such an amazing place. We left on a Friday morning and spent the day exploring Washington D.C. and Maryland. Saturday morning we drove to Rehoboth Beach, Delaware about 3.5 hours from Washington D.C. We spent the day walking the boardwalk, shopping and watching the Husker game.

We woke up around 10 a.m. ready to do some swimming and relaxing on the beach. It was Sunday, September 11th and also our 7th wedding anniversary. We rented our chairs and umbrella and planned to relax. Well, we were excited to body board so Brian and I hit the water. Body boarding, by the way, was so much fun, or it was for about five minutes. We were standing in waste deep water and riding the waves onto the shore. I started for the beach to sit down because I was out of breath. That's when I turned to look at Brian. He was facing me and a wave hit him knocking under. I really didn't think anything of it. I had been knocked down twice and while it was scary, I was fine. I watched and noticed he didn't pop right back up like he had been. Then I saw him bob up face down. I thought for a moment he was just messing with me. I started out toward him and realized this was no joke. Swimming out to him is blank for me. I remember flipping him over and seeing his face covered in blood, and he was choking on it. I couldn't touch where he was because the undertow had taken him out where it was deeper. I don't know how I got him in without drowning us both. I remember screaming. We were not alone. We had people all around us. Nobody came to help. I screamed at our friends Barry and Whitney, who were napping. Finally Barry heard me and came running out. He helped me get Brian the rest of the way in. I got to about waste deep and couldn't pull him anymore. He told me he couldn't feel anything and he was paralyzed. The strength of the wave had slammed him face first into the sand. Barry pulled him to shore and finally the lifeguards came running. Someone finally called 911. I didn't hear a thing going on around me. When the ambulance showed up, they loaded Brian on a backboard with a neck brace and on to a John Deere Gator that drove us up to the waiting ambulance. We then experienced the longest drive of our lives. We drove to Lewes, Delaware, which ended up being about twenty minutes from the beach.

We reached Bebe Medical Center, both covered in sand. They took him right in to a room, while I filled out the necessary paperwork trying to explain what exactly had happened the best I could. I asked Brian if I should call anyone and he gave me a firm no. "Why scare anyone until we know what is happening?" He didn't want his parents or brother and sister as scared as I was but, I myself needed help. I sent an SOS to my sister, brother-in-law and mom. I needed some reassurance and prayers. I guess you are never to old to need your mom to tell you everything will be ok.

We were not there long when Barry and Whitney showed up. They had gathered our stuff and had taken it to our hotel room. In all honesty the rest is a blur of Whitney calling Brian's mom because I couldn't bring myself to do it, five hours of tests, tears and some laughs thanks to our friends. Hours later Brian finally moved his toes. We could all breathe. His spinal cord was bruised. The strength in which he had hit the sand had jarred his Spinal Cord very hard and it was swollen. His cheek/eye socket was broken, and his nose was broken in two places. Brian's body kept going into shock making his blood pressure and pulse drop but with some fluid and laying him flat he would come back to normal.

I stepped outside to have a breakdown and passed a girl about my age in a wheelchair waiting on the curb. She asked if I was with that guy who got hurt at Rehoboth Beach. I said yes. She asked how he was, I told her. She then told me she had gone into the water after our ordeal and broke her legs.

The hospital staff told us there were 108 water rescues and 2 deaths the day before. Maybe the beach should have been closed. Maybe we should have been told to enter at our own risk. Or maybe we should have had some common sense. I don't know. I left to change, shower and grab some stuff for Brian. The hospital was insistent that I didn't stay with him because it was against the rules. But after Brian pleaded that it was our anniversary, they allowed me to stay with him. Barry and Whitney brought us sandwiches and Rolos for our anniversary dinner.

The next morning, Brian was in a lot of pain and swollen, but we got the ok to leave the hospital and head back to Maryland. We were scheduled to fly out that night, but the Doctors said maybe waiting another day or two would be best. We spent the next few days in our friends parents home. We finally made it home Wednesday morning. Brian was unable to work, use his arms or walk more than a few steps for weeks. We had barely sat down when Doug and Betty Merz came by and had made us dinner and offered to take Alex when things were too hard for me to handle. Brian's sister had an amazing plan to have volunteers cook meals for us. It was a Godsend! I could worry about taking care of Brian, Alex, work and our three dogs instead of cooking and shopping for food. We had so many people do such amazing and selfless things for us. Our friends and family had gone all out. Ben Hullman, Brian Daake and the Falls City Elks Lodge had an amazing benefit for Brian to help cover his medical bills.

We are so in debt to the Falls City community for the outpouring of support we have had. Today, Brian is about 90% back to normal. He has moments where something goes numb or he is in pain, but he is alive and walking so he never complains. He has to watch what he does, no bumper cars, no rough housing, or football but he is so appreciative of all he has, I don't think he cares. Now, a year later we are still over whelmed with well wishes and support. I am sure there will never be a day that I quit thanking you all. We are so blessed and we think about that everyday. So again from the bottom of my heart, THANK YOU! Now you know, we are not as adventureous as everyone had thought. We just happened to live and learn the fact that things happen in a split second. That one wave happened to be larger than any other had been, Brian was just in the wrong place at the wrong time. We live bigger, laugh harder and love like there is no tomorrow. We learned a valuable lesson. We walk now, we don't run through life.

To borrow one from the great Yogi Berra, it was "Déjà vu all over again" for the Falls City Sacred Heart football season Friday night, as the Class D2 top-ranked Irish put on a clinic in their 76-6 homecoming drubbing of Meridian.

Berra, for those living under a rock and unfamiliar, was a Hall of Fame New York Yankee catcher who uttered that famous phrase when he witnessed Mickey Mantle and Roger Maris repeatedly hit back-to-back home runs in the Yankees' seasons in the early 1960s.

The Irish jumped all over Meridian and before the visitors could blink the score was 33-0 at the end of the first quarter. Following a three-and-out on Meridian's first possession of the game, Irish head coach Doug Goltz dialed up a little trickeration when he had junior Chaz Dunn field the punt, act like he was going to return it and then Dunn threw a lateral pass back across the field to senior Clay Finck who returned it 59 yards for the opening touchdown.

Sacred Heart would go on to score on seven first-half possessions (would've been eight, but a 60-yard TD run by Sawyer Kean was negated by a holding penalty), while also tacking on two points from a safety when Sean Strasheim and Logan Scheitel sacked Meridian's quarterback in the end zone with 1:53 to go in the half. All told, the first half saw the Irish defense hold Meridian to five three-and-outs, while also recording two takeaways and a turnover on downs.

"Meridian is a young team, so we over-matched them physically," Coach Goltz said. "We gave up very few yards or first downs."

The Irish held Meridian to 110 yards of offense, but as Goltz noted, almost half of those yards came late in the fourth

quarter on a 22-yard run and the 25-yard touchdown pass with just a minute left to play.

Senior Brody Chandler led the Irish defense with 11 tackles. four of which were unassisted. Sophomore Zavan Kirkendall had 10 tackles and junior Jarod Fiegener joined Strasheim and Logan Scheitel with one sack each.

Offensively, the Irish had six different players score at least once - Barnhill, Kean, Austin Malone, Brandon Schawang, Lane Scheitel and Colin Niemeyer – and Barnhill, Schawang and Niemeyer all had multiple scores in the game.

Barnhill continued his torrid season Friday night, carrying the ball nine times for 96 yards and three touchdowns. To date, Barnhill, who was also crowned homecoming king after Friday's game, has averaged 10.9 per carry, amassing 544 yards and

14 touchdowns on the ground, while also hauling in five catches for 49 yards and a score. And those numbers have all come in games where Barnhill and the other Irish starters have played little, if any, in the second half.

With Sacred Heart outscoring their opponents 243-24 in the first half of the first five games, the backups have received loads of valuable playing time and have been better than basically all of the opponents they have faced, including many of the first five teams' starters.

Two of those reserves are sophomores Kean and Austin Malone, who have been on the field frequently in the second half and have combined for 43 carries, 432 yards and eight touchdowns.

"It's always good for the non-starters to get to play," Goltz said. "It's tough, though, to get our varsity ready for a close game, but it is what it is. The best measure of improvement is making fewer and fewer mistakes."







After starting the season 0-2, the Falls City Tigers have rattled off three consecutive victories for the first time since 2007 and earned themselves a 'contender' consideration in yesterday's Lincoln Journal Star rankings.

The Tigers spoiled the Syracuse Rocket's homecoming festivities Friday night in a 32-8 victory and have outscored their last three opponents 140-15, allowing just one offensive touchdown in that stretch.

Junior back Mitchell Harling was dynamite in the win, carrying the ball 23 times for a career high 180 yards.

"We knew at some point this season Mitchell was going to have a breakout game," Tiger head coach Darin Fritz said. "He is getting better at reading his blocks and running tough."

Senior Cord Huettner followed up his record performance from the week before with 11 carries for 63 yards and two touchdowns. Syracuse did a good job of containing Huettner, but the bruiser broke loose for a 58-yard touchdown run in the fourth quarter that saw him break a handful of tackles, jump over a pile and pull away from a Rocket defensive back on his way to the end zone. Huettner did most of his work clearing holes for the Tiger backs and Coach Fritz was very pleased with his captain's performance.

"We knew they would key on Cord, so the plan was to take a look at what the defense wanted to stop and exploit it in other areas," Fritz said. "I think Cord was the best lead blocker in the

state Friday night."

Wade Maddox, Jordy Stoller and Jesse Butrick are the other three backs who round out the Tiger backfield and Friday they combined for nine carries, 154 yards and two touchdowns. Stoller's score came on a reverse with 3:30 to go in the second quarter when he broke loose and took the handoff 37 yards for the touchdown. Butrick punched one in from seven yards out just five minutes earlier.

Falls City, again, had an impressive performance on the defensive side of the football, but Syracuse definitely made them

earn it. The Rockets had a sizable advantage in time of possession and their lone scoring drive totaled 28 plays and chewed up more than 12 minutes.

"It was a little disconcerting whey they were on their long drive, but they had to most of the third quarter to score, so we really made them work for the points," Fritz said. "I thought the defense played fantastic again. We gave up more yards on the ground than I would like, but it was another very solid effort by all."

Senior defensive back Codie Witt had a career game for the orange and black. Witt picked off two Syracuse passes, returning one for a touchdown

Huettner was second on the team with 14 tackles, including a team-high five unassisted, and Wade Witt added 10 tackles.

The Tigers improved to 2-0 in district play with the win and face their final non-district opponent, Fairbury, at Jug Brown this Friday.

The Jeffs, who sit at 2-3 on the year, are coming off a 27-6 home loss to Sandy Creek, but Coach Fritz expects a great effort from the visitors this week.


