Mayor reiterates support for EDGE

Mayor Tim Hersh expressed his support for Falls City EDGE when the City Council met Monday, Nov. 5, in Council Chambers.

He thanked EDGE Executive Director Beckie Cromer for her quarterly report and said he knows the job of economic development can be "very stressful" and that he and the City "support you 100 percent."

The stress Mayor Hersh spoke about involves the proposed Consolidated Grain and Barge project, a \$23-plus million development in south Falls City. The project has sparked a lawsuit and criticism from some businesses and citizens who believe it would be harmful to established businesses in the county.

In her report, Mrs. Cromer said her office has been pretty much consumed by the CGB project and wants to make sure that all EDGE partners and the public is informed about the project. She said EDGE is doing all it can for its "corporate partners" in Falls City and encouraged citizens to access the web and attend public town hall informational meetings as Falls City moves forward.

Mrs. Cromer also spoke about an extension of the Memorandum of Understanding regarding Vantec, recommending that the extension be granted. She said Vantec's profile is "on an up-tick," although the manufacturing plant is suffering as so many others are in this economy. City Clerk/Treasurer Gary Jom said Vantec "is meeting their obligations" included in the MOU, with the exception of employment numbers, which are at about 50 percent of those

'STARS AND STRIPES FOREVER'

Veterans Day in Falls City has been a special event since the late Marshall Maddox made it that way. His wife, Sherry, with lots of help from Veterans organizations, has continued the tradition.

Monday, Nov. 12, was no exception. Flags were flying, bands were playing and young people were singing. The gymnasium at Falls City High School was filled Monday morning with those who simply wanted to honor those who serve, and have served, their country with honor and distinction. Richardson County, NE, boasts a proud military and service to country tradition that is acknowledged at this time of year, every year.

Mrs. Maddox introduced Viet-

nam veteran Roy Schoen, who now serves as a team leader for the Lincoln Veterans Center, which provides readjustment counseling services to young men and women who are returning from war. She said the 11 a.m. ceremony was intended to honor all veterans, those who now serve and those who have served. Mrs. Maddox pointed to the Veterans Day ceremony Sunday at the Tomb of the Unknown in Washington, where President Barack Obama laid the traditional wreath and described this nation's veterans as "the real heroes."

"We honor their contributions and sacrifices," Mrs. Maddox said, and those of their families.

Schoen said it was "an honor" to speak in Falls City and honor the veterans in the audience, including those he knew from Vietnam and the World War II vets in attendance.

"Every veteran has a different story," Schoen said. He urged the students in the audience to "ask them" for those stories and "encourage them" to share them. Those stories, he said, are "sorely missing" from our national discussion and history.

Schoen said he comes from a "very patriotic" family that taught responsibility for the community and "service to our country." He quoted the pledge all make as they enter the military, urging young people to "pay attention" and "recognize and participate in the process" that defends America's way of life and its political process. "Register to vote and vote," the speaker said.

After his remarks, Schoen invited questions from the Falls City High and Sacred Heart students in attendance.

He said he would "like to see universal" service from young people, be it in the military, Peace Corps or Teacher Corps." With service now volunteer, some personnel have logged four or five tours of duty in places like Afghanistan, because of a

lack of numbers.

Schoen said he and his colleagues deal with cases of PTSD,

drug and alcohol abuse and fam-

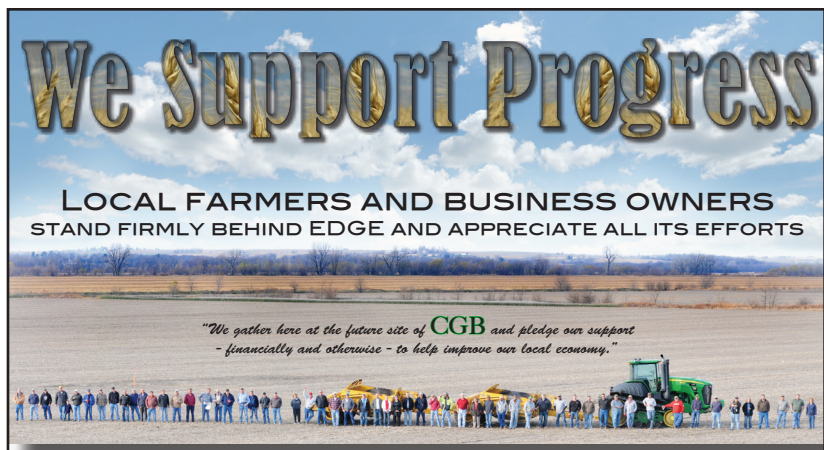
The Maestro

Reflections on Veteran’s Day

Reflections on Veterans Day

In 1944, along the northern coastline of France in a place called Normandy, the future of civilization hung in the balance. At 6:30 a.m. on June 6, the first wave of American troops landed at Omaha Beach. As their Higgins boat troop carriers opened, 18 and 19 year-old young men from cities and farms, from New York to Nebraska, were asked to do the impossible. Dash across hundreds of yards of open beach with no cover, face a hail of German gunfire, mines and mortars, and take the high ground. Somehow, someway, they withstood the violence and made their way to steep hillsides.



Last winter, I stood where those soldiers landed, at the water’s edge, and looked across that beach. It is hard to get the mind around the chaos of that day - to feel what they felt - as the horror unfolded. I made my way to the hillside, now so peaceful and lovely, and stood in a German bunker. A young German soldier named Severloh manned the machine gun that day. He fired for nine hours straight, weeping at the slaughter as I was told.

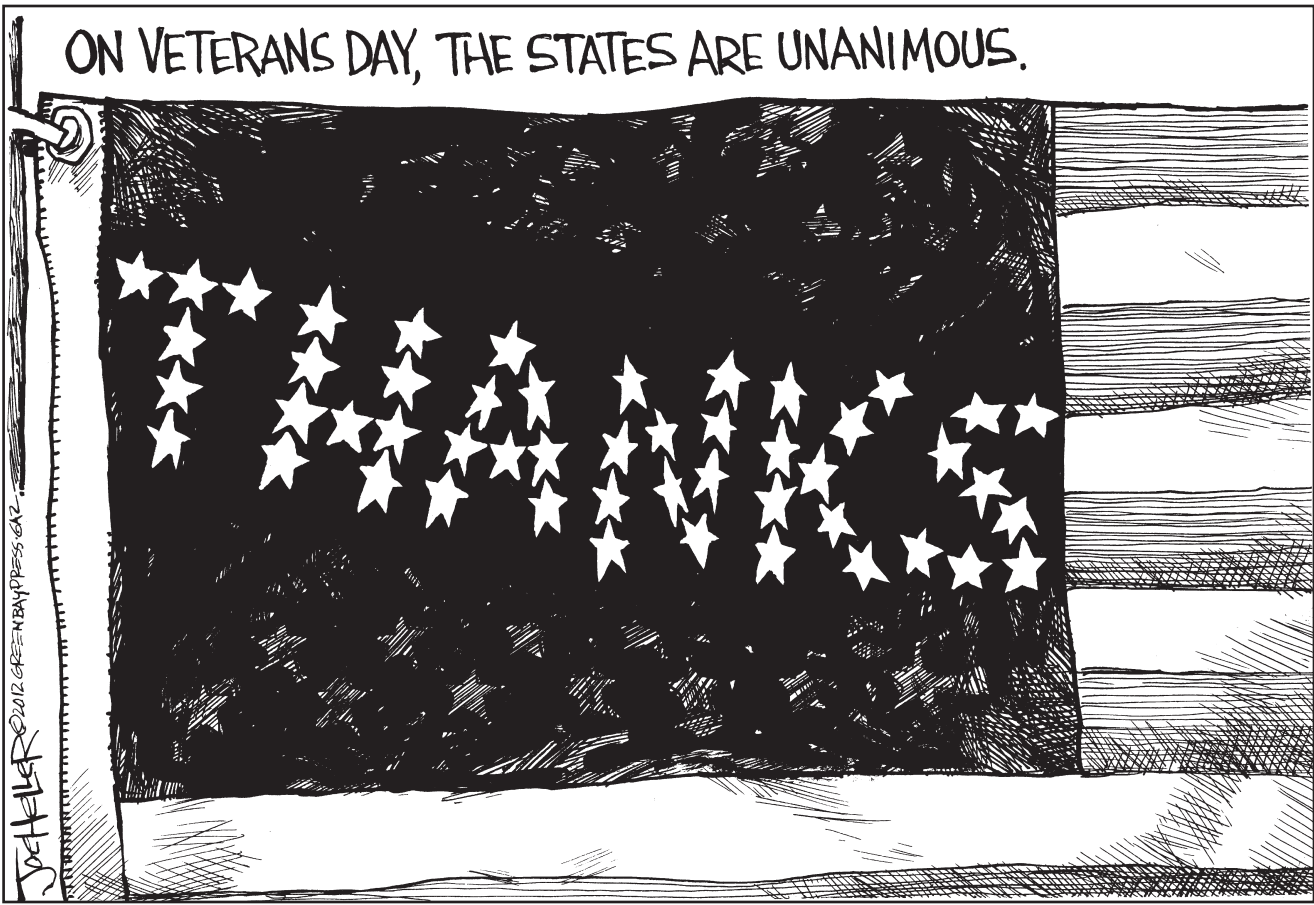
I walked around the nearby American cemetery, with its orderly rows of white crosses testifying to the dear price our soldiers paid. I stopped at the grave of Billy D. Harris from Oklahoma. He had married young and died young. His young wife didn’t know her husband had been killed and buried there until about ten years ago. Such is the chaos of war. She never remarried – she had all her hopes that her husband would return.

I proceeded on to the little town of Sainte-Mère-Église where our airborne troops landed the night before the D-Day invasion. Some fell into the town square occupied by the Germans. One soldier’s parachute got caught on the church roof and he hung there as the battle raged below. A replica of the parachute and soldier still hangs from the church.

In August of 1944, a young medical doctor left his wife and two children and joined the army. He initially headquartered in a hospital in England, where the last official records show he was located. As Patton’s army moved against the Germans, Captain Luther Fortenberry went into action in France, probably to begin field hospital operations. In November of 1944, he was killed by ordinance explosion. He was my grandfather. He was initially buried at the cemetery at Sainte-Mère-Église and eventually re-interred at Arlington National cemetery in northern Virginia.

As part of our civic life, we honor the memory of all those who have served us. We all know of the great battles and heroic sacrifices at places like Bunker Hill, Omaha Beach, Khe Sanh, and Fallujah. What we do not know are the untold stories, witnessed by no-one, of Americans who fought it out to the death to preserve our country. We also do not know the untold stories of the many who left their families and quietly performed their duty, with no questions asked or demands made. The veterans who maintained tanks and aircraft, cooked, computed, cleaned, and drove.

To all who have served: Thank you. We honor you this Veterans Day. We have just been through a very hard fought, difficult election. Yes, it was a bit nasty, a bit out of the margins of civility, but it was still conducted without violence and without bloodshed. Veterans Day reminds each generation that sometimes the tranquility of order comes at a very high price.



Voters say ‘No’ to more pay for senators, longer term limits

Nebraska voters gave an overwhelming “no” to paying state senators more money and extending the now limited terms they can serve. But they approved of placing the right to hunt and fish in the state constitution and a measure that would make it possible to impeach officials for wrongdoing done while campaigning.

While they were at it, they returned Nebraska to the status of having two Republican U.S. Senators for the first time in 36 years with Deb Fischer’s defeat of Bob Kerrey by 118,217 votes according to unofficial returns by the Secretary of State.

Fischer, a Sandhills rancher and former state Senator, defeated Kerrey, a decorated war hero who had also served one term as Nebraska governor and two terms as a U.S. Senator before moving to New York City where he became a college president. Fischer’s 58 percent to 41 percent drubbing of Kerrey came mostly at the hands of voters in Nebraska’s sprawling Third District where cattle clearly outnumber voters and the land – even that disputed parcel in Cherry County that Kerrey tried to make an issue – goes on for miles.

Not since Republican U.S. Senator Roman Hruska, a David City native, retired in 1976 after 22 years in Washington, has the state had two Republican U.S. Senators. The venerable Carl Curtis, a Kearney County native, went to Washington in 1955 and stayed until 1979. But former Omaha Mayor Ed Zorinsky, a Democrat, changed all that in 1976 when he defeated Republican John Y. McCollister and started the one from each party Senate makeup. Jim Exon, Bob Kerrey and Ben Nelson, all three former Democratic governors in a mostly Republican state, wore the title of the other U.S. Senator from Nebraska during the 36 years.

Voters gave a 68 percent to 31 percent rejection to a legislative pay raise to \$22,500. The going rate for Nebraska’s 49 state senators in the officially non-partisan Unicameral has been \$12,000 since 1988. Proponents of the increase argued that the major obstacle to raising the salary is the basic misunderstanding of just how hard they work for the money. Opponents said that the average senator receives a \$12,660 per diem reimbursement each year. Lawmakers who live within 50 miles of the Capitol receive \$46 a day during each day the Legislature is in session. Those further than 50 miles away receive \$123 a day and payment for one round-trip home per week.

Voters also said “no” to expanded term limits from two terms to three terms. The vote against was 64 percent to 35 percent for, according to unofficial results reported by the Secretary of State. The term limits first went on the books in 2006 after Nebraskans bought into the idea that this would be a great way to “get rid” of certain senators with whom they had become disgruntled. Interestingly enough ... “He’s Baaaaaacccckkkk!” Omaha voters gave the nod to the legendary Ernie Chambers

in his bid to come back after sitting out the mandatory one term. He defeated incumbent Brenda Council 67.16 percent to 32.84 percent after she was charged with gambling away campaign funds and received only misdemeanor penalties after agreeing to seek treatment.

Seventy-six percent of Nebraska voters agreed with a ballot measure to enshrine hunting and fishing in the state constitution. Nebraska was one of four states considering the move -- Idaho, Kentucky, and Wyoming were the others and 13 states already have it and seven others considered it but didn’t put it before voters. Proponents said it is important to protect the sports now before animal rights

groups act to challenge that.

A final ballot measure to make it possible to impeach officials for wrongdoing done while campaigning passed 83 percent to 16 percent. Currently, Nebraska elected officials can only be impeached for actions they take while in office. Proponents said the measure plugs a loophole exposed by the case of former University of Nebraska Regent David Hergert who was impeached in 2006 and removed from office for manipulating campaign finance laws when he ran for election in 2004. They said that he was impeached only because he signed a false campaign finance report after taking office.

I am very pleased to extend a warm welcome to Senator-elect Deb Fischer as a colleague in the U.S. Senate. Nebraskans have entrusted us with the tremendous responsibility of representing their ideals and concerns in Washington. I look forward to working with Deb to do just that. She'll take the oath of office in January.

Before that happens, Congress has a serious laundry list of issues it must address. Terms like "fiscal cliff" and "Taxmageddon," referring to a host of deadlines and tax increases at the end of 2012, paint a stark picture. The situation we are in is severe, and the need to reach some agreement is imminent. Failure to do so will have a potentially devastating impact on families and businesses in Nebraska and across the country. With only a few weeks before the end of the year Congress must address these fiscal challenges.

It's important to pull the curtain back and understand what is at stake behind the catch phrases and labels. The current tax rates, which have been in place for the last 12 years, are set to expire at the end of this year, just as some new taxes are scheduled to take effect. At \$536 billion per year, this would be the single largest tax hike in U.S. history. Roughly half comes from the expiration of the tax rate reductions and investment income tax rates implemented during President George W. Bush's tenure.

Many Nebraskans are rightfully concerned about the expiration of estate or "death" tax policy. Currently, estates in excess of \$5 million are taxed at 35 percent. If this policy is allowed to expire, estates will be taxed at a rate of 55 percent with only a \$1 million exemption, dramatically expanding the scope of those affected. While a \$1 million estate sounds like a lot of money, more than half of Nebraska's farms would exceed this exemption in land value alone.

Another looming tax hike is the Alternative Minimum Tax, which was originally designed to keep high-income earners from avoiding income taxes through various exemptions. However, over the years, the "high income" threshold has been eroded by inflation. This mark for a family filing joint taxes is currently \$74,450, but if congress doesn't act, it will revert to \$45,000. The Congressional Research Service estimates the number of Nebraska households impacted will climb from 16,546 in 2009 to 134,289 in 2013.

In addition, there are other expiring tax provisions including a number of popular deductions, like the child tax credit. To be clear, tax reform will not be easy. Deductions will be affected, but the goal is to lower overall tax rates and simplify your tax paperwork.


President Obama's healthcare law will also add an additional \$22 billion in new taxes next year alone. Besides those tax hikes, a round of automatic spending cuts known as sequestration are scheduled to kick in on New Year's Day. The cuts, totaling \$1.2 trillion over 10 years, are largely across the board, with half coming out of our national defense. I believe Congress must significantly reduce spending, but we need to carefully examine this blanket approach. I believe we can do better.

Despite disagreements about the right answer to our fiscal crisis, one thing remains uncontested: a new recession awaits us if we don't responsibly address this fiscal cliff looming on the horizon. It's time to make the difficult decisions that have been repeatedly put off. The alternative—crushing tax burdens and a shrinking economy—will undoubtedly be far worse.

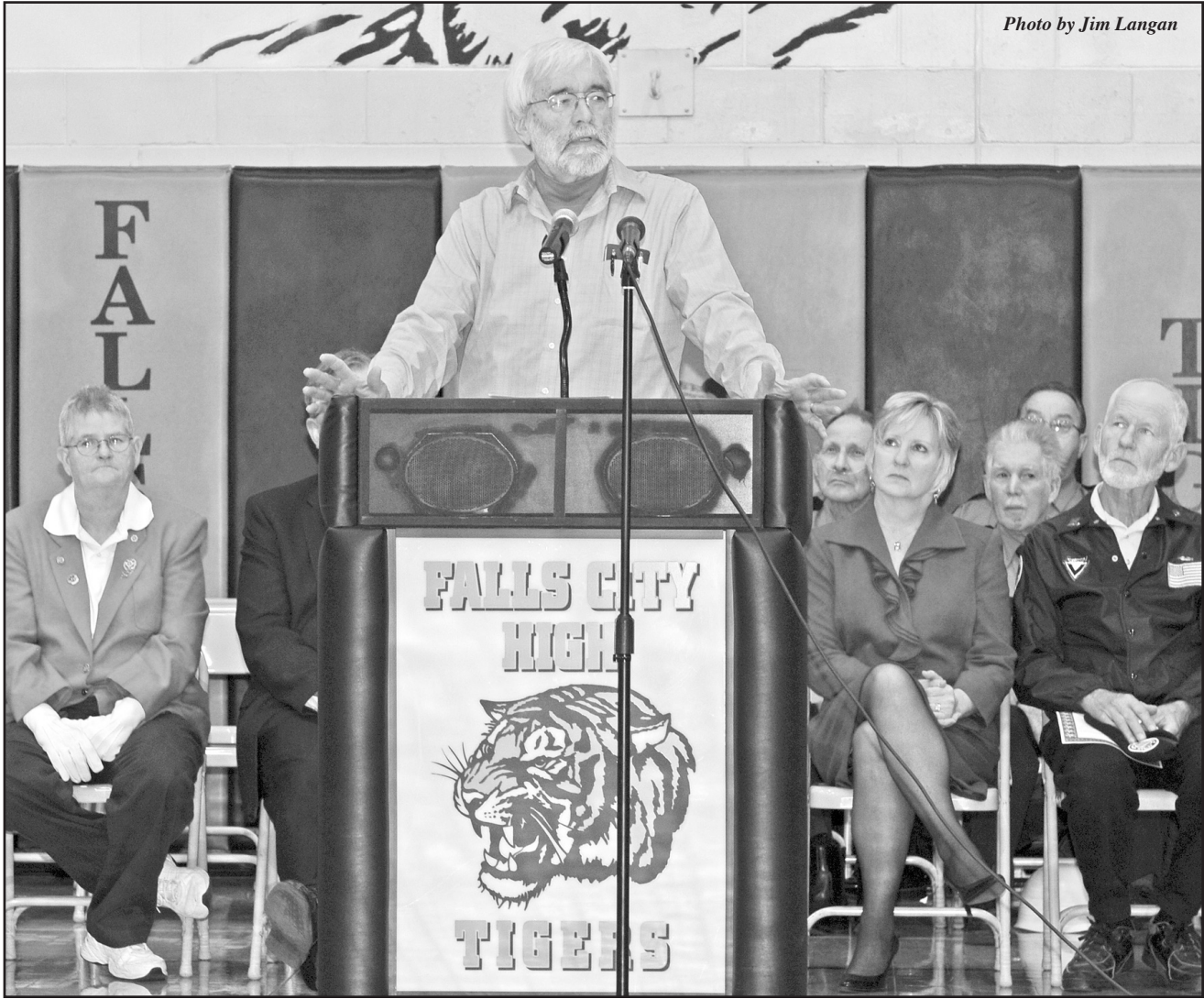
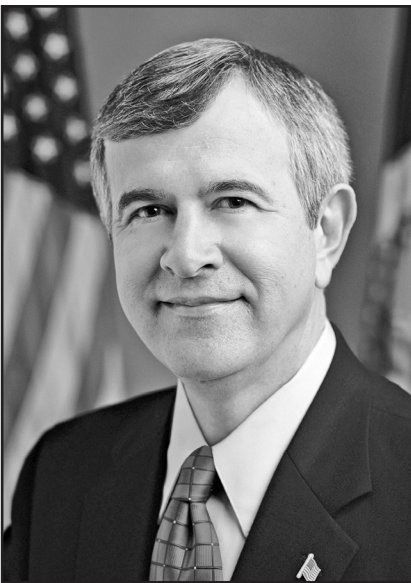

anticipated. Council members approved the extension.

Fire Chief C. Ken Simpson appeared before the Council to say the department is "a little short handed" because several part-time drivers have changed their regular full-time jobs and cannot fill in. He said he and Ralph Gilkerson have called for a part-time driver to work while they take a day or two off, to no avail. Simpson requested that more part-time drivers (a minimum of two) be added, which would not affect the Fire Department budget. The drivers would require training and would bring the total to eight positions. Simpson was very complimentary of the department members, saying he believes "we have the crew right now to get the job done." Council members approved the request.

In other developments, the Council:

—Approved a curb cut request at 1102 Stone.

—Approved minor changes in the City's Injury Prevention Program as recommended by the Safety Committee.

—Appointed Mike Dunn as City Attorney and Richard Halbert as Deputy City Attorney (reported in last week's Journal). Mayor Hersh had sought the resignation of Doug Merz and Bob Meyer from those positions, then, using his authority, removed them from the positions.

—Heard a report from Jorn regarding routine maintenance and projects within the city. Jorn asked that those who rent the auditorium leave it as they found it and said a problem has persisted with dogs running at large at Steele Cemetery. Should the problem continue, citations will be issued.

—Approved bids from EZ Construction Co. as recommended by SENDD for three owner occupied housing rehab projects. Each is in the amount of \$24,995.

—Approved requests for a wedding reception at Prichard Auditorium on Dec. 31, 2012, and that alcohol will be served.

The Mayor and Council met in special session Oct. 25 and held a public hearing regarding \$200,000 in redevelopment reuse funds. No one from the public spoke. Mrs. Cromer was present to say EDGE supported the measure, which received Council approval.

In addition, a loan/block grant of \$500,000 for the CGB project, as recommended by the Citizens Advisory Committee, was approved.

ily conflicts with returning veterans. "We help them deal with these issues," he said, while noting that Post Traumatic Stress Disorder affects from 14 to 18 percent of the veterans he sees.

A student asked about the reality that "we don't seem to win wars anymore." Schoen said he did not "have a good answer for that," but pointed to the Vietnam War, that may well have provided strength to other southeast Pacific nations through the U.S. presence.


He encouraged everyone to welcome returning veterans and thank them for their service.

The program opened with the posting of colors by the Falls City Ceremonial Honor Guard. The Falls City High School band played "The Star Spangled Banner" and the Rev. Lyle Schoen provided the invocation. Mrs. Maddox, a member of the VFW Ladies Auxiliary and Veterans Day chairman, introduced guests. The combined FCHS and Sacred Heart chorus members sang "American Anthem." Rev. Schoen gave the benediction. The colors were retired by the Honor Guard as the FCHS band played "Stars and Stripes Forever."

Veterans Day activities included an afternoon parade on Stone Street and a dinner and program Monday evening at the First United Methodist Church.

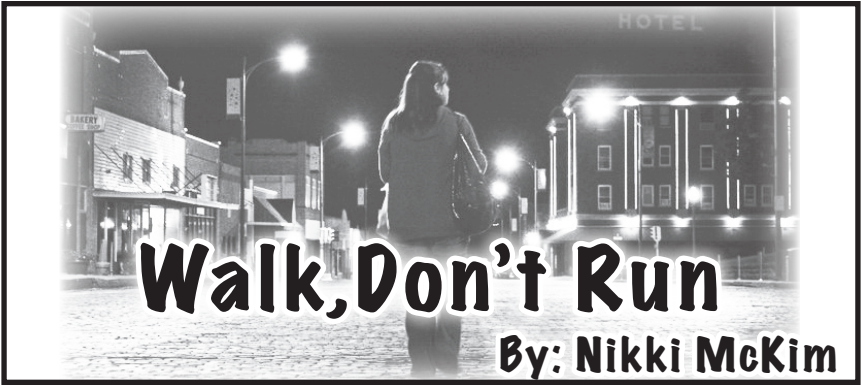

Mistrial declared in District Court

A 46-year-old Falls City man will stand trial again in January after Judge Daniel Bryan declared a mistrial last Tuesday in Richardson County District Court.

Michael Patnode is facing a Class 1-C felony charge of sexual assault of a child in the 3rd degree, and two Class 1-B felony charges of 1st degree sexual assault of a child. He has pled not guilty to all charges.

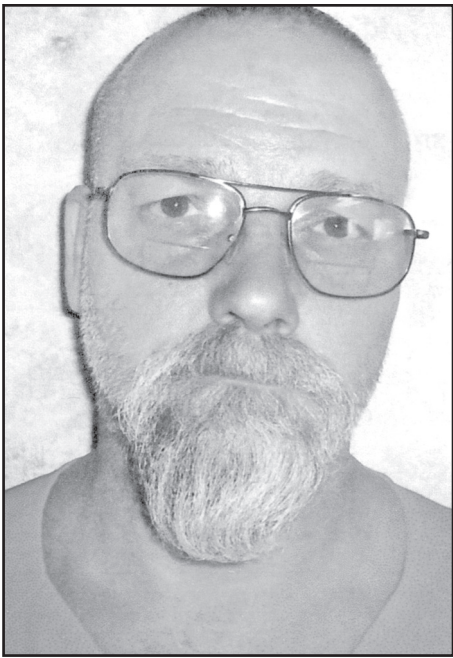
Patnode is accused of having sexual contact with a child less than 14 years of age on the first charge and on the other two charges Patnode allegedly subjected a child between 12 and 16 years of age to sexual penetration.

A new trial date was scheduled for Jan. 8 in Richardson County District Court, when Patnode will be tried on the same charges.

Attorneys for Patnode, who is accused of sexually assaulting a child, filed a Motion for a Mistrial, arguing that Patnode’s 5th and 14th Amendment due process rights had been violated.

Jeffrey Pickens, lead counsel with the Nebraska Commission for Public Advocacy, the agency representing Patnode, said the violation occurred because evidence was introduced to the court that was unlawfully obtained when investigators with the Falls City Police Department first approached Patnode about the accusations. Mr. Pickens said his client requested an attorney when first approached by investigators, but information was gathered by the FCPD before Patnode was given representation.

“The 14th Amendment due process clause prohibits, at the state level, evidence introduced by the State that was obtained after Mr. Patnode invoked his right to an attorney,” Pickens

said. “I made a motion for a mistrial after a witness for the State testified that my client had requested an attorney and information was gathered from him without counsel being present.

“Judge Bryan gave the prosecution time to do some research and to provide some legal authorities as to why a mistrial should not be declared. Obviously Judge Bryan was not per-

sued by those authorities and declared a mistrial. It’s just a bright-line rule. It’s very straight forward that when that (evidence is acquired after the defendant invokes his right to an attorney) happens, there’s a mistrial.”

Pickens said the law clearly identifies the procedural rights and restraints of the State and that the mistake to go forward with that evidence was made by the investigators and the Richardson County Attorney’s Office.

“It’s because in a jury’s eyes, only a guilty person would say, “Well I want a lawyer before I talk with you about these accusations,” or, “I don’t want to talk to you about them.” That’s why that kind of evidence is prohibited,” Pickens said.

The Class 1-B felony charges carry a maximum sentence of life in prison, with a minimum sentence of 20 years. The 1-C felony charge carries a maximum of 50 years.

Patnode was convicted of sexual assault charges in January of 2001 and spent two years in the Lancaster County Jail.



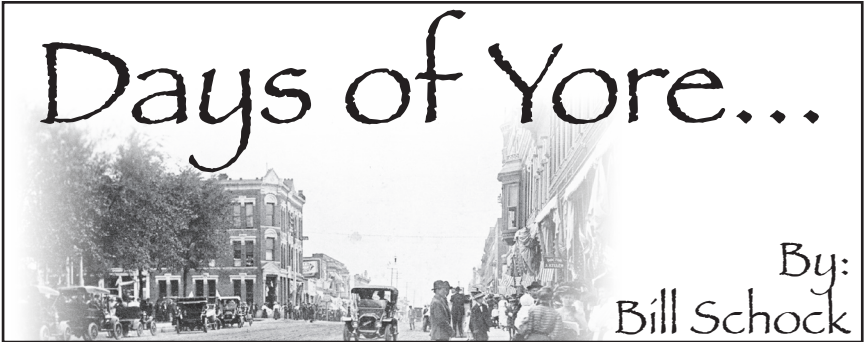

Something had to give Tuesday night at Jug Brown Stadium.

Two undefeated teams with contrasting styles of football – Falls City Sacred Heart’s explosive, quick-scoring offense versus Humphrey St. Francis’ physical, chew-up-the-clock ground attack – collided on the turf of Thomas Field Tuesday night in the Class D2 semifinal and many in attendance expected a tooth-and-nail battle similar to the last time these two 8-man juggernauts squared off in 1996.

The outcome Tuesday night was much different, however, than that last second, heartbreaking loss for the Irish nearly 16 years ago to the day.

Haiar’s play came on the defensive side of the ball when he jumped in front of Sacred Heart’s Sean Strasheim (No. 40) to intercept a pass with 4:35 remaining in the first half. Werner’s catch came three plays after Haiar’s interception on a 3rd and 13 from their own 20-yard line. Werner pulled down the catch despite a great effort from Sacred Heart’s Lane Scheitel. The pass-and-catch totaled 33 yards, extended the drive and eventually to the Flyers third touchdown of the game.

Third-ranked Falls City Sacred Heart, playing in their first semifinal since 2003, fell 38-13 to No. 2 Humphrey St. Francis, ending their season at 11-1.

At stake was a trip to Lincoln and a game at Memorial Stadium next Monday morning for a shot at the state championship.

Big and physical, St. Francis imposed their will early on and made everything difficult for the Irish, holding FCSH’s explosive offense to 34 total yards in the

first half and a season-low 97 on the ground for the game. Sacred Heart entered the game averaging over 320 yards per game on the ground.

Offensively, the Flyers backfield—JJ Oltmer (sophomore RB), Chad Haiar (senior RB) and Nathan Classen (senior QB) – ran behind five burly seniors up front – RG Tristen Foltz (235 pounds), LG Michael McPhillips (220), C Corbin Eisenmerger (235) and Ends John Wieser (215) and Jake Werner (195). The trio combined for 43 carries, 240 yards and all five of the teams touchdowns.

The first quarter felt like the first couple rounds of a heavyweight championship boxing match. Both teams sort of stood in the middle of the ring, feeling each other out and were content on throwing jabs. Neither team’s offense really threatened in the opening frame, but the Flyers took control in the second quarter when their jabs turned into shots to the body by way of three impressive scoring drives.

Oltmer, who finished with a game-high 144 yards and a touchdown on 19 carries, busted loose early in the second

quarter for a 25-yard run and an 18-yarder to set up the first Flyer touchdown. Then, he

added a 33-yard run to set up the second touchdown and finally, a 14-yard burst led to the third score of the quarter and gave St. Francis a 22-0 halftime lead. The runs of 18, 33 and 14 all ended inside the 2-yard line at the south end of the field and each time Classen punched in the quarterback sneak.

The three drives totaled 24 plays and chewed up over 10 minutes of clock. The third TD came with just 47 seconds remaining in the half and seemed to knock the air out of Sacred Heart.

“Those drives were kind of demoralizing,” FCSH head coach Doug Goltz said. “We watched enough film to know how physical they were going to be. That first quarter we did pretty well, but their runs sort of kept getting a little bit longer with each carry and we just struggled to get off their blocks. Our kids fought hard, but they just kept hammering the iso and that toss play at us.”

Offensively, the Irish could not get anything established consistently, especially in the first two quarters. Sacred Heart had five drives in the first half, three ended with 3-and-outs and the other two were stopped by an interception and halftime. The first Irish first down did not come until midway through the second quarter.

“We struggled blocking their linebackers,” Goltz said. “Their front five was so good that their defensive backs could play back and it really limited us as far as throwing the ball.

“We needed to cut into their lead before halftime, but

our small guys couldn’t quite get their linebackers blocked, especially Wieser. We didn’t get him blocked all night long.”

Irish senior quarterback Lane Scheitel had a decent stat line through the air, finishing 10 of 20 for 131 yards, including a 49-yard touchdown pass to senior Clay Finck late in the game, but an interception with 4:35 to go in the second quarter set up St. Francis’ third touchdown.

Sacred Heart got some things going offensively in the second half, but two of their drives fizzled out on fourth down and another ended on a miscue between Barnhill and Scheitel that resulted in a fumble, setting up a nail-in-the-coffin Flyer touchdown two plays later.

On 2nd and 8 from the Irish 23-yard line, Oltmer took the pitch around the right end and broke free into the Irish secondary and ultimately delivered the knockout punch. He added the 2-point conversion and with 4:41 left in the third quarter St. Francis led 30-0.

The Flyers defensive front kept the heat on Scheitel the rest of the game, keeping him out of his comfort zone and never gave him a chance to establish a rhythm throwing the ball.

Goltz credited St. Francis’ physical play and knew his team would have to have their best to advance to Lincoln.

“We were going to have to play a pretty flawless game,” Goltz said. “We made too many mistakes and they are too good to make mistakes and win.

“We just didn’t execute well enough.”

Senior running back Lane Barnhill, who had one of the best seasons ever for an Irish running back, finished the game with 60 yards on 13 carries. Barnhill’s 2012 season reads like this: 142 carries, 1,517 yards (10.6 yds/att) and 31 TDs on the ground, as well as 9 receptions, 93 yards and a touchdown receiving.

Scheitel led the Irish defensively accounting for 18 tackles, eight of which were unassisted. Senior Brody Chandler was a part of 11 tackles, while juniors Jarod Fiegenger and Brandon Schawang combined

for 10 solo tackles and 24 total stops. Fiegenger also recorded two quarterback sacks and finished the season with a team-high 13. Schawang finished the season as Sacred Heart’s leading tackler with 114 stops, including 52 solo.

Goltz, who led the Irish to their state record 26th straight playoff appearance, praised his team’s effort throughout the season, but particularly noted the effort and leadership his seven seniors provided in the offseason the last couple of years.

“This was a really special group of seniors,” Goltz said. “One of the better groups we’ve had around here in awhile. The kids worked really hard in the offseason and it’s been this senior class leading the way.”

Joining Barnhill, Chandler, Finck and Scheitel in their final Irish football games Tuesday night were Will Burenheide, Brady Cromer and Derek Bippes.

Humphrey St. Francis will face Giltner in the Class D2 State Championship game Monday at 10:45 a.m.

Top-ranked Giltner (12-0) defeated Shelton 60-20 in the other semifinal Tuesday night.

By and large, Nebraskans headed to polls

Based on the initial data, nearly 67 percent of registered Nebraska voters cast their ballot in the Nov. 6 general election, according to Secretary of State John Gale.

“That is short of our initial prediction of 71 percent turnout,” said Gale. “We had

hoped to come close, if not exceed what we had in 2008. All the conditions were ripe for that to happen. The weather cooperated, there were highly contested races, early voting appeared to be strong and polling places were busy on Tuesday.”

Counties continue to count provisional ballots, which will bump up the final total. Provisional ballots are utilized if there are questions about a voter’s registration. At this point, 779,285 people voted across the state.

As far as each of the congressional districts are con-

cerned: 67.5 percent voted in District 1, 66.7 percent voted in District 2 and 69.8 percent voted in District 3.

The county with the highest voter turnout was Hitchcock with 86.7 percent. The next highest turnout was Sioux County with 80.1 percent. The lowest turnout was in Thurston County with 46.8 percent.

“While we did not reach the projection, I am pleased that, by and large, Nebraskans headed to the polls,” said Gale. “I know that since early voting started in October, our county election offices all across the state have been extremely busy. We appreciate their efforts as well.”

Gale also said that there are some races that may warrant an automatic recount, after factoring in provisional ballots. “There are a couple of Legislative races and one race for the Southeast Community College Board that could apply.”

Counties have until next week to tabulate their provisional ballots and report the results. The final statewide results will be certified on Dec. 3.

Thursday is Nat’l Rural Health Day

Amazing things are happening in rural America. These small towns, farming villages and frontier areas are fueled by the creative energy of ordinary citizens who historically have been willing to step forward and take risks in order to provide a wealth of products and resources for the rest of the country.

Meanwhile, rural hospitals and health systems face declining reimbursement rates and disproportionate funding levels that make it challenging to meet the physical, social and economic needs of their communities.

These are just a few of the issues that Nebraska Rural Health Association, the National Organization of State Offices of Rural Health, and other local, state and national rural stakeholders hope to bring to light during the second annual National Rural Health Day on Thursday, Nov. 15, 2012.

NOSORH created National Rural Health Day as a way to showcase rural America and increase awareness of rural health-related issues. “National Rural Health Day gives NOSORH and its partners the opportunity to ‘Celebrate the Power of Rural’ and showcase the good works of America’s 59.5 million rural citizens,” notes NOSORH Director Teryl Eisinger. “It also allows us to highlight the unique healthcare issues being faced by rural citizens and promote the efforts

SORHs in particular play a key role in addressing those needs, Eisinger explains. All 50 states maintain a SORH, each of which shares a similar mission: to

foster relationships, disseminate information and provide technical assistance that improves access to quality health care for rural citizens.

“Together, these State Offices provide technical assistance to more than 28,000 rural communities each year,” she says.

The Nebraska Rural Health Association is a nonprofit membership organization with over 500 individuals and organizations. The association’s mission is to provide leadership on rural health issues. NeRHA membership consists of a diverse collection of individuals and organizations, all of whom share the common bond of an interest in rural health.
