St. Paul's Lutheran Church celebrates Centennial Nov. 24


On Sunday, Nov. 24, 2013, the people of St. Paul's Evangelical Lutheran Church (20th and Towle Sts.) will gather to celebrate 100 years of ministry in the Falls City area.

The celebration will begin with a festival worship service at St. Paul's at 10 a.m. Following the service, a banquet will be held at Prichard Auditorium, with a program featuring special music and greetings from special guests. The day's events will conclude with an open house at St. Paul's.

The community is invited to join us for light refreshments and displays featuring historical items and recordings of significant events in the congregation's history. Founded by the Rev. William T. Kahse, the Missionary Superintendent of the Evangelical Lutheran General Synod of the United States of North America for Nebraska, the charter was signed on Dec. 3, 1913 by Ernest Gruber, Jacob Miller, Martin Nolte, Gottlieb Viegel, Andrew Ketter, Henry Roesch and Lewis A. Meinzer.

The congregation began meeting in the Electric Theatre

County forced to make decision on jail

At this point in their preliminary concept planning, members of the Richardson County Jail Committee are looking at two basic options.

One (Option 1) is to convert the county-owned Armory building just west of Falls City into a 24-bed jail and Law Enforcement Center. The other (Option 2) is to close (or be forced to close) the current Richardson County Jail atop the Courthouse and transport

While the current jail has met recent inspections,

the majority of jail spaces required by Nebraska Jail Standards are lacking — insufficient for the operation of a modern jail.

Committee members met Nov. 7 and are expected to make a recommendation when they meet again at 6:30 p.m. Tuesday, Nov. 19, in the District Courtroom at the Courthouse.

Sheriff Randy Houser has said that if the jail were to close, a couple of prisoners could be transported to Nemaha County, but most would be taken to Cass

County. The county would pay a daily fee per prisoner housed at another facility and would be responsible for all medical expenses. Any liability would remain with the county. And housing fees would be subject

Jay Weingarten of Prochaska & Associates presented and described the budgets for each option. The construction budget for the Armory was estimated at

ragedy was only narrowly avoided Monday afternoon when two Ford F-250 pickup trucks collided on Highway 73, less than one mile north of

Richardson County Sheriff's Office, responded to a 911 call made from Merz Farm Equipment just after 1 p.m., moments after the collision occurred.

According to Jeremy Goldsberry of the FCPD, an eastbound 2008 F driven by Christopher Wilcox, 39, of Falls City, entered Highway 73 from a stop sign and collided with a northbound 2000 F-250 operated by Stanley Duerfeldt, 56, also of rural Falls City. The airbag in Duerfeldt's vehicle, which was traveling at an estimated 60 miles per hour, deployed and he suffered only minor injuries. Neither Duerfeldt nor Wilcox were transported to the hospital by ambulance.

nearby Community Medical Center for treatment of a possible neck injury.

No citations had been issued as of 4 p.m. Monday, though the accident remained under investigation.

A couple of weeks ago, this column addressed a concern by a local bird feeder/lover who is concerned about what appears to be a dwindling bird population in Falls City. She said her feeders are simply not attracting the numbers they used to and wondered why. In the time since that column appeared, I've received some possible explanations:

The use of pesticides and fertilizers. Not necessarily agricultural, but mostly in town on yards, where lots of folks want their landscaping to be weed-free and green. It's hard to blame them. People take pride in their yards and want them to enhance the appearance of their properties. But in all likelihood, the chemicals applied to yards do have an impact on our aviary friends.

Critters. From squirrels to cats, possums and raccoons, and blue jays that scare birds away, the bird population has a lot to deal with. The fellow I talked to emphasized the stray cat numbers in town and the impact that could have on bird numbers. As an example, I have



a feeder that I can see from my kitchen. The other day, a stray cat camped out underneath it and the feeder attracted no activity. I went outside and shooed the cat away, but birds stayed away for quite

Hawks. A caller from southeast Falls City said he's noticed an increasing number of hawks perched on phone lines and feasting on birds and squirrels (yes, squirrels).

"They're knocking the heck out of them," he said. The birds the hawks don't dine on are frightened away. "They're scared to death of them," he said. Not all that long ago, I remember a hawk or two downtown and the mess they made as they made quick work of other, less aggressive and defenseless birds.

The column also brought a response from Arley Minshall of Salem, who builds (to specification) and sells bird feeders and birdhouses. In the photo that we've included, Arley has crafted a feeder in the form of a log cabin, a wren house and a more conventional feeder. He also makes bluebird houses and crafted a Husker-themed work for someone as a Christmas gift. Arley said his unique houses and feeders are a pastime and are made mostly of oak. He, too, has noticed the decline in bird numbers. Those who would like to attract birds using one or two of Arley's creations can contact him at 402-245-5138.

Elsewhere in today's Journal is a story about the options being considered by a county-appointed jail committee. When the county purchased the Armory building west of Falls City, the idea was that someday it would be converted into a jail and law enforcement center. That was good foresight.

The county's current jail is inadequate. It's been a source of contention with Jail Standards for about as long as I can remember. At some point, the facility will be ordered shut down. There's just no escaping that fact. Think what you want about those who call it home from time to time, but also consider the Sheriff's Department employees who are charged with keeping prisoners safe, judges who have to consider the conditions before sentencing people to time in those conditions and Jail Standards officials, who, after all, have to consider actual "jail standards."

Two basic options are on the table. One is to convert the Armory into a jail and law enforcement center. The other is to eventually (I'm guessing sooner rather than later) close the jail and transport prisoners to other facilities, with the county picking up the significant tab.

We expect an awful lot from local law enforcement and it is my belief that our Sheriff's Department and Falls City Police Department are conscientious in their efforts and duties. Not many who commit criminal acts in Falls City and the county, or are suspected of those acts, are not arrested. "Professional" is the term I'd use to describe our officers, deputies and related workers.

It just makes sense to me to provide a safe, code-friendly facility. The costs to revamp the Armory are high, but not as high as transporting and paying boarding fees. And certainly not as high as might occur in a lawsuit.

Retention of best, brightest deserves consideration

A few weeks ago, I shared some ideas from the former director of one of the state's most philanthropic private foundations who urged Nebraska lawmakers to dip into the state's \$679 million cash reserve fund to invest in community development to make the state even more attractive to outsiders.

Lyn Wallin Ziegenbein, longtime executive director of the Peter Kiewit Foundation, told members of the Legislature's long-range planning committee to use some of the money as a catalyst for communities to build: libraries and parks; public art and plantings; health facilities; large recreation areas; and supported law enforcement to bring them up to par as part of the "Good Life."

I received some pushback on the topic. Good ideas and laudable goals, I was told, but the stuff of fluff. "Putting lipstick on a pig," one person said. I spent enough time doing community development and historic preservation work in a previous life to know that physical improvements on a building mean nothing if the structure isn't sound and occupied with a viable business. Neither is the quality of life any better with nice infrastructure and available amenities if the workforce isn't educated and innovative.

It was suggested that the better way to attract those sought after "outside parties" to want to invest in and become a part of Nebraska is to focus on a better educated workforce in areas of technology, science, and math along with a change in attitude toward strengthening what is already there. There needs to be creative thinking by better educated students and teachers to go along with the money infusion that was suggested to the legislative committee.

The "woe are we" mentality of small towns has to be broken. There needs to be an understanding of why the best and the brightest often leave these places never to come back. Often they have left to go someplace where they can be the best and brightest surrounded by other best and brightest. Big cities are full of people who once lived in smaller places and would love to return to a simpler lifestyle some day, but only if they could take their challenging careers and best and brightest colleagues with them. The number of people who can work remotely at these tech type jobs grows exponentially, al-

most daily. So why can't they go back home? My previous life experience revealed several factors that need to be addressed. One is housing. I look at communities like Sidney or Chadron that have a lot going for them - Sidney with a worldwide headquarters for popular retailer Cabela's and Chadron with a four-year college. But there are not enough entrepreneurial or skilled builders who realize the opportunity sitting in front of them to build or remodel housing for the expanded workforce. The builders and remodelers who are that smart are too busy already. I heard from a Cabela's employee in Lincoln who was offered a better job at the same

company in Sidney, but turned them down because there's no place to

We don't need more public art, but we need better-planned and implemented festival type activities (music, food, art) in smaller communities that attract the type of people that towns really need to be attracting. For the "best and brightest" that communities want to attract, such activity is as appealing an amenity as parks and libraries. Look at the awesome festivals in rural states like Colorado, Washington and New Mexico that draw huge crowds, often from out of state. It's got to be more than just the (insert town name here) festival. AND, that takes money and talent to pull off.

We don't need brand new and shiny, but we need to rehab our existing deteriorating libraries and bring the facilities and their systems into the 21st Century. The last thing we need are more parks, but we need to put money into taking care of the parks we have.

Everyone wants shiny and new but that's not going to fix the problem and it will only create new problems. Preservation saves money and pays dividends.

Let's hope that the Legislature is paying attention as it looks at longrange solutions and visits with the hands-on community developers and preservationists who have the experience to know what is really needed.

Over the weekend the metropolitan newspapers were filled with "what were you doing when you heard that President Kennedy had been assassinated" accounts.

Bringing it closer to home, I asked fellow Journal employee Ron Dodds where he was and what he was doing. His answer was quick—he was eating dinner at his parental home when the breaking news came over their tv set.

He finished off the meal in a hurry and returned to the Journal where he was operating a linotype. He knew he and the others would be pressured to get the type of the United Press story of the Dallas shocker set before the press deadline.

Scott Schock, our publisher, was a freshman at FCHS. He was in a class seated in the balcony of the old gym when the news came. School continued.

Our other four employees hadn't been born.

I was the Journal's city editor working on late items for the afternoon's paper and was seated next to the chattering teletype when bells on it began ringing—big news was on its way. The president had been shot in Dallas! Bits and pieces about the scene in Dallas began appearing and then shortly after l p.m. the teletype, with more bells ringing, ran off a paragraph that President Kennedy was dead.

Within minutes the UP's Merriam Smith's memorable story of the assassination began unfolding. Thanks to the three linotype operators in the back shop the complete story made it into that Friday's Journal.

I remember that business came to a standstill in Falls City that weekend as most everyone remained glued to their TV sets. Scenes and anchormen's (like Walter Cronkie) accounts were played over and over but that didn't matter. Breaking news interrupted flashes them. We just couldn't

get enough information. Then on Sunday we—again nearly everybody—were watching when Jack Ruby shot Lee Harvey Oswald at point blank range. My gosh, how much more could there be? There was--on Monday the funeral service and the historic walk to Arlington National Cemetery. Everything is being reviewed on tv this week on the 50th anniversary of the assassination and it all will come back.

Although I believe I probably voted for Richard Nixon rather than JFK in the presidential election, I regarded Kennedy as the real World War hero he was. I have been intrigued with the assassination for the past 50 years and have read most all of the books about the assassination and President Kennedy the Library has on its shelves as well as numerous others. William Manchester's "The Death of a President," published in 1967, tops all of them (even Bill O'Reilly's "Killing Kennedy"), in my opinion. Manchester was commissioned by the Kennedy family to write the book, but the had a falling out with the family over it, and was sued by Jacqueline Kennedy.

With Oswald's death, the source of the why's and how's began and have persisted for these 50 years. One has to come to the conclusion that Oswald fired the shots. I still can't fathom how he did it so rapidly and so accurately with a two-bit, bolt-action rifle, even with a scope. The conjectures are endless.

Here are some personal bits with a relationship to the above. In 1962, Colonel Ernest J. White, a lifelong friend from Falls City days who was the commanding officer of Otis Air Force Base on Cape Cod, Mass., invited me to spend a January weekend there and possibly to shake hands with President Kennedy or maybe just observe from up close as he flew into Otis on Air Force One for the weekend at the famous Kennedy compound. Ernie always met the President and escorted him to the compound. So on Thursday an Otis AFB Constellation aircraft picked me up at the Lincoln Air Force Base. A couple of hours into the flight bad news came over the plane's radio. A 14-inch snowfall had closed down the Otis runways except for emergencies and the President had cancelled the trip. So our pilots diverted to McGuire AFB in New Jersey. The next day we flew to Otis and I spent the weekend learning how the fighter pilots there would tangle with any enemy aircraft approaching our upper East Coast. I also nre than glimpsed the red telephone on White's desk connecting him with the White House. Any peon would have been impressed.

I don't think it has been so much an idolization of John F. Kennedy with me as it has been a lasting intrigue with that horrific day in Dallas. Along with most everyone visiting Dallas Dorothy, our daughter, Laurie, and I had to see Dealey Plaza and the School Book Depository building. Dorothy and I also visited the Eternal Flame burial site in Arlington National Cemetery and in Boston's environs the Kennedy Memorial Library with the replica of JFK's PT 109 boat outside.

Of course I'll be watching at least some of the documentary programs this week. The Omaha World-Herald summed it up real well in Sunday's special section on the assassination with the headline, "Frozen in Time." What took place in Dallas on Nov. 23, 1963, sure has been for me.

Medicare enrollment time: Your options

Before reviewing options for next year's Medicare coverage, it's important to understand how Medicare fits with the Affordable Care Act often called Obamcare. With all the media attention focused on shoppers in the individual market and their troubles navigating the government's website, it's no wonder seniors want to know if they have to sign up somewhere to keep getting their Medicare benefits. Do they have to shop in the exchanges? What happens to their premiums?

Relax! The answer is seniors and disabled people on Medicare don't have to do anything. The Affordable Care Act is basically aimed at people who don't have insurance from another source. That means people whose insurance is Medicare cannot shop in the state exchanges. For that matter neither can people who have coverage from their employers, the military, or Medicaid.

Contrary to political rhetoric, the Affordable Care Act does not reduce anyone's Medicare benefits. In fact, it calls for more coverage--free preventive services such as mammograms and annual check-ups, for example. Medicare beneficiaries have been slow to take advantage of these services.

of these services.

Some beneficiaries are afraid they will be cut off from Medicare as they get older. That fear is understandable given the political talk about changing Medicare to save money for the federal government. Most of that talk centers on making "wealthier" beneficiaries pay more for

D (drugs) benefits. But Congress has not addressed that so far this year. So the talk is, well, just talk.

their Part B (doctor and outpatient services) and Part

What about that fear of rationing---that 90-year-olds won't get care they need at the end of their lives. The Affordable Care Act does not allow any kind of rationing under Medicare, and there are no death panels—those imaginary end-of-life committees that scared seniors a few years back. If a procedure or service is medically necessary, then Medicare pays according to the program rules. The Affordable Care Act prohibits Medicare from using the cost effectiveness of a service or treatment to determine whether to cover it.

Seniors also want to know if can they keep their doctors and other healthcare providers. It's easy to see why they are concerned when media outlets have been running stories about limited provider networks in the state shopping exchanges.

Depending on what supplemental insurance seniors choose to cover their Medicare coverage gaps, they may not have an unlimited choice of providers. As a trade-off for cheaper premiums, these beneficiaries may well find their choices of doctors, hospitals, and other providers are limited. That's because insurers selling in the state exchanges have obtained large discounts from certain providers that allow them to pass the savings on to patients in the form of lower premiums. But as a trade-off for cheaper premiums, those who enroll in these plans may well find their choices of providers are limited.

But some Medicare beneficiaries also have restricted choices if they choose an HMO, a type of Medicare Advantage plan, which offers seniors a lower monthly premium than traditional Medigap policies do. There's a catch, though. They must use providers in the insurer's network.

If you want to choose your providers without limitations, then sticking with traditional Medigap policies is the best choice. Medigap Plans F and C cover medical expenses with minimal cost-sharing, and they are still the gold standard for many.

With a Medigap policy, you'll have to also buy what's called a stand-alone drug plan.

So the calculation c


So the calculation comes down to the cost of the policy plus the cost of the drug plan and freedom to choose your providers versus restrictions and a lower monthly outlay.

There's one big difference right now between what Obamacare shoppers and Medicare seniors face. The government's website Medicare.gov is working while the HealthCare.gov site still has technical troubles. But that doesn't mean Medicare shoppers will get all the information they need to make a good choice. I looked at Medicare Advantage plan options available to beneficiaries living in one zip code area in Lincoln, Neb. Important details about the plans were missing--- among them the premium. It's kind of hard to make a good decision without that.

Beginning Jan. 1, 2014, campers at Kirkman's Cove Recreation Area and Iron Horse Trail Lake will pay a little more to hook their RVs up to electricity at those parks.

\$2,821,020, with other (soft, i.e. construction phase testing, furnishings, equipment, etc.) costs projected at \$805,260, for a total of \$3,626,280.

Estimates for transporting and boarding prisoners in another county for 20 years are projected at \$7,910,629. But that's just for 20 years. The costs to transport and house would continue indefinitely, or until the county builds a jail. The county would be vulnerable to fluctuations in available beds and/or rates.

The 20-year period of transport and boarding costs is used as a comparison with the length of a construction bond, which could be used to finance Option 1.

Denny Macomber from Jail Standards attended the Nov. 7 meeting and pointed out that Richardson County has saved a significant amount of money by purchasing the existing Armory. The costs to build a jail from the ground up would be much higher.

Andy Snyder from Smith Hayes explained financing options. A 5-cent tax increase (allowable for construction of county facilities such as jails) would generate, over time, about \$7,250,000 for a project. The current budget for Option 1 would represent a tax increase of about 2.5 cents per \$100 of taxable valuation, or approximately \$25 per \$100,000 of valuation.

At the conclusion of the Nov. 7 meeting, committee members gave their thoughts and opinions about the project. Among the discussion items: refitting the Armory as a jail/Law Enforcement Center appears feasible (it is an infrastructure and will need to be done sooner or later; the costs are better now than they will be in the future; interest rates are low); the tax costs to taxpayers could become difficult, depending on ag land valuations and lower commodity prices; could the number of cells/beds be cut?; if the number of cells/beds were cut, that would reduce the number of classifications of inmates that could be held; is the project overpriced?


A preliminary committee vote on a possible recommendation to the county board was seven in favor of proceeding with the project and two against.

Irish roll in to state final, 61-44, over Wynot

By Jim Langan Whew. The long march to Lincoln is over.

Falls City Sacred Heart outdueled Wynot Monday afternoon in the semifinals of the Class D2 playoffs and escaped with a 61-44 victory to secure the school's first state finals appearance since 1994 and their first ever at the home of the Cornhuskers.

The top-ranked and still undefeated Irish (12-0) handed No. 3 Wynot (11-1) their first loss of the season and in doing do will play for the D2 state championship next Monday afternoon at 2:45 at One Memorial Drive.

"It's great for these kids," said FCSH head coach Doug Goltz, who entered Monday's game with an 0-4 record in state semifinals since winning sixstraight championships from 1989-94. "Last year we made it to the semifinals and they got a taste of being that close. I think this year they knew how close they were, they knew what it would take to get here and busted their tails all season long. They are such a great group to coach and I'm happy for them that they get a chance to play at Memorial Stadium.

"The whole game, with that many points being scored, was kind of a blur, but the stop right before the half was huge. They get that touchdown and they have all the momentum, instead we took the momentum and the lead into the half."

The stop Goltz was referring to, which was one of only a handful the entire game by either team, came at the Irish one-yard line with one second left on the clock and the Irish clinging to a 40-32 lead. Wynot quarterback Jackson Sudbeck's pass fell incomplete, as did the Blue Devils hopes of tying the game before the intermission.

Wynot, behind Sudbeck's three second-quarter TD passes,

stormed back in the game after trailing 26-8 at the end of the first, but the Irish made the play and kept the momentum.

"In that second quarter we were kind of reeling," Goltz said.

"Their offense is just so tough to defend because the quarterback puts the ball on the money and they've got a lot of guys who Wynot offense, which entered can catch the ball. They decided to just run that combo route on one side or the other and (Davis) Wieseler got to the middle on the post route too many times and that's what we talked about trying to take away the second half. Wieseler is a great, great end. He's as good as I've seen in a long, long time."

Goltz pointed to his defensive line's effort and said despite their

final sack numbers for the game, the pressure frustrated Sudbeck.

The Irish held the prolific the game averaging 54 points per game, to 12 second-half points and came up with two huge interceptions in the fourth quarter. Irish senior Jarod Fiegener's first interception of the season came with 7:51 left in the game and FCSH clinging to a 47-44 lead. That came after senior Chaz Dunn picked off Sudbeck for the second time early in the fourth quarter with the Irish leading by only two, 40-38.

Sudbeck still finished the

game with 413 yards passing and five touchdowns, but the majority of the yards and three of the TD passes came in the first half.

"We made a few adjustments at halftime to take away the long ball to Wieseler," Goltz said. "We moved Austin (Malone) to the middle and we also sort of backed off, kind of daring them to run it and Chaz had some big interceptions. The whole defense played great and it was really a great team effort."

Dunn first interception came on the Blue Devils' second drive of the game as they were threatening to score with the ball deep in Irish territory.

Defensively, Wynot rarely had an answer for Goltz and the Irish. FCSH scored touchdowns on nine of their 15 possessions and that included two turnovers two punts and taking knees on their final possession to end the

The Irish scored on their first four possessions, three came via the arm of Dunn and the other via the legs of junior running back Sawyer Kean. Dunn found senior Colin Niemeyer for a 41yard TD pass on the first Irish drive, then Kean raced 20 yards for a score to put FCSH ahead 14-0 with 5:14 left in the first quarter.

Wynot's failed fourth-andone attempt set up Dunn's second TD pass of the game – a 29-yard pass to Malone on fourth down and four with 2:19 remaining in the first – and moments later, Dunn again found Malone who raced 49 yards to the end zone

and put FCSH ahead 26-8.

Kean and Dunn each added TD runs of three and 54 yards, respectively, in the second quarter to keep the Irish in front, but Kean's workload increased in the second half as the Irish looked to keep the ball away from Sudbeck and the Wynot offense.

"The offense did a really nice job," said Goltz. "We thought our offense was going to be able to take care of the ball well enough and it did. The first half Wynot did a pretty good job of defending our speed option, so we kind of changed the blocking scheme a little bit and we were able to spring Sawyer loose and he reads blocks well. The first half they did a pretty good job of scheming us, but I thought in the second half we did a good job of out-scheming them a little bit."

Kean finished with a gamehigh 220 yards and four TDs on 29 carries.

Dunn threw for 233 yards and five touchdowns on 15-of-22 attempts. Dunn now has 1,725 yards passing on the season and surpassed Brian Lemerond's single-season mark of 1,528 yards set in 1998. Dunn also added to his singleseason TD pass record, which currently sits at 32 on the year.

Falls City Sacred Heart senior quarterback Chaz Dunn accounted for six touchdowns - three rushing, two passing and a pick-6 – and helped lead the top-ranked Irish over visiting Humphrey St. Francis, 51-30, in a Class D2 quarterfinal matchup Tuesday night at Jug Brown Sta-

The Irish trailed briefly, 8-7, midway through the first quarter, but answered on a five-yard TD pass from Dunn to junior Logan Scheitel and then pulled away in the second half after leading 21-14 at the break. FCSH is now 11-0 and into the semifinals for the second-straight year.

Dunn's performance was exceptional, to say the least. He completed 28-of-32 pass attempts for 255 yards and two scores, rushed for three more touchdowns and his 32-yard interception return for a TD with midway through the fourth quarter put FCSH ahead 44-22 and grounded the Flyers for good.

Senior Colin Niemeyer hauled in nine receptions for 109 yards, while Scheitel finished with a game-high 10 receptions for 95 yards and a TD junior Austin Malone caught six passes

Recruiting Report

The visitor list for Nebraska-Michigan State weekend has evolved into a big opportunity for NU to build their 2014 recruiting class.

Raymon Minor (6-3/210) an athlete from Richmond, Va. has added his name to the official visitors list for the Nebraska-Michigan State game this weekend in Lincoln. Minor's long been considered a strong lean to Virginia Tech, but is also weighing offers from Ohio State and West Virginia. He also counts Clemson, Miami and Wisconsin among his nearly 30 offers. Defensive coordinator John Papuchis is his lead recruiter, as he works that Del-Mar-Va area for NU (Delaware-Maryland-Virginia).

The Huskers are recruiting Minor as an athlete, and he could project as a safety or wide receiver. He plays both positions for his high school, and professes no preference.

Another late addition is defensive back Josh Keys (6-2/180) of Perkinston (Miss.) Gulf Coast Community College. This will be Keys' first official visit, but NU is also battling Auburn, Baylor, Georgia, Missouri and Texas A&M for his commitment.

Keys is a rare junior college prospect who will graduate in December and will have three years to play two, having never redshirted. He's among the top 5 JUCO cornerbacks according to all of the recruiting services, and could provide immediate help at a position where NU graduates seniors Stanley Jean-Baptiste, Ciante Evans, Andrew Green and Mo Seisay.

Committed receiver prospect Demornay Pierson-El (5-9/174) of Alexandria, Va., along with current Huskers senior defensive end Jason Ankrah and redshirting freshman linebacker Marcus Newby, all hail from the same region as Minor. Pierson-El will be visiting this weekend as well, and those current and committed Huskers will share their background and reasons for choosing Nebraska. I wouldn't expect a commitment from Minor, but hopefully NU can give him a lot to consider.

Another committed player visiting this weekend is defensive back Trai Mosley (5-10/171) of Pflugerville, Texas. Mosley will be in town with his high school teammate and Colorado commitment Chance Waz (5-11/173). The two play in the same defensive backfield at undefeated Pflugerville Hendrickson High, which has moved up from class 4A Division I to class 5A Division II this season and is 11-0 on the season. That's Texas' second-largest classification, so the level of competition is strong.

Most recruitniks expect Waz to flip from Colorado to Nebraska after the weekend, however the NU staff will need to do some work to hold onto both as Mosley was recently offered by Oklahoma and Baylor.

In Tuesday's paper we talked about defensive line prospects Joe Keels (6-4/280) of Highland (Kan.) Community College and Dalvon Stuckey (6-2/305) of Pearl River (Miss.) Community College visiting. Keels, a Wisconsin commitment, will still visit, however Miami pledge Stuckey cancelled his visit on Thursday afternoon. He stated that "it just didn't work out", and will be visiting Auburn instead.

Quarterback Zack Darlington (6-1/210) of Apopka, Fla., who had his season ended by concussions in September, will also be in town for his official trip. With Minor and Pierson-El on campus, it's a good plan to have the guy who could be throwing them the ball on hand also. Darlington continues to rehab from his head injuries, and there's been no decision made yet as to whether he'll be cleared to play in college. That choice likely won't be made for another 18 months, as he's destined for a redshirt season his freshman year in Lincoln. With NU's world-class Center for Brain, Biology and Behavior located in Memorial Stadium, Darlington's care and diagnosis will stay on the cutting edge.

A couple of high-profile unofficial visitors will be in town also. Hays, Kan. 2015 quarterback Alex Delton (6-0/193) excelled at the Rivals250 Underclassmen Challenge Presented by Under-Armour last summer before running a verified 4.42 40-yard dash at Kansas State's team camp.

He has an early offer from Kansas State, and has also received attention from Notre Dame, Missouri and Oregon. He lists Kansas, Kansas State, Missouri, Nebraska and Vanderbilt among his favorites. A member of the Rivals 250 to watch for 2015, Delton should be among the top 15 dual-threat quarterback prospects. Getting him on campus for a big game atmosphere like Michigan State may lead to a Big Red Weekend visit in the spring.

In addition, 2015 Rivals 250 athlete Marguise Doherty (6-1/190) of Kansas City, Mo. who already holds offers from Nebraska, Illinois and Missouri will make the trip. Doherty visited during Big Red Weekend and received scholarship offers from both Bo Pelini and Darrin Erstad. Like Minor, Nebraska hasn't pigeon-holed Doherty into a position. This will be another case of getting a guy on campus and deciding where he fits best.

Doherty has very good straight-line speed, but on film doesn't show the change-of-direction or lateral quickness to play cornerback in college. I would expect Nebraska sees him as a safety prospect.

Wide receiver Dallis Todd (6-5/205), an Oklahoma commit since April, was a surprise visitor Saturday as well.

The Richardson County Commissioners, meeting in regular session Tuesday, Nov. 12, awarded tire bids and a motor grader bid that had been under review.


Huppert reported no problems, but said he is still waiting for a quote on the repair to the steps on the south side of the Courthouse


Beckner reported no problems. Commissioner Davidson requested that one of the outdoor ashtrays be placed on the north lower level entrance to eliminate some of the littering.

G.I. trip short-lived for FCSH Lady Irish

Not even the stifling swelter of a sauna-like gym could warm up the Falls City Sacred Heart volleyball team last Thursday night in Grand Island.

With the opening service of Sacred Heart's first-round state volleyball match with Stuart coming at 8:30 p.m., the G.I. Northwest High School gym had already played host to five hotly contested matches and entertained throngs of fans. By match No. 6, the mercury on the thermometer inched close to 90 degrees, yet Sacred Heart pulled a 180, emerging cold and flat after running hot most all fall.

Fourth-seeded Sacred Heart, making its first state appearance since 2009 after earning one of two wildcard berths in Class D2, managed only two brief onepoint leads throughout all of the opening two sets and lost in three straight to underdog Stuart: 25-23, 25-18, 25-22.

"I really wasn't expecting us to be nervous," FCSH Head Coach Susan Witt, herself coaching at state for the first time, said. "We just didn't play well and that's about the main thing. We played a little timid kind of safe," she said.

Stuart consistently gave FCSH opportunities with missed serves, but were stingy on defense and got a strong game up front from freshman Harlee Fischer (20 match-high kills, three
