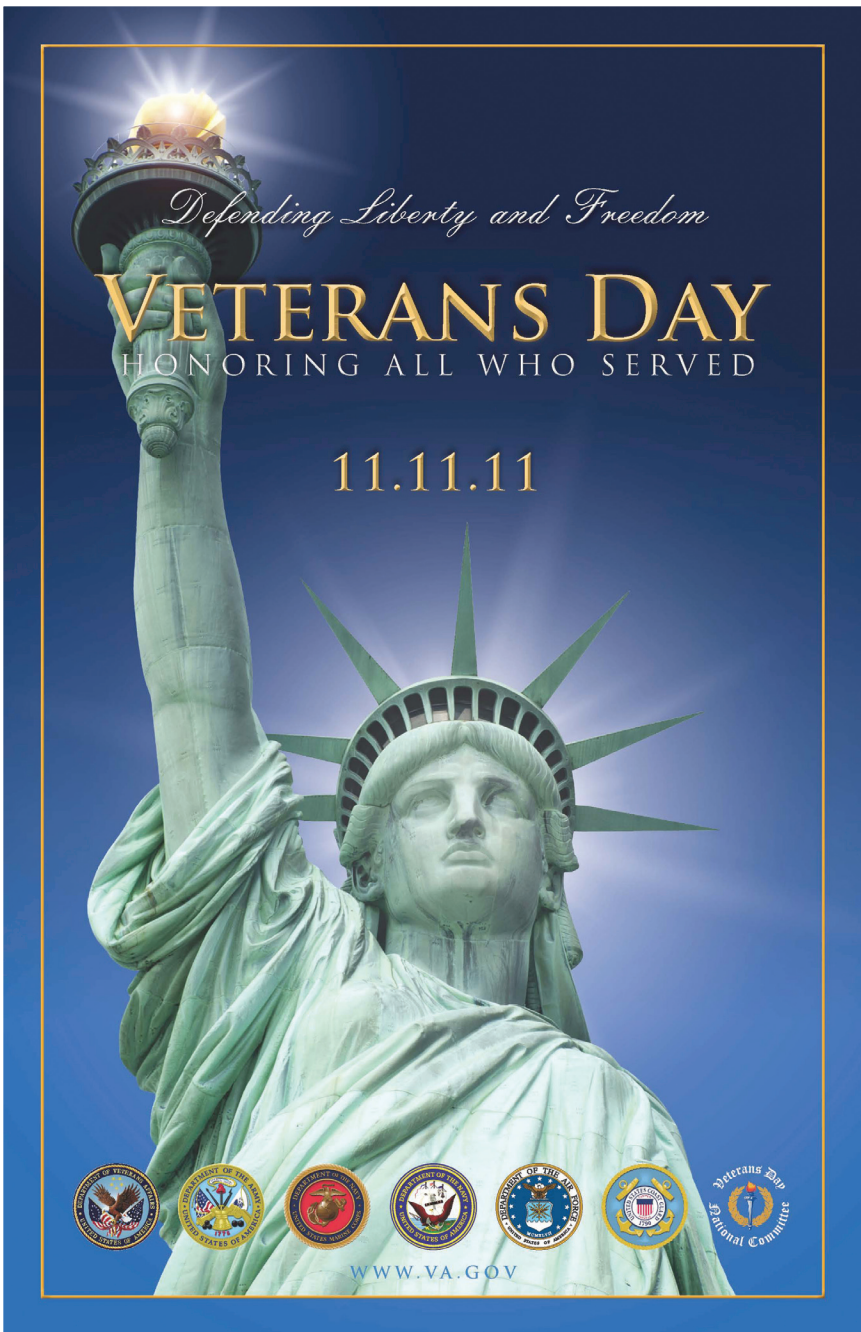

Population shifts prompt changes

Population shifts have prompted changes in the three commissioner districts in Richardson County, as well as to the First, Second and Third Wards in Falls City. At their meeting Monday night, the city council moved to waive the first and second readings and adopt on final reading Ordinance 2011-109, which changes the Ward boundaries.

The commissioners, during their Nov. 1 meeting, adopted a resolution to change the commission district boundaries.

All of the changes are as a result of 2010 Census figures, which also made Richardson County a part of Nebraska's 3rd Congressional District.

The city ordinance calls for the following:

First Ward: All that part of the town lying north of the centerline of 23rd Street extended to the west boundary of the municipality and extended east to the centerline of Morton Street; then south on Morton Street to the centerline of 22nd Street; then east along the centerline of 22nd Street to Fulton Street; then south on Fulton Street to the centerline of 21st Street, then to the east boundary line of the municipality.

Second Ward: All that portion of the municipality lying south of the First Ward and lying north of the centerline of 18th Street extending west to the west boundary line of the municipality and extending east on the centerline of 18th Street to the centerline of Valley Avenue; then extending north on

Valley Avenue to the centerline of 21st Street.

Third Ward: All that portion of the municipality lying south of the First Ward from the centerline of 21st Street and Valley Avenue extending east on the centerline of 21st Street to the east boundary of the municipality and all that portion of the municipality lying south of the Second Ward and lying north of the centerline of 14th Street extending to the west boundary of the municipality and extending east to the centerline of Barada Street; then south along the centerline of Barada Street to the center line of 13th Street; then east along the centerline of

13th Street to the centerline of Fulton Street; then north along the centerline of Fulton Street to the centerline of 14th Street; then east along the centerline of 14th Street to the east boundary of the municipality.

Fourth Ward: Will remain that portion of the municipality lying south of the Third Ward.

In Richardson County, the District 1 and 2 boundary line in Falls City is now 21st Street, so Falls City's Second Ward will be split for commissioner elections and representation. District 2 also lost the precinct of Salem, which is now included in

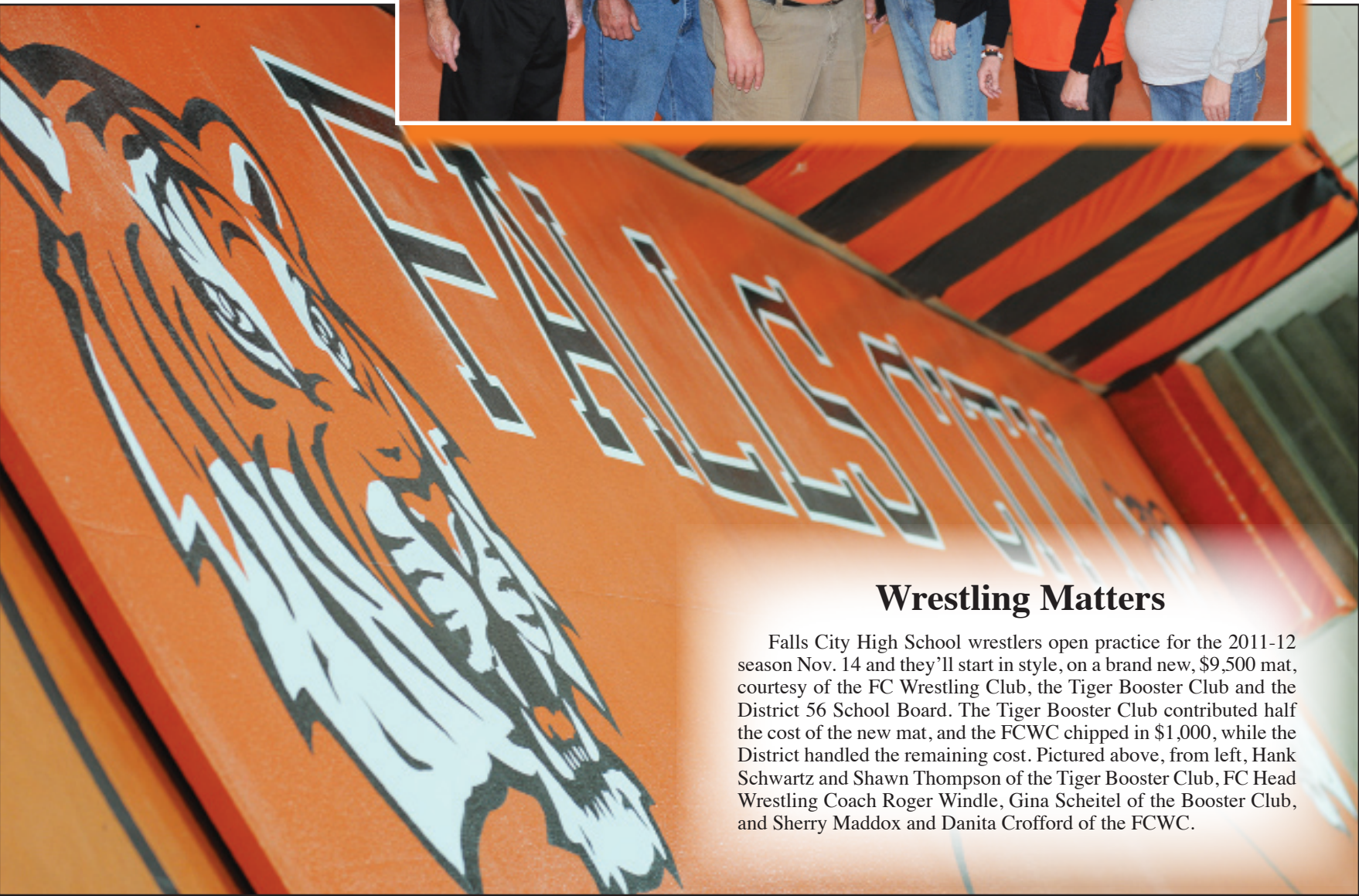

In Richardson County, 8.9 percent of all income from Social Security

If Richardson County residents didn’t receive their monthly payments from the Social Security Administration, 8.9 percent of total personal income in the county would be lost, a total of \$27,172,438 in 2009.

Richardson County is more dependent on Social Security payments than is the rest of the country. Nationally, 5.5 percent of total personal income in 2009 came from Social Security payments. In Nebraska, 5.5 percent of all income comes from these payments.

In Richardson County, 2,300 people receive some form of Social Security payment, either an old age pension, a survivor benefit or a disability check, according to the Social Security Administration and the Bureau of Economic Analysis. Social Security beneficiaries represent 28.3 percent of the total county population.

In rural counties such as Richardson and counties with smaller cities, Social Security payments constitute a much larger chunk of the local economy than in urban areas. A greater percentage of people in rural America receive these payments than in urban counties, and so rural counties have higher average payments per resident.

“In many rural places, Social Security is a very critical element of the local economic base,” said Peter Nelson, a geographer at Middlebury College in Vermont. “It’s less important to a place like Los Angeles because there is so much additional economic activity going on there.”

Total Social Security payments in Richardson County amounted to \$3,344 per person in 2009. The national average was \$2,199 per person, and in Nebraska it was \$2,203.

Social Security payments in Richardson County have been changing as a proportion of total income. These payments amounted to 6.8 percent of total income in 1970, 10.6 percent in 1980, 10.0 percent in 1990, 8.8 percent in 2000 and 8.9 percent in 2009.

Social Security payments are particularly important to rural counties and small cities because the money is largely spent in the community. “The seniors who get these payments are primarily going to spend their money locally,” said Mark Partridge, a rural economist at Ohio State University. “And they are a key reason why some communities are still viable. If this money dried up, there wouldn’t be a lot of these small towns.”

Social Security payments amount to 5 percent of the total income in urban counties. In counties with small cities, these payments amount to 8.2 percent of total income, and in rural counties such as Richardson County, Social Security totals 9.3 percent of all personal income. More than one out of five Americans living in small cities and rural counties received some kind of Social Security check in 2009.

Judith Stallmann, an economist at the University of Missouri, explained that Social Security payments help generate the sales that keep a rural business afloat.

“We find that Social Security income can be the difference between success and failure for some local businesses,” Stallmann said. “If you took away, say, 10 percent of the demand, would that local business be able to remain open? Often it’s that 10 percent that keeps them going. Social Security is providing that margin.”

Social Security payments go to those over the age of 62 who have filed for benefits, to survivors of insured workers and to those with disabilities. The program is mainly funded by payroll taxes. In Richardson County, 69.6 percent of recipients were retirees in 2009, 13.7 percent were survivors and 16.7 percent were disabled.

Changes to Social Security are being discussed in Congress, which is looking for ways to balance the larger federal budget. If benefits are cut — or if the eligibility age is increased — rural counties and small cities would be disproportionately affected, according to Peter Nelson.

“Cuts would have a bigger negative impact on rural places, absolutely,” Middlebury’s Professor Nelson said. “They are more dependent on Social Security.”

Emergency Alert test Wednesday

On Wednesday, Nov. 9, at 1 p.m., the federal government will conduct the first nationwide test of the Emergency Alert System (EAS). The test will last 30 seconds. During this period, regularly scheduled television, radio, cable and satellite shows will be interrupted as the system is being tested.

The Nebraska Emergency Management Agency would like to ensure that all Nebraskans are aware that this event is just a test, and not a real emergency alert. The test is being conducted by the Federal Emergency Management Agency, the Federal Communications Commission and the National Oceanic and Atmospheric Administration, as part of ongoing efforts to keep the nation safe during emergencies and strengthen the nation’s resilience against all hazards.

The national EAS is an alert and warning system that can be activated by the president, if needed, to provide information to the American public during emergencies. NOAA’s National Weather Service, governors and state and local emergency authorities also use parts of the system to issue more localized emergency alerts. The test is an important exercise in ensuring that the system is effective in communicating critical information to the public in the event of a real national emergency.

NEMA, along with FEMA, encourage the public to use this event as a reminder that everyone should establish an emergency preparedness kit and emergency plan for themselves, their families, communities and businesses. Execution drug obtained by Neb. Dept. of Corrections

The Nebraska Department of Correctional Services received 485 grams of sodium thiopental on October 25, 2011. The chemical was manufactured by NAARI, a pharmaceutical company headquartered in Switzerland. The cost was \$5,411.

The supply includes two batches (42 grams and 443 grams) with expiration dates of May 2013 and December 2013, respectively. Samples were tested and confirmed to be sodium thiopental by an independent U.S. laboratory.

Director Robert P. Houston said, “With the receipt of this chemical, NDCS stands ready to fulfill its statutory obligation with regard to capital punishment.”

On May 25, 2011, NDCS became licensed by the U.S. Drug Enforcement Agency (DEA) to import sodium thiopental.

A Capitol Commentary

Elected officials these days devote considerable energy and expense to staying in touch with their constituents, at least in part to determine which way the political winds are blowing on the issues of the day.

They hold town hall meetings. They commission polls. They solicit Facebook fans. They even tweet from the floor of Congress to fellow Twitterers—or is that twits?—during the president’s State of the Union message, presumably to let voters back home know how much they want to stay in touch. And many rely on the assessments of longtime friends and political supporters to relay a sense of what voters are thinking.

But what if voters don’t know what to think? What if they don’t have time to focus on the details of a complex issue? What if they are so bombarded by messages from deep-pocketed advocates of a particular viewpoint that they tune out altogether?

And what if their views are just plain dumb, like those of placard-carrying Tea Party demonstrators earlier this year whose signs famously read: “Keep the government out of my Medicare?”

Nebraska lawmakers called into special session over the proposed Keystone XL oil pipeline face a barrage of competing opinions, but the apparent uncertainty and lack of consensus on the issue might reflect a similar uncertainty among many of their constituents.

So what are elected officials to do when they don’t have a clear reading on what constitutes a politically safe vote?

They might do well to remember a line from the musical “1776,” based with considerable historical accuracy on the drama surrounding the signing of the Declaration of Independence.

Lyman Hall, a delegate from Georgia, tells his fellow delegates that while he favors independence, most people in Georgia oppose it so he plans to err on the side of his constituents and vote no.

A couple of scenes later, though, he changes his vote, telling the assembly: “In trying to resolve my dilemma I remembered something I’d once read, ‘that a representative owes the People not only his industry, but his judgment, and he betrays them if he sacrifices it to their opinion.’ It was written by Edmund Burke, a member of the British Parliament.”

That line from the musical is, in fact, a reasonable paraphrase from a 1774 speech by the Irish-born political philosopher who indeed supported the American Revolution. Burke was an intellectual leader in articulating the principles of representative government.

Burke, of course, lived a couple centuries before a time when opinion polling, coupled with forms of instant communication, makes it possible to accumulate and statistically analyze the purported views of virtually anybody about virtually anything. In some ways, that probably makes it easier—or at least politically safer—to campaign for and hold public office.

But lawmakers and executive branch officials who decline to act in the absence of consensus among their constituents are abdicating their responsibilities, as Edmund Burke saw it.

He believed voters elected a representative with the expectation that he—and in Burke’s day it was always he—would use his judgment about how best to govern his fellow citizens, knowing they wouldn’t always agree. Not an easy thing to do, using independent judgment. But that’s the standard our form of government demands from our elected officials, even if it means telling constituents you think they’re wrong.

Volunteers are breast cancer survivors who give patients and family members an opportunity to express feelings, talk about fears and concerns, and ask questions of someone who is knowledgeable and level-headed. Most importantly, Reach to Recovery volunteers offer understanding, support, and hope because they themselves have survived breast cancer and gone on to live normal, productive lives.

How it works

Through face-to-face visits or by phone, Reach to Recovery volunteers give support for:

- People recently diagnosed with breast cancer
- People facing a possible diagnosis of breast cancer
- Those interested in or who have undergone a lumpectomy or mastectomy
- Those considering breast reconstruction
- Those who have lymphedema
- Those who are undergoing or who have completed treatment such as chemotherapy and radiation therapy
- People facing breast cancer recurrence or metastasis (the spread of cancer to another part of the body)

Volunteers are trained to give support and up-to-date information, including literature for spouses, children, friends, and other loved ones. Volunteers can also, when appropriate, provide breast cancer patients with a temporary breast form and information on types of permanent prostheses, as well as lists of where those items are available within a patient's community. No products are endorsed. Aside from the emotional support provided, volunteers may also assist patients with other resources within their community to help them through treatment and beyond.

Wetland compliance, flooded land repairs

With the Missouri River floodwaters receded, many landowners and agricultural producers have started work to repair the land that was affected by this summer's flood.

Some of these producers may be participating in the Farm Service Agency's Emergency Conservation Program (ECP) for assistance, while other producers are working independently to get lands rehabilitated for planting next spring. Either way, producers doing such repair work need to keep in mind conservation compliance requirements, including wetland compliance, as they move forward.

"It's important for landowners and producers who are planning or completing rehabilitation work to evaluate whether their plan includes only taking land back to pre-flood conditions, or if additional work is going to be done," said Richardson County Farm Service Agency Executive Director Shawna Mitchell. For example, in some cases it may be very easy for a contractor to take soil deposits from the flood in one part of a field to fill in a wet area that existed before the flood in a different part of the field, and this may or may not be acceptable under wetland compliance rules. Mitchell emphasized that anybody doing rehabilitation work should contact their local Farm Service Agency office.

"Producers can discuss their repair plans with their local FSA office and the Natural Resource Conservation Service (NRCS) to determine if there are any conservation compliance concerns moving forward," Mitchell said. Meeting conversation compliance requirements is important for maintaining FSA program benefit eligibility. "By visiting with our office, we can document the producers' repair plans and hopefully avoid any conservation compliance issues related to flood damage repair projects in the future," Mitchell noted.

Keys to safe winter driving

Nebraska Dept. of Roads’ crews are prepared for winter weather’s annual badgering. Workers and equipment will be out to clear the highways and to monitor changing conditions through the snow, the cold and bold (drivers). Motorists should be prepared, too.

Watch For

When traveling outside of a business or residential district, it is unlawful to follow a highway maintenance vehicle (snowplow, truck or grader) more closely than 100 feet when it is plowing snow, spreading salt or sand, or displaying a flashing amber or blue light. If conditions permit, however, drivers may carefully pass a maintenance vehicle.

Snowplows cause soft snow to swirl. It can become difficult to see a plow, or the plow operator to see you. Drive with your headlights on. Make sure your headlights, taillights and windows are clean and clear of snow so you can see and be seen.

Plowing snow on multi-lane roadway is often done in tandem. Give the plows plenty of room. Do not pass on the right side and always stay where the operator can see you.

Beware of icy spots when driving, especially on bridges and in sheltered areas. Drive at a reduced speed and allow plenty of distance for reacting to traffic. Slow down gradually when approaching curves and intersections.

Motorists may use studded snow tires in Nebraska from Nov. 1 to April 1. School buses, emergency vehicles and mail carrier vehicles may use them anytime during the year.

Check often for current weather reports through local media before you travel. Keep a radio on. Weather conditions change rapidly and so do the road conditions.








Check For

For 24-hour-a-day, year-round Nebraska traveler information, dial 511 on your cell phone or landline. If outside Nebraska, dial 800-906-9069. 511 provides motorists current information about weather conditions, road conditions and travel advisories. Know before you go. The 511 system and various other weather links are available at www.transportation.nebraska.gov.

Make sure everyone in a motor vehicle wears a seat belt and children are in a car safety seat. Do not use cruise control in wet or snowy weather and do keep your gas tank full.

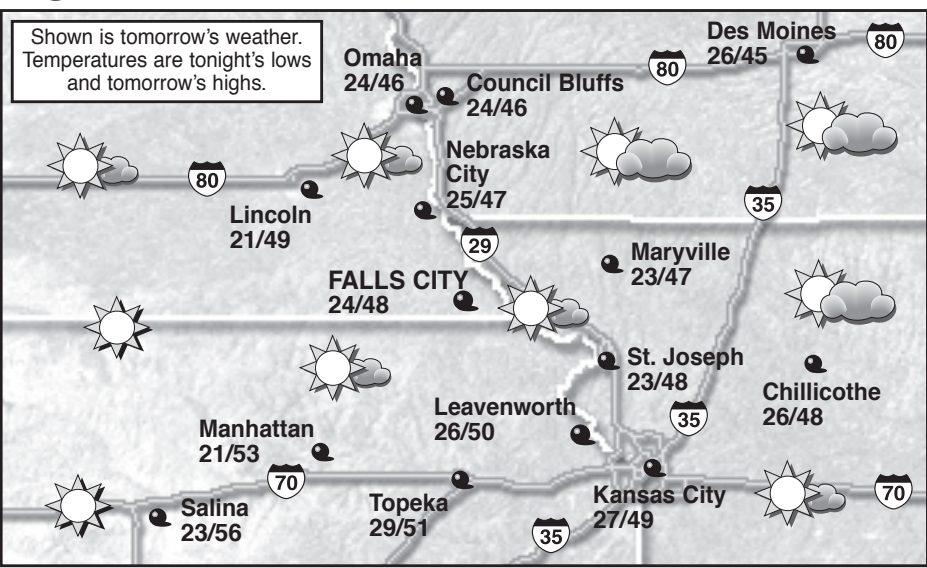

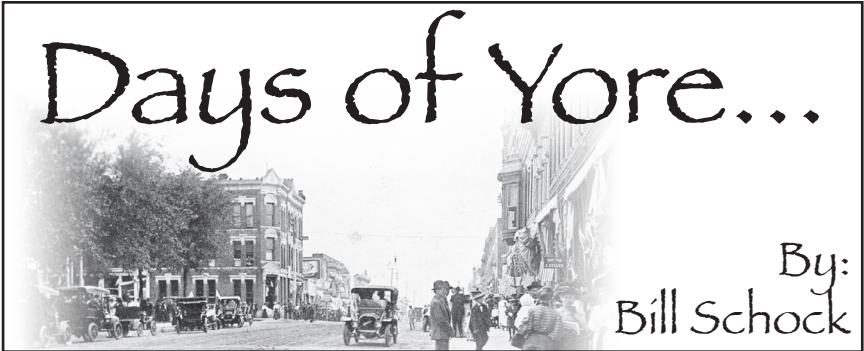

Turnovers and unfortunate bounces doomed the Irish in their second round playoff game at Clarkson last Wednesday. The Red Devils defeated the Irish 28-20 in a game that saw the Irish fumble the ball five times with three of them being recovered by Clarkson. Sacred Heart was also intercepted twice. The Irish, who finished the season 8-2, did force five fumbles, but the luck was not on their side that afternoon and they were unable to recover any of the Clarkson mistakes.

"We didn't take care of the ball and that really hurt us," said Head Coach Doug Goltz. "We hadn't really fumbled much all year long, but we did against Clarkson."

In fact, Sacred Heart's starting backs had only lost five fumbles in their first nine games.

The turnovers led to a lot of snaps for the Clarkson offense and according to Goltz it probably wore his players down. "We needed to keep the ball away from their offense, but they rushed twice the number of times we did," Goltz said. "The fourth quarter field position from our fumbles and punting in

to that stiff wind gave them the short field and their size in the line and backfield took its toll."

Sacred Heart's punter Brody Chandler was forced to punt into a difficult wind in the final frame, which made it nearly impossible to launch a good punt. Chandler's two punts in the fourth netted 14 and 15 yards.

The Irish defense did a tremendous job early of stopping the Red Devils while being backed up in their own territory. Three times in the first quarter Clarkson took possession inside the Irish 30-yard line. All three times Sacred Heart's 'D' held.

Garrett Harrington scored twice on runs of 74 and 65 yards and finished with 18 carries for a 178 yards.

Lane Scheitel tied the game early in the third quarter on a 12-yard quarterback keeper and finished with 12 carries for 51 yards. In the wind though Scheitel struggled throwing the ball completing just three of his nine passes for 18 yards while throwing two interceptions. Scheitel entered the game completing nearly 50 percent of his passes and had only thrown three interceptions in the previous nine games.

Again, Goltz pointed to the fourth quarter as being an uphill struggle that unfortunately the Irish were not able to overcome.

Sacred Heart had five possessions in the final quarter - lost fumble, 14-yard punt, 15-yard punt, interception, interception.

"The whole fourth quarter was played deep in our territory due to fumbles and poor punts," Goltz said. "Our defense wore down and they got two touchdowns in that quarter."

"This team had an exceptional year considering how young our team was," said Goltz. "Four sophomores played considerable time and only one senior played both ways. I think we really did more with less when you look at our lack of size and experience. Our assistant coaches really coached these kids up and made us a team that was tough to beat. Our seniors really did a nice job of leading us all year long."

Why can't the offensive line play consistently, and why is there no rotation to get the younger guys ready?

Where did guys like **Jeremiah Sirles** and **Tyler Moore** go so wrong since the Wyoming game that they're suddenly only "usable" in emergency situations? Sirles started all of 2010 and Moore started the first few games of this season as a true freshman. Suddenly they're not worthy of even seeing the field to spell guys like **Jermarcus Hardrick** and **Marcel Jones**? What gives?!

Why do we not have a backup for the hurting and undersized **Mike Caputo**? What's going to happen next year when Caputo's gone? Why not get your backups some reps in real game situations so if you lose a guy to injury your backup is ready to play? If **Cole Pensick** is your backup, then shouldn't he have played more than limited time in four games this late in the year?

Why do those young running backs sit so much? **Rex Burkhead** wasn't full speed against Northwestern - that was obvious to anyone watching the game. So why didn't **Aaron Green**, **Ameer Abdullah** and **Braylon Heard** get more touches?

When Northwestern continued to run the same downhill, between the tackles plays over and over why not bring **Will Compton** back into the game? Compton has been playing very well of late, and with the way **Lance Thorell** was getting roasted what would it have hurt to let Compton try and cover if Northwestern checked into a throw?

On top of it all we get the head coach throwing his offensive line under the bus after the game. Pelini always talks about "pointing the thumb," yet in this case he pulled out his index finger and jabbed it right into his offensive line's faces.

There are too many questions with too few answers. Pelini needs to get control of things quickly, or this season could end with four straight losses.

Recruiting has been busy in recent weeks. NU used home games with Ohio State, Michigan State and Northwestern to bring in a host of profile prospects, but as of this column not one had committed.

Nebraska hosted nine official visitors for Ohio State weekend, four of whom were already committed to the Big Red. Those who were not committed have yet to make a decision, but Rivals.com four-star athlete **D.J. Foster** (5-11/190) of Scottsdale, AZ, has eliminated NU. The other three are all still "in play" as far as NU is concerned.

Four-star prospects cornerback **Brandon Beaver** (6-1/176) of Compton, CA, safety **Jordan Diggs** (6-2/190) of Cape Coral, FL, and athlete **Devin Fuller** (6-0/185) of Old Tappan, NJ, were on hand along with three-star linebacker **Tyrone Neal** (6-1/225) of McKeesport, PA.

Diggs has long been one of NU's top targets at safety. He has visits scheduled to Tennessee (Nov. 4) and South Carolina (Nov. 25). The Gamecocks will be a strong challenger, as his father played there and the younger Diggs grew up as a fan. NU's in very good position, though, thanks to Diggs' relationship with Husker linebacker commitment **Michael Rose** out of Kansas City who is "like a brother" to Diggs.

Fuller, rated among Rivals' top 50 players nationally at all positions, bring a type of athleticism and excitement comparable to current NU freshman **Jamal Turner**. Fuller's only official visit to date has been NU, but says he'll take his other four allotted trips from among schools like Georgia Tech, TCU, Rutgers, Miami, Kansas, Alabama, Connecticut, Boston College, Penn State and UCLA.

The battle for Beaver will be between the Huskers and half of the Pac 12, including Arizona, Arizona St., Cal, USA, UCLA and Washington.

Neal has his choices down to West Virginia, Syracuse and NU and planned to make his decision "within three to four weeks" as of mid-October, but has yet to announce anything. Nebraska has been his only official visit, but he has seen West Virginia unofficially twice and will make an official trip there before his commitment.

The Michigan State game saw a smaller group, but one with just as much star power as five-star defensive end prospect **Jonathan Bullard** (6-4/255) of Shelby, NC, headlined the group. Joining him were four-star offensive lineman **Ronnie Stanley** (6-7/285) of Las Vegas, four-star linebacker **Quanzell Lambert** (6-2/230) of Sicklerville, NJ, and three-star defensive back and LSU commitment **Derrick Raymond** (6-2/175) of Metairie, La.

Raymond was the surprise of the group, and although he rated the trip a "10" he remains committed to LSU. That's unlikely to change unless the Tigers decide to drop him.

Bullard is the highest-rated prospect to visit NU this year, ranking as Rivals' No. 19 overall prospect nationally and the No. 3-ranked defensive end. The Huskers will battle Clemson, Tennessee, Florida and South Carolina for his pledge, and it will be an uphill battle. Just getting him on campus was a big win, and if they can get an in-home visit scheduled you never know what might happen.

Lambert has already visited Northwestern, Iowa and NU and has trips scheduled to Oklahoma and Alabama before he'll make a choice. He holds his cards pretty close to the vest, but it appears that NU will be in this until the very end.

Stanley is an intriguing prospect, with great foot speed for a guy of his size. He visited Arkansas before his trip to Lincoln, Notre Dame will get a visit, and he's also considering Florida State, Auburn, Oklahoma, Washington and Miami.

NU hosted another group for the Northwestern debacle, including possibly their top cornerback target in **Mohammed Seisay** (6-2/200) of E. Arizona Juco. Seisay, who has also visited Indiana and will see Illinois soon as well, was very impressed with his trip to Lincoln and the time he spent with his hosts **Alfonzo Dennard** and **Daimion Stafford**. As a December graduate, Seisay will make a decision soon. North Carolina, Oklahoma, and Oregon State are in competition for his final two official trips.

Linebacker **Thomas Brown** (6-2/212) of Gardena, CA, and defensive end **Taiwan Johnson** (6-3/240) of Manvel, TX, were two more official visitors during Northwestern weekend. Johnson has already visited Arkansas and will trip to Oklahoma State before making a choice, while Brown will see Arizona State Nov. 18. Both said that NU remains in strong contention.

Petal, MS, two-sport athlete **Anthony Alford** also made the trip to NU. A highly regarded baseball prospect, Alford spent time with **Khiry Cooper** and also met with NU baseball coach Darin Erstad during his time in Lincoln. He holds NU in his top five along with LSU, Mississippi State, Ole Miss and Southern Miss.

Despite not receiving commitments from their recent visitors, NU did add junior college linebacker **Zaire Anderson** (6-1/220) of Riverside, CA. Anderson's film reminds many of current Husker **Lavonte David**. Originally from Philadelphia, Anderson chose NU over an offer from Mississippi State and growing interest from a number of programs nationally.

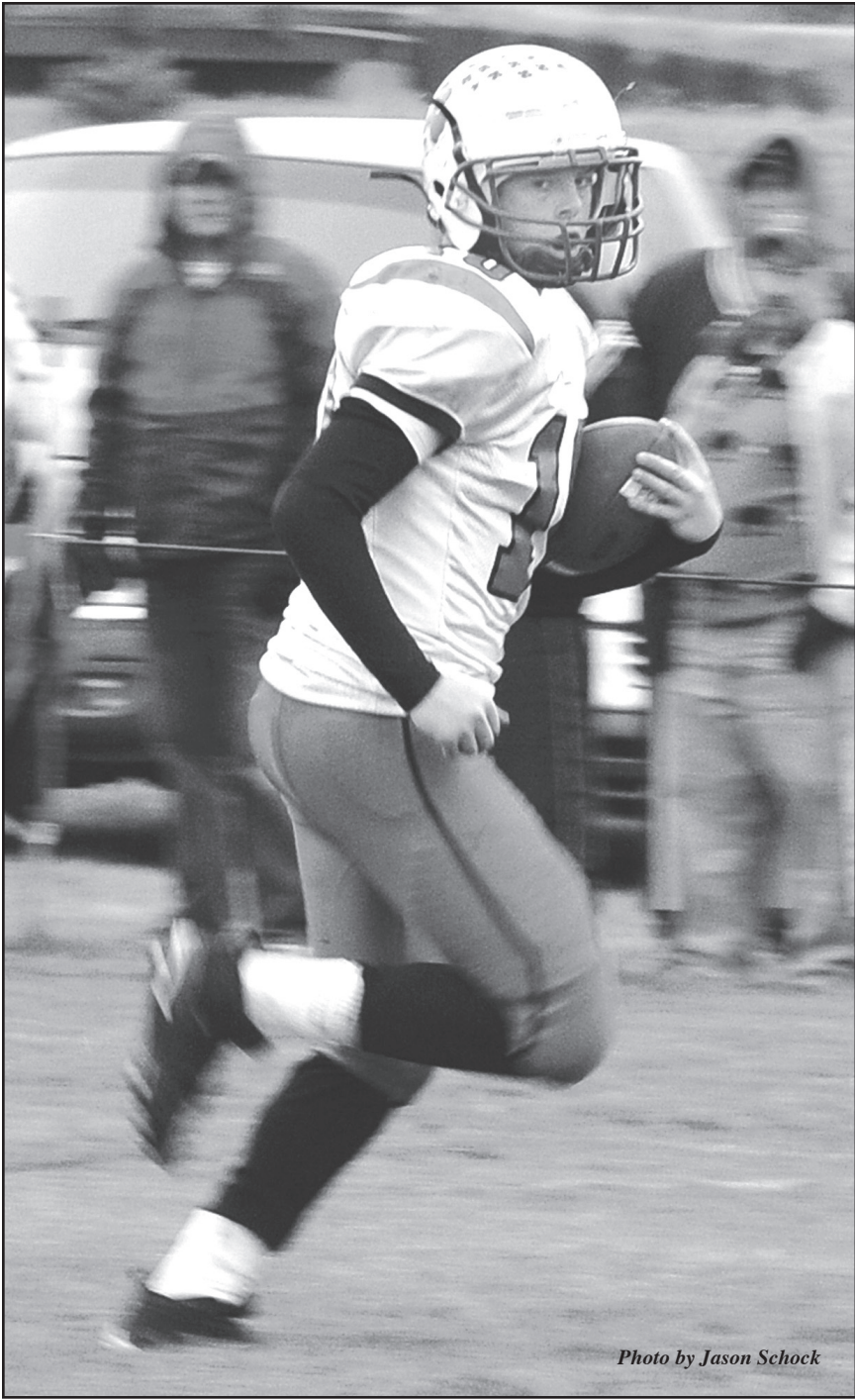



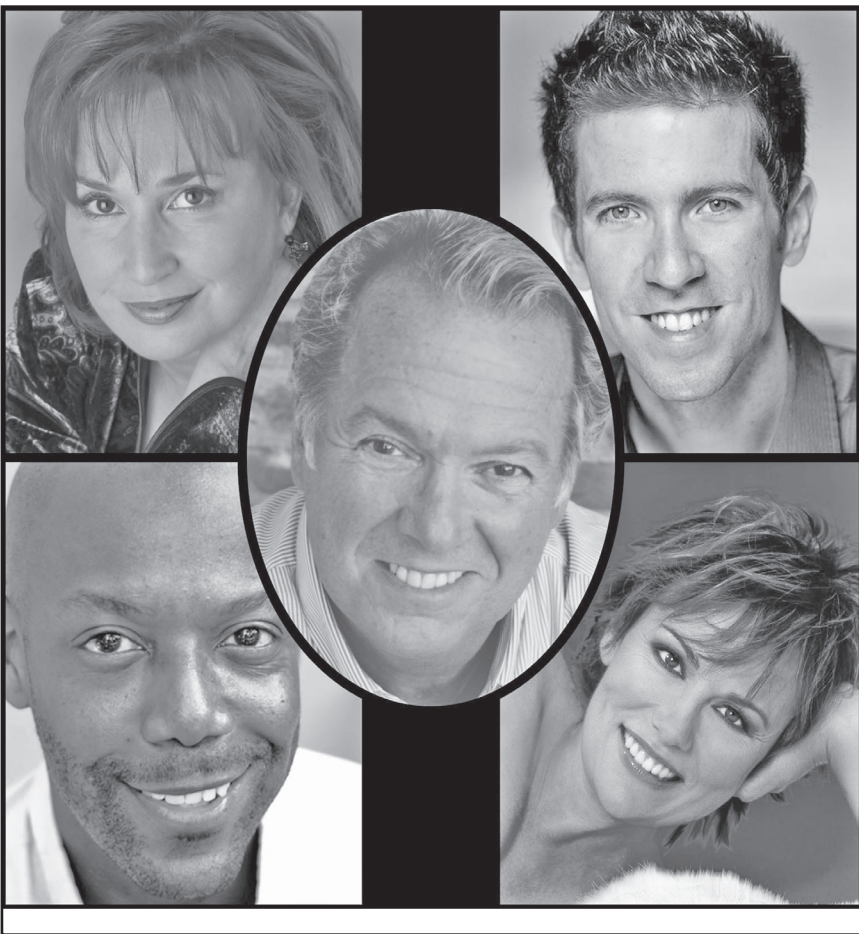

Broadband in Nebraska:
Much success, but still work to be done

From compiling health-care information to giving football coaches a tool to analyze video, from providing a jobs bank for western Nebraska employers to helping brides-to-be plan that special day -- those are some of the ways Nebraskans are tapping into broadband Internet access.
But there’s more work to be done to make sure such access is available across the state, even in the most rural of areas, said speakers Tuesday at the Broad-band Connecting Nebraska con-ference in Lincoln.
It’s an economic-development issue, said Jessica Zufulo, deputy administrator of the Rural Utilities Service at the U.S. Department of Agriculture. Broadband Internet is a “central pillar of economic growth in any community,” she said.
“Without access to affordable high-quality communications in-frastructure, rural Americans will be relegated to second-class citi-zens in this information econo-my,” she added.
Zufulo said there’s a direct link between available broadband access and job growth, and noted that the Recovery Act includes funding for building this infra-structure in rural areas. The need is great; only one in 10 applica-tions were funded.

A succession of Nebraska en-trepreneurs testified to the impor-tance of broadband access and their success tapping into it.
For example, Deb Bass of the Nebraska Health Informa-tion Initiative said her organiza-tion’s success so far -- with about 1.9 million patients in its secure, web-based information system, 26 percent from outside the state -- is only the beginning of how health care will be transformed. Mobile applications are the fu-ture, she said, as health-care con-sumers schedule appointments, pay bills, choose providers and more via their Smart Phones.
David Graff, owner of Hudl, is also bullish on broadband. While still a student at the University of Nebraska-Lincoln, he founded the company, which has grown from 12 clients in 2008 to about 7,000. The Haymarket-based firm pro-vides football and other coaches software to analyze video. Most of his clients are high school coaches, but he also has three NFL teams, 50 Division I college programs and two NHL teams.
Nebraska is an ideal location to base such businesses, Graff added. Office space is reasonably priced, UNL offers a well-educat-ed hiring pool and the state has excellent programs to encourage such investment.
“That support is the kind of thing that’s going to enable com-panies like ours to continue to de-velop in Nebraska,” Graff said.
Megan Hunt’s Princess Laser-tron helps women plan their wed-dings. Another entrepreneur who started her business in college, Hunt worked with 300 brides last year, 46 percent of them from out-side the United States. A longtime blogger and early adopter of so-cial media, Hunt praised Nebras-ka’s “culture of risk taking and innovation.”
Speaking of risk taking, Ne-braska farmers, too, are tapping into broadband. Brandon Hun-nicutt, a fifth-generation farmer whose family has worked the same land for more than 100 years and whose Twitter handle is @ cornfedfarmer, said adopting the latest communications technol-ogy is as important to agricultural producers’ future as adopting the latest production technology.
It’s all about “being able to do more things in a more effi-cient manner,” Hunnicutt said. Ultimately, he expects to be able to upload his data from his trac-tor cab to web-based apps to get analysis and feedback on a host of production decisions.
Elsewhere, Gering and Scotts-bluff have the Twin Cities De-velopment Association, which is serving six communities in the re-gion with an online job bank, said Darla Heggem of the association. And Rod Wagner of the Nebraska Library Commission said prog-ress is coming, although not as quickly as the commission would like, on improving Internet access at public libraries, a key resource for people who cannot afford their own computers or access.
Wagner said Nebraska has the fourth-highest per capita use of computers in public libraries, a need libraries are struggling to meet. They often need to impose time limits on use, and nearly one-half of public libraries’ comput-ers are more than four years old. Those users include unemployed people filling out online job ap-plications; families of members of the military using Skype to talk to them; and senior citizens tak-ing classes.
“It’s clear that a lot of good things are happening in Ne-braska,” said Rod Armstrong of the AIM Institute, presenter of the conference with partners in-cluding UNL, Nebraska Public Service Commission, Nebraska Information Technology Com-mission and the Nebraska Depart-ment of Economic Development.
The conference, first of what is expected to be an annual event, was part of a broadband mapping and planning initiative funded by a grant to the Nebraska Public Service Commission by the U.S. Department of Commerce’s National Telecommunications and Information Administration to increase the adoption and use of high speed Internet.
