Tubach exhibition ‘true homecoming’

Native son and nationally recognized artist Allan Tubach will be in Falls City on Friday, May 3, for the opening of an art show that will feature the Richardson County Library and Community Foundation’s collection of Tubach’s works.

The solo art show will take place in the Stalder Art Gallery of the Falls City Library and Arts Center.

The library will open at 5:30 p.m. on May 3, with the gallery talk starting at 6:30. According to Christina Wertenberger, curator of the Stalder Gallery, the purpose of the exhibition is to honor Tubach for his donations to the people of Falls City — donations of art, time and expertise.

Tubach, a 1957 graduate of Falls City High School, has worked as a professional artist his entire adult life. He served for two decades as

Council may next meet in new City Hall

Mayor Tim Hersh informed the City Council during their April 15 meeting that their next meeting might be at the newly renovated City Hall.

“Hopefully, if all goes well, the May 6 meeting will be in the new location,” Hersh said.

The former Family Medicine Clinic is in the final stages of renovation. Moving from the decades-old location, at 1820 Towle, will be a major task but just might be mostly accomplished in advance of the May 6 council meeting.

With the possibility of retirements, Utility Supt. Alan Romine said the Board of Public Works has recommended that up to two additional linemen be hired. Romine said the additions are suggested based on the “demographics of the workforce as it is now” and with an eye “down the road.”

Five linemen currently work in the utility department. Some of them are approaching or already have reached retirement age, Romine said. Clerk/Treasurer Gary Jorn said several projects are upcoming and if retirements do occur, at least some of those projects would have to be contracted, a much more expensive proposition.

Romine said he would estimate the costs to hire a new lineman at between \$73,000 and \$80,000, including benefits. His request was to advertise the position(s) in a variety of publications and websites.

Councilman Kirby Robidoux asked about budget implica-

School finance formula changes heading for full debate

When it comes to choosing sides on taxation and spending issues in Nebraska, it all boils down to whose ox is getting gored.

School finance is one of those issues that has historically – the current formula is 23 years old (even though it gets tweaked every couple years) and school financing agreements were being made before Nebraska was even a state back in 1867 – been a battle between large and small, the perceived “haves” and the “have nots.”

In a few weeks, the current Legislature will address yet another set of proposed changes in LB407, a measure advanced 5-3 by the Education Committee and championed by chair Sen. Kate Sullivan of Cedar Rapids. As in the past, the changes are intended to reflect the current state of the economy. Stopgap measures, some would say. Band-Aids, according to others. Weeks of negotiation by the committee failed to reach a compromise by large and small school districts.

If one doubts that school finance is serious business in Nebraska, know that the Nebraska Council of School Administrators has a website dedicated strictly to the issue. The Nebraska Association of School Business Officials, an affiliate of NCSA, provides oversight.

The website explains the intricacies of TEEOSA, the Tax Equity & Educational Opportunities Support Act, which is the current school finance formula for Nebraska public schools. TEEOSA was originally enacted by the Nebraska Legislature in 1990 and amended numerous times since then.

The website says it best: “School finance has a direct correlation and consequence to children and their educational opportunities, their present lives and their future. Any parent with children in school and/or any proponent of equity and quality of educational opportunities has a vested interest in school finance policy, within all levels of government.”

“A direct consequence to children’s lives and their future.” Pretty ominous words to what often boils down to arguments between school lobbyists and the senators who propose or support changes.

“Even before Nebraska was a state, the responsibility to fund education has been shared between state and local sources,” said Sen. Sullivan. “Just as school funding has been continually revised, we continue to study the formula to improve it and make it fit in current circumstances.”

She said the bill makes two types of changes. The first would be permanent modifications; the second would phase in the scheduled return to permanent provisions that were temporarily modified over the last few years in response to economic conditions. Some of the permanent changes would allow tuition and transportation fees paid to other districts to be included in general fund operating expenditures. The teacher education allowance, the instructional time allowance, averaging adjustment and the local choice adjustment would be eliminated.

The phase in provisions would

include a base limitation allowable growth rate (the amount the budget could grow) for school districts of 1.5% for 2013-14 and a local effort rate (the amount of local tax support) of \$1.03 for 2013-14 and 2014-15. The base limitation rate for school districts was 0.5% for 2012-13 and would return to the permanent provisions of 2.5% for 2014-15. The local effort rate was \$1.0395 for 2012-13 and would return to the permanent provisions of \$1.00 for 2015-16.

During testimony on the bill in February, Hastings Public Schools superintendent Craig Kautz said the bill was not a perfect solution for

his district, but the best proposal for the state because it is a collaborative effort. Ralston Board of Education President Linda Richards opposed the bill, saying that her district constantly has had to adjust and make sacrifices to accommodate a continually evolving aid formula.

The bottom line: smaller districts seemed to support the measure as advanced. Lobbyists for the larger districts vowed to take the fight to the floor of the Legislature. Such battles are generally messy and do have consequences. With the session in its final 30 days, time is of the essence.

the art director of the *Omaha World-Herald*, and has served on numerous boards and civic organizations in the Omaha area. He and his wife, Omaha attorney Dorothy Picton Tubach, have traveled extensively, resulting in 950 paintings that explore the United States and the diverse cultures in 22 countries. Three hundred fifty of the works represent Nebraska, with over 75 set in Richardson County. Much of his work has reflected his eastern Nebraska roots with the people, places and architecture as a focus.

In a recent email to the Richardson County Arts and Humanities Council, Tubach stated that “this exhibition is truly a ‘homecoming’ for me, with works that carry many memories. Most of these paintings were collected by dear friends, Merle and Marcia Stalder, with Merle’s first purchase of ‘Ghirardelli’ from a small show I had at the Lydia Bruun Woods Library in 1970. Another early painting for the same show, ‘Courthouse Steps,’ was purchased by the Friends of the Library and now hangs in the new library.

“Many of the other works in the show evoke memories of the paintings inspired by Richardson County and Falls City, while oth-

ers represent travels. ‘Autumn Sonata’ is a view from the boyhood home of Mozart in Salzburg and is a celebration of the Stalders’ marriage and their love of music, while ‘Crescendo’ celebrates the nearby Brownville Concert Series. The exhibition comes full circle with another early work, ‘Epitaph for Falls City’ (from the falls), painted in 1974, representing the settlement area southwest of town known as ‘Nemaha Falls,’ where in 1857 John Stumbo built his mill at the falls, which gave name to Falls City.

“Our family farm was 3/4 of a mile west from this site and overlooked the same Nemaha Valley. From here as a boy I could see the landmarks of Falls City on the hill beyond and in 1976 inspired the painting ‘Falls City Window,’ which hangs in the new library.”

The gallery talk May 3 will be a homecoming for a Falls City native who has never forgotten his roots. The Arts and Humanities Council hopes that the Falls City area will give him a warm welcome home. A reception honoring the artist will be held following the gallery talk.

tions, as well as the City’s hiring freeze that has been in effect for about five years. His motion to “table” any action until budgetary matters are resolved and the council discusses the “hiring freeze” died for the lack of a second.

Jorn said he questioned whether the freeze “shouldn’t be lifted.” He noted the skills that are required for so many City positions and the time it takes to learn those skills. Romine explained, for example, that three water plant employees are nearing retirement age and the tenure required for licensure is a lengthy one. “This should be addressed” as well, Romine said.

Eventually, the council voted to approve advertising for the linemen positions. Robidoux and Councilman Mike Dougherty cast “No” votes. Romine explained that while two linemen will be sought, that is not a guarantee that two will be hired. The possibility of other utility employees applying to transfer also exists.

The council gave first reading approval of an ordinance that would adjust the meeting time of the third Monday-of-the-month regular meeting from 7 p.m. to 6 p.m. Councilman Don Ferguson had suggested the ordinance change.

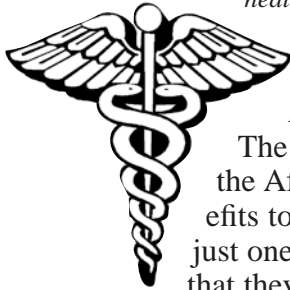

‘Thinking about health’ Too few seniors take Medicare wellness exams

“Thinking About Health,” Week 10 (seniors & Medicare wellness exams) is part of the Nebraska Press Association’s partnership with Rural Health News Service. Funded by a grant from The Commonwealth Fund and distributed through NPA, the Rural Health News Service will provide Nebraskans with unbiased health-related information, designed to help better understand the health issues facing our communities, state and nation.

The health reform law more commonly known as the Affordable Care Act called for some new benefits to encourage prevention and wellness. There’s just one problem, though, the word has yet to spread that they are available. In a nutshell, not many of the people they are intended to help are taking advantage of them.

In January 2011, Medicare began paying for an annual wellness exam, but Medicare data show that only about 14,000 Nebraskans out of 250,000, or a little less than 6 percent enrolled in the program actually received the exam.

Nationally the number is not a whole lot better. Last year only 12 percent---about 3.1 million seniors and disabled people---enrolled in traditional Medicare (not a Medicare Advantage plan) got their wellness visit. Even though the number has increased since the benefit became available, the numbers point to underuse of a service that many experts believe is worthwhile for seniors.

It’s fair to say that doctors may not always, mention the exam to patients, or they may just give it without noting that it’s part of Medicare’s attempt to improve the health of the elderly people. It’s also possible seniors are confused by what the exam actually is. Whatever the reason, more seniors need to be aware of what it is and what it is not.

The visit is not a full-fledged physical—the kind where you have to undress. Instead it’s basically a visit with the doctor to assess your health risks. Patients will be asked to fill out a short Health Risk Assessment to determine their tobacco use and risk factors for diseases such as depression and diabetes. The doctor may also take your height, weight and measure your body mass and blood pressure.

A physician may also discuss strategies for improvement. Research shows that doctors don’t often talk to their patients about weight loss or diet, but when they do, there’s evidence that their patients do try to lose weight.

The exam is free for Medicare beneficiaries if their doctor has agreed to accept Medicare’s payment in full. Most doctors do. But if your doctor doesn’t accept the payment, you may experience what’s called “balance billing,” and that means you will have to pay the difference between the doctor’s fee and Medicare’s payment.

At the exam, your doctor may do other tests or provide other services. Some of those---vaccinations to prevent pneumonia, flu shots, and counseling about tobacco cessation---may be covered under Medicare’s preventive services benefit. Other things might not be covered so don’t be surprised if you get a bill for services you thought were free because they were provided during the exam.

For a list of Medicare’s preventive services, consult the Medicare & You handbook, or check them out at <http://www.medicare.gov/pubs/pdf/10110.pdf>.

If you’re new to Medicare, you are eligible for a similar exam called the “Welcome to Medicare preventive visit.” You can get this visit anytime during the first 12 months you sign up for Part B—the part of Medicare that pays for hospital outpatient care, lab tests, and doctors’ visits.

This service hasn’t been used much either. The Centers for Medicare and Medicaid Services told me that the latest data show that only about 6 percent of new beneficiaries had the Welcome exam last year, up from nearly 5 percent the year before.

To me these low numbers indicate that Medicare and others haven’t done such a hot job of advertising one of health reform’s benefits. They also seem to contradict the talk in Washington that seniors use too many medical services, and therefore, should pay a greater share of their health care expenses.

While doctors, government agencies, and the media should do much more to let people know about services they’re entitled to under Medicare, word of mouth from seniors can also help spread the word.

Terror in Boston

Pete Duryea was in the city to make his dream of running the Marathon come true. He had trained running for months. But that dream became an urban nightmare soon after he finished his race, at 2:58 Eastern Time. As a devoted mom, I tracked Pete’s run on my computer and after he completed the race I decided everything looked ok, so I went upstairs to rest.

Soon after 4:09—about an hour later, the first bomb exploded! My daughter called me for news of Pete’s safety. I turned on the TV. I’ll call him! Pete’s cell phone was dead so I called Carol Walters who assured me

that her family and Pete were ok. After a nervous two hours, Pete called me from somewhere in Connecticut, where he was driving alone back to Nebraska. This was his story:

Carol’s son Eddie finished the race 30 minutes before Pete, so he and his dad left to find their car. Kindly, Carol stayed behind to greet Pete at the Finish Line. Since it takes a little time for an exhausted runner to recover from a long 26-mile run, they were slowly walking about three blocks down on Boylston Street. They heard an explosion, turned, then heard another blast, and saw the smoke at the nearby Finish Line. Stunned, they couldn’t believe that they were seeing a terrorist attack! Not in the U.S., not in Boston, not here! Shocked, they hugged and ran down their own ways—Pete toward the smoke to find his shuttle bus and gear, and Carol to find her family. The bus was nearby, so Pete boarded it for the return to the Start Line, nearly thirty miles away At first the authorities ordered the bus to remain there, but finally let the runners return to their cars.

At this time, Pete is still

driving home. I heard he was on Omaha radio this morning. He was so grateful his family was not in the stands at the Finish Line where the nightmare took place.

When he arrives at a huge family wedding this weekend, he’ll get lots of big hugs! We are so grateful to have him back!

WAIT Training

Shelly Donahue returns to FC



Shelly Donahue, who has taken her message of hope and challenge to 48 states and eight foreign countries, will return to Falls City to present WAIT Training assemblies to middle school and high school students on Wednesday, May 1, and to parents of K-12 graders that night at 8 p.m. at the high school.

Shelly, who was last in Falls City in 2009, will speak openly and frankly about the issues confronting our teens in the area of sexuality. Using stats from research she will boldly speak on how teens can someday experience “the best sex ever” by waiting for marriage.

Responses of those who have come to the seminar in the past has been phenomenal. One parent commented, “Shelly was awesome. She gave a great presentation that was funny, informative, and right to the heart.” Feedback from the evaluation sheets was overwhelmingly positive and supportive of the message heard. Several commented afterward, “This message needs to be heard by all of our parents, teens, and educators.”

Shelly has 34 years of experience as an educator - 19 of which as a health and PE teacher, as well as a coach and mentor. She does “WAIT Training” in public and private schools across the country. “WAIT” stands for “Why am I Tempted?” and is part of the educational and equipping program of the Center for Relationship Education in Denver, CO.

She cites the physical, intellectual, emotional, social, spiritual, and financial consequences of being sexually active during the teen years. She also gives data supporting her rationale. For instance, teenage boys who are sexually active are eight times more likely to commit suicide. Many teens will use alcohol and drugs to cover up the pain.

Her message is encouraging. She quotes from the National Survey of Family Growth statistics released by the Centers for Disease Control and brings out that teen sexual activity continues to decrease: 68 percent of boys and 67 percent of girls, ages 15 to 17, have never had sex.

“This is the best class of teens we have had for many years. We need to applaud them,” she said.

She will also stress the importance of parents loving and talking to their teens. A major concern is that we have a generation of girls in which “Daddy left.” Teen girls often try to fill the void of an absent father by becoming sexually active. An alarming statistic is that in 71 percent of the cases in which teen girls became pregnant, the boyfriend was 21 years old or older.

Today’s teens face many issues. Hollywood portrays sex in a deceiving way. Pornography is more readily available than ever due to our advanced technology and will be the cause of more divorces than any generation has ever seen. Whereas those who are senior citizens worried about two major STDs when they were teens, there are now 28 sexually transmitted diseases, four of which are viruses.

She will encourage parents to have loving boundaries for their children, to talk with them, and to applaud them when they do right. She will challenge parents to lovingly and courageously express to their teen, “When I was your age, I made my choices. Now I am here as your parent to help you make yours.”

Shelly’s focus is for teens to “live well, love well, and marry well.” She will conclude her presentation that there are also ways to have a second chance to start over. Her passion: “This generation wants this message. They have just never heard it.”

A parent and educator at a previous meeting wrote, “I wish I would have had this message when I was a teen.”

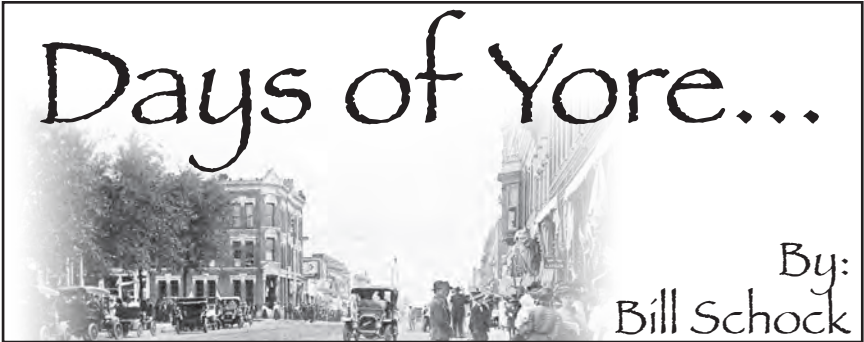

Blake Vitale to be honored by Red Cross May 2 at Lincoln’s Cornhusker Hotel

A young Falls City man will be formally acknowledged for his heroic act next Thursday evening, May 2, in Lincoln during the 12th Annual “Tribute to Heroes Awards Dinner” sponsored by the Nebraska/Southwest Iowa Region of the American Red Cross.

Blake Vitale, a 12-year-old seventh grade student at Falls City Middle School, along with seven others from southeast Nebraska will be recognized for their selfless acts of heroism and beginning tomorrow night, Lincoln-based KLKN Channel 8 will tell each of their stories as part of their “KLKN TV8 Heroes” series. Blake’s story will air next Monday and be available on the station’s website.

Deputy State Fire Marshal Raymond Nance and Development Director Christine Rasmussen with the Red Cross presented Blake with his “Good Samaritan Award” last month during a ceremony held at the Middle School.

Blake’s story occurred during the early morning hours of Nov. 23, 2012, when he awoke to his stepmother, Lisa Collier, screaming from the downstairs that the kitchen was on fire. Blake, sleeping upstairs in a bedroom with stepbrothers Kolten (10) and Aidan (8) Davis and Michael Collier (10) got his brothers up and forced them downstairs and out of the home as the ceiling was falling around them.

Blake spoke with Journal Editor Jason Schock a few days after the fire and the following excerpt is from story “Blake Vitale truly his brothers’ keeper,” which ran Dec. 4, 2012:

“Lisa was yelling our names and telling us to get up. Aidan got up and started running, but Kolten wouldn’t stand up,” Blake, an 85-pound FC Middle School seventh grader who excels in wrestling and basketball said. “I had to make him stand up and I pulled him down the stairs. He kept wanting to sit down and sleep, so I had to push

him outside. I could see, but I couldn’t breathe very well.”

Downstairs, the elder Vitale and Lisa managed to get seven-year-old Cayden Collier and their two-year-old son, Wesley, out of the inferno to safety, so the entire family – two adults and seven children – escaped physically unscathed.

The home, owned by Marvin Arnold, of Falls City, was a complete loss and the family lost all their belongings. The American Red Cross was called to help the family with clothing and immediate needs.

Tom Vitale said he hated to think what the family could’ve lost had it not been for his brave 12-year-old.

Blake, though, said he knew what he needed to do.

“I just did what was right.”

Drought-damaged lawns require proper care

Blossoming trees and flowers signify the return of spring, but so does green grass.

Spring brings colorful plants back to life, including lawns throughout the state. As turf re-emerges from winter, Zac Reicher, University of Nebraska-Lincoln turfgrass management specialist, offers suggestions for how to help lawns recover from a dry year.

Reicher said that winter conditions were favorable for healthy spring lawns. Nebraska received enough snow to prevent the worst of winter drying but not enough to cause problems like snow mold. At the same time, last summer’s drought could cause some problems as turf resurfaces from the winter.

“If your lawn was not green and growing by the time winter got here, it is not going to magically reappear over the winter,” Reicher said.

With that in mind, Reicher recommends seeding as soon as possible – no later than mid-May – in dead lawns. Seeds will be competing with weeds during this time of year, and early planting will make them more competitive. Because of the undeveloped root system, it is also important to keep the seedlings well watered throughout the summer and apply fertilizer carefully.

“Since the seedlings will not develop a good root system until next fall, low rates of fertilizer applied frequently will be most effective,” Reicher said.

Pre-emergence herbicides can damage new seedlings and should be avoided. However, weed control is important so that weeds will not overtake the growing turf. Suggestions for products and application are available at turf.unl.edu.

For those lawns that survived the drought and winter, mowing early in the season will result in healthier grass as summer arrives. Because grass grows from its crown at the base of the plant, or essentially from the ground up, waiting too long to mow could cause the new green grass to be “scalped.”

“You’re getting rid of the dead, brown leaf material from winter, but as the green leaf material pushes itself up, you don’t want to mow too much off,” Reicher said.

Tornado season is here

While conditions are much different this spring than last, tornado season is here. A year ago we already had had several tornadoes in Nebraska. The unseasonably warm temperatures we had last year, spawned a number of tornadoes that caused significant property damage and loss of life in the south and other parts of the Midwest. While we have had below normal temperatures and winter-like conditions recently, it is important for us to be ready for potential severe weather and tornadoes any time.

We all remember five years ago, when Johnson was hit early in the season by a tornado and then the area was hit again later in the season. Remembering this, the last thing you want to hear is that tornado season is here! Unfortunately it is. The climate continues to be ever changing, and the weather is extremely unpredictable, so we should be prepared to expect any type of weather this spring and summer. Temperatures have been fluctuating tremendously from day to day this spring, which can be very conducive to severe weather, including tornadoes.

Are you ready for a tornado? Do you know what to do if a tornado is headed your way? With severe weather beginning, it's time to be prepared for tornadoes. Air temperatures have been fluctuating tremendously from day to day this spring, which makes us very vulnerable to severe weather, including tornadoes.

What are some things we should do to be prepared for a possible tornado? First, you need to have a place in your home where family members can gather if a tornado is headed your way. It could be in your basement or else in a center hallway, bathroom or closet on the lowest floor if there is no basement. If you are in a high-rise building, go to a place in a hallway in the center of the building, you may not have time to go to the lowest floor. Your place of work should also have a tornado plan. If you are unaware of it, find out what it is.

If there are storm warnings issued for your area, listen to your local radio and TV stations for updated storm information. You need to know the difference between a tornado WATCH and WARNING. A tornado WATCH means a tornado is possible in your area. A tornado WARNING means a tornado has been sighted and may be headed for your area. Go to safety immediately. If a tornado WATCH is issued, listen to your radio and TV and be alert to changing weather conditions. Environmental clues that indicate a tornado may be developing include: A dark, often greenish sky, a wall cloud approaching and large hail. Blowing debris may also be a sign of an approaching tornado. People say a tornado sounds like a freight train. If a tornado WARNING is issued go to the safe place you picked to protect yourself from glass and flying objects. If you are outside, hurry to the basement of a nearby sturdy building or lie flat in a ditch or low-lying area. If you are in a car or mobile home, get out immediately and head for safety as described above. After the tornado passes, watch out for fallen power lines and listen to the radio for information and instructions. Use a flashlight to inspect the damage, never use candles! A gas line may have ruptured, leaving highly combustible natural gas or propane in the area.

The most important thing is to be prepared for a tornado and don't take the threat of a tornado lightly. The destruction and devastation from tornadoes can be unbelievable.

The Nemaha Natural Resources District issued an Order at the April 11, 2013, Board Meeting approving the dissolution of the District-wide temporary 180-day stay on water wells and the proposed revisions to the District's Groundwater Management Plan Rules and Regulations as brought before the District Board of Directors. The proposed revision to the rules and regulations will apply geographically to include all lands and water bodies within the boundaries of the Nemaha NRD. Also the proposed revisions will apply stratigraphically to all groundwater located within the Nemaha NRD and is not limited to just groundwater found in the Missouri River Alluvial aquifers, Paleovalley Alluvial aquifers, shallow aquifers, or other such bedrock aquifers within the District. The proposed revisions to the rules and regulations include the following:

- Requiring the installation and use of flowmeters on all new and replacement high capacity wells,
- Allowing no more than two high capacity wells to serve a single purpose, and
- A high capacity water well permit ranking system methodology.

Eastern red cedar trees a nuisance

Eastern red cedar trees are becoming a nuisance tree, growing where they are not wanted. But instead of removing and wasting the trees, a University of Nebraska-Lincoln graduate student is trying to simplify a way to use the material for good.

Adam Smith, a first-year natural resource sciences graduate student, is conducting research that could help people throughout Nebraska use eastern red cedar trees in a non-wasteful and even helpful way.

Smith, who graduated from UNL in 2009 with a bachelor's degree in fisheries and wildlife, is attempting to estimate the volume of woody material a property has available for biomass utilization purposes, often in the form of woodchips and used as a heating fuel, based on the

height and diameter of the trees on the property. When Smith began his job at the Nebraska Forest Service as the forestry project coordinator, he saw an opportunity to assist landowners in using unwanted red cedars as an economic resource.

"The alternative to woody biomass utilization is to pile the trees and destroy them, when they could be a source of income," Smith said.

After selecting forest inventory points throughout the state, Smith collected data on the location, species, diameter and height of trees at these points. Research by Tala Awada, professor and interim director of the School of Natural Resources, is used to estimate



the mass of red cedar trees per cubic foot. The estimate of tree mass per cubic foot and Smith's volume estimate together will determine the total weight of each tree and therefore estimate total available woody material in the area.

Smith gathered data from across the state and saw a noticeable difference between regions. Although more moisture in eastern Nebraska makes it easy for the trees to establish rapidly in the region, red cedars also can grow in harsh conditions. In western Nebraska, this allows the trees to outgrow other vegetation struggling with hot, dry conditions. Since there is more available land in the west, the trees have more space to grow as well.

"If the trees have the opportunity to get a foothold, they will," Smith said. "And the cur-

rent drought conditions offer the perfect opportunity for these trees to continue expanding."

Smith's research will give professionals the opportunity to calculate how much woody material is available to be used as biomass fuel and offer landowners help in finding a market for it. According to Smith, the

landowner can benefit not only from the profit from selling the wood, but also can reclaim the land where the red cedars had been growing.

"An outdoorsman will appreciate the ability to walk through the grasslands of Nebraska again," he said.

Owner occupied housing rehab pre-applications sought

Securing housing rehab grant assistance is the goal of an effort underway in Falls City. The goal is to make grant funds available to owner occupants in Falls City that will allow them to address substantial rehab needs in their homes.

To make that happen, the Falls City Housing Advisory Board and SENDD are conducting the background work necessary to gain the award of a Community Development Block Grant from the Nebraska Department of Economic Development. Early response from interested homeowners is being sought, seeking feedback from potential applicants to provide specific documentation for the grant pre-application that is due in May.

The early steps to design a 2013 Housing Rehab Program for the City of Falls City have begun. During their April 15 meeting, the City Council gave the "go ahead" to begin this task and bring an application back to the council for formal public hearing. At the moment, there are no guarantees that Falls City will be able to host a housing rehab program in 2013.

SENDD staff notes that Falls City is able to seek funds to address approximately 8 to 12 owner occupied homes (renters are not eligible). To get a competitive application assembled, SENDD feels that there is a need to take the preliminary steps to pre-qualify both the interested families and their homes. To do that, pre-application forms are now available at City Hall. The first deadline for the return of owner occupant information via the pre-addressed envelope attached to these pre-apps is May 20, 2013. The City will submit a pre-app to NDED by May 31. Then, the City will continue to collect pre-apps through July 1, as the City's final app is due to NDED by July 19.

SENDD staff cautions that there are no guarantees at this time that Falls City or any specific homeowner will get assistance. While the City and homeowners need to respond now to have a chance to secure assistance, there will be a considerable waiting period before the Nebraska Department of Economic Development makes funding announcements.

Who is a likely rehab candidate and what is rehab?

Top priority is a Category 1 level for very low-income owner occupant households that may qualify for 100% grants via rehab assistance. Construction needs specific to each home will be determined by an inspection of the home, but typically include heating, plumbing, roofs, windows and doors, etc. If Falls City does not have enough applicants in that range, then a Category 2 "Moderate" threshold will be used. This second category of homeowners would likely receive a 50% grant and they would have to repay 50% of the total project cost.

Annual income level used to identify those households with the greatest need listed first (100% forgiven over a five-year period); Moderate level listed second (50% forgiven/10 years, no interest):

- 1-Person Household, \$19,950; \$31,950.
- 2-Person Household, \$22,800; \$36,500.
- 3-Person Household, \$25,650; \$41,050.
- 4-Person Household, \$28,500; \$45,050.
- 5-Person Household, \$30,800; \$49,250.
- 6-Person Household, \$33,100; \$52,900.
- 7-Person Household, \$35,350; \$56,550.
- 8-Person Household, \$37,650; \$60,200.

If you own a home within the Falls City City Limits, you meet the first threshold. If you are interested in housing rehab assistance, please check your 2013 adjusted gross income total against these limits. If the income for everyone residing in that household is below either of these thresholds, you should be able to meet the second threshold of pre-application. Interested households that meet specific income limits have an opportunity to submit a pre-application and are encouraged to submit them as soon as practical. If you are the advocate family member providing support to an owner occupant who would benefit from this kind of substantial rehab to their home, you might want to offer to get the pre-application and assist them in filling it out and getting it mailed.
