

## Mini Park needs touch up as 30th birthday nears

The Falls City Mini Park, located on the west side of 1500 Stone Street, will celebrate a 30<sup>th</sup> birthday in August. And while 30, perhaps, is too young for a complete facelift, some of those years were pretty hard on her and a nip here and tuck there would make for a perfect

Efforts are being made to restore the park and her three prized murals to their former glory after Mother Nature has not been particularly kind. A few years ago, a tornado blew the roof off of True Value and jammed it into the murals. This past spring, more damaging winds took down the west mural. Tootie Ebel and Pat Steinman restored the centers of the paintings and added a wide border to each. The framing on the building had simply given way and rotted out. A couple of weeks ago, Dave Sailors, with the assistance of Jeff Martineau, replaced the mounting frame and the mural panels. However, they are both showing their age, and are starting to rot. Ebel and Steinman plan to survey the damage and attempt to fix the paintings, but the panels are in very fragile condition and their life span is limited.

# Deputy survives shooting; gunman remains on the loose

Richardson County Sheriff's Deputy Josh Nincehelser is recovering well from a gunshot wound suffered in an early Monday morning shootout just off Highway 75, about four miles north of the intersection of Highways 4 and 75.

Deputy Nincehelser, 25, of Humboldt, was on routine patrol at approximately 2 a.m. when he encountered a silver or tan Dodge Neon with no license plates stopped on 717 Road, approximately one-fourth of a mile

west of Hwy. 75. Nincehelser approached the vehicle to ask the driver, a hispanic male, if he needed assistance. The driver did not speak English and as the deputy was attempting to communicate, the man produced a silver semi-automatic pistol and fired at least three shots at the officer, hitting him in the bi-

Nincehelser returned fire - five shots - as the gunman sped away. The deputy gave chase for about four miles before realizing he'd been shot.

# City Council cool with beer and barbecue, but firemen less than stoked about PD's new proposal

Bland was not on the menu last Monday night at City Hall, as the owner of a new restaurant peppered one council member on the subject of sauce and barbecue, while firefighters continue to fume as the City Council considers going back on a promise it made to the Falls City Fire Dept. just a month ago.

In May, the Council, against the recommendation of the Management Committee and City Clerk/Treasurer Gary Jorn, voted 7-1 to replace retiring fireman Ralph Gilkerson with another full-time fire truck driver. The City is advertising the job opening in today's Journal classified section. But last Monday (June 2), FC Police Chief Duane Armbruster proposed the idea of adding a full-time city employee who would work for both the Police and Fire Depts.

The Council tabled the issue, will discuss it further (and possibly even bring it to a vote) at the Monday, June 16, meeting (6 p.m. start). The idea of a second vote regarding the one fireman job was not well-received by FC Fire Chief Ken

"The proposal made here by Duane and the Police Dept. is in direct opposition from the approval by the Council a month ago. The Council approved hiring a replacement for Ralph Gilkerson," Simpson said.

Simpson 10 years ago fought the Council against going from three paid drivers to two. He lost then, but this time around, on May 5, he successfully convinced the Council the town's need for two full-time paid firefighters. Or so it seemed.

Armbruster argued that most towns the size of Falls City are served by all-volunteer fire departments. Council members now are asking themselves if Falls City, specifically, can be sufficiently served by one full-time fireman, a

part-time fireman, a few part-time paid drivers and the FC Volunteer Fire Dept.

"Two firemen working 24-hour shifts and part of that time is down time - they're actually sleeping, and I'm not saying that's bad or trying to start a war or anything," Armbruster said.

Armbruster proposed that a new employee could cover shifts for the Police Dept. part-time, do code enforcement with the power to arrest and issue citations and reports. He asserted it would save the city "a bunch of money." The Fire Dept. the last several years has assumed some duties previously performed by the police, such as building permits and nuisance calls. That's not working out very well, Armbruster said.

"Right now, to be up front with you, we're struggling to keep up with the nuisances and the City Attorney is on us quite a bit about not having the facts right, not having the photos right," he said. "The firemen have no power to arrest, no way to take action, so we end up doing it all anyway."

The Council allows the FCPD to hire two part-time officers, but according to Armbruster it's nearly impossible to fill the positions.

If someone goes through training and becomes certified, they'll go elsewhere and find a full-time job, Armbruster said. "We have the positions, but there's nobody to fill them."

The proposal, he said, would eliminate the need for part-time help for the FCPD, as well as overtime hours, and provide the manpower needed to conduct more thorough investigations. The department officially has eight full-time officers, as Jeremy Goldsberry was sworn into office earlier in the meeting.

"It would definitely help our department and I don't see how it would hurt their department," Armbruster said. "Sometimes you gotta do what you gotta do to do what's best for the city and I think this is best for the city."

Simpson said the fire department is getting "overtaxed."

"In 2008, we took building permits. In 2010, the police were overworked so the Fire Dept. took over nuisances. Now, in 2014, the FCPD is getting its ninth (sic) officer, don't do nuisances and they ask us to take a shift," he said.

Simpson provided the Council a 19-page document authored by the International Association of Fire Fighters and the International Association of Fire Chiefs titled "Police and Fire Consolidation, an Ineffective Use of Resources." The manual condemns the increasingly common practice of combining roles of fire fighters and police officers, particularly as cross-trained personnel who perform tasks directly involving public safety. The document contains few statistical references, and admits as much in the third paragraph of the introduction: "Research and academic/municipal studies are limited on this issue, therefore, the content herein includes the opinions of IAFF and IAFF officers, staff experts and members of the IAFF and IAFC," it reads.

The manual itself is undated, but the few references that are cited date back at least three decades, bringing relevance to 2014 into question. Unsuccessful consolidation efforts in Peoria, IL, in 1970, Daytona Beach, FL, in 1979, and Durham, N.C., in 1985, are cited, as is one man's 1971 doctoral dissertation. The document's authors attack a 1977 survey conducted by the International City Management Association, an organization referred to as "advocates of consolidation," which "produces publications that extensively cover the subject from a city manager's perspective."


"Today's city managers may be more easily tempted by the argument that consolidation

Netflix boasts many original programs that are now on par with network quality shows. ## Governor says he's interested in university job

Arrogance or ignorance. Who among us would use stationery from our current employer to apply for another job? To say nothing of using the time, physical resources and personnel of our current employer to make the announcement that we were seeking said

Apparently the lame duck governor of Nebraska who wants to be the president of the University of Nebraska system.

Did I mention that six of the eight people (NU Board of Regents) who will decide on the person to have that iob are people who have contributed to the governor's campaigns for his current

That's just a sample of the furor caused by Governor Dave Heineman's announcement that he's an applicant for the \$400,000 - plus job of NU President that was recently vacated by J.B. Milliken. Heineman said he thought that his friend J.B. would be a lifer in the job and that's why the termlimited governor didn't express inter-

State Democratic Party Chairman Vince Powers says he thinks the Republican governor violated a state law that bans public officials from using their office or government resources for personal use or financial gain. He says he'll file a complaint with the state Accountability and Disclosure Commission over the governor's actions.

The governor's staff set up the news conference in the governor's hearing room in the state Capitol, sent out media releases before and after the event — all at taxpayer expense. He also sent letters to university regents notifying them of his candidacy on his official office stationary, Powers said.

'The governor should not be using his office to promote his candidacy," said Jack Gould, issues chairman for Common Cause Nebraska, a political watchdog group. "He should not be using his office to gain any advantage over any other candidates.

Heineman called his public disclosure an issue of transparency. Some regents and others have expressed concern that his entry into the race will cause others to avoid seeking the job. In Florida, once State Sen. John Thrasher entered the field, interest dropped off to the point that university trustees are only interviewing Thrasher, a move that hasn't gone over well with faculty members looking for strong academic credentials. Heineman, a West Point graduate, has worked only in politics.

NU Board of Regents Chairman Howard Hawks of Omaha said he thinks the governor has a right to reveal himself as a candidate if he chooses and it's his right to do that at the Capitol. A provision of the state Political Accountability and Disclosure Act prohibits public officials from using government personnel, resources, and property of funds under their control for personal gain although there is an exception that allows incidental or trivial use of resources.

Powers pointed to former Lt. Governor Rick Sheehy who resigned after making hundreds of phone calls to women using his state cell phone last year. At the time, the governor said public officials are held to a higher standard and "that trust was broken." Powers said Heineman should resign to be consistent with his treatment of Sheehy. Sheehy reimbursed the state \$500 for using the state issued cell phone and Hawks said he met with Heineman May 19 at Heineman's request and explained the process. Hawks said they did not discuss his plans to make his candidacy public, and that he and other regents have committed to not discussing specific candidates until they get to their final four.

Heineman told reporters that he would not seek to change current NU policies that he has opposed in the past, including charging in-state tuition rates for children of illegal immigrants, allowing stem-cell research, and providing job benefits to same-sex couples. 66-year-old

conservative Republican is a former Army Ranger with a bachelor's degree from West Point. He served as state treasurer and lieutenant governor before becoming governor nine years ago when Mike Johanns resigned to become U.S. agriculture secretary.

Hawks has previously said that he hopes to hire a current university chancellor or president for the job. Heineman doesn't have any experience running a university, nor does he have a graduate degree. But the governor said chancellors and provosts pretty much run the university particularly as it relates to academics. As such, he says his qualifications for the job would work.

Consider this something else to occupy our minds until football season begins and the November election

## Unnecessary antibiotics can be harmful

How many times have you walked away from the doctor's office with a prescription for an antibiotic to treat a cold? Probably many. Over the decades we've been conditioned to believe that antibiotics are sort of an insurance policy against some malady that might be worse than a cold or that they will make the nasty symptoms magically disappear.

In recent years, study after study has shown that this "just-in-case" medicine comes with oodles of side effects and serious consequences that might make patients think twice before dashing off to the pharmacy. And yes, it might mean questioning your doctor's judgment—something most patients are reluctant to do.

While antibiotics can cure a strep throat that's caused by bacteria, they aren't going to do much to get rid of a sore throat caused by a virus---the culprit causing most sore throats. And while they are helpful in clearing up bladder infections, says the Mayo Clinic, antibiotics aren't much use when it comes to curing the flu or most coughs.

Still, doctors prescribe them anyway. Warnings surfaced more than 20 years ago that taking antibiotics when they are not helpful could make patients resistant to them years later when a serious infection develops. Such resistance may make it tough or even impossible to cure these patients.

Yet last fall a study showed that between 1997 and 2010 primary care and emergency room doctors prescribed antibiotics about 60 percent of the time for sore throats. The lead researcher, a primary care doc from Brigham and Women's Hospital in Boston, noted that "the right antibiotic prescribing rate for adults with sore throat is probably around 10 percent." So it seems many of us are taking way too many of these drugs.

The fact that American doctors are all too willing to prescribe antibiotics hit home a couple of weeks ago when I was traveling in Europe. I had what seemed like a garden-variety cold several days before I left. Since it was lingering, I decided to check it out the day after I arrived in London and made my way to what the British call the A and E Department (for accidents and emergencies) at a nearby hospital.

The doctor who examined me saw no indications that would warrant antibiotics---no red ears, no red throat, no congestion in the lungs. She warned this viral infection might turn into a bacterial illness, but for the time being, the doctor explained antibiotics were unnecessary and possi-


Another week passed, and the symptoms got worse. It was clear I needed to visit the National Health Service again. Sure enough this time a doctor spotted signs indicating an antibiotic might be in order. But she didn't prescribe a Z-Pack, Cipro, or any other high-powered drug, which is what I have seen doctors do at urgent care centers in New York City. One time a physician give me Zithromax which he said would help the lungs, the ears, the sinuses and throat in case I had something in those areas that needed treatment.

In England I got a computer-generated prescription for old-fashioned amoxicillin, which a pharmacy filled in less than five minutes. No one asked about coinsurance, copayments or whether the drug was on the formulary---barriers patients face here. In fact, I paid nothing for the medicine. Medicines are free in the UK to those over age 60. Nor did I pay anything for the two visits to the health service. Initial treatment at A and E departments and walk-in clinics is free to all overseas visitors.

My point is not to tout the ease of getting treated as a foreigner in the U.K. but to note the proper care that I received. It made me think about all those times U.S. doctors sent me out with a prescription for the latest and greatest wonder drug, a treatment that might come back to hurt me some

The antibiotic worked, and the whole experience underscored that questioning your physician when you show up with a cold may be the best medicine of all.

can cut costs, even if that argument is unfounded, when faced with the pressure to decrease budgets," it

The 1977 ICMA survey of cities was an attempt, according to the IAFF/IAFC document, to prove consolidation was effective in "achieving a higher standard of service at lower cost, to improve fire protection, reduce response time, create greater numbers of trained career fire fighters, reduce nonproductive time of fire fighters and create a greater number of trained career police."

The IAFF/IAFC manual claims "that many of the cities in the ICMA survey reported that they had not actually achieved their goals with consolidation," but made no citations to strengthen that claim. However, the authors do refer to a 1980 Ryland Research study that revealed that reduced staffing at fire stations "stretches resources too thin." The study revealed consolidation leads to higher fire loss, poorer prevention capabilities hence more fires, and more uniformed injuries or deaths per fire.

With two full-time firemen on the department, Falls City provides fire coverage 24 hours per day throughout the week, starting at 8 a.m. Monday. One of the two works an eight-hour shift on Saturdays, leaving 56 hours per week covered only by six part-time drivers and the FC Volunteer Fire Dept.

Jorn said he didn't like the proposal at first, but has changed his mind.

"We've been fortunate to get part-time officers. We're not going to get them in the future. They have to be certified and nobody is going to go out and get certified by themselves. We need to think about how we can make it beneficial for both the Police and Fire Dept.

"When our previous mayor decided he wanted to cut people, whenever anybody quit or retired, we never replaced them. Not only the Fire Dept. has assumed more duties - I assumed duties, (Utility Supt.) Alan (Romine) assume duties, (Deputy City Clerk/Treasurer) Carol (Bentley) assumed more duties. We have worked toward making it more efficient for the city,"

"We gotta start looking to the future," he said. "Not just today, but the future of Falls City and it's not just the Fire Dept., but it's the Police Dept. - it's going to be hard to get these officers in the future. It's not going to be a career a lot of people want to take."

On May 5, Steve Scholl made a motion to replace Gilkerson and Kirby Robidoux seconded that motion. Jerry Oliver, Mike Dougherty, Don Ferguson, Jim Wisdom and Angie Nolte all voted to pass the motion. Casting the lone vote to delete a driver was Judy Murphy.

It was not the first time Murphy, the representative of Falls City's Second Ward, stood conspicuously alone and apart from a gang of "yeas." Nor was it the last.

During last Monday's meeting, Rachel Witt, owner of Dickey's Barbecue Pit, which opened in Falls City last month to a famished community of voracious carnivores turned fat and happy regulars. Witt asked the Council for its blessing in

Dickey's efforts to offer suds with their smoked goodies.

"Beer and BBQ - they kind of go hand-in-hand," Witt said.

The Council agreed, by a 4-1 vote, with Nolte and Robidoux abstaining and Oliver, Dougherty, Wisdom and Scholl voting yea. Murphy predictably voted "no," as she has for every liquor application that's come before her. Anticipating the "no" vote, Witt said she and several Dickey's employees canvassed Falls City's Second Ward throughout the day Monday, asking folks if they disapproved of alcohol sales at Dickey's. Though admittedly not a scientific poll, Witt said there was only one resident - an elderly woman - who expressed she didn't want alcohol sold at Dickey's.

After the vote, Witt asked Murphy about her "no" vote.

"I always vote no," Murphy

"That's why I'm asking," Witt retorted.

"I just think that even though you have personal opinions, the City Council is elected to represent its constituents," she said.

Yesterday, Witt expanded on that point. "If 500 people live in your Ward and 251 are in favor or against any issue, that should be the way you vote, I think."

Murphy defended her consistent record of "no" votes on anything alcohol-related.

"That would be arbitrary if I voted 'no' for everybody else; people would wonder if I got something under the table or something," Murphy said. And, she added, "I get a lot of people who thank me for always voting 'no."

Armed with the Council's favor, as well as the approval from those at the First United Methodist Church, located caddy corner to Dickey's on 17th and Harlan, Witt will take Dickey's request to the Nebraska Liquor Commission before the end of June. Getting the church's blessing could be enormous in their bid - state ordinance prohibits alcohol sales within 150 feet of a church. However, it's unclear if that means 150 feet from front door to front door, or 150 feet from the building's most adjacent points.

In other news:

- The Council took no action concerning an alley located between McLean and Fulton Streets between 4th and 7th Streets. The dedicated alley includes a city easement for utilities but has never been graded or rocked. The Council suggested the neighbors work out a solution.

- Approved two requests to build metal buildings. One for Charles and Carol Bentley at 1923 Clifton, the other for Ben Howard at 620 Harlan.

- The Council voted to accept a donation of the grass lots at 111 W. 17th St. from Southeast Nebraska Communications.

- A three-year contract to have Julie Bauman CPA of Falls City do the City audit was approved. The price will be \$12,250 for 2014, \$12,500 for 2015 and \$12,750 for

- Council members voted unanimously to have the City Attorney draft an ordinance to allow all terrain and utility type vehicles to operate within the city limits. The idea was proposed by Terry Tisdel.

- Council members also approved the purchase of a 2015 Ford Explorer from Hullman's Ford in Falls City for use as a police department patrol vehicle at a cost of \$27,252 which is the state bid price.

- An ordinance passed on first reading to change the start time of the second meeting of each month to 7 p.m. The vote was 5-2 with Nolte and Wisdom voting no.







Monday. Houser said all areas from the Richardson/Nemaha County line south to Hwy. 4 and the area between Hwy. 75 and Hwy. 105 had been completely searched, including all barns, sheds and buildings. Four teams of law enforcement officials conducted the search, as well as an aviation team by helicopter. A nationwide broadcast was made Monday morning.

Sheriff Houser hinted that the subject may have connections to the area, as officials are working on leads locally. "We are working on what we think is a very good lead," he said.

Houser stressed that a manhunt is still underway. Law enforcement agencies throughout the region are seeking the suspect's vehicle. If anyone sees a vehicle matching the description or has any information about the driver they are asked to contact the Richardson County Sheriff's Office right away at 402-245-2479 or the Nebraska State Patrol at 402-471-4545.

The individual being sought after is

considered extremely dangerous and members of the public should not attempt to apprehend him or contact him under any circumstances.

Nincehelser, meanwhile, Monday night was recovering well in a Lincoln hospital.

"Josh is good and he is wanting to come home," Sheriff Randy Houser

The bullet that struck Nincehelser, a 2007 graduate of Humboldt-TR-S High School, went completely through his bicep, causing a flesh wound that needed staples to close.

Just last summer, Houser recognized Nincehelser with a certificate of commendation for exceptional performance of duty in a stressful and dangerous situation. The deputy had responded to a possible drug overdose call at a residence in rural Richardson County when he and emergency medical personnel were confronted by a teenage girl wielding a knife and threatening to kill people. Nincehelser calmly took control of the assailant, placed her in handcuffs and detained her in his patrol vehicle. He called for assistance, but 13 minutes elapsed before help arrived.

"Performance such as this is characteristic of Deputy Nincehelser's grace under pressure and ability to calmly respond to high stress situations, which reflects great credit upon himself, the Richardson County Sheriff's Office and all law enforcement officers," Houser said at the time.







# Mini Park needs touch up as 30<sup>th</sup> birthday nears

you is to give a donation of either a commitment of labor in the park or money to hire someone to do it," Mini Park Mom Mary Whitehouse, said. "We need people who will keep the flower beds weeded and free of weeds and tree sprouts. We need people who will mow and do so on a regular schedule."

The Mini Park was an effort of the merchants of the 1500 block back in the early 1980s. Ron and Madeline Keller, Mrs. Whitehouse, Rev. Vern Bohrer, Roger Kiekhaefer and Pinky Hampton, along with many others, pooled resources to level out an area that was struck by lightning. The fire left an eyesore that needed to be cleaned up. Fundraising projects were held and many people donated items for the park. Ebel and Steinman brought together artists and Bolejack Sign Co. obtained the panels for the artists. The James family loaned the old turkey factory for the artists to paint in and thus the Mini Park was born. It was dedicated on Aug. 16, 1984.

Many other community efforts have enhanced the park at Christmas time and it has become a centerpiece of downtown Falls City.



A couple of weeks ago, Dave Sailors, with the assistance of Jeff Martineau, replaced the mounting frame and the mural panels at the Mini Park, located on the west side of 1500 Stone Street. However, the murals are showing their age. Efforts are being made to restore the park, which will turn 30 years old in August, and her three prized murals to their former glory after Mother Nature has not been particularly kind.

The Mini Park's paintings offer a visual representation of the history of Falls City. It is broken into three panels, each of which represents a period of the history of the town. The first panel, mounted on the left, represents the time period of 1800-1900. This mural depicts the earliest days of Falls City, and includes renditions such as Indian earth lodges, a young farmer and

horse plowing the ground, the falls of the Nemaha river (which gave the name to Falls City), and the first courthouse.

The center panel represents the period of 1900-1940. This mural includes such paintings as apple orchards, the first train station that brought a labor force to Falls City and increased property values, modern farming equipment and gas engine vehicles. The center panel also depicts the original Sts. Peter and Paul Catholic Church, a view of Main Street when the roads were made of dirt, the first courthouse, Falls City High School's first building (where North School now stands), the old water tower where artist John Falter can be seen sitting on top, and the Lydia Brunn Woods Memorial Library.

The last panel, mounted on the east, displays many aspects of the industries of Falls City. The Veterans Memorial on the courthouse lawn. The National Guard Armory. Falls City Middle School. The 1500 block of Stone is also depicted, to represent the growing businesses of the community. Last but not least, the mural ends with modern farming. The mural begins and ends with agriculture, which is the heart of the Falls City community.

For more than 20 years Mrs. Whitehouse held a third grade mini history class in the park, bringing it's story to life. The murals have certainly stood the test of time. For 30 years, the brushstrokes in the paintings have told the story of Falls City's beginnings. Many have donated their time to the upkeep of the park, including Kevin Malone and Bob Aitken, who have mowed the lawn for the past 20 years

While he was excited for the chance to play football again as a member of the South team in the 2014 Nebraska Shrine Bowl, Falls City Sacred Heart graduate Jarod Fiegener, however, came away from his weekplus stay at Shrine Bowl camp with a greater appreciation for what the game means aside from football.

Even though the South team lost the game to the North, 30-7, the Sacred Heart graduate took much more away from his experience than just Saturday's contest.

Fiegener said he was excited about the prospect of playing in the game from the time he was notified he'd been selected for the team.

Fiegener said he likes playing on the defensive side of the ball and didn't care whether it was at linebacker or on the line. For the Shrine Bowl, he was tabbed as a defensive end.

Since the South was carrying only five defensive lineman on its roster, Fiegener said he was looking forward to getting quite a bit of playing time in the game

"I think it will be a lot of fun," Fiegener said. "I'm excited to get out to Kearney and play. It's for a really good cause."

The week started with the South athletes reporting to camp on the Doane College campus Friday afternoon, May 31. The North team camp was held at Nebraska Wesleyan University in Lincoln and those players reported the same day. Saturday night, a picnic was held for the South team at Doane.

Fiegener said South team practiced twice a day, except for Wednesday when they made a trip to the Chicago hospital. "The coaches push us pretty hard," Fiegener said. "They work us pretty hard."

Fiegener said the coaches seemed happy with the team's progress during the week.

The South team was scheduled to scrimmage Sunday night, but it was postponed to Monday morning due to weather. After both teams scrimmaged, Fiegener said the two traded film to allow them to scout each other.

On Wednesday, June 4, the South team traveled to Omaha for its flight to Chicago to visit the Shriners Hospital for Children there. The North team traveled to the St. Louis Shriners Hospital the same day.

"We got up about 4:30 a.m. and then we had to bus to Omaha," Fiegener said. "The planes were delayed and everything because of the storm. We got out there and it was really nice to see all the kids and tour the hospital.

"We really figured out what we're playing for after going on that visit. We play it for those kids. The proceeds go to the hospital, so it was nice to get out there and see all that." Fiegener said the coaches had been saying all week the hospital visit would be important for the players.

"The coaches were saying it would chance our attitude after we got out there (Chicago)," Fiegener said. "And it really did. After we got out there and saw all those kids go through what they were and everything — it was a life-changing experience."

Friday, both teams bussed to Kearney in the afternoon and took part in an evening banquet at the Ramada Inn. Saturday's activities started with the Shrine Bowl Parade at 10 a.m., followed by the game at 2 p.m. Playing in the Shrine Bowl game gave Fiegener another chance to be on the field, playing the game he loves.

"I've always loved football. It's always been the sport I love to play," Fiegener said. "I love playing defensive mainly. It's just a passion, I guess."

Fiegener said the highlight of his high school career at Sacred Heart was winning the Class D2 Nebraska State High School Football Champi-

The Irish finished the 2014 season a perfect 13-0 after downing Stuart, 63-14, in the state final.

"My highlight was definitely winning the state championship this year," Fiegener said. "That was our goal, basically every year I played, but we finally got it as seniors. That was a great experience and I'm really proud to say I'm a state champion."

Fiegener will be continuing his football career at the next level, taking the field for Doane College in the fall.

"It's nice to be up here this week to learn where all the facilities are," Fiegener said. "Now, I basically have the campus down so I'll be ready for when I come here this fall."

# Big Red Recruiting Report

#### **Business as Usual**

One of the things about recruiting is that change is inevitable. Nebras-ka's class experienced some change recently, as receiver **Spencer Tears** (6-1/172) of Oak Lawn, Ill. decommitted. Word on the street indicates a mutual decision, but because college coaches cannot comment on recruits we don't know NU's stance for certain.

In early May Tears competed in the Rivals Camp Series in Chicago and was measured at 6-foot-1 instead of his listed 6-foot-3. At that same camp, Tears was clearly outperformed by Husker legacy **Clester Johnson Jr.**. (6-2/181) of Bellevue West.

Johnson was in the discussion for receiver MVP and has since added offers from Wyoming and North Dakota State. Another strong performance at the Nike camp in Columbus, Ohio bumped Johnson's profile even more. He will visit Nebraska for Big Red Weekend June 7 hoping to earn a Husker offer. If the offer comes it's safe to say that NU will be among his top choices.

Safety Agran Williams (6-0/185) of Atlanta is the most recent com-

Safety **Aaron Williams** (6-0/185) of Atlanta is the most recent commit for NU, spurning offers from Kansas State, Mississippi State and Ole Miss among others. Williams began starting as a 14-year-old freshman at Atlanta's George Carver HS, playing in Georgia's largest classification. As a freshman Williams was good enough to earn first-team all-region and he has never looked back. Last season Williams was first-team all-region for the third time as well as first-team all-state.

Another recent addition to NU's roster at safety is **Kieron Williams** (6-0/195) of Shreveport, La. who spent 2013 at the Air Force Academy Prep School. Williams was recruited to Air Force by new NU defensive backs coach **Charlton Warren**, and when Williams decided to transfer from Air Force Warren was the first person he called. Despite immediate offers from schools like Iowa, Cal, Indiana, BYU, and Colorado, once he visited Lincoln he was quick to pull the trigger. As a prep school transfer, Williams is immediately eligible and has five years to play four at NU.

Also at safety redshirt freshman **Drake Martinez** (6-2/195) has chosen to transfer from Nebraska. Injuries derailed his spring and he fell behind other young safeties like **Nathan Gerry, Leroy Alexander** and **D.J. Singleton**. The younger brother of **Taylor Martinez**, Drake Martinez's intended destination was unclear at press time.

NU continues to recruit defensive backs, looking to take one more in the 2014 class. The top two targets – **Hunter Dale** (5-10/191) of River Ridge, La. and **Will Sunderland** (6-2/186) of Midwest City, Okla. – will both be on campus for Big Red Weekend June 14.

Sunderland is a consensus four-star prospect who lists NU, Ohio State and Oklahoma as his top three schools. He's already visited OU and will be at OSU later this summer. A timeframe for his decision isn't set.

Dale is considering multiple schools, highlighted by Oregon, Penn State and Florida. He plans to visit UCLA, Ole Miss, Miami and Tennessee this summer as well. Former Huskers **Walker Ashburn** and **PJ Smith** both attended Dale's high school and he's also close with 2014 signees **Glenn Irons** and **Jaevon Walton** as well as 2015 commit **Kendall Bussey**. In fact, Dale and his mother will be traveling with Bussey to Big Red Weekend June 14.

### **Receiver Happenings**

During the 2014 recruiting cycle Rivals' No. 6-ranked receiver, **Damore'ea Stringfellow** (6-3/225) of Moreno Valley, Calif., chose Washington over Nebraska. After a true freshman season that saw him catch 20 passes for 259 yards and one touchdown, Stringfellow was suspended indefinitely by new coach **Chris Petersen** after an alleged assault near the University of Washington campus.

Stringfellow pleaded guilty to two counts of fourth-degree assault, then asked for and received his release from the Husky program. His first call was to NU receivers coach **Rich Fisher**, and after a University investigation the Huskers accepted his transfer. Stringfellow will likely sit out the 2014 season as a redshirt and begin his Husker career in 2015.

Stringfellow's addition helps offset the loss of 2014 signee **Monte Harrison** (6-3/200) of Lee's Summit, Mo. who was chosen No. 50 overall by the Milwaukee Brewers in the Major League Baseball draft. Mock drafts had listed Harrison as high as No. 17, and he was invited to attend the draft in person. He was the final player invited to the draft to be chosen, so his expectations were obviously higher.

Milwaukee's draft pool of \$7,605,600 covers their top 10 rounds and any bonus money in excess of \$100,000 given to players taken in rounds 11-40. The slotted money for the No. 50 pick is \$1.1 million. That seems like a lot of money, however the Brewers also made two first-round picks before Harrison.

Harrison's camp made an initial offer of \$1.8 million, and apparently that was all Milwaukee needed to hear as they immediately agreed to terms. Even with the addition of Stringfellow, the loss of Harrison and decommit of Tears means NU will likely look for two receivers in the 2015

### Big Red Weekends

With the big start NU has on the 2015 class and the limited numbers they'll be able to sign, Big Red Weekends (June 7 and June 14) have more of a 2016 flair to it.

The June 7 list included Clester Johnson, Jr., 2015 receiver **Charles Fessler** (6-4/195) of Erie, Pa. and defensive end **Christian Rector** (6-4/240) of Los Angeles, Calif. as well as 2016 defensive back **Brittain Brown** (6-0/185) of Canton, Ga., running back **Devin White** (6-0/230) of Springhill, La. and defensive end **Noah Fant** (6-4/210) of Omaha South.

June 14 will have the aforementioned Dale and Sunderland, as well as Rivals top 100 receiver **DaMarkus Lodge** (6-2/187) of Cedar Hill, Texas and his teammates linebacker **Richard Moore** (6-3/195) and quarterback **Justin McMillan** (6-1/177). 2016 offered linemen **John Raridon** (6-3/290) of West Des Moines, Iowa and **Matt Farniok** (6-5/310) of Sioux Falls, SD will also be in town.

The best commitment chances seem to be Fessler, Raridon, and Farniok. There's also an outside shot at Dale due to his mother visiting with him and Bussey, Irons and Walton all being on campus as well.



\* Trust is sometimes hard to come by but make every attempt. The sooner you learn to trust her and she trust you, the better the relationship will be.


