Tenley Ann Babb, daughter of Sheena Heineman and Jacob Babb suffers from Angelman Syndrome. This year’s 8th Annual Chasin’ Dreams Benefit will help cover her medical bills.

The eighth annual ‘Chasin’ Dreams Benefit Ride will be held for two-year-old Tenley Babb, who suffers from Angelman Syndrome and requires weekly speech and physical therapy sessions in Omaha.


Looking at Tenley, daughter of Sheena Heineman and Jacob Babb, you would never know that she suffers from the mysterious and often misunderstood syndrome. She has a smile that both lights up the

room and reveals a genetic condition that will affect her for the rest of her life.

Angelman syndrome, first described as a unique syndrome in 1965, is a neuro-genetic disorder caused by a small deletion of the 15th chromosome. The exact incidence of AS is unknown but is often misdiagnosed as Autism in several cases. The most typical age of diag-

nosis is between two and five years of age when the developmental delays are most visible. Nearly all children with AS have a developmental delay; functionally severe. Movement or balance disorder, behavioral uniqueness including frequent laughter and smiling with a happy demeanor and hand-flapping or waving movements and speech



City Council votes to bring Disc Golf to Falls City

Logan and Marc Merz on behalf of the TSMF Foundation stood before the Falls City, City Council last week to request approval for installing a new Disc Golf Course at Stanton Lake. The proposed 18 hole golf course at Stanton Lake is shooting to be the best Disc Golf course in Southeast Nebraska.

Disc golf is played like traditional golf but instead of using clubs and balls, players use a disc or Frisbee. The sport was formed in the 1970’s but

has recently exploded in popularity in the last few years. In recent years, Auburn has put in a course as well as Peru, Sabetha, Horton, Mahoney State Park and Beatrice. Indian Cave is currently in the processes of adding a course as well.

“It’s a low-impact sport, low impact on the environment and low impact as in the elderly can play it. It’s not hard, just a lot of walking. Good for exercise, promoting well being and wellness in the community,” said Logan Merz.

Could they get elected again?

After my column appeared about Governor Ricketts trying to get his Republican legislative ducks in a row by calling out the names of the ones who didn't support him on all of his initiatives, a friend told me it was the senators' fault.

He went so far as to say there were a couple of term-limited senators from his neck of the woods who likely couldn't get re-elected if they could run because the people are so upset with them. The constituents are disillusioned because they don't feel they are being represented by the people they elected, he said.

OK. I get that. It happens every year and this year was no different. It has been happening for years. There have always been a small group of party loyalists who have waited for the governor's direction before taking a stand. This is not unique to the Ricketts' administration and goes back decades.

Nebraska's constitution clearly calls for a separation of powers among the executive, legislative and judicial branches of government. More importantly, it calls for a non-partisan legislature. Yes, leave your party affiliation at the door, please and thank you, and vote for what you feel is the best thing for your constituents. Sounds simple enough. So what's gone wrong?

pol-i-tics: noun "the activities associated with the governance of a country or other area, especially the debate or conflict among individuals or parties having or hoping to achieve power." Power. When you voted for the person to represent you, did you think you were giving that person power to do much else than represent you? Did you ever think that your vote would represent an anointing of that person to rise to bigger and better things (read that higher office) on the backs of you and your fellow constituents?

Or did you vote for the person because you heard them say something that sounded like something you might say? Did you give them the opportunity to be away from friends and family for a whopping \$12,000 a year so they could be your voice in the greater realm of government? I once had a rancher in southwest Nebraska tell me they voted for a longtime incumbent just to get him out of town.

Through the years I have had a number of state senators tell me that they headed to Lincoln with an agenda and the best intentions of their constituents in mind. They had high hopes that their best ideas would see the light of day and possibly become law.

Then they ran into politics and realized they first had to convince

48 colleagues and a governor before they could see the dream fulfilled. I never knew a state senator who finished the first few weeks in office with an assurance that things were going to go his or her way. Only the ignorant or the arrogant would see it otherwise.

Perhaps the biggest thing a senator has to get used to is the small role they each play in the ongoing daily grind of government. They are, at the end of the day, one green or red light on the unicameral tote

board. That's not insignificant, but it does put things in perspective. Each snowflake is unique, but enough of them clumped together can close a road.

Each senator has a stand on an issue and a vote. If someone is manipulating that vote, they have surrendered their individual convictions and their commitment to their constituents.


Not voting the way of the governor is not a bad thing and it certainly isn't worth a public chastisement. Remember, the Nebraska Unicameral is a non-partisan legislative body. There is a reason it has worked that way for years and there is a reason it must remain that way.



50 Years Ago
(June 14-20, 1966)

A severe hail-storm swept through Richardson County leaving many fields in the area nearly bare. The golf ball sized hail and two inches of rain swept through the area in a less than 20 minutes.

For the second year running, M.O. Armbruster and Armbruster Motor Co. received the quality dealer award from Chrysler Motors Corporation.

Falls City residents had quite the shock when they were awakened by the Civil Defense warning system. A long, continuous blast was a malfunction in the system. Adding to the confusion, several occupants of a car were riding through the city shouting: “Omaha’s been bombed, go to your basement!”

General business activity in Falls City during April was 4.4 percent better than it was the year prior.

County Agent Tom Aitken advised farmers to go take a trip for two weeks. When they come back, their hail damaged corn may not look nearly so bad. He told farmers that the corn may survive the hail damage.

The average woman spent five to six years of her life doing dishes but that time could be cut in half with a new product called a dishwasher. With a dishwasher, only 35 minutes were needed for clean-up.

The *Journal* took an ad from a couple of night crawler salesmen. Mr. Glenn Cudney and Mr. Kevin Davis slashed prices on their night crawlers from 50 cents a dozen to 20 cents.

Bedbugs were drafted and put into service in Vietnam. Servicemen wore the bugs in a canister around their necks. When the bugs stirred and got excited they were detecting the fresh scent of humans from distances up to 100 yards.

Armbruster Motor Company celebrated 15 years in business in Falls City. To celebrate the business offered free coffee and gave away 14 free Polaroid camera’s to a lucky few.

Mr. and Mrs. Charles Kirkendall Jr. lined up their eight children in their field in the North fork bottom to show the amazing difference it made



when he planted 30-inch rows instead of 42-inch rows of corn. Pictured above **L-R: Mrs. Kirkendall and Rodney, Mr. Kirkendall and Mike, Jimmy, Richard, Pamela, Leroy, Kenny and Dennis, who is nearly hidden in the corn)**

Three Falls City youths left Omaha by air for San Diego, CA , where they began recruit training in the U.S. Navy. They were John C. Weaver, Michael K. Morgan and Ronald O. Johnson.

25 years ago

Dr. Terry Malcolm joined the staff of the Midlands Dental Center in Falls City and Sabetha. His area of special interest were orthodontics, fixed prosthodontics and forensic dentistry.

Charlie Ebel and his son, Brad, were combining wheat for the earliest start on the harvest Charlie could remember.

The home of Jack and Carmen Miller, about nine miles northeast of Falls City was hit by a tornadic-like wind. Several trees were blown down, windows in the home were blown out and power was knocked out.

Jospeh Heim of Dawson gave his seventh gallon of blood at the Red Cross Bloodmobile.

Bart Keller, a 1991 graduate of Sacred Heart, accepted a check for \$250, from the Falls City Area Jaycees. The check represented the first academic and community involvement scholarship given by the Jaycees.

Eric Willman and Eric Nelson were named co-winners of the Dick J. Prosser Memorial Engineering Scholarship worth \$1,000.

Video One! in Falls City was advertising a 1-day rental on Nintendo’s for only \$1.00.

The *Journal* received notice that the Union Pacific Railroad Company filed an application to discontinue its crew-changing operation in Falls City. At the time, it was estimated that 65 train service positions would be involved.

15 years ago

Five area teens were injured in a crash south of Falls City when a blown rear tire sent the southbound car careening off Highway 73.

Brad C, McCoy graduated from the United States Military Academy at West Point, NY with a bachelor degree in engineering and a commission as a second lieutenant in the Army.

Creighton University awarded David L. Jones a doctor of dental surgery degree during its spring commencement ceremony.

An 1880’s barn on the Stalder Cattle Co. farm, southwest of Salem, was named a Recognition Award winner in the national Barn again competition along with four other barns across the nation.

impairment. In numerous cases, there is a delayed, disproportionate growth in head circumference and seizures. Other symptoms associated with AS is a protruding tongue, tongue thrusting, swallowing disorders, wide mouth with wide spaced teeth hypopigmented skin, hair and eye color; increased sensitivity to heat abnormal sleep-wake cycles and fascination with water and crinkly items.

Tenley was between six and nine months old when her family noticed she wasn’t meeting her developmental milestones. They started physical therapy in March of 2015 when Tenley was ten months old. Over time therapy helped and Tenley began to crawl days after her first birthday, but progression was very slow.

In November 2015, Tenley was taken to a pediatrician in Omaha who noticed after the first visit that she exhibited signs of Angelman Syndrome. A genetic test was ordered and after a long two weeks, her mom received the call that it was, in fact, Angelman Syndrome. Tenley exhibits the most typical symptoms including happiness, smiling, laughing, arms flapping, developmental delay, speech impairments, jerky movements and nystagmus in her eyes. Luckily at this time, Tenley has not suffered from seizures.

In recent weeks, you may have noticed the purple and teal ‘Team Tenley’ shirts around Richardson County. When Heineman made the shirts to participate in an Angelman Syndrome Foundation walk, others around the community wanted to show their support as well. Over 300 shirts were sold, not for profit but to just to show community-wide support for the beautiful little girl who has captivated so many. Heineman is hoping to bring awareness to such a rare syndrome that most people haven’t even heard of and give them a better understanding of those living with AS.

On May 21, people around the community and Tenley’s family and friends proudly wore their ‘Team Tenley’ shirts in support of their girl and to participate in the Angelman Syndrome Foundation walk. The walk, held in Olathe, KS gave Tenley’s family a chance to raise money for the Foundation and meet with other parents who have an ‘Angel Baby.’



‘Everyone was very kind, and it was nice to be able to relate to others,’ said Heineman.

The large group of Tenley supporters left their mark during the walk raising over \$820.00 for AS research, the second most of any team entered.

Life has changed for Tenley and her family. The road will be long and sometimes difficult but they have an incredible support system and know that Tenley brings joy to anyone she’s around.

“Tenley’s blessing. She not only brightens our lives everyday with her smile but she always puts a smile on everyone’s face. Doesn’t matter where you are with her, someone always makes a comment about her smile, it’s so contagious. There’s never a dull moment with her and she’s always teaching us something new. There are challenges we face but everyday is a new day. We are learning new ways of communication and what her gestures mean. Hope Never Ends,” said Heineman.

The ‘Chasin’ Dreams Benefit Ride is set for Saturday, June 18, at Wild Bill’s, Hwy 159 and Main in Rulo. Registration is at 11:00 a.m. and take off is at noon. The last card drawn will be at 4 p.m.

Riders will leave Wild Bill’s Bar & Grill for The Would Eye in Falls City, then ride to Red’s in Hiawatha, Swing’n Doors in Rulo, then back to Wild Bill’s. All will depart and ride as a group. Fees are \$20 for the pilot, \$15 for the co-pilot and \$5 for a second hand.

After the ride, a free-will donation will be accepted for a meal at Wild Bill’s. Door prizes will be available, and an auction is planned. There will be live music featuring Scott Lane and Justin before and after the auction until midnight. Money raised will go toward Tenley’s medical bills.

Sheriff Pounds requests termination of current 911 agreement with City

Richardson County Sheriff Don Pounds told the County Commissioners last week that he believes the county is capable of handling the 911 dispatching for all of Richardson County.

The request comes several months after Sheriff Pounds had recommended moving the Public Service Answering Point to the under construction Jail and Law Enforcement Center west of Falls City. In doing so Sheriff Pounds asked to combine services for the Sheriff's Office and Police Department in an effort to save money. Richardson County has paid the City half the costs for services due to the City handling the 911 services for the entire County. This cost is upwards of \$130,000 per year. The county is currently upgrading the 911 system to Next Generation 911. Next Generation 911 will enhance the 911 system to create a faster, more flexible, and resilient system that allows 911 to keep up with changing technology.

Sheriff Pounds requested the County Commission discuss terminating their agreement with the City for the 911 dispatching services and use the money to offset the added personnel costs required at the new Jail and Law Enforcement Center. The new facility is scheduled to open in August.



Protect yourself and your loved ones from mosquito and tick bites that cause disease

As people begin to spend more time in the outdoors, the Southeast District Health Department wants to remind you to take precautions to prevent diseases that are transmitted by mosquitoes and ticks.

Mosquito bites can be more than just itchy and annoying. They can cause you to get sick. The most effective way to avoid West Nile virus disease is to prevent mosquito bites. There is no evidence that people can get West Nile virus from infected animals or people, or that people can transmit the West Nile virus to other animals, birds, or people. People over 50 years of age have the highest risk of developing a severe illness because as we age, our bodies have a harder time fighting off disease. People with compromised immune systems are also at increased risk, however, anyone can get the virus. People with mild infections may experience fever, headache, body aches, skin rash and swollen lymph glands. People with more severe infections may experience high fever, headache, neck stiffness, stupor, disorientation, coma, tremors, occasional convulsions and paralysis. If you have any of these symptoms, contact your doctor. Be aware of the West Nile virus activity in your area and take action to protect yourself and your family.

Tips to protect yourself and your loved ones from mosquito bites that cause West Nile virus:

Use insect repellent with DEET. Always follow product instructions. Parents should apply this product to their children, avoiding hands, eyes, and mouth. Do not use insect repellents with DEET on children younger than 2 months. Do not use repellents containing more than 10% DEET on children younger than 2 years.

Cover your skin as completely as possible when outside when mosquitoes are present and active. Wear long sleeves, pants and socks.

Make sure there are screens in your home's windows and doors. Make sure the screens are free of rips, tears and holes.

Eliminate all standing water in yards and around your home and

property where mosquitoes can breed, including: plastic containers, pool covers, wading pools, ceramic pots, clogged drainpipes, and wheelbarrows. Also change water in bird baths twice a week.

While it is a good idea to take preventive measures against ticks year-round, be extra vigilant in warmer months (April-September) when ticks are most active. Ticks can transmit a variety of diseases including Rocky Mountain Spotted Fever and Lyme disease. These can affect people of any age. Typical symptoms include: fever, headache, abdominal pain, vomiting, and muscle pain. A rash may also develop, but is often absent in the first few days, and in some patients, never develops. Rocky Mountain spotted fever can be a severe or even fatal illness if not treated in the first few days of symptoms.

While it is a good idea to take preventive measures against ticks year-round, be extra vigilant in warmer months (April-September) when ticks are most active.

Tips to protect yourself and your loved ones from ticks:

Use repellents that contain 20-30% DEET on exposed skin and clothing for protection that lasts up to several hours. Always follow product instructions. Parents should apply this product to their children, avoiding hands, eyes, and mouth. Do not use insect repellents with DEET on children younger than 2 months. Do not use repellents containing more than 10% DEET on children younger than 2 years.

Use products that contain permethrin on clothing. Treat clothing and gear, such as boots, pants, socks and tents with products containing 0.5% permethrin. It remains protective through several washings. Pre-treated clothing is available and may be protective longer.

Be sure to check for ticks after coming indoors or coming from tick infested areas. Parents should check their children for ticks under the arms, in and around the ears, inside the belly button, behind the knees, between the legs, around the waist, and especially in their hair. Examine gear and pets. Ticks can

ride into the home on clothing and pets, then attach to a person later, so carefully examine pets, coats, and day packs.

Deadly two days brings renewed call for travel safety

A deadly two day period on Nebraska roadways has the Nebraska State Patrol, Nebraska Department of Roads, and their safety partners urging motorists and pedestrians to do their part to reduce serious injury and fatality crashes through voluntary compliance with all traffic safety laws.

Ten people were killed in six separate crashes from Wednesday, June 8, through Thursday June 9. The crashes occurred in Adams, Dakota, Kearney, Lincoln, Merrick and Platte Counties.

Of the 10 motor vehicle occupants killed two were wearing seat belts. Six were not wearing seat belts and restraint use is unknown for two of the fatalities.

"While the circumstances of each crash are unique, one common denominator is the failure to buckle up," said Field Services Major Mike Gaudreault. "Wearing a seat belt correctly increases your odds of surviving a crash by up to 50%. We encourage all motorists to put the odds in their favor and wear their seat belt every trip, every time."

To-date in 2016, 85 people have died on Nebraska roadways compared with 105 people on this date a year ago. Of the 85 fatalities in 2016, 67 have been passenger vehicle occupants, with 49 (73%) unbelted.

Captain Gaudreault said, "During the summer months we typically see increased traffic including more pedestrians and cyclist on our roadways. By watching out for each other, and complying with all traffic safety laws we can all help keep our roadways safe."

City Council votes to bring Disc Golf to FC

With a course in Falls City being PDGA (Professional Disc Golf Association) approved, it would be featured on PDGA websites bringing people from all over the country to Falls City. Disc Golf supplies will be stocked in Falls City businesses to bring commerce to the area.

“I played in a tournament last weekend in Lincoln, and there were people from over eight hours away; from Kansas, and out west of Kearney. If we host a tournament and get the proper channels on the PDGA website, people will come from eight to ten hours away to play tournaments if the course is good and I’m a firm believer that this course is very good,” said Logan.

There are only a couple courses near Falls City with an 18 hole course, but Logan wants to step it up a notch and add features such as a water hole, which few courses have. The water hole feature raised questions with the Council, who asked what would happen with discs that go into the lake. According to Merz, floating discs are an option, and there are special utensils made to retrieve the discs but for those who are new to the sport or don’t think they could clear the lake, there will be an alternate route that doesn’t require you to throw the disk over water.

The course is also designed by Logan Merz to leave zero maintenance to the city. There will be no weed eating around the holes and no cost to the city at all. Everything will be funded by the Tanner Shelby Merz Foundation and the hole sponsors.

“I don’t like to do anything halfway. It’s all or nothing for us,” said Marc Merz. “We want to have tournaments and for the tournaments, the money used goes back into the town. It’s an up, and coming thing and people are loving it. We need to get on the bandwagon.”

Before the final vote Council President, Judy Murphy questioned the liability to the city since the course is on city property. Marc Merz explained that there would be little to no liability.

“What liability would we ensure that isn’t already there? It isn’t any different than somebody walking through the grass. The pins aren’t hazards; they aren’t sharp,” said Merz adding “We’re ready to go tomorrow. You give us the green light, and we’re ready to go.”

The Council voted unanimously to approve the project.
