OIL, THAT IS

Local farmer Alvin Simon has made an interesting discovery west of Falls City: An oily substance seeping out of the banks of a creek on his farmland.

Simon, who says he has known about it for decades, has decided to

This spring, as Richardson County has experienced heavy rains, the oil started showing up all over the place. Bill Sydow, executive director of the Nebraska Oil and Gas Conservation Commission, told the *Lincoln Journal Star*, "It's possible

there's an oil field down there and

for whatever reason it's just leaking, or its been leaking for a long time and nobody's ever noticed."


Sydow admitted that heavy rains could have played a role in the appearance of oil, saying that runoff traveling toward the water table would displace any crude creeping up. There are records of dry holes near Simon's land but no history of any drilling. Sydow said the oil isn't a remnant of past production and are no pipelines in that specific area that could have broken.

In 1994, Simon had his land tested by Orion Geophysical Consulting of Lakewood, CO. He was told there weren't high enough

> levels of petroleum to warrant further investigation. But, Orion said that didn't mean there wasn't a possibility of oil and gas pools in deep formations.

The same year, Interstate Land Co., of Topeka, KS advised Simon that the possibility of conducting any further testing required Simon wait until all crops are out, and the ground is frozen, as to eliminate the possibility of property and crop damage. Midwest Laboratories, Inc., of Omaha, reported that the Total Extractable Hydrocarbons were high but stated it was a "man"

Some \$17,000 in cash, prizes

The second annual "Sauce and Cycles" BBQ and motorcycle rally, scheduled for July 10-11, will be twice as spicy, Chamber/Main Street Executive Director David Branch boldly predicts.

Even though the inaugural "Sauce/Cycles" was by most accounts a smashing success, with BBQ professionals coming from as far away as Louisiana, the sequel is expected to be bigger, because more money is up for grabs.

Branch said the event needed some time to get traction and now it's ready to burn rubber.

Whereas last year's cycle winners received a \$100 gift certificate from Holstein's Harley-Davidson, of Omaha, this year two \$500 gift certificates, as well as custommade trophies, are on the line, and the next eight places walk away with \$250 certificates.

Likewise, whereas a year ago Branch said "60 or 70" volunteers were needed, this go around it'll take closer to 200 to get the many jobs done because of the anticipated surge in attendance. Branch estimated 2,500 people passed through


fuss--budget in hot pursuit?

Eastbound and down, loaded up and truckin'

Jim Jones has spent a considerable chunk of the past 35 years atop 18 wheels, zig zagging back and forth an astonishing four and a half *million* miles over the blacktop road that connects each of 48 United States.

No matter how you slice 4^{1/2} million miles — it's the equivalent of 820 *round* trips between New York to Los Angeles, 18 perfect circles around the world or nine quick getaways *to the moon* — it's an extensive amount of windshield time! A lifetime's worth, really.

So it's time for this journey to end and, in a way. Though he'll be 66 in September, he isn't retiring. About the same time the dog days of summer morph into football season, Jones will kill the engine and climb down from his cab one last time. But only to jump with both feet into he and his wife Shirley's successful tool-rental company, Pony Creek Rentals. The business hosted a 10th anniversary celebration this spring, but in a way it felt like a grand opening, as Jones talked about finally being on site throughout the week, as opposed to popping in and out every weekend.

The Falls City High and University of Nebraska graduate long ago, during one of those lengthy face-to-face confrontations with the windshield, entertained the idea of changing occupations.

"I was driving through all these small towns throughout the country and I said to myself that 'they

all have a rental place, Falls City should have something like that - maybe that's something we could do. Maybe someday I could get out of this seat and do something else," he said with a laugh.

That was 2003 and the fact of the matter was that Jim Jones was incredibly lucky to still be driving; still, in 2015, he's incredibly lucky he got out of that seat alive, let alone of his own accord. Free will was nearly extracted from the equation in 1997 on a cold November night on a dark highway south of Chicago.

Jones was cutting through the brisk Lake Michigan wind with a 50,000-pound haul doing 60 miles per hour. In an instant, Jones realized the semi in front of him was at a complete stop in the highway, though no brake lights were illuminated to confirm for his eyes what his brain screamed in fear.

"I hit left real hard," he said. Of course mass times velocity equals momentum and Jones'





There Something Wrong With This Picture?

The state treasurer, a state senator from Omaha and a senior adviser to the governor walk into the Nebraska Secretary of State's office.

It's not the set-up for a joke. There is nothing mildly amusing about it. In fact, it's a matter of life and death.

Treasurer Don Stenburg, state Senator Beau McCoy and privately paid adviser Jessica Moenning are doing the bidding of Governor Pete Rick-

etts, whose attempt to keep the death penalty on the books was thwarted by a legislative veto override dur-

ing the waning days of the recently completed session. McCoy and Stenberg are the co-chairs of Nebraskans for the Death Penalty and Moenning – who is paid an undisclosed amount by Ricketts - will be the campaign coordinator of the attempt to put the death penalty question on the ballot.

Stenberg was the Attorney General during the only three executions since 1959 when mass murderer Charles Starkweather died in the electric chair at the Nebraska State Penitentiary. The state killed Wili Otey in September 1994, John Joubert in July 1996 and Robert E. Williams in December 1997. They were the first executions since 1976 when the U.S. Supreme Court reinstated the death penalty.

There hasn't been an execution since. There are currently 10 men on death row.

The group formed less than a week after lawmakers voted to override Gov. Pete Ricketts' veto of a bill (LB268) to abolish the death penalty. Ricketts endorsed the campaign on June 2. His senior adviser, Jessica Moenning, will serve as the referendum effort's campaign coordinator. Moenning has managed

Ricketts campaigns since 2006. Moenning, first appointed several months ago by Ricketts, is officially a privately paid senior adviser. That arrangement has prompted questions about a private employee, paid out of the governor's own pocket, being involved in public policies. To whom is such an employee accountable? Ricketts says she is accountable to him and he is

accountable to the voters. It's called political patronage and is legally defined as the practice or custom observed by a political official of filling government positions with qualified employees of his or her own choosing. It's been done before. Governor Ben Nelson hired campaign director Sunny Foster to head the Department of Administrative Services. Governor Mike Johanns hired his neighbor and good friend Lori McClurg to head DAS. Governor Dave Heineman hired campaign manager Carlos Castillo to head DAS. But those people have all been public employees, paid for by public funds.

Ricketts said Moenning's position fits with his pledge to run state government differently. Keeping her on his private payroll, rather than the state's, will allow her to better focus on long-term strategies and setting up advisory committees to provide broader input on policy decisions.

Well, excuse me Governor. Does that mean that Nebraskans for the Death Penalty is an advisory committee and that allowing the state to execute the men on death row is a long-term strategy? Forgive me, I thought it was all just a knee-jerk response to the Legislature voting to override your vetoes of the death penalty measure and two others.

I must admit that your comment that you need someone like Moenning who can really be divorced "from the day-to-day ... and not get caught up in the urgent things that happen every day"

> really has me confused given the urgency that you have portrayed in needing to

get enough signatures quickly to allow you to execute people before the public has a chance to vote on

Silly me, I would have thought that addressing the crying needs in the Corrections System in the aftermath of a bloody Mother's Day riot that left two dead in Tecumseh would be more of a long-term strategy issue. To say nothing of the new round of appeals that will be filed on behalf of the death row inmates in an effort to further derail your blood lust.

And, while we're at it, surely state Treasurer Stenberg has some fiscal things to deal with and Senator McCoy has more pressing constituent issues to address.

18-wheeler loaded with 50,000 pounds of steel wasn't going to turn on a dime regardless of how hard he hit it.

"I think he must have fallen asleep - he didn't hit the brakes but all I know is that when I got stopped, I could reach out the windshield and touch his semi."

Jones had his seat belt on, but his foot was pinned inside the wreckage of twisted steel. It was close to midnight and he remained in that position, with every bone in his foot broken - "some two or three times " - until after 3 a.m. Emergency responders were quickly on the scene, armed with pain relief and cutting-edge "jaws of life" type construction equipment. Unfortunately, the equipment was so "state of the art" nobody knew how to operate it.

Though a doctor on the scene was adamant the foot should be amputated, rescue workers eventually cut Jones free from his rig, with both his feet attached, and loaded him in the nearby helicopter for a flight to Loyola University Medical Center.

Thanks to modern medicine, patience and a blessing or several, the decades-long (and running) Sunday School teacher at the First Christian Church was back behind the wheel within nine months. Soon, the wheels were turning in Jim's head, too, particularly when he'd drive past a tool rental place in some dinky run f 2002.

In the fall of 2002, another somewhat mystical "nudge" that helped Pony Creek Rentals exist came in the form of fire, when the Jones' barn burned to the ground.

Obviously, it had to be replaced, so Jim essentially got a license to build what every meat-eating male deep down wants most — civilization's biggest garage ever. Maybe not, but at 3,600 square feet, it's large.

"I had to have it big enough for the truck," Jim said.

With help from friends, as well as his son, Dan, Jim started building the garage that might eventually free him from life over the road.

"Jim never wrote down a single plan - he's a mathematician or something," Shirley said. "He can pull those figures and numbers from his head when the rest of us need to grab a calculator."

It's true. While returning to Falls City each Friday, Jim would figure out how much wood he'd need for the project, call Larry Shubert at Home Lumber and it would be waiting for him when he rolled into 703 Loop, one mile south of Falls City.

As soon as the barn became realty, so did Pony Creek Rentals.

"We really weren't thinking about it when we built it, but we bought a skid loader and a jackhammer, an excavator and started taking appointments with people at noon and 5 p.m., because I was still working," Shirley said.

"When we first started, we didn't have much traffic, but we kept adding each year and it's constant now," Jim said.

The above-mentioned skid loader has 3,200 hours of operation on it, but it's not the Jones' only one anymore. They rent nearly every tool you can imagine, from tractors to trailers, to generators and hammers, tillers and staplers, to compressors and a wheelbarrow.

Jim also hauls about 150 tons of Colorado river rock to his place each year. Most of it is currently landscaping much of Falls City.

Soon, he'll climb out of that rig - and get to work.

"We'll see if we can't make this

thing go," he said.

Trust me, Pony Creek Rentals will go just fine — because what's an extra mile to a guy with 4^{1/2} million on his odometer?



during the day Saturday and 700 purchased wristbands for the evening's entertainment. As was the case in 2014, the "High Heel Band" will both perform Saturday night, from 7-11 p.m.

The Kansas City BBQ Society Sanctioned Contest will be staged with \$1,850 going to the Grand Champion, \$950 to the Reserve Champion, and \$500 to the Second Reserve Champion. In the four individual categories (ribs, pork butt, brisket and chicken), \$500 will be awarded for first, \$400 for second, and so on, with \$50 going to 8th, 9th and 10th place finishers. That's a total of \$10,500 in prize money.

Last year's Grand Champ, Iowa's "Smokey D's," which had previously been featured on TLC's hit show "Pit Masters," will not return to FC this summer, Branch said, so someone else is assured of walking away with the big money.

For the Backyard Grillers, \$500 is on the line for the Grand Champion and \$250 for Reserve Champ. Six places will be paid in both "ribs" and "pork butt" categories, starting at \$400 for first, then \$300 for second and so on, to \$50 for sixth place, for a total of \$3,000 in prize money.

The locals also proved to be heavy hitters in both categories a year ago, with Matt and Danelle Cromer, of "Crome's Smoke," upsetting "Smokey D's" for second place in the professional "brisket" category. Jason Mackey's "Sun-Mart" team also finished in the money in the sanctioned contest, placing sixth in both "brisket" and "ribs."

Locals who dominated the Backyard Grillers Division included Allen Phroper of "Big Al's BBQ," Mitch and Julie Sailors and Brandon Liberty's "Limp Brisket," Jeff Fankhauser's "Up in Smoke," Mackey and Falls City native Todd Finner.

Check-in for cookers and People's Choice rib pick-up will be from 10 a.m. to 5 p.m. Friday, followed by a Sanctioned Cookers Meeting at 5 and a Backyard Grillers Meeting at 6. People's Choice Turn-in runs from 7:05-7:20, with People's Choice Voting from 7:30-8:30. At 9:30 - or when it's dark - a movie will be featured.

In other news:

— Transportation Supervisor Rob Baker reported total mileage for the 2014-15 school year was 184,389 miles and 21,564 gallons of fuel were used. Both the mileage and fuel consumption was lower than the previous school year, primarily due to more home activities. The district will be purchasing two passenger vans during the 2015-16 school year as per the vehicle replacement schedule.

— The board considered and discussed a resolution to authorize the issuance of not to exceed \$895,000 of General Obligation Refunding Bonds, Series 2015 for the purpose of refunding the Series 2010 Bonds in order to achieve interest cost savings and to cover all costs of issuance

— Improvements are underway in the FCHS parking lot, including the concrete expansion in the north lot area and the chip/seal of the asphalt section of the lot. Furthermore, various sidewalk sections at North, South and the high school will be addressed by replacement.

The summer roofing plan is updated and the work timetable is being put together by Tremco.

— AdvancED External Visit: Oct. 4-6, 2015 will be the dates of the AdvancED External Team Visit. We have been notified Mike Griffin from South Carolina will be the Lead Evaluator on the team. We will have a five-person team in Falls City. Two out of state members and three in state members, are yet to be assigned.

— Staffing Update: for the 2015-16 school year includes the following positions:

1) Early Childhood Teacher

(Sixpence Grant awarded June 5-accepting applications); 2) Title 1 Teacher-.25 FTE - Jenny Bauman offered contract; 3) High School Office Asst. (TBD); 4) High School SPED Paraeducator – Lyle Wissman; 5) Elementary SPED Para – Karrie Bauman; 6) Elementary SPED Paraeducator - .75 FTE – Jenny Bauman.

- The USDA Fresh Fruit and Vegetable Grant provides \$11,000 to North, \$8,000 to South, and \$8,000 to the Middle School. Funding through the Fresh Fruit and Vegetable Program will help increase fresh fruit and vegetable consumption at the elementary and middle school. The program is designed to help combat childhood obesity by teaching children the importance of developing healthy eating habits. The FFVP expands the variety of fruits and vegetables children experience and hopefully increases their fruit and vegetable consumption.

National School Lunch Program Equipment Assistance Grant of \$7,315 provides funding to purchase new and/or update school meal program equipment. The funds will allow District 56 to purchase two, new ovens for the FCMS kitchen. The ovens currently being used are 38 years old.

The USDA continues to implement the Healthy, Hunger Free Kids Act, requiring school meal programs to serve more fresh fruits, vegetables and whole grains. The school meal program experienced a 7% increase in food costs over the 2013-14 school year. In order to keep our school meal prices in line with Federal paid lunch equity requirements and the increase in food prices, a small increase will be recommended to help offset some of the additional cost. The meal price proposal will be reviewed for approval at the July board meeting.

— Substitute Teacher Rate: The current daily rate for a substitute teacher in District 56 is \$110, which is comparable with neighboring districts and has assisted in attracting qualified substitute teachers. No rate change is recommended.





Jury finds Craig (MO) man, 48, 'not guilty' of attempted murder of girlfriend's estranged husband

A 48-year-old Craig, MO, man accused of shooting a handgun at his then-girlfriend's estranged husband during a domestic disturbance last fall in Dawson was found not guilty of attempted murder in the second degree by a jury last Tuesday in District Court.

After the jury deliberated for some four hours, Joseph D. Senn Jr. was also found not guilty of two other felony charges: using a firearm to commit a felony and terroristic threats. The jury did find him guilty of carrying a concealed weapon, a misdemeanor. He will be sentenced Aug. 11.

Senn Jr. and 43-year old Natalie Auxier were arrested in a Uhaul truck on Oct. 4 by then-Richardson County Sheriff Randy Houser and Deputy Jeff Frederick along Highway 73 north of Falls City after the officers were dispatched to the residence of Buckley Auxier in rural Dawson. According to the arrest affidavits, Mr. Auxier called to report that Senn had fired a handgun at him. Houser and Frederick were en route and met Mrs. Auxier and Senn, who was driving, in a southbound Uhaul truck on Hwy. 73 near the pumping station.

A loaded 9-mm handgun was allegedly found inside the truck, in firing position, stuffed behind the passenger seat and covered in clothing. Jail personnel said they later found an unspent bullet that matched the bullets in the magazine of the collected handgun in Mrs. Auxier's personal belongings as she was being placed in a cell. Shell casings were later found at the Auxier residence that matched Senn's 9mm.

During the trial, Senn testified that a week or so prior to the altercation, he had taken "around six shots" at a basketball with the handgun during a demonstration for two friends, who both corroborated Senn's testimony.

After reaching plea deals or dropping charges in 100 percent of its cases over a three-year period, the Richardson County Attorney's Office has failed to get convictions in the only two cases presented to juries. In December 2014, then-20-year-old Phillip Doerr, of rural Verdon, was found not guilty of two felony charges of making terroristic threats and using a firearm to commit a felony.

Senn is free on bond until the Aug. 11 sentencing date. He faces a fine and up to a year in jail.

'Hmong Textiles In America' opens at Stalder Gallery today

Hmong flower cloth (or paj ntaub) is one of the world's great textile traditions and an excellent example of cloth as community. Despite its deep roots in Hmong culture, this complex art

was not widely known outside Asia until after the Vietnam War, when Hmong refugees arrive in the United States. The works illustrate the

profound relevance of textiles as infrastructure in the Hmong culture, an art form that shifted as it adapted to fit new realities. Now visitors to Stalder Gallery, located inside the Falls City Library and Arts Center, can experience the exhibition, "Cloth as Community: Hmong Textiles in America", opening today, June 16.

The exhibition features 28 textiles-flower cloths and embroidered story clothes—by those in the Hmong community.

Cloth as Community will hang in the Stalder Gallery from June 16 through Aug. 11. The library is open from 10 a.m. to 8 p.m. Monday through Thursday, closed Fridays and open from 9 a.m. until noon on Saturdays. The Stalder Gallery is free to the public with support being given by the Richardson County Arts and Humanities Council as well at the Library and Community Foundation of Richardson

A Gallery Talk is planned for Aug. 7, with Kansas State Professor of Art Geraldine Craig, who assisted in the original text for the "Cloth as Community" exhibition and is an expert in Hmong textiles.

The story of Hmong textile production reflects the shift in the creation of textiles with traditional abstract patterns created for family and ceremonial

use to its evolution as a source of commerce and telling of a new life abroad. The works also reveal the radical upheaval Hmong refugees experienced, as many crossed the Mekong River to

Thailand. Hmong women traditionally


produced complex clothing that established clan identity through abstract geometric designs, created by embroidery, appliqué, reverse appliqué, and indigo batik. These patterns continue to influence the aesthetic choices of contemporary makers, even as those choices were mediated by refugee experience and economic concerns. Historically, textiles in village life were not sold but they held important spiritual protections. In refugee camps and beyond, the sale of textiles generated important income for families, and this creation of textiles for commerce brought on changes to this centuriesold art form. Story cloths emerged with pictorial art, sometimes sharing escape

narratives of those in refugee camps. As the memory of the Vietnam War receded and American buyers required more upbeat subjects, many of the story cloth subjects morphed into representations of a new life in America or nostalgia for the pastoral life left behind (animals in a jungle, scenes of

village life, or illustrated Hmong folk tales with English text). The works in this exhibition demonstrate a period in time when old paj ntaub influenced new designs,

often produced at a larger scale or with more space devoted to the triangular borders, and embroidered story cloths changed to fit a new market that was different from tourists or relief workers in the camps. The works show how the profound relevance of textiles as infrastructure in the Hmong social fabric has never been part of a fixed cultural tableau, even as the narrative is adapted to fit new realities.

Organized and toured by ExhibitsUSA, a national part of Mid-America Arts Alliance, the exhibition was first curated in 1999 by Carl Magnuson, a cultural anthropologist, working with a Hmong refugee community. Curatorial updates have been done by Geraldine Craig, who has published more than a hundred essays on contemporary art and Hmong textiles, in venues such as the Hmong Studies Journal, The Journal of Modern Craft, Art in America, and Surface Design Journal. Craig is currently department head of art at Kansas State University, and previously served for six years as Assistant Director for Academic Programs at Cranbrook Academy of Art. ExhibitsUSA sends more than 25 exhibitions on tour to more than 100 small- and mid-sized communities every year. Based in Kansas City, Missouri, Mid-America is the oldest nonprofit regional arts or-

made thing."

Simon thought about acting on it at the time but decided to put the land in the Conservation Reserve Program instead. The CRP is a costshare and rental payment program under the United States Department of Agriculture and is administered by the USDA Farm Service Agency. The program is designed to remove from produced 40 to 45 million acres of highly erodible cropland. Some of the benefits include lower water-treatment costs and lower sediment removal costs.

Richardson County has a long and rich history of oil production. Nebraska's first oil producing well was drilled west of Falls City. In December 1940, oil production from the southeast Nebraska area had amounted to about 75,000 barrels of oil for the month. In August production mounted to 199,000 barrels. It seemed as though the rate would climb in the future. Yet in September of 1941 showed a decline of 33,000 barrels under August. Producers were having difficulty in selling their crude oil.

Simon recently collected a sam-


ple of the oil to have it tested and is talking with oil companies inviting them to come take a look at his discovery. Simon told the Lincoln Journal Star, "I'm going to get somebody to drill and start drilling. I've got some oil people interested."

on bluff east of the mouth of the Nemaha River, southeast of Rulo. It was the first point of measurement of Nebraska and was vital to the county's settlement. Mrs. Meinzer noted that a perfect replica of the monument, built by John Seeba, Historical Society vice president, is in the adjacent Ag History build-

The birthday party's entertainer, Darrel Draper of Omaha, did just that with a great mixture of fact and humor, Dressed in early-settler's garb and with a voice putting a fog horn to shame, the reenactor took his audience on a trip of the trials and tribulations of families coming to the west from Indiana, Ohio Pennsylvania and New York to settle on that "free land" enticement, including the "garden spot" of southeast Nebraska.

TBI Awareness

Husker legend, Chiefs Hall of Famer Smith takes a swing at players' union

As Falls City Journal Editor Jason Schock wrote a week ago, "In teaming up with a local charitable juggernaut and narrowing its focus, Community Medical Center will later this month host its biggest — in a myriad of ways — charity golf tournament ever."

For the 5th annual CMC golf event, the hospital's foundation has partnered with the Tanner Shelby Merz Foundation and the twosome is fixed on a singular, stated aim: Traumatic Brain Injury Awareness. Whereas the previous four events were held for the general benefit of the CMC Foundation, this time the cause is specific, and the event is a two-day affair. A "Celebrity Gala Dinner" will be held Thursday, June 25 at the Elks Club, followed by the four-person golf scramble Friday, June 26 at the FC Golf Club. Thursday, following dinner, attendees will hear from guest speaker Dr. Arthur Maerlender, the University of Nebraska's Director of Clinical Research and Associate Director for the Center for Brain, Bi-

ology, & Behavior.

In terms of celebrity, the 2015 version of CMC's charity golf tournament looks to be different than anything Falls City has hosted in decades. Not since, perhaps, the days when "Handsome" Harley Race and "Bulldog" Bob Brown appeared on the same Prichard Auditorium wrestling card, if not longer.

Former Nebraska All-American, Kansas City Chief Hall of Famer and two-time Super Bowl Champion Neil Smith headlines a bill that includes former Huskers Johnny "The Jet" Rodgers, Tommie Frazier, Steve Taylor, Jerry Murtaugh, Lawrence Pete, Calvin Jones and others. WBO World Lightweight Champion Terence "Bud" Crawford has accepted an invitation to attend as well.

Smith, now 49, was the second player selected in the 1988 NFL draft and one of the few "home runs" the Chiefs hit that decade. KC actually traded up from No. 3 to get the defensive end, who was picked before receivers Tim Brown (Raiders, 6th), Sterling Sharpe (Packers, 7th) and Michael Irvin (Cowboys, 11th), all three now members of the Pro Football Hall of Fame. If Chiefs fans were chafed by that move, they quickly forgot all about it, as the former Husker, with linebacker Derrick Thomas, headlined one of the NFL's best defenses throughout the early- to mid-1990s. Smith's 7-foot, 1-inch wingspan eventually formed a home run swing rivaled in fame by only that of maybe George Brett at the Truman Sports Complex, and nose strips became all the fashion at Arrowhead. Smith "hit" a leaguehigh 15 "home runs" in 1993 and didn't miss a Pro Bowl from 1991 to 1995. He then went to Denver and helped the rival Broncos win back-to-back Super Bowls (XXXII and XXXIII). The New Orleans native went home after retiring, but returned to Kansas City following Hurricane Katrina and in 2006 was inducted into the Chiefs Hall of Fame.

But in 2013 Smith and nearly two dozen other former Chiefs, including Albert Lewis, filed concussion lawsuits against their former employers and last summer sued the NFL Players Association, alleging the union withheld information regarding the long-term effects of traumatic brain injuries.

Smith is a life-long loyal Husker, but his appearance in Falls City likely has everything to do with the event's affiliation with CB3 and the cause of TBI.

Last August, Smith, and several other former Chiefs — all now in their 40s — claimed the players association has for decades been aware of the evidence linking repetitive TBI to long-term neurological problems but ignored the risks to players and failed to alert players to the issue. A Missouri judge in May ruled the cases should be heard separately, which could force team officials to testify about claims they hid the risks of repeated head injuries.

Smith played 13 years in the NFL and recorded 105 sacks. He and the other players who sued, however, developed "post-concussion syndrome — e.g. mood, behavior and cognitive dysfunction — and neurological impairments/damage" between late 1987 and early 1993 when there was no NFL collective bargaining agreement in place.
