Red-Carpet Treatment

There’s no place like home. JR and Lisa Ramer know that feeling well. After being away from Falls City and his home for nearly four months JR last Wednesday returned by motorcycle escort home to Falls City after fighting his greatest battle — the battle to survive.

In 2007 Gene “JR” Ramer was diagnosed with cardio myopathy, which is heart failure that causes the heart to beat very fast. Ramer had to start driving to Creighton Medical Center in Omaha to receive care. He received a pacemaker and defibrillator that did well for a few years. The doctors soon noticed that his health was declining, so they referred him to Nebraska Medical Center in October 2012. During this time Ramer went for a two-day heart transplant evaluation and stress test, which he failed. The next day he had a heart catheterization. That day after the procedure Ramer’s doctor, Dr. Lowes, told Lisa something that no wife wants to hear. “He told us JR was too sick to go home,” Lisa recalls. For JR to survive while he waited for a new heart they would have to put in a heart pump. This mechanical pump is used to support heart function and blood flow in people who have weakened hearts. The placement was successful and JR was able to return home after three weeks in the hospital to slowly heal.

Healing from this procedure left JR waiting three months to be placed on the heart transplant list. While he wait-

ed he was attached to two batteries that connected to a line that ran through his stomach and to his heart. This device

pumped blood for his heart. At the time he was good enough to be placed on the 1B transplant list meaning his was on medication to help his heart function adequately while he waited for a donor heart. At this point though Ramer was not sick enough to be placed at the top of the list.

The pump helped him for a while but in February of this year his heart kept going out of rhythm. His defibrillator began to short out and shock him. On March 3 his doctors made the crucial decision that he needed to be hospitalized and put on a heart rhythm medication that ran through an IV to keep him from continuously being shocked.

Finally the Ramers received some hopeful news — JR would be moved to the top of the 1A list, meaning he was critically ill and desperately needed a new heart; but being moved to the top of this list would make receiving a new heart a reality sooner rather than later. The doctors told the Ramer family to be prepared for a long wait. Due to JR’s tall stature he would need

a heart that would fit a man of his size. So the Ramers did their best to get comfortable and wait. JR and Lisa’s three sons, Josh, Toby and Eli, delivered a large screen television and lots of family photos to their dad’s room. The Ramer family became quick friends with all the nurses and soon found their

At 60, Dick James hits his stride

At age 57, Dick James weighed nearly 300 pounds and was fearful that he might lose both his legs from Adult Onset Diabetes. Three years later and 125 pounds lighter, those thankful legs crossed the finish line at the Lincoln National Guard Marathon.

Dick, of rural Verdon, competed in the marathon May 4 and got third in his age group of 19 competitors.

He ran the full 26 miles in 4 hours, 8 minutes, and 32 seconds. His previous time, which he ran at age 20, was three minutes and 16 seconds more.

He trained for the race by running three- and four-mile runs, and worked his way up to eight and 10 miles. In February, he suffered a minor leg injury and wasn’t able to train for five weeks. However, he was still able to obtain third place in the marathon, and

was only passed by one person the entire time. He passed 109 people. He outran many 20-21 year olds and a few state-medalists along the way. Three years ago, none of this would have been achievable for Dick.

At his heaviest, Dick weighed around 285 pounds. In August 2010, he decided to make lifestyle changes that would affect him forever. He joined the Take Shape for Life program here in Falls City, led by Linda Santo. He also went on a diet and consumed only

Gunman still at large; officer to return Thursday

Richardson County Sheriff’s Deputy Josh Nincehelter, injured by a gunman’s bullet June 9 on a county road north of Dawson, will return to active duty Thursday, Sheriff Randy Houser said. Houser said Nincehelter will work day shifts for the time being.

“He’ll be released for duty tomorrow (Tuesday),” Houser said. “And start back to work Thursday.”

No arrest has been made and Houser Monday had nothing new to report about the gunman, a Hispanic male who authorities allege fired three bullets from a silver semi-automatic pistol at Nincehelter, 25, in the early morning hours of June 9. One bullet hit Nincehelter’s arm and the others hit his patrol vehicle. The pickup has since been sent to the Nebraska State Patrol lab in Lincoln.

Deputy Nincehelter, of Humboldt,

Humboldt native Albin appointed Commissioner of Labor by Governor

Humboldt native John Albin, 60, has been appointed by Governor Dave Heineman as Acting Commissioner of Labor.

Albin is currently General Counsel for the Nebraska Department of Labor. He received his Juris Doctor degree from the University of Nebraska College of Law in 1979

and has been with the Department of Labor for more than 24 years, having begun as an administrative law judge in 1990. Albin joined the Department’s Legal Division in 1993 and became General Counsel in 2000. Prior to joining the Department of Labor, he was in private practice.

“I look forward to this new opportunity to serve the citizens of the state of Nebraska,” Albin said.

Also on Monday, Gov. Heineman named Dacia Kruse, 42, Acting Director of the Nebraska Department of Economic Development. Kruse currently serves as Deputy Director of the Department of Administrative Services, a position she has held for three years.

“I am excited to join the team at the Department of Economic Development and to build on the momentum that has been created with the national recognition Nebraska continues to receive as a place to create jobs,” Kruse said.

I’ve been out of the loop for a couple of months and, in all likelihood, it’s not necessary to write why. That can come later, after my meager garden is in shape and my house has been thoroughly vacuumed and dusted. Outside, I have some painting to do, window well covers to install, windows to wash, a garage to clean, myriad organizing everywhere . . . the list goes on. Almost makes me miss the safety and learning that took place in Des Moines, then Bayard, Iowa, where I met some great people who offered lessons for folks like me to get their lives in order.

Let me first say that the staff here at *The Journal* did a great job in my absence. It’s kind of humbling to realize that not a beat is missed in one’s “awayness.” Kudos to Jason, Nikki, Bill, Chelsie, Ron, Judy, intern Molly Chapple and all of the others who stepped up. Should I consider retirement? Maybe. But I think I’ll hang around for a bit, just in case there are some good stories left in my brain and typing fingers. Hopefully, positive stories.

Nothing in my time at *The Journal* has surprised me more than the horrible violent crimes that have had to be reported. Most are familiar with the “Rulo Cult” murders and the “Boys Don’t Cry” slayings. But somewhere in that time span, or close to it, were other tragedies in our county. Traffic deaths. A battered, dead baby. A shooting death that, to my memory, was never really resolved. A controversial (senseless?) shooting that resulted in death in central-east Falls City. Not exactly what I’d bargained for when I traded a career in teaching to small town journalism.

In reflection, positive news has predominated, but we’ve had more than our share of the bad stuff. I recall sitting in the District Courtroom years ago (more than once) and literally shaking because the testimony was so hideously graphic. We were a five-day-a-week paper at the time, so the assignment was to hustle back to the newspaper office and try to get the day’s developments in the same day’s paper. I’d be lying to say it wasn’t exciting, but such stories were never pleasant to report.

While I was gone, Jason and Nikki did a super job of reporting the shooting (it could have been much worse) of a deputy sheriff in our county. The story just happened to break at the right time for *The Journal’s* deadline, although those two put in a long day and night reporting it. It’s called a “scoop” and I’m proud of both of them.

Also while away, primary elections were held in the county. On the Republican side, Don Pounds prevailed over Sheriff Randy Houser. I’m confident that Pounds can do an outstanding job (I had the chance to work with him at times while he was a State Patrol Investigator). Pounds knows what he’s doing.

But I felt bad for Houser, who, I thought, was an excellent sheriff. I know this: Randy Houser has been open with the media and on-point in reporting the facts, thus keeping the public informed. His support for a new jail facility in our county was prudent, I thought. It seems to me that the Richardson County Sheriff’s Office has been well-served by Houser.

Nationally, news is breaking in Iraq, where Islamist militants are waging (effective) war on the ruling Shiites. Anyone surprised that a civil war is underway in a region that is so obviously historically and religiously divided? Factor in Syria, Turkey and Iran and the Middle East is on the brink of all-out explosion. And let’s not forget Afghanistan — a country (a stretch to call it that) that will likely become even more chaotic in the months and years to come. Don’t forget Pakistan and its nuclear capability. Foreign policy just gets more and more complicated and complex. No easy solutions. In fact, maybe no solutions at all.

Now there’s an optimistic world view if ever there was one.



Group petitions to allow voters to determine min. wage

Notwithstanding action of the Legislature, there’s a move afoot to raise the minimum wage in Nebraska for the first time in five years.

The current minimum wage -- \$7.25 an hour -- matches the federal wage. Twenty-one states have minimum wages higher than that. Washington state has the highest at \$9.32. Seattle has a minimum wage of \$15 per hour. Two Nebraska border states, Colorado and Missouri, have rates of \$8 and \$7.50 respectively. Nebraska lawmakers failed to approve an attempt in April to raise the rate to \$9 an hour in three steps over the next three years. The bill stalled at the first of three rounds of debate on a 20-20 vote.

With time running out in the session, Omaha Sen. Jeremy Nordquist and term-limited Lincoln Sen. Danielle Conrad were joined by some colleagues in announcing a petition drive under the banner of Nebraskans for Better Wages to get the issue of a \$9 minimum wage over the next three years before the voters in November. Nordquist, noting that the living wage in Omaha is \$8.70 an hour, said he supported the bill and the petition drive because Nebraska’s middle class is shrinking and the median household income along with it.

Proponents must submit 83,000 verified signatures by July 3 to get the measure on the ballot. They will submit more in an effort to ensure the quota in case some signatures are invalidated. Nebraska law requires petition circulators to gather signatures from 7 percent of registered voters and that total must include at least 5 percent of registered voters from each of 38 counties — two-fifths of Nebraska’s 93 counties. Petitioners are being paid \$10.50 to \$12.50 an hour to collect valid signatures.

Looking at the politics of the measure, Democrats generally support it and claim that Republicans don’t because they are all about corporate America and big profits. Republicans blast Democrats for their sense of entitlement at any cost.

The question remains, where does the money for the increased wages come from?

Bob Hallstrom, a lobbyist for the Nebraska Federation of Independent Business, said studies show that raising the minimum wage hurts employment and often results in the lowest-paid employees losing their jobs. He said small business owners have to decide what to cut. Or, prices have to be raised with the cost passed on to the consumer. He cautions that an increase in the minimum wage, particularly on the heels of a recession, is a concern for struggling small businesses because it adds cost to their bottom line.

Nordquist contends that states that have raised the minimum wage have found those fears are overblown. He said higher pay for low-income workers would benefit Nebraska’s economy by lifting wages

broadly and putting money in consumers’ pockets.

According to the Bureau of Labor Statistics, an estimated 3.6 million U.S. workers in 2012 were paid at or below the federal minimum wage, including about 32,000 Nebraska workers. Nebraska ranked 13th-highest for the percentage of hourly workers making at or below minimum wage and second highest among neighboring states.

Nebraskans for Better Wages has received more than \$300,000 in donations so far. Union groups such as the Nebraska State Education As-

sociation, the state AFL-CIO, the Nebraska State Council of Electrical Workers and the Nebraska State Utility Workers are among major donors to the cause. Conrad has a contract to receive \$30,000 from the group for campaign management consulting.

Proponents say that raising the minimum wage would allow more families to make ends meet. Opponents say it will be a burden to small businesses and will force them to increase prices to make ends meet.

The issue will obviously directly affect Nebraskans. Thus, putting it to a vote of the people in November is a good move.

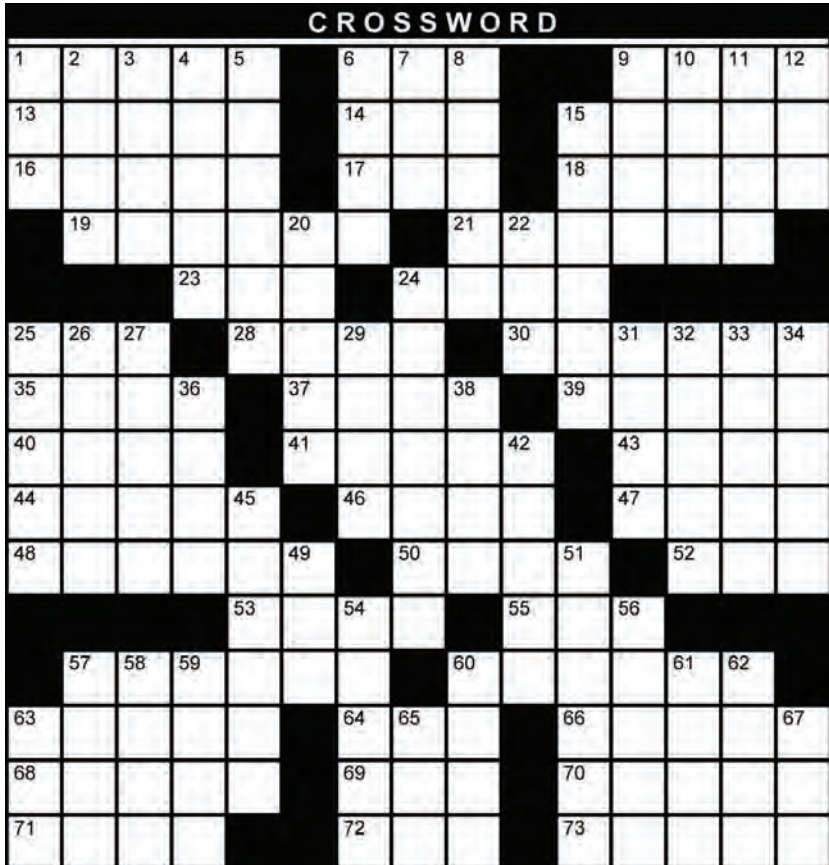

“hospital family” gathering in JR’s room to visit and watch Jeopardy every day. JR was okay to walk the halls of the 7th floor but needed a nurse to accompany him outside because his health was continuing to deteriorate. Lisa said, “life became a routine” during this time.

May 15, 2014 — a date nobody in the Ramer family will forget. It was the news they had been waiting and praying for. A member of the Heart Transplant Team came into Jr.’s room around 11 a.m. and told the family that they had a heart. Tears openly flowed as several nurses started prepping Jr. for his surgery. At 2 p.m. the surgery team came in and wheeled JR out into the hall. The nurses, techs and staff all lined the hallway and cheered and gave him high fives as they wheeled him into surgery.

Lisa said it was a very emotional moment.

“Everyone was crying and hugging, we had become very close with everyone up there.”

Surgery took an excruciating 10 hours. JR was taken straight into ICU, where he remained for a week until he was able to go back to the 7th floor, and waited to be released.

The day finally came where JR was strong enough to go home. It was Wednesday, June 11 and something special was about to happen. Lisa knew what was brewing in the heart of Falls City, but JR didn’t.

Brad Campbell, of Falls City, shares JR’s passion for riding motorcycles. Campbell had been thinking for a long time about what he could do for JR. It was over dinner one night that Brad spoke with Rhett Blakely and soon an idea was hatched. Campbell went home and started planning. He had contacted Lisa to make sure it was alright then he posted it on Facebook and it escalated from there.

When I asked Campbell why he decided to do it he told me “I’ve known JR all my life and wanted to do something for him.”

He knew how much JR loved to ride and knew he couldn’t do it anymore so he wanted to honor his passion. After many motorcyclists from the surrounding area and some from Omaha joined the escort, Brad learned he wouldn’t be able to participate due to an appointment. Campbell did, however, sound more than pleased with the outcome of his plan. He made it very clear that he didn’t do it alone and had “lots of help from others.” He says all he really did was put the bug out there and keep everyone informed of when they would be returning home.

Brad’s idea paid off and last Wednesday Lisa and JR were escorted home from the hospital by several motorcyclists with their youngest son, Eli, leading the way. As they made their way back to Falls City all JR could say was “Oh my, Oh My, This is such an honor.”

A little before 6:30 p.m. the motorcade made their way into Falls City. Citizens cheered and waved as the Ramer’s made their way down Harlan Street.

“Seeing all the people who care so much was very overpowering,” Lisa said.

The closer they got to Falls City the more emotional they got. As they pulled into town many Falls City residents lined the streets to welcome them home. Banners had been made to hold along the route reading “Welcome Home Jr.!” and “We love JR” The back windows were rolled down so everyone could catch a glimpse of the man of the hour waving to each of them. Many on the route couldn’t contain their emotions and happy tears welled up in their eyes. From the First United Methodist Church at 17th and Harlan all the way to Farm and City Supply at 26th and Harlan you could see people standing along the street welcoming this family home.

As the Ramer’s and their motorcade pulled into the First United Methodist Church parking lot their vehicle was swarmed with smiling friends and family ready to give their well wishes. It was quite the celebration and perfect reminder of why Falls City is an amazing place to live.

I asked the Ramer’s if they knew anything about the heart donor, but at this time they don’t know anything. They would like to write a thank you letter to the family of the donor. First they will need to give the letter to the transplant team to read and decide if it’s appropriate, then they will give it

to the donor’s family. The family will then decide if they want to respond or meet the Ramer’s. Lisa told me that her and JR had always been organ donors but never thought they would be on the received end. Organ donation is as easy as signing the back of your license.

Lisa reminded me “One donor can save many, many lives!”

JR is living proof of how important organ donation is. Ramer is home and doing well, getting stronger every day. He posted a message to Facebook on June 7 that seems to sum up his great appreciation of this new chapter in his life: “Never give up, because the best goes on. Bless the donor family for my precious gift.”

MediFast food products. By March 2011, he had lost 82 pounds. What really fueled Dick to get in shape were some bad patterns in his genes. His great-grandfather, grandfather and father all had Adult Onset Diabetes and had to have one or both legs amputated. The fear of

losing his legs and his determination to be in healthy shape is what led Dick to success.

In 1999, he was diagnosed with sleep apnea, a chronic condition that obstructs your airways when you are sleeping. He had to use a breathing machine when he slept and took medication for his ailment. After Dick completed the health program, he was able to quit using the sleep apnea machine and all medications. He says he feels as energized as he did 30 years ago.

Running isn't a new hobby of Dick's, though. He has been running since he was a young boy, all the way through high school track. Dick gives credit to his mentor, Louie Fritz, who was his 8th and 9th grade Physical Education instructor. “Louie would write up workouts for me and send them to school with his brother Phillip,” Dick stated. “I even went to see him before I ran the marathon to let him know what I was doing.”

The love of running was passed down from Dick to his son, Matt. They attended youth track meets and enjoyed going to high school state track meets for many years. Last spring, Matt was at the state meet for another reason — as the assistant track and cross country coach, Matt led the Lincoln Southwest Girls' track team to a Class A state championship title. Matt's cross country team at Southwest also brought home gold at state last fall.

It doesn't end here for Dick. Since February, he has lost six more pounds and is planning on losing more. He is preparing for several upcoming marathons this summer and next fall. Next spring, he will return to the Lincoln National Guard Marathon and hopes to achieve a time of less than 3 hours and 40 minutes.

Dick lives by the famous Wayne Gretzky quote, “You miss 100% of the shots you don't take.”

“If you don't try, you will never know what you can achieve. So you might as well give it a shot,” he urges. “Many people just don't expect a 60-year-old to be running marathons. There aren't high enough expectations for people.”

Dick's story proves what can happen when you take a risk to exceed society's expectations. Although we might not all be marathon winners, we can all take a little inspiration from his bravery and determination.

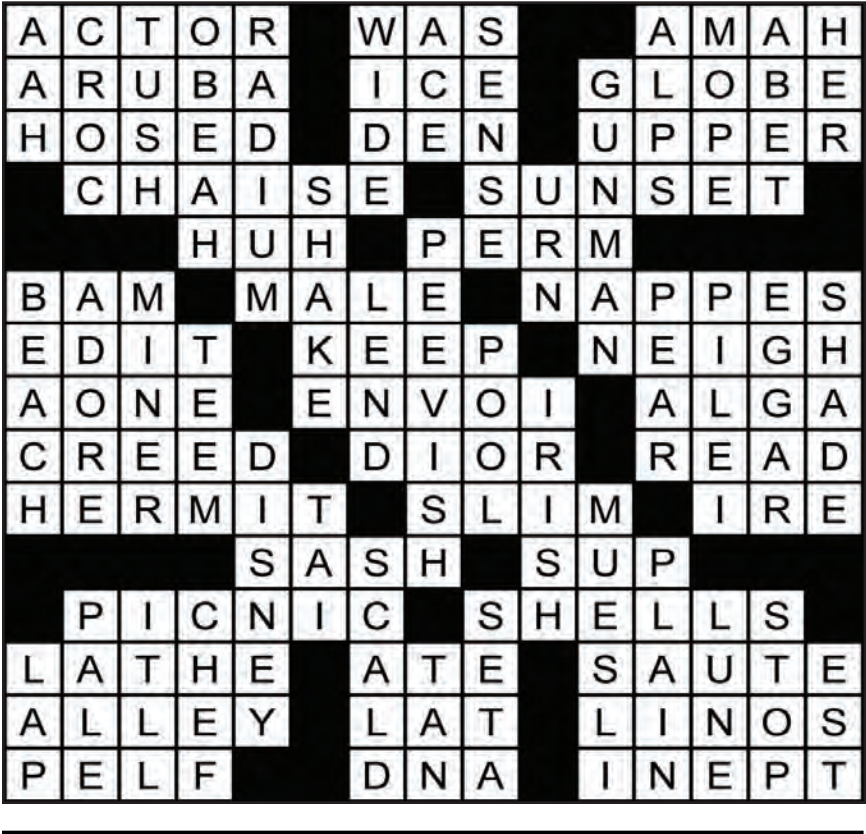

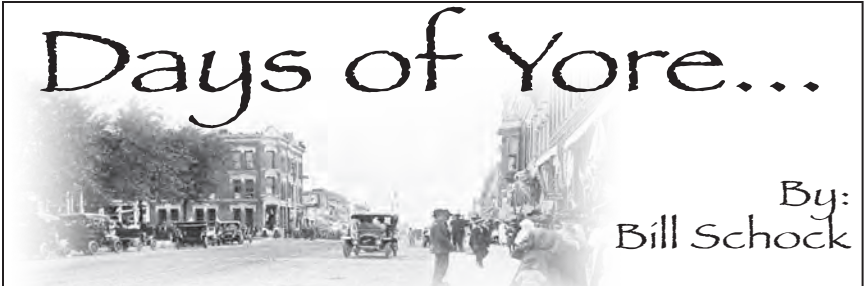

The Bachelor Desert

Perhaps in an effort to encourage immigration, particularly of marriageable women, the Red Cloud Chief in 1874 publicized an area of western Webster County and eastern Franklin County as a "Bachelor Desert," in which single men worked small acreages, trying to carve out a home on the frontier. A letter to the editor, published by the Chief on January 29, introduced the term. In humorous vein, the writer, hoping to attract interested females, described several bachelors living in the Bachelor Desert:

The first was "a robust stalwart, light-haired sandy-whiskered, rather quick-tempered good honest, industrious, educated Grange-stricken, bachelor of about 35 winters. Senator Wilson [the bachelor] has all of thirty-two acres under cultivation. He raised last year 100 bushels oats, 75 bushels wheat, 500 bushels corn, strange to say he fattened with a part of the same corn, five shoats of which he butchered three at the age of six months, which averaged in weight 165 pounds each. He has on his premises two dwelling houses, corn-crib, and the ruins of a hen house, the downfall of which was caused by a man trying to burn a fire break around his hay stack while the wind was blowing a lively gale from the west."

Another bachelor, the Rev. James Knox, cultivated twenty-five acres "and it yielded a crop for him last year of 600 bushels of corn, potatoes, pumpkins, squashes—plenty of just such stuff as bachelors use." Knox's possessions included a team of young mules, a wagon, a hog, two yearling calves, a dog, and a cat. "He lives in a dugout at present, but expects to build a new house soon, and sell the dugout for a post hole."

A third bachelor, a Professor Chapin, had his twelve acres "all broke up, and raised last, 250 bushels of corn, and other things in proportion. He has one yoke of work cattle, one cow, several head of swine. He has a log house at present, but he is going to build a new frame house soon." M. Shaw, "a fine Scotchman, a bachelor of 30 summers, good looking, industrious," worked as a stone mason and rented out his acres.

Inhabitants of the Bachelor Desert enjoyed a brief moment of fame after the letter appeared in the Chief, with a corresponding elevation of their matrimonial prospects. On February 19 a subsequent letter to the newspaper from Riverton in Franklin County noted that the bachelors named in the article "have appeared in public ever since, shaved, clean shirts with buttons, and newly patched pants, and boots well greased." A letter from Inavale, published in the Chief on February 26, from a group of bachelors in that area, said that they were making improvements to their acreages rapidly and hoped in the near future to be able to support families.

Robert Hunzeker to Fatherhood Hall

So now they had two little boys and me...My dad said...Well, I guess God already gave us our girl."

The Nebraska Fatherhood Hall of Fame began in 2007 as a way for Christian Heritage to recognize outstanding Nebraska fathers, promote fatherhood, and encourage the involvement of fathers in the lives of their children. Approximately 900 fathers have been nominated in eight years, and over 80 have qualified for induction into the Nebraska Fatherhood Hall of Fame. Blue Storm tries to end three-game skid tonight

The Falls City Blue Storm Seniors blew a 4-2 fifth-inning lead in a 9-4 road loss to Doniphan County Saturday and now carry a three-game losing skid into tonight's home game with Springfield at SNC Field.

FC improved to a season-best 11-3 on the year last Tuesday with an 11-4 victory at Hiawatha, but have since lost its mojo, falling Wednesday at home to Louisville, 14-10, before going two-and-through at the Doniphan County Tournament in Wathena, losing to Atchison Friday, 10-1, and to the hosts the following day.

Against Doniphan, FC scored two in the top half and didn't trail throughout the first five and a half innings, leading 4-2 entering the bottom of the fifth. But Doniphan tied it with a pair of runs in that inning and then blew it open with a fifth-inning rally. Colton Masters (2-for-4, 3 runs, 4 RBI) got to FC pitcher Logan Scheitel for a three-run homer and eventually scored five in the frame. The Storm loaded the bases with just one out in the seventh, but stranded them all. Third baseman Chase Thompson came to the plate after going 3-for-3 with two RBI, but flew out to center to end the game.

Thompson and center fielder Tyler DiGiacomo (2-for-3) each doubled in the first inning, helping FC jump out to a 2-0 lead. Catcher Derek Bippes reached and scored in the first and fourth innings, and singled in the fifth, driving in DiGiacomo.

Doniphan pitcher Phoenix Keller went six and one-third, striking out eight FC batters and walking just two. The Storm did touch him, though, recording 11 hits.

Scheitel pitched the entire sixth, was saddled with five earned runs and took the loss. Starting pitcher Weston Witt went three innings, allowing four hits and no earned while striking out two and walking one. Reese Hogue came on in relief, throwing the fourth and fifth innings for FC. He gave up just one hit and no earned runs, but walked three. A trio of errors haunted the Blue Storm against Doniphan.

Falls City plays five games in five days - four on SNC Field - starting tonight at 8 p.m. They travel to Auburn Wednesday (8 p.m.), and return home to face Beatrice Thursday (7:30), Plattsmouth on Friday (8), and Sabetha Saturday (6). The league tournament in Auburn starts

a week from today (June 24).

Atchison 10, Blue Storm 1

In the first round at Wathena, FC pitcher Derek McCann had a one-hit shutout going through four innings and FC took a 1-0 lead in the bottom half when DiGiacomo singled, advanced to second on a single by Thompson, went to third on a sacrifice fly off the bat of Ben Bauman and then scored on a passed ball.

Things changed dramatically in the fifth, however. Atchison plated 10 before FC recorded a single out and each and every one of them came around to score. Four errors, a walk and three singles produced the longest inning of 2014 for Falls City.

The Storm combined for 3-of-18 hitting, drawing two walks to seven strikeouts.

Louisville 14, Blue Storm 10

Eleven hits weren't enough for FC, as it lost a shootout Wednesday at SNC Field.

Chaz Dunn got on base four times, singling in the first and fifth innings.

Bippes was the game's losing pitcher, allowing seven runs in three and one-third.

The top of the first saw Louisville take an early 4-0 lead, but FC answered with five in their half. FC scored on a two-run error, an RBI single by McCann, a fielder's choice and an RBI single by Hogue.

FC posted one run in each of the fourth, fifth and seventh innings. In the fourth, Bippes came across on an RBI single by McCann, and a Dunn single scored DiGiacomo in the fifth.

Louisville didn't relinquish the lead after scoring five runs in the sixth.

Blue Storm 11, Hiawatha 4 (11 innings)

Last Tuesday's win was FC's third in a row, seventh in its previous eight games, and pushed the season series with Hiawatha to a perfect 3-0.

But it was hardly as easy as the score may indicate. There were six lead changes and Hiawatha brought one across in the bottom of the seventh to force extra innings.

The Blue Storm eventually exploded for seven in the 10th to clinch the win. FC scored on two hit batsmen, an error, walks by Witt (2BB, 3 runs) and Dunn (3BB, 2 runs), and a two-run double by Thompson (2-for-6, 2 RBI). Bippes drove in three and DiGiacomo another two for FC.

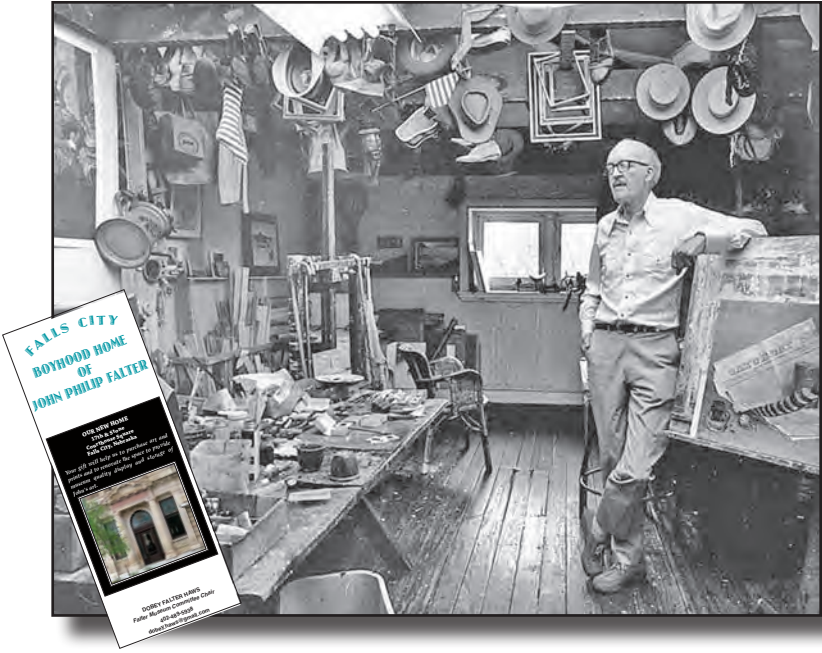

Barbara Hemphill, a 1964 graduate of Falls City High School, will share her story of the impact growing up in Falls City has on her life and her business, and to celebrate the power of “Together We Are Better” with the opening of the John Philip Falter Art Review Saturday, June 21, at the Stalder Art Gallery in the FC Library & Arts Center.

Barb is the daughter of the late Everett and Doris Frost. She will also be in Falls City this weekend to celebrate the FCHS Alumni Weekend with the 50-year Class of 1964.

The library opens at 9 a.m., Barbara speaks at 10 and then follows with a tour of the Falter artwork. Cookies and lemonade will be served.

The John Philip Falter Museum is to be located in the lobby of the former Richardson County Bank building at 17th and Stone Sts. With \$80,000 donated as of June 1, the project is edging closer to its construction goal of \$100,000. The opening date is the Christmas win-

dow opening downtown (Friday, Nov. 28).

John Philip Falter became a world renowned illustrator and historic painter, but never lost his love for Falls City. Following his death in Philadelphia in 1982, his studio and some of his paintings were donated to the Nebraska State Historical Society in Lincoln. The NSHS is loaning the Falter Museum Committee his studio.

The project is certainly fortunate to have Barbara Hemphill’s enthusiastic support. Frequently referred to as “The Paper Tiger Lady,” she is a well-known author and expert in paper, information and time management, and work/life balance.
