High radon in Courthouse

During their Tuesday, June 12, meeting, the Richardson County Commissioners requested that Extension Educator Lyndsay Chichester obtain quotes to mitigate radon levels in the lower level of the Courthouse.

Radon is an invisible, odorless gas that is highly prevalent in southeast Nebraska. Radon has been shown to cause cancer, especially lung cancer.

Chichester reported that tests taken in her office measured more than double the reading at which mitigation is recommended. Kits to measure radon levels are available in the Extension Office.

Sheriff Randy Houser presented information and specifications for an advertisement to receive sealed bids for the purchase of a patrol unit to replace a unit that is out of order for mechanical reasons. The board recommended and approved the purchase of a new motor for the unit in order to get it back into service, rather than the purchase of a new unit at this time.

Also Tuesday, Commissioners Dave Sickel, Bill Ely and Jim Davidson: Designated County Clerk Mary Eickhoff as the budget-making authority for the approaching fiscal year.

Bigger. Faster. Stronger

Bigger. Faster. Stronger. These three words are directly tied to success in athletics and a look around any successful program one will find the needed avenues to obtain them.

With the new weight training facility open and excitement abound, the thought of the tides turning has the athletes, coaches and administrators of the Falls City Public School system eager to get to work.

A company called, appropriately, Bigger Faster Stronger, based in Utah, presented the new blueprint for success to athletes and coaches at a clinic at the end of May.

The coaches spent an entire day with two of the BFS representatives learning about core lifts, auxiliary lifts, flexibility, speed and plyometrics, among others. Then, two days were spent with the athletes to allow them to soak up all the necessary information to obtain future success. Nearly 80 high school and middle school kids participated in the two-

Since the BFS clinic and the opening of the new weight room, FCHS P.E. teacher Randy Rech has said the participation has been the highest he's seen since coming to Falls City in

"It's been great," said Rech. "It is such a great program (BFS) and to have it now with the new facility, the

kids are really getting after it." Rech said in the two-plus weeks the weight room has been open they are averaging nearly 80 kids a day. Around 60 high school students- 40 boys, 20 girls - and another 20 junior high students have hit the ground run-

New FCHS weight room open house this Friday

The Falls City Tiger Bootster Club along with the Falls City Public Schools and the Board of Education recently saw the fruits of their labor when the new weight training facility opened June 1.

The new facility is located in the large, Tiger orange shed located in the northwest corner of Jug Brown Stadium/ Thomas Field. To declare it top notch would be doing it a disservice.

Totaling nearly 1,900 square feet, the new facility houses four brand new, state-of-the-art weight racks which all sit adjacent to four wood custom-made lifting platforms emblazoned with a Tiger logo. The six-post racks allow for bench press, squats and cleans to be done simultaneously by three different people. Also new are six various weight machines, two

dumb bell benches and 15 sets of dumb bells ranging from five pounds to 75 pounds in weight.

All of the equipment was picked out by Athletic Director Darwin Palmer and bought from Power Lift, Inc. out of Jefferson, Iowa. Power Lift is also the same company that furnished the University of Nebraska's weight training facility and the have numerous clients in both professional and collegiate athletics.

Superintendant Tim Heckenlively, who worked closely with Palmer during the entire process, applauded the AD's efforts in putting the facility and equipment together.

"Darwin was pretty instrumental in putting everything together," said Heckenlively. "He really went to town researching the sizes and specs of everything."

The total cost of the project was \$75,000, of which more than \$42,000 has been privately donated. Josh Rhodd and Anthony Shafer with Top Quality Construction donated more than \$1,200 worth of time and materials and Ryan Rieschick with Rieschick Drilling donated his time and effort into installing a well and bored holes for the new geo-thermal heating and cooling unit, which was installed, in kind, by Alan Meyer of Meyer Home Cen-

Supt. Heckenlively said the need for a new facility was paramount to the future success of Tiger athletics.

"We're trying to change the culture," said Heckenlively. "We're really excited. The kids are really getting after it and it's taking off."

He commended the generosity of the Tiger Booster Club and said the outpouring of support for the new facility following the announcement in February was tremendous. Heckenlively said donations are still being accepted as finishing touches are still in the works. Pledge cards are available at Falls City High, the Central Office in the Middle School or can be found at fctigers.org

An Open House for the public to view the new facility will be this Friday from 2-4 p.m.

North School Principal Ernie Valentine is monitoring the junior high students who work out on the same days from 9-10 a.m.

Also, six coaches were certified in the BFS program – Rech, Darwin Palmer, Don and Terri Hogue, Kory Huppert and Michael Huettner. The coaches were given a 102-question test and had to score above 90 percent – each coach surpassed 95 percent.

The BFS Total Program is a "training program that allows every athlete to make great gains and break many personal weight lifting and performance records each week."

Each athlete is given their own daily program to follow, which includes a well-rounded set of exercises focusing on all the aspects of attaining top, physical condition. Separately there are "in season" and "off season" workouts for the athletes to follow, which ultimately allow for enough rest and are designed to prevent injuries.

Something unique to the BFS program is the "Dot Drill," which had many of the athletes feeling they had their shoes tied together during the first few attempts. The "Dot Drill" takes place on a rubber mat consisting of five dots – two at the ends and one in the middle – and requires the athlete to complete five sets of jumps using both feet in some and the right or left in others. The goal is to increase quickness and strengthen ankles and calves by improving accuracy and time on the drill.

All in all, the new training program paired with the new weight room have many Orange and Black supporters excited for what's to come.





have used that little rhyme as you prepped for a social studies test in a Nebraska school

> childhood. Names and dates,

during your

once deemed as important as knowing the circumstances surrounding a particular historical event, are losing popularity in the classroom. The rote memory of facts is becoming passé as the Nebraska Department of Education revises its social studies standards for the first time in decades.

The early draft of the new standards directs teachers who teach to expose students instead to broad concepts and analytical skills. Teachers are encouraged to go beyond the textbook and look at newspaper editorials and personal correspondence from the people involved in events.

"It's involving kids in the process of history," says Nebraska Wesleyan University assistant history professor Kevin Bowers. He directs a grant-funded historical studies program that has helped more than 150 Lincoln Public Schools teachers earn master's degrees.

Teachers are learning that multiple perspectives are important. Students need to explore the impacts of documents and events by determining people groups that would have been af-

fected the most and the least. It's creating problems that students can work through in the classroom, says LPS social studies curriculum specialist Randy Ernst.

"Research shows us over and over that kids remember better when they process it more deeply," Ernst said. He admits that giving teachers the freedom to do just that does come with a cost. With social studies instruction time already severely challenged by the need to teach for high stakes reading and math tests, the question in creating new standards is: What do you include and what do you leave

Nebraska's social studies standards were last revised in the 1990s. Ernst believes the urgent need for revision is to allow teachers to teach the skills students need to be able to evaluate sources in an information - saturated world.

Bowers says good teaching and good standards are a combination of content and skills. They are not totally separate but are "inextricably intertwined." Thus, there is still room for names, dates and facts.

Meghan McNeal, an LPS elementary teacher who is currently enrolled in the Wesleyan master's program, likes the challenge. "We are learning to teach students to think like historians and to be able to fit the facts together and know why they go together, "she said.





Affordable health care at risk

Many Nebraskans have contacted me to talk about the health care reform law that the U.S. Supreme Court is expected to rule on sometime this month. Officially, it's the Affordable Care Act, because that's what it's supposed to do - make health care affordable and available to all, but it is at

There is a fear that this is an activist Supreme Court and it will overturn all or part of the law, which the Congressional Budget Office says could raise insurance premiums by 15 to 20 percent, making it unaffordable and caus-



Nebraskans I've talked with like portions of the law, but not the mandate that requires people to have insurance. The mandate is necessary in order for the entire package to work.

Personal Responsibility

The mandate requires everyone to have insurance, which helps pay for the bill and makes them responsible for their own health care if they get sick or injured. No longer will the millions of uninsured Americans be able to rely on the vast majority of taxpayers who have health insurance and pay extra to take care of them.

The estimated cost for those who have insurance to cover the costs of the uninsured is \$78.5 billion. Last year this uncompensated care cost responsible Nebraskans a total of \$431 million. **Affordable Care Act Helps Children**

The full law doesn't take effect until 2014, but parts of it are already being implemented. In Nebraska, 15,000 young adults have been allowed to stay on their parents' insurance policy up to the age of 26, which is important during a weak economy.

If the high court throws out the law it could also jeopardize coverage for the 61,000 Nebraska children who have a pre-existing condition like asthma or diabetes who are now insured for the first time.

Affordable Care Act Benefits Seniors

Senior Citizens will pay more for prescriptions if the law is thrown out. It has already begun closing the "donut hole," meaning lower prescription costs for seniors. More than 24,000 Nebraskans on Medicare have already seen their prescription prices fall, saving each person on average more than \$600 last year. If the law is ruled unconstitutional it will also impact the ability of seniors to receive preventive services with no deductibles or co-pays. Last year, more than 197,000 Nebraskans on Medicare received free colonoscopies or a free wellness visit with their doctor. If the law is overturned, insurance companies will no longer be banned from limiting lifetime coverage for chronic diseases which last year affected 701,000 residents in our state.

Critics Should Offer Alternatives

If the activist Supreme Court rules as expected and tosses out the law, the Tea Party wing and other critics will then be obligated to stop these grave consequences that will hurt thousands of Nebraskans by finally offering alternatives they've avoided putting forward for two years.

Should they fail, we'll know all along they were just playing politics with the lives of children, seniors, small business owners and families.

Work begins on Highway 73

Work began today on nearly 14 miles of Highway 73 north of Falls City to Highway 75. The \$4.19 million improvement project is expected to be completed by November 2012.

Traffic will be controlled by one-lane work zones. Drivers are reminded to drive cautiously and obey flaggers in the construction zones.

Highway 73 was closed north of Falls City for most of 2010 and reopened in January 2011.





Historical Society

This was in the days before refrigeration. The large number of cattle were driven down the road to the Verdon railroad depot's livestock pens and loaded into several cars. Mr. Bowers and a broker then boarded the train which traveled eastward at 30 mph at the highest speed. The cattle would have to be unloaded periodically for exercise, feeding and watering.

The train proceeded to an eastern city packing plant after the broker made arrangements for their sale. Then the men returned home on a lot faster train. When the refrigerated cars became available, the animals could be sent to closer packing plants like Armour in North Kansas City or the Omaha stockyards.

Also, some accounts of the earliest pioneers in the county were given and some stories by Charles Nutter of his memories of the 1920s were read.

Get creative! Art is cool

Youth in grades 6-12 are invited to attend an art program entitled "Expressive Community" at the Falls City Library & Arts Center from 4-6 p.m. Tuesday, June 26.

The program will be directed by Falls City native Andrea Jenkins, a 2012 graduate from UNL with an Art Education Endorsement for grades K-12. She has studied in Italy, New York City and Koelzer's Salvage in Rulo, and also with Pat Steinman. This project was supported in part by state aid funding appropriated by the Nebraska Legislature, granted and administered by the Nebraska Library Commission and the Friends of the Library.


Sapp Bros. pledges \$500,000 to Oak Bowl



Be prepared for anything in your crops, landscapes

With the extremely early spring and summer conditions and erratic weather patterns, we have seen a number of different insect pests, some weird looking plants affected from diseases, insects, environmental conditions or possible spray drift. It is important to be prepared for anything this year in your crops, gardens and landscape. The very warm, dry conditions we experienced the past 6 weeks have led to some infestations of two-spotted spider mites in soybean fields. This is 4-6 weeks earlier than we usually see these pests in soybeans. The dry conditions only magnified issues with rootless corn that was seen around the region more this year than normal.

A large portion of the region received some excellent rains last week that really improved growing conditions for crops. With the hot conditions we are seeing this week, significant rainfall will be needed the remainder of the summer to produce a crop. It is important to check fields to determine if an insect pest or disease is in your field that may require treatment. In continuous corn fields, corn rootworm have emerged way ahead of schedule. Continuous corn fields should be checked to determine if you have a problem and an insecticide needs to be applied.

There have also been reports of frogeye leaf spot in soybeans. There have been reports of Goss's Wilt in south central Nebraska. This disease enters the corn plant after it has been damaged by hail, winds or blowing sand. Remember this is a bacterial wilt, so treatment with a fungicide is not effective. It is important to get a positive identification of a disease before any treatment is applied. You can contact me at (402) 274-4755 or your local Extension office if you have questions. UNL Plant Diagnostic Clinic can provide this service.

As far as problems with plants, trees and flowers in landscapes this year, there have been a number of calls on different issues. There have been spruce spider mites on spruce and cedar trees earlier this spring, but with hot, dry conditions, be prepared to see the two-spotted spider mites on other trees and shrubs this summer. If the needles or leaves of trees are turning brown or yellow, you may want to check for spider mites. If you hold a piece of white paper underneath the needles or leaves in a branch of a tree or shrub and shake, you may find several small specks on the paper. If after a short time they start moving, you probably have spider mites. If populations are not too great and you have a small tree or shrub, you may be able to knock the spider mites off with water. There also may be natural predators that will keep the populations in check. There are horticultural soaps, oils or miticides that can also be used to control this pest. There have also been a number of calls about aphids on trees. Control of aphids is similar to the spider mites, except there are also a number of insecticides that can be used for control. Unless you have trees that have been infected every year by aphids and are under stress, treatment usually isn't required. The important thing is to help reduce stress on trees by keeping them well watered, especially during the heat of the summer.

Another insect people are concerned about is bagworms. While I have not seen any bagworms yet, it is important to keep a watch out for this pest. They have caused considerable damage to coniferous trees and shrubs in the area for many years. With the warm temperatures, they should have hatched already. They are much easier to control when they are small.


The Reavis-Ashley Chapter DAR, Falls City, met Friday, June 9, at the Cornerstone Coffee Haus in Seneca.

Alice continued her battle for civil rights and is credited with drafting the Equal Rights Amendment, which was passed by the Senate in 1972. Currently, there is a bill in Congress to award Alice Paul the Congressional Gold Medal for advancement of equal rights for

'Medicare' call a scam

Scams that can result in financial ruin target people of all ages. But senior citizens should be especially cautious. Jenny Margrave of Falls City certainly was.

Jenny received a phone call last week from a woman purporting herself to be representing Medicare. She told Jenny that "new cards" were being issued and that certain information had to be certified — information that included Jenny's bank account number.

After listening long enough, Jenny told the caller that "this sounds like a scam." The caller promptly disconnected.

Jenny recognized the call for what it was and knew that no one from Medicare would request a bank account number via the telephone. The Journal has reported on many similar attempts at fraud, including supposed "sweepstakes" bonanzas.

The basic rule to remember is never, under any circumstances, provide personal banking information of any kind over the telephone. Legitimate callers would never ask for that type of information.

And while the call to Jenny was not of the "get rich quick" variety, it is smart to remember that anything that sounds too good to be true most likely is.
