This same imagination made some other changes in the name of art. Falter found it necessary to delete three city blocks, shift a grave-yard and omit the school playground altogether.

Sweeping Beauty

There’s a new rodeo princess in town: ‘Miss’ Ella Heineman

You can call her Miss Ella. Or Miss Missouri. Or Miss Princess. But whatever you call her, be assured that Ella Heineman earned the title of “Miss” a few weeks ago when she won the first-ever princess contest sponsored by the Missouri Junior High School Rodeo Association.

The pageant was held in conjunction with the rodeo state finals in Palmyra, MO, on May 21-22. The daughter of Russell and Lisa Heineman, of Falls City, Ella is 12 going on 20. Poised and eloquent, she is more polished than some people twice her age. When describing her stature, “tiny” is too big of a word. (She doesn’t weigh 90 pounds with jeans, boots and spurs on). But when she climbs into her saddle, she rides with the air of a queen. That ability is just one of the reasons that Ella swept most of the categories during the princess pageant.

She was nervous at first, though.

“I had never entered a pageant before, and thought it would be really competitive and serious,” Ella said. “But the other girls were a lot of fun and supportive, and I made some good friends.”

Ella and four other contestants spent several hours in front of a panel of five judges, competing in such categories as personal interview, speech, impromptu speaking, written test, horsemanship, personality and appearance. The last category was actually the toughest.

“Appearance is definitely important for the princess,” Ella said, “So we wanted everything I wore to match. It took mom and me a few days to tie-dye my jeans to match my shirt.” One effort was too dark, the next too light. But the pair finally got the color just right, and Ella wore turquoise blue from chin to toe (her cowboy hat was white.) She tied for first in the appearance category.

The next toughest event was impromptu speaking.

“The judges asked every girl the same question, and we had to answer right away,” Ella said. “The question was ‘If you were a brick in a building, where would you be? On the bottom, in the middle, or at the top?’

“I said I would be at the bottom,” Ella said, “Because I like to support people.”

Smart girl. Apparently the judges liked her answer, too— or maybe they liked the sparkle in her eye when she said it— because she won the category. For her speech, she decided to talk about her first year in junior high rodeo in Missouri. She and

three are timed events. In barrel racing, the rider completes a clover-leaf pattern around three barrels that are set up in a triangle. The barrels are at least 60 feet apart, and the horse is running at full speed. Some of the top junior high kids in the nation finish the pattern in less than 14 seconds.

“I don’t go that fast yet,” Ella said. “But I’m practicing.”

In goat-tying, Ella bolts out of the gate on horseback, with one end of the rope in her mouth, and the other end in her back pocket. She bales off of her horse when she reaches the goat. She tosses it onto its side, ties three of its legs together, then raises her arms in the air to show that she’s done.

“It’s really fun,” Ella said.

She just recently started competing in pole-bending, too, and thinks her horse, Levi, is a natural. (In pole-bending, the horse and

Coach of the Year Award caps epic year for Prichard

Throughout his career, Lincoln East girls basketball coach Dennis Prichard has always been able to recognize situations not suited for him and move on if necessary.

He saw it right away as a broadcast journalism major at the University of Missouri in the mid-1980s. Prichard recognized it again after three seasons as the Peru State women’s basketball coach, a stint that came on the heels of teaching and coaching 17 years at Falls City Sacred Heart, where as a head coach he guided the Irish to 11 state titles in girls basketball and boys and girls track.

The 2016 Journal Star Girls Coach of the Year thought he’d reached that point after nine seasons at the Spartan helm. East ended the 2014-15 season with its fifth straight first-round loss in districts. The Spartans finished 12-12 that season after posting sub-.500 marks the previous four seasons.

“We had some lean years, and I questioned whether I should still be coaching and that maybe I needed to be in a small rural town again,” said Prichard, who guided East to the state tournament in two of his first three seasons.

“I had some conversations with (East boys coach) Jeff Campbell

The First United Presbyterian Church in Falls City celebrates 150 years

EXISTENTIAL SESQUICENTENNIAL

The First United Presbyterian Church of Falls City, was organized in 1866 by a committee of the Highland Presbytery. At the first meeting E.C. Cooley was elected and ordained as an elder, plus six people were received as members of the church. The early records were lost in a fire sometime before 1871. The first house of worship was located at 15th and Harlan Streets, on the south side of 15th Street and facing west. It was dedicated on Nov. 1, 1873.

In February 1908, the congregation voted to begin building a new church. In the words of church historian Mrs. W. R. Boose, a “fine brick edifice” was built at 20th and Harlan Streets. The building was dedicated June 19, 1910. The following Sunday, six infants were baptized: Loren Allison, Helen Tanner, Mildred Neitzel, Paul Davies, David Davies and Harry Marmet.

Unfortunately, a fire destroyed much of the new building on Sunday afternoon, Jan. 10, 1932. For more than four years, worship services were held in the American Legion Hall. In December 1934, plans were made for the construction of a new building on the existing foundation. A ceremony for the laying of the cornerstone was held May 17, 1936. The cornerstone included a list of members, lists of committees and officers, a church hymnal, a Bible, a coin and a historical record of the church. The new building was formally dedicated during worship on Sept. 27, 1936.

The women of the church took turns serving dinners for the public every third Thursday. Proceeds from the dinners helped the congregation pay off the debt for the new building. The last debt payment was made in April, 1945 — two years ahead of schedule.

The year 1953 brought the election of the first women to the Board of Trustees. In 1955, the steep entrance steps were rebuilt in the more gradual approach seen today, and in 1958 Mrs. Thomas Still and Mrs. Lester Hoban were elected to the session. They were the first women elected as elders in the congregation. The summer of 1963 brought welcome air conditioning to the church building. The church manse was sold in 1970 and moved to another location in Falls City. Later, a handicapped accessible ramp was built on the site of the manse. During the pastorate of Rev. Roxie Sullivan, the pastor’s office was relocated to make room for a bathroom on the second floor and the kitchen was remodeled.

During the pastorate of Rev. Don Wilson, the church shared a parish with the United Presbyterian Church, of Pawnee City. Later, the congregation formed the NEB-KAN parish with First Presbyterian

The First United Presbyterian Church at 20th and Harlan Streets was formally dedicated on Sept. 27, 1936. The debt payments were paid off in less than a decade. The congregation will celebrate 150 years of worship with several events, beginning this Sunday, June 12.

Saturday, April 30-Day three of my five day Film Festival trip.

I only watched two full feature films all day Saturday. The morning started at the historic Graumins Egyptian Theatre a block from our apartment. I had planned to go see *Field of Dream* or *One Man's Journey* but everyone was buzzing about the 90th Anniversary of Vitaphone presentation. Ron Hutchinson, a widely recognized film historian founded "The Vitaphone Project," which seeks out missing soundtrack disks and picture elements for early talkie shorts and features. The project has found over 3500 previously lost soundtrack disks and restored over 90 early sound shorts from the twenties and thirties. I love film and I love history so at the last minute I turned left to head to the Egyptian. I am so glad I did! We were treated to 11 early sound shorts from Warner Bros. They included many vaudeville acts like George Burns and Gracie Allen-which was so adorable my heart almost couldn't take it; Baby Rose Marie and my personal favorite Vitaphone short was "The Beau Brummels" starring the vaudeville comedy duo Shaw & Lee. I laughed until I cried at the comedy duo. My heart yearned for Alex because I knew he would have loved the dry and absurd jokes in this short.

I left the Egyptian and went to the Hollywood Roosevelt Hotel where I set up shop for the next eight or so hours. Club TCM had a day of amazing presentations. The first was Cari Beauchamp's "My First Time in Hollywood" presentation. "My First Time in Hollywood" is a new book by Beauchamp, which is a collection of stories written by some of the biggest stars and other power players of Hollywood's classic era such as Anita Loos, Colleen Moore, Harold Lloyd, Noel Coward, Marie Dressler, Mary Pickford, Gloria Swanson, Myrna Loy, just to name a few, about what it was like for them to arrive in Hollywood. Bringing these stories to life, Beauchamp invited Saturday Night Live star Laraine Newman, Bruce Goldstein, David Ladd, Suzanne Lloyd (granddaughter of Harold Lloyd), and Sunset Boulevard star Nancy Olson Livingston to come up and read a few stories aloud. It was surreal to see Nancy Olson aka: Betty Schaefer standing in front of me. *Sunset Boulevard* is one of those amazing films that I can't get enough of and I went to this presentation with the sole purpose of seeing her. She was incredibly gorgeous in person too.

I decided to stick around Club TCM for the presentation by noted film archivist Serge Bromberg. This presentation focused a lot on the restoration process and how prints from various sources are combined to create restorations of films. I won't lie, I glazed over and decided to roam the room chatting with everyone. I know I probably missed some fascinating stuff but I hadn't met a few people yet so I went on tour for an hour introducing myself. In the process I ended up meeting Matt from Warner Brothers who I had a great time talking to. I walked away from that conversation with a copy of *The Best Years of Our Lives* for Brian and two autographed copies of *The Nutty Professor* starring Jerry Lewis.

The next presentation was 'A Conversation with Elliott Gould.' Mr. Alec Baldwin was the interviewer and I had held my seat all day near the front for this one moment. I could have reached out and touched Baldwin and I had to restrain myself several times from doing so.

I was watching Jack Donaghy from *30 Rock* interview Trapper John from *M*A*S*H*! You guys, it was so cool. I heard bits and pieces but for the most part I just zoned out and snapped over 1,000 pictures during the hour long interview.

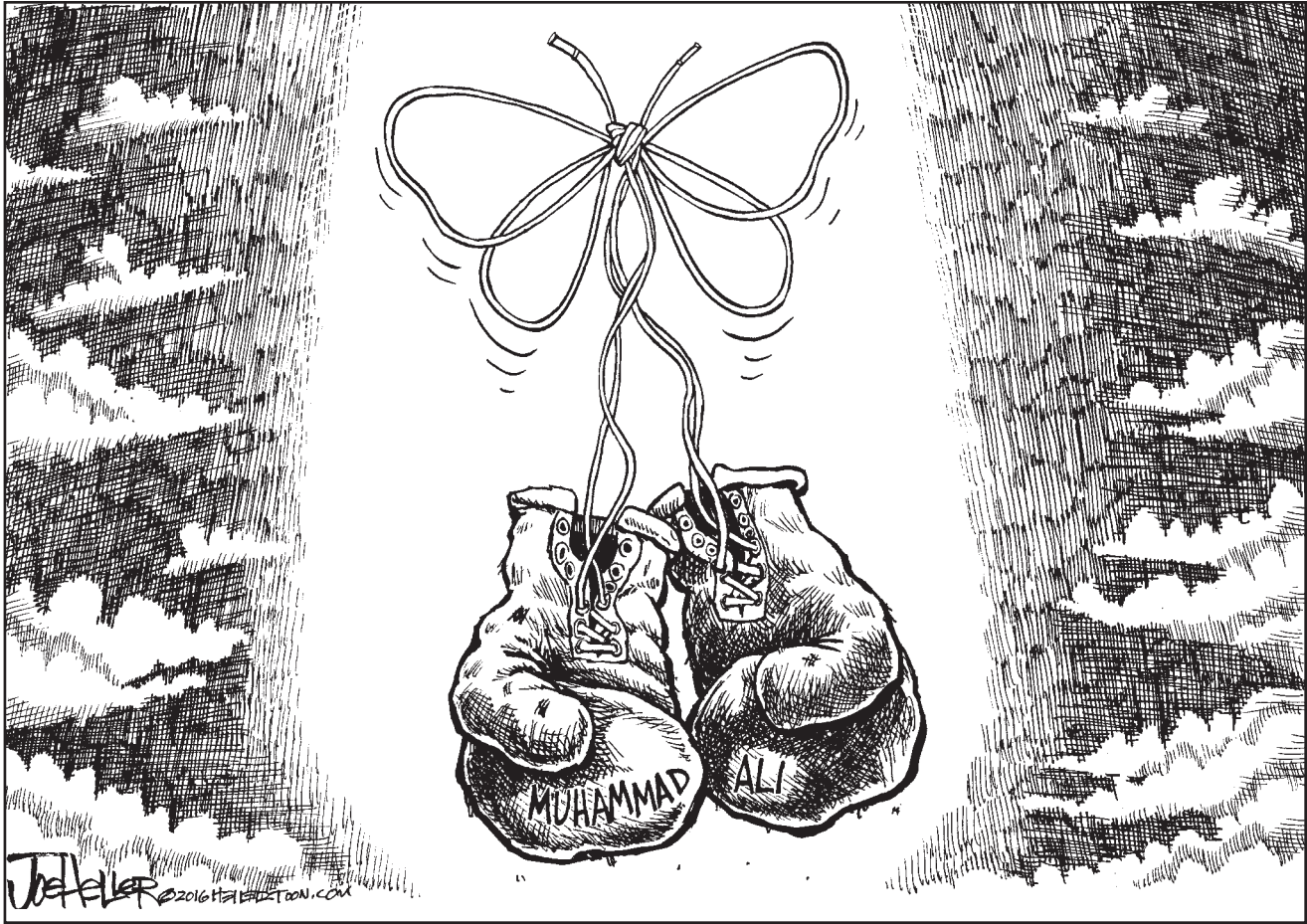
This was followed by the presentation "Hollywood Home Movies." The home movies are pulled from the Academy's collections and show movie stars at home or behind the scenes of different films. She had shared the film with her patients when she worked in a hospital before she became an actress. The comedy was one that I hadn't seen but one I will be buying as soon as possible. Again the magic of sitting in a full theater laughing with others and sharing the love of a great black and white movie is incredible. Memorial Day is over, it must be summer

Memorial Day has come and gone, so it must officially be summer in Nebraska. School is out, the public swimming pools are open and travelers are hitting the road buoyed by low gasoline prices and frustration with the TSA and air-

lines. This holiday, which became an official federal holiday in 1971, started out as Decoration Day after the Civil War back in 1868. Give credit to the Grand Army of the Republic, an organization of Union veterans founded in Decatur, IL, for designating it as a time to decorate graves of the war dead with flowers.

The practice of decorating graves goes back to Southern tradition. Competing Union and Confederate holiday traditions eventually merged creating one Memorial Day, which also encouraged decoration of the graves of soldiers from all wars. That tradition eventually included decorating the graves of loved ones, war casualties or not.

I grew up with Decoration Day. I remember my mother cutting roses and other fresh flowers to place on the graves. I remember packing into the car with my siblings and folks as we drove to the cemetery on the north edge of town, usually in time to hear a speech, see the raising of a flag, perhaps the playing of taps.

We were awash in a sea of patriotism and remembrance. We were there to visit grandparents we never, or barely, knew. Sometimes we would read the dates and the names on the headstones and ask our parents about long-since departed aunts and uncles and cousins. There were also the graves of people who had been killed in automobile accidents or disasters. Visiting those graves seemed mandatory, as there was always someone there to tell the story and refresh the memory of that important piece of history.

We tolerated, maybe even enjoyed, the solemnity of the occasion because we knew it would be followed with a picnic or some other sit-down meal with aunts and uncles and cousins. There would be potato salad and homemade ice cream. The day would be like an extended Sunday after church when such family gatherings usually took place.

I remember sitting in front of my folks' old Airline console radio listening to the reports from the Indianapolis 500 automobile race. That event just celebrated its 100th anniversary this year. Hearing the roar of the race cars and the excited voices of the track announcers was as much a signal that summer was to begin as anything.

Just as surely as Decoration (or Memorial) Day was the start of summer, we knew that Labor Day marked the end. But the time in-between was one set aside for Kool-Aid and sunflower seeds, picnics and baseball games, fishing and camping. Yes, those were simpler times and most of us didn't have to worry about summer jobs or much of anything responsible.

But then we got older and the world seemed to get more serious. American involvement in the affairs and well being of the rest of

the world meant more loss of life and more soldiers to bury and honor. The same television that finally allowed us to see the Indianapolis 500 also opened our eyes to the windows of the world. It surely added to our concern for and understanding of things well beyond Nebraska.

We had one television channel on which we watched the 1956 Republican National Convention – in black and white – and saw Nebraska's Terry Carpenter nominate Joe Smith for President. Joe was a figment of Carpenter's imagi-

nation – one that he parlayed into a fair amount of national publicity – and the whole thing was more entertaining than disruptive. It was one incident during one summer of my youth.

This summer we will be overwhelmed with two political conventions – covered in living color by far too many television stations for far too long a time – and a resultant volume of spin-doctoring that will last well past Labor Day.

This might be a good time to remember the simpler times of Decoration Day and the memories of war heroes and lost loved ones.

You can have your politics and all of the attendant controversy.

Just pass the potato salad and the ice cream, please and thank you!

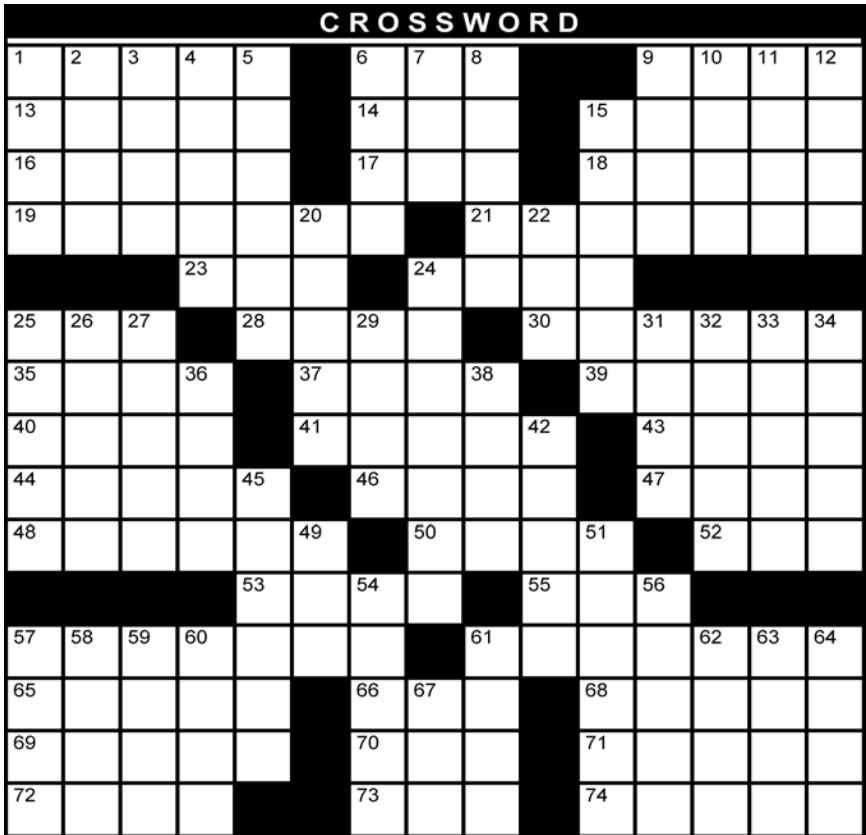

EPA mandates harm Nebraskans

Take a drive across Nebraska and you will see farm equipment almost everywhere: tractors, combines, center pivots, and more. You name it; chances are Nebraska producers use it. Year round, our farmers and ranchers rely on a wide variety of agricultural machinery to do their job of feeding the world.

Many of these producers store fuel in aboveground tanks on their property. Often, this is because they live miles from the towns where they can refuel.

While most fuel storage tanks are located miles from major waterways, Washington wants to regulate them anyway.

Despite the EPA's limited understanding of production agriculture, the agency believes these fuel tanks threaten water quality. Under a regulation intended for major oil refineries, known as the Spill Prevention, Control, and Countermeasure rule, the EPA wants to restrict the amount of fuel our ag producers can store on their land. This rule would force families to make costly upgrades to fuel storage tanks. It would also impose heavy fines if these tanks go over the on-farm fuel limit exemption mandated by the federal government.

As a cattle rancher, I understand the negative impact this mandate would have on our agriculture community. As your U.S. senator, I am doing something about it.

Last Congress, I successfully brokered a bipartisan provision in the 2014 Water Resources Reform Development Act, which was signed into law. My provision protected Nebraska's ag community from the SPCC rule by implementing a 6,000-gallon exemption for on-farm fuel storage. It also required the EPA to conduct a study to examine and determine the exemption threshold for on-farm fuel storage. The study was released last year and it quickly became clear that the results were based on flawed data.

EPA regulators claim we need this rule to protect water quality, but the facts tell a different story. In its study, the EPA failed to show that on-farm fuel storage poses a significant risk to water quality. The report cited seven examples of significant fuel spills, yet none of them occurred on a farm or ranch. Even more misleading, they pointed to one spill in particular that leaked 3,000 gallons of fuel. The only problem is, the liquid was jet fuel, something I have yet to find on farms in Nebraska.

Nebraska's ag community remains under threat by this burdensome rule and for no reason. That's why, last month, I introduced a bill that will address this issue head on.

My legislation, known as the Farmers Undertake Environmental Land Stewardship or "FUELS" Act, would provide relief for Nebraska families with on-farm fuel storage tanks. This bill completely exempts farms and ranches with 10,000 gallons or less of on-farm fuel storage. This exemption would also apply to farms with larger storage capacities of up to 42,000 gallons and no history of fuel spills. Finally, regardless of capacity, the exemption applies to livestock operations with animal feed ingredient storage tanks.

Both the Nebraska Farm Bureau and the Nebraska Cattlemen strongly support this legislation. I was glad to work with them to help ensure producers are not harmed by this unnecessary federal red tape.

We all want clean water. We all want to maintain a healthy environment. But the citizens of Nebraska know how to protect our state's resources better than bureaucrats in Washington.

Through common-sense legislation like the FUELS Act, we can work together to provide regulatory relief. I will continue this work to lower costs and cut red tape so that our ag producers can support their families.

Thank you for taking part in our democratic process. I look forward to visiting with you again next week.

Lake McConaughy, Harlan Reservoir among best in U.S.

Voters have selected two Nebraska lakes to a list of 100 family-friendly boating and fishing lakes in the nation.

Lake McConaughy and Harlan County Reservoir made the annual top 100 list, which is compiled annually by the Recreational Boating and Fishing Foundation.

"Lake McConaughy is located in western Nebraska at the edge of the beautiful Sandhills, which provide Lake Mac with more than 75 miles of white, sandy beaches, all of which are open to the public," said Colby Johnson, superintendent of Lake McConaughy SRA. "Boating and fishing infrastructure is located conveniently at several areas around the lake and anglers can target dozens of fish species."

Lake McConaughy is located near Ogallala in Keith County, and Harlan County Reservoir is located near Republican City.

Florida's Everglades National Park was voted the No. 1 place to fish and boat in America. The list was announced June 2 by RBFF. Nearly 650,000 votes were tallied nationwide in this America's Top Family Fishing and Boating Spots Sweepstakes - up 132 percent from 2015.

Criteria for the top places to boat and fish included having a public body of water within an hour of a major city, good fishing opportunities and family-friendly amenities.

RBFF also encouraged Nebraskans and anglers and boaters across the nation to celebrate National Fishing and Boating Week, June 4-12, by enjoying their favorite fishing or boating lakes.

RBFF is a nonprofit organization whose mission is to increase participation in recreational fishing and boating, thereby restoring and protecting the nation's aquatic natural resources.

One primary election recount ordered

One recount will be conducted in the wake of the May 10 primary election, Secretary of State John Gale said Monday. Gale and the other members of the Nebraska Board of Canvassers ordered a recount for Public Service Commission District 5 involving Republican candidates Jerry Vap and Mary Ridder. Thirty-six votes separated the candidates, led by Ridder.

Gale said the recount would be conducted starting Wednesday morning. Results will be presented to the Nebraska Board of Canvassers at 3:30 p.m. Monday, June 13, in the Governor's Hearing Room. The meeting is open to the public.

Vap had 21,877 votes and Ridder received 21,913 in the primary. State statute allows for an automatic recount if the margin of votes between candidates is less than one percent of the total votes received by the top vote-getter.

The board also considered a potential recount involving the Board of Regents race in District 6. That race was left off all ballots in Webster County, affecting 715 voters. The board voted to accept an e-mail notification from candidate Mary George, waiving her right to a recount.

Gale said normally, his office would have preferred to receive a signed letter from the candidate, but acknowledged that George was out of town at the time.

"After discussion, the board felt it was sufficient in this one circumstance to accept the e-mail confirmation of her intent."

The board then took up the issue of advancing all three candidates to the general election in that race.

"While George did waive her right to a recount, they recognized that such a waiver did not preclude the board from weighing whether all three candidates should advance in the general election. It was important to balance that decision with her right as a candidate if the probability was high that she was adversely affected in the primary election due to an error," Gale said.

Noting the margin of votes garnered

by the candidates in each county did not indicate a high probability that the error in Webster County adversely impacted the final outcome in that race; as well as the decision by George to refuse a recount, the board voted to certify the results of that race as submitted. As a result, Marsha Fangmeyer and Paul Kenney will appear on the ballot in November.

All other races, with the exception of the recount ordered for PSC District 5, were also certified by the board.

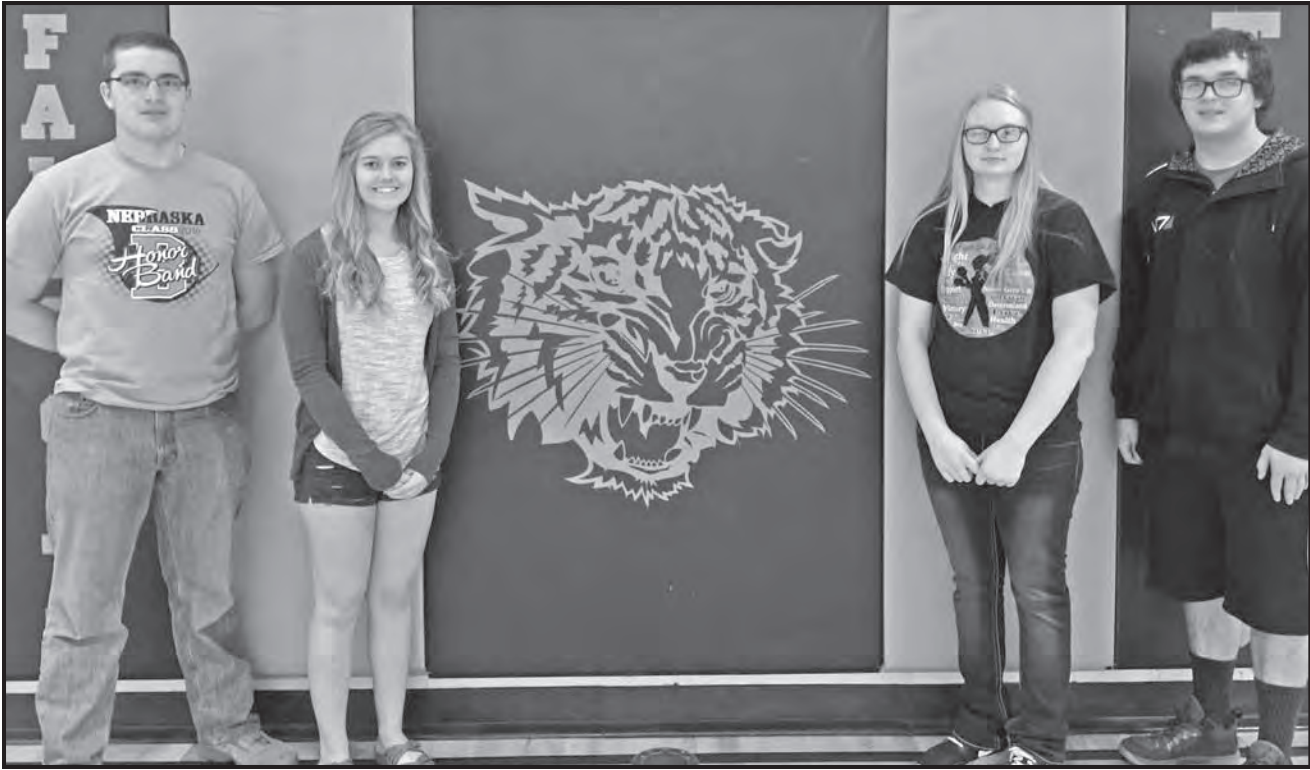

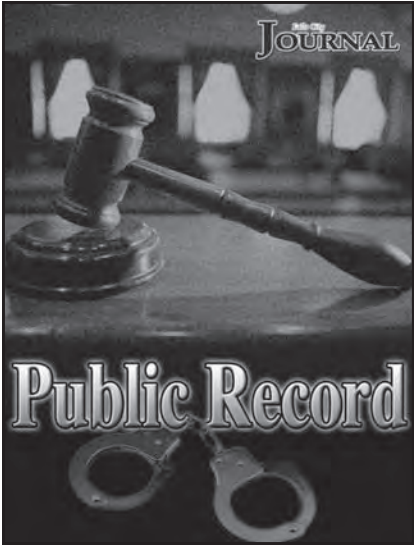

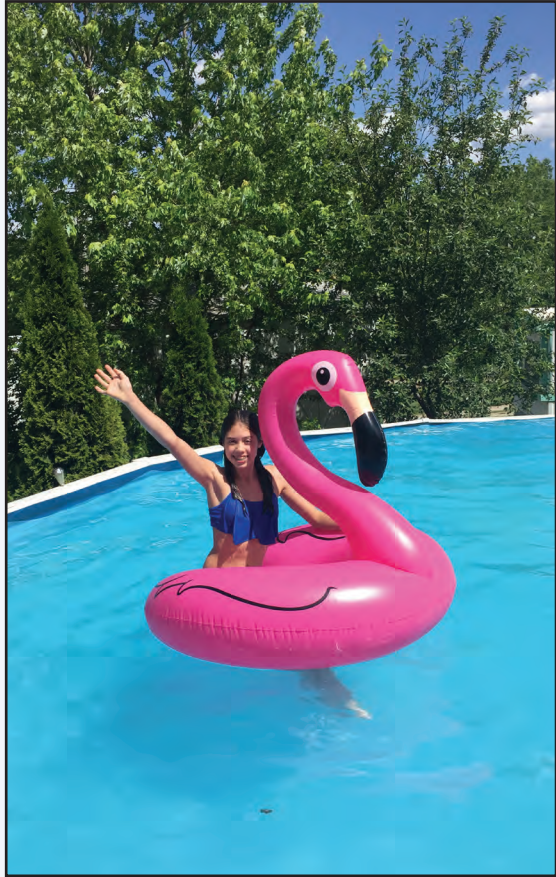

More than 80 high schools were invited to make nominations for the all-star squads.

‘State’ Legislature meets before statehood

On July 4, 1866, the first session of the Nebraska State Legislature convened. As most Nebraskans know, Nebraska did not become a state until March 1, 1867, when President Andrew Johnson signed a proclamation to that effect. How then could the state legislature meet some eight months before statehood? The answer is provided by a look at the complex political developments leading up to Nebraska’s official statehood. On April 19, 1864, the Republican-controlled Congress passed a Nebraska statehood enabling act. The act authorized the governor of Nebraska Territory to order an election for June 6, 1864, to choose delegates to a constitutional convention, followed by the convention itself on July 4. If the convention drafted a state constitution, it would be submitted to voters for approval at the October 11 territorial election. Presuming that the constitution was approved and it met congressional requirements, the President of the United States would proclaim Nebraska a state. As it turned out, most Nebraska voters in 1864 did not favor statehood, largely because they feared increased taxation to support a state government. They elected delegates to the constitutional convention who were pledged not to draft a state constitution and the convention adjourned immediately without doing so. When the territorial legislature met in January 1866, it was dominated by Republicans who favored statehood, as did the governor and other territorial officers, also Republicans. Congress’s 1864 Nebraska statehood enabling act was still in force. This time, the legislature simply drafted a state constitution to avoid the expense of holding a constitutional convention, and called an election for June 2,

1866, for the people to vote on the constitution and elect state legislators and state officers. The constitution provided that once it was approved, the state legislature would meet July 4, 1866, to elect two U.S. Senators for Nebraska since, in those days, Senators were not elected directly by the people. When the constitution was narrowly approved in the June election, Nebraskans assumed that statehood would soon follow but they were wrong. Not only did the President veto the first Nebraska statehood admission bill, the new constitution provided that only white men could vote. When a second Nebraska statehood bill was introduced in Congress, many members refused to approve it due to the “whites only” voting provision in the Nebraska constitution. It would not do to let Nebraska get away with this suffrage restriction when Congress was requiring the former Confederate states to write new constitutions giving male former slaves the vote. In February 1867, as Congress demanded, Nebraska’s legislature nullified the constitutional provision that limited voting to white men. In the meantime, the newly-elected state legislature convened on July 4, 1866, as the new constitution provided, and on July 11 elected John M. Thayer and Thomas W. Tipton as U.S. Senators-elect. The two men could not actually take their seats in Congress until statehood finally came on March 1, 1867. During this session, the essentially powerless state legislators did enjoy a benefit of office: an excursion on the Union Pacific Railroad then being built west from Omaha. On July 7 they rode three passenger coaches to the “end of track” near Columbus, where they watched the tracklayers at work and had lunch washed down with champagne before returning to Omaha that night. 

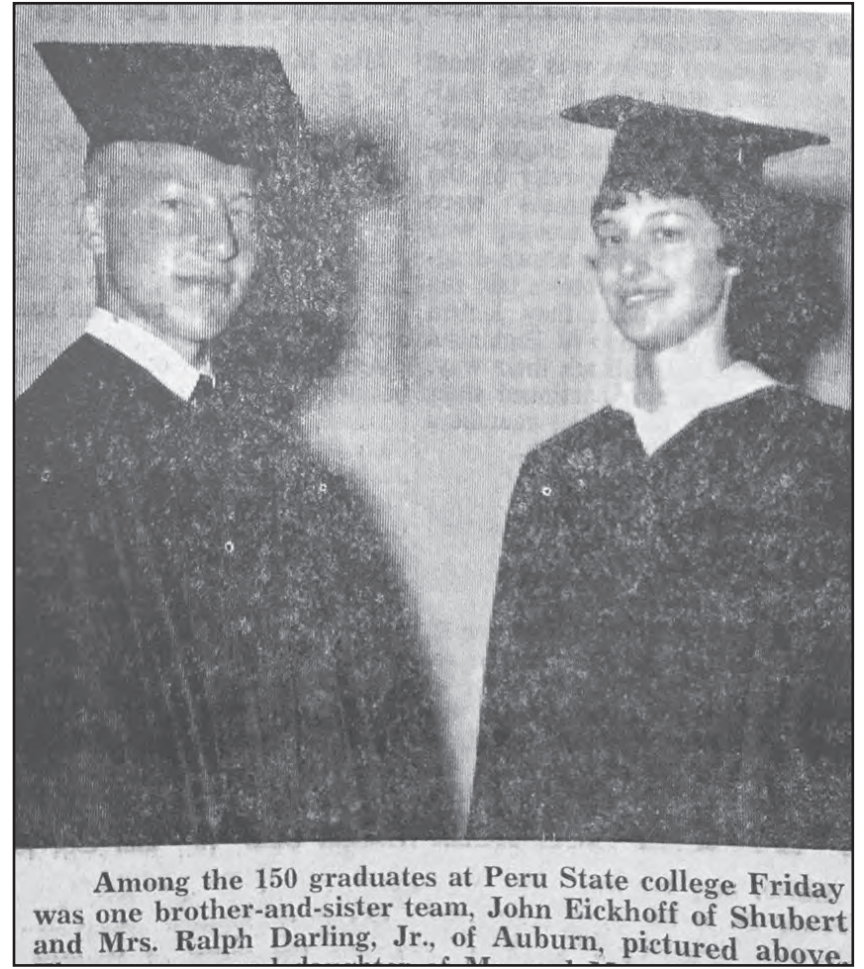
**50 Years Ago

Howard Todd, who retired from the U.S. Marines after 22 years of service, decided to make Falls City his home. Todd was an orphan and had no real home but enjoyed the small town life of Falls City and decided to stay.

With the nation's wheat reserves shrinking, farmers were encouraged to boost their production of wheat.

Approximately 600 people — 192 from out of town — attended the "old Weaver home" open house. Hostesses greeted guests in 1800's era gowns and took them on guided tours.

25 years ago

Fr. Brian Connor was the guest of honor at a going-away basket supper picnic at Dallas Jones Park. Fr. Connor was to be replaced by the Rev. Charles Townsend.

In an effort to bring awareness to the realities of polio, Gov. Ben Nelson designated June 1-7 Polio Survivors Awareness Week.

A daughter, Jessica, was born to Mr. and Mrs. Mike Ramsey, of Falls City. She weighed eight pounds and three ounces.

Work was underway on the repainting of the city water tower at 25th and Crook Streets. Workers hung suspended from the side of the dome, sandblasting the old paint off on both the inside and out before priming, painting and adding the finish coat. It was planned to take up to six weeks to complete.

Recently graduated FCHS golfer Chris Veigel carded the first hole-in-one of the season at the Falls City Country Club, aching the 152-yard fifth with a 7-iron.

A new flagpole was dedicated at the center of three ball diamonds at Dallas Jones Park.

Barney Meinzer threw out the long-awaited ceremonial first pitch of the 2001 FC Summer Recreation softball and baseball season. It was the first pitch ever at Grandview Park, which was renovated in the off-season.

and (East AD) Wendy Henrichs about whether I was the right person here. Wendy assured me that I was.”

And Henrichs proved to be right. Prichard’s 10th team at East ended up having the kind of season in 2015-16 that most squads can only dream about. The 23-5 Spartans won their final 12 games, a streak that included both the district and Class A state titles.

“This year was good for me, no question,” said Prichard, who owns a 389-182 career record. “It’s re-energized and motivated me. It’s given me the confidence to know I’m going to be OK here.”

While this year’s Spartans carried out Prichard’s basic basketball philosophy of uptempo offense and full-court pressure defense, the team came together as a group in a way no previous squad under his watch ever had.

“The seniors took this team over and everyone bought in from top to bottom. I didn’t have to do much in terms of team bonding and chemistry,” Prichard said, referring to the senior starting group of Super-State guard Grace Barry, guard Caroline Spethman and the 6-foot duo of Elyssa Jurgens and KJ Roh.

“We got a great routine going and the kids were locked in every practice and every game,” the coach added. “Their confidence grew as the season went on, and we had so many kids step up and make plays at crucial times in the state tournament.”

Prichard, a Falls City native and graduate of FC High, had no intention of teaching and coaching when he left to go to Missouri as a broadcast major.

“I discovered pretty early I didn’t have the personality for it,” he said. “I knew it before I got done there, and I should’ve changed majors, but I didn’t want to quit.”

In the fall of 1986, Prichard came to Nebraska in hopes of working on his masters degree and getting involved in sports information

work. That lasted one semester.

“I knew then I needed to do something different,” he said. “I realized I needed to be closer to athletics than that.”

So he went back to Peru State to get his teaching endorsement and joined his friend, Doug Goltz, on the coaching staff at Sacred Heart. Prichard was a social studies/physical education teacher, an assistant football coach for all 17 years and a boys basketball assistant coach for 11 seasons, including eight seasons when he was also girls head coach.

Sacred Heart’s football team won six straight state titles from 1989 through 1994, and the boys basketball team took home four straight from 1988 through 1991. He became the girls head coach in 1989.

“It was a head coaching job and an advancement,” Prichard said. “I wasn’t trying to get into girls basketball, but now I’m glad I did.” Prichard’s girls basketball teams won three straight Class D1 titles in 1998, ’99 and 2000, and reached the state finals in 2002 and ’03. His Sacred Heart teams went to state eight straight years from 1996-2003.

Prichard became Sacred Heart’s head track coach in 1991 and led the boys and girls teams to four state titles each during his tenure.

An opportunity to jump into college basketball came at Peru State in 2003. But after two seasons, Prichard knew it wasn’t a good fit.

“I was a little naïve, I thought I could get things turned around there,” Prichard said of the move to Peru State, which allowed him to get his master’s degree. “I discovered that I’m not a recruiter, it’s not my personality. I thought it would be best to get back into high school.”

Now after 10 years as a coach and social studies teacher at East and with a state title under his belt, Prichard thinks he’s found a home.

“My family is entrenched here now,” Prichard said, referring to his wife, Pam, and daughter Natalie. He also has two older stepdaughters, Ellie and Hannah. “I’m not looking to go anywhere else.”

rider weave among a line of poles, careful not to knock any over.)

“Levi weaves the poles really well,” Ella said. “He changes leads very smoothly.”

None of those events were part of the Missouri princess contest, though. The only category on horseback was “horsemanship.” For that event, each of the contestants had to demonstrate her poise in the saddle while following a list of judges’ commands. Those commands included loping around the arena while carrying the American flag.

“It’s actually harder than it looks because the flag has to be held a certain way,” Ella said.

She must’ve made it look easy then, because she won that category, too. In the interview session, the judges asked a wide variety of questions, including the name of the celebrity rodeo star for whom Ella would most like to work. She chose Fallon Taylor.

“Fallon runs a program called ‘what the helmet,’” Ella said. “She tries to get people to wear helmets while riding their events. Rodeo is a fast sport, and people do get thrown off of their horses. I just think it’s smart to compete with a helmet on. I always wear one when I run barrels.”

That was a first place answer.

The last two categories that Ella won were the “written test,” and “personality” portions. The written test featured 50 questions about rodeo events and the MJHRA’s corporate sponsors. The personality category was all about—well—personality. In other words, the character and individuality that each contestant showed as she competed in all of the other categories.

Ella’s personality won the judges over, and that comes as no surprise to this writer. During our interview, she showed a personality that would endear her to any judge. For example, when asked how often she practices, she said, “I practice every day, whether it’s in the arena, or just riding my horse to make him stronger. But it’s doesn’t really matter how much you practice.

What matters is how much you want to practice.”

That was spoken like a true princess. But that answer wasn’t a “miss” at all. In fact, it was a very huge hit.
