
What a different July 21! Normally, we and all our county farmers would be praying for rain on very thirsty corn and beans.

Many residents unhappy with DOR plan to take a lane from Harlan Street

The Nebraska Department of Roads hosted a large crowd of citizens at a public information open house regarding a proposed change of U.S. Highway 73 at the Falls City Senior Center last Tuesday, July 14.

Most folks who came out were not in favor of the new three-lane design. DOR District 1 Engineer Tom Goodbarn said the three-lane design is being done all

over the state and works very well. He noted the concern of truck traffic and proximity of businesses, but explained that with a three-lane highway, a center turn lane flows easier, allowing traffic to separate and not leave others stopped

behind others making a left turn.

On Harlan Street, from 19th Street north, all current medians are planned to stay.

turn lane.

The proposed project is estimated to cost \$2.9 million and would be paid for by federal and state funding sources. To overlay the highway would cost roughly \$1.9 million.

Identified as In Falls City and North, the proposed project would resurface about 2.94 miles of US-73, starting at 7th Street, just north of the southern corporate limits of Falls City, and extending to approximately one mile north of the northern corporate limits of Falls City.

The purpose of this proposed project is to preserve the US-73 transportation asset, improve the reliability of the transportation system and perpetuate the mobility of the traveling public. The project need is based on the current condition of the roadway.

The planned construction would consist of milling and resurfacing the existing roadway and shoulders. Additional improvements would include stabilizing the surfaced shoulders, earth shoulder construction, transitioning foreslopes, concrete repairs, ADA curb

ramp construction, grading, and removing guardrail.

The four-lane section from 7th to 19th Street would be reduced to three lanes, which would include a northbound, southbound, and a center two-way left-turn lane. The three lanes would be reconstructed with full depth oncrete pavement.

This project would require the acquisition of additional property rights

The four-lane section from 7th to 19th including new rightof-way (ROW), and Street would be reduced to three lanes, temporary easements which would include a northbound, (TE) due to the proposed reconstruction southbound, and a center two-way leftof sidewalks and curb ramps to meet ADA requirements. Access to adjacent properties

> would be maintained during construction, but may be limited at times due to phasing requirements. Impacts to wetlands are not anticipated.

> Construction could begin as early as spring of 2017 with completion by fall of the same year. The proposed project would be constructed under traffic, with lane closures controlled with approved temporary traffic

> The public is being encouraged to make suggestions or express concerns regarding this proposed project. Comments will be collected through July 29. Jeffrey Allen Schmahl, 58, former well-known television reporter, founder of Nebraska football's famed "Tunnelwalk," and author of the popular inspirational blog The Last Train, passed away in the early morning hours of Tuesday, July 14, at his home in West New York, NJ, following a 15-month battle with pancreatic cancer.

Among the survivors is Jeff's sister, Judi (Bill) Carter, of Falls City, recently retired 35-year educator with FC

Public Schools. A Celebration of Jeff's Life will be held at 2 p.m. Saturday, Aug. 8 inside Memorial Stadium, West Stadium - Club Level 3. "Here

we'll be celebrating Jeff's life, accomplishments and sending love up his way. Anyone who knew him, loved him,


was inspired or impacted by him is more than welcome to join us on this day of remembrance," his family posted on The Last Train

website late Monday. "For those unable to join us on this special day, we will be posting a fund to donate in his memory for any person who feels like giving. Please do this instead of sending flowers."

The Falls City Travelers 14-and-Under Softball Team saved its best for last in 2015, capturing the ASA Class D State Tournament Championship this Sunday in Hastings. FC entered the event with a pedestrian 14-12 record and didn't finish higher than third in any regular season tourney, but Coach Rich Witt's girls got on a roll at the right time, posting a perfect 5-0 record over the course of two days. After a pair of blowout victories over Friend (13-0) and Pierce (14-2) Saturday morning, the Travelers earned a come-from-behind 16-9 win over O'Neill that night, overcoming an early 4-1 deficit and breaking a 6-6 tie with a 10-run fifth inning explosion. Sunday, FC advanced to the title game with a dramatic comeback over Albion. Trailing 4-3 after five complete innings, FC used a one-out, four-run sixth to get the upper hand in a 10-6 win. Albion defeated O'Neill to set up a rematch with FC, but they hardly had enough left in the tank to touch FC pitcher Maggie McNeely, who tossed a two-hitter over seven innings in a 5-0 championship game victory.



The state championship was the fifth in three years and ninth overall for the Travelers program, which next summer will celebrate it's 20th season.

"This was kind of a rebuilding season for us," Travelers founder and coach Carl Messner said, "with a lot of new players and a lot of young players at all age groups. We didn't field a 18-under team this year, not having any older players. But even with just four age groups we still won 82 games, finishing the season 82-49-1, and also went over the 1,200-win mark."

"I'm looking forward to next year; we will be more experienced at all ages and will have 18-and-Under again. I'm setting a goal to next year's players to win at least 90 games, so we can top the 1,300-win mark."



State planning 150th birthday and times have changed

Sesquicentennial, a one-hundred-and-fiftieth anniversary.

The planning has begun. The Governor and his wife have unveiled the logo for the event and announced that it will be happening in 2017. Thus, it has begun. Historians will look at the past 150

years and begin their analysis. **Futurists** will prognosticate. It's likely too

soon to tell what celebration will entail, but one could look at

the last time Nebraskans honored a historic milestone -- the quasquicentennial or 125th Anniversary. There were 1,243 sanctioned statewide events during the yearlong recognition in 1992. That's more than two celebrations per each of Nebraska's 535 cities and villages.

It was an unusual time in Nebraska. The University of Nebraska-Lincoln Cornhusker football team had lost a bowl game - been shut out even -- in a 22-0 loss to Miami in the January 4, 1992, Orange Bowl. Tom Osborne's team finished as Big 8 Champions and had a 9-2-1 record.

There was a Democrat in the governor's office - Ben Nelson who would go on to serve two terms. Nelson – who actually was more of a political centrist - had defeated Republican Kay Orr, the state's first woman governor who had sought a second term. Mrs. Orr had defeated another woman, former Lincoln Mayor and Democrat Helen Boosa-

lis, for the job four years earlier. Nebraska had 1.596 million population. Lincoln, the Capital City, had just short of 196,000 residents. The official Birthday Bash - August 22, 1992 - was held on the lawn of the State Capitol. Seeing anything - short of "keep off the grass" signs – on that lawn was highly unusual. But there it was on a bright August day. Everything from Lincoln resident Gary Kuck's Great American Race winning 1936 Ford to a number of large birthday cakes. Historical displays and vendors dot-

ted the grounds. The evening events were planned for Seacrest Field, Lincoln Public Schools' 30-year-old athletic field that had room for 10,000 spectators. In those days, the only turf that was more sacred than the beautifully manicured Capitol lawns, was at Memorial Stadium. The field and the stands, which seated about 70,000 people, were for Nebraska football and Nebraska football alone, thank you very much.

So it was that a capacity crowd paid \$2 per ticket for the event at the southeast Lincoln stadium to enjoy a "first-time-ever-in-Lincoln-history" outdoor laser light show and listen to country singer Billy Ray Cyrus and comedian Bill Cosby.

Cyrus, whose hit single "Achy Breaky Heart" had just become a cross-over sensation climbing the charts, brought the house down with a tribute to Nebraska grocery store chain Hinky Dinky by changing the words to "don't you take my Hinky Dinky cart." The 54-year-old Cosby did the same thing with his routine on a visit to the dentist, among other popular stand-up favorites.

These were simpler times. Cyrus' daughter Miley was born three months later and took years to become a popular entertainer as sweet Hannah Montana and then a not-so-popular edgy performer. Cosby had, likewise, not fallen

from grace amid allegations of

sexual misconduct. Nebraska now has 1.826 million people. Lincoln has grown to 258,000. Ben Nelson has been a U.S. Senator and retired. Tom Osborne has

been a U.S. Congressman and failed Republican gubernatorial candidate and retired. Memorial Stadium has

hosted Farm Aid concerts and Larry the Cable Guy and high school football championships. The Husker football team has lost its share of bowl games and had several coaching changes in the past 25 years.

Seacrest Field has just undergone a \$4.5 million renovation. But Lincoln also has the Pinnacle Bank Arena and a newly expanded entertainment venue - the Haymarket that would likely get the nod for the 150th Birthday bash.

Here's hoping that the logo, an Art Deco inspired ear of corn using inspiration from the state Capitol and paying homage to Nebraska's agricultural backbone, will be only the beginning of a great event for all Nebraskans to share.



and Iris (Vicki) Schmahl. The family moved from Minnesota to Grand Island when Jeff was in grade school and Al Schmahl began a long and distinguished career at the Grand Island Independent. Jeff graduated from Grand Island Senior High in 1974 and from the University of Nebraska in 1978 with a degree in broadcast journalism, following in his father's shoes. While at UNL, Jeff was a four-year letterman on the Husker tennis team. He was married to Maria Ramirez on Dec. 19, 1981, in Lincoln. Schmahl worked as a television sportscaster for 14 years at KOLN/KGIN in Lincoln. He started working for the UNL Athletic Dept. in 1993, taking a leadership role in the creation of HuskerVision and became known as the founder of the Huskers' famed "Tunnel Walk." In 2003, Jeff followed former Nebraska AD Bill Byrne south to Texas A&M to become Senior Associate Athletic Director for the Aggies, in charge of External Operations.

After retiring in 2013, he and his wife moved to New York City to join as co-owners of Schmackary's, a cookie company their son started near Times Square.

He learned on April 16, 2014 that he had pancreatic cancer and that it had spread to his liver. Weeks later, on May 6, the son of a newspaper man and marvelous award-winning communicator with a legion of friends started *The Last Train*, prosing to friends, family and fans on life and death and enriching all that occurs in the meantime.

"I hope my words encourage you to make the most of the train ride you are on right now," he wrote in that first entry. "That's really what is important to make the most of your life right now and to have a positive impact on the people in your life right now."

Schmahl's last entry came just more than a year after his first, on May 14, 2015 (his son, Zach, wrote an update on July 8, a video tribute created by one of his former students was posted on July 10 and news of his passing was shared by his family that morning).

"It's been almost 14 months since my diagnosis and I am truly thankful not just for the time I've been given but especially for the quality of life I've been able to experience," Schmahl

FSA declares disasters for nearby counties

Farm Service Agency, Denise Lickteig announced that Nemaha, Johnson, and Pawnee are three of 28 Nebraska counties designated as contiguous natural disaster areas due to severe storms, tornadoes, straight-line winds, and flooding conditions affecting parts of Nebraska. Other counties include Banner, Box Butte, Butler, Chase, Cheyenne, Clay, Custer, Dawson, Dodge, Douglas, Fillmore, Frontier, Garden, Hayes, Hitchcock, Keith, Logan, McPherson, Perkins, Sarpy, Scotts Bluff, Seward, Sheridan, Webster and York.

These counties were designated a Presidential Major Disaster on June 30, 2015, based on an May 6 to June 17, 2015 storms. This designation authorizes Emergency Loans for eligible producers. Lickteig stated, "Producers in these counties are encouraged to contact their local FSA Service Center for detailed information about available programs and updated disaster designations."

Emergency Loan applications are available for qualifying physical or production losses caused by these disaster conditions. Physical losses include structures, equipment and livestock while production losses include crops. These loans do require security and the ability to repay the loan. The deadline for submitting applications is Feb. 25, 2016. For more info, contact the Nemaha FSA office at 402-274-4987.

In addition to the EM Loan

Program, the FSA has other disaster assistance programs which can be considered in assisting farmers to recover from their losses. Contact your local FSA Service Center or access additional information about Farm Loan and FSA Disaster Assistance programs at www.fsa. usda.gov

Travelers will threaten 1,300 wins in '16, it's 20th ball season

The Falls City Travelers' 14and-Under Softball Team beat Albion 5-0 Sunday afternoon in Hastings to win the ASA Class D State Softball Tournament. Pitcher Maggie McNeely threw her best game of a tremendous tournament in which she earned all five victories. In the championship, she faced 27 hitters, surrendering just two hits in seven complete innings.

FC entered the tourney with a pedestrian 14-12 record and its third-place league tourney finish was its best of the regular season, but Coach Rich Witt's girls got hot in Hastings. After a pair of blowout victories over Friend (13-0)

and Pierce (14-2) Saturday morning, FC earned a come-from-behind 16-9 win over O'Neill that night, first overcoming an early 4-1 deficit in the third inning. With two outs and third baseman Teresa Morehead and catcher Randee Witt both on base with singles, Abbey Balfour drilled a pitch to left. It sailed over the left fielder's head and seemingly never stopped, allowing Balfour to earn a true inside-the-park homer. Two frames later, FC broke a 6-6 tie with a 10-run fifth inning explosion. Witt (3-for-4, three runs scored) and Hannah Kirkendall (who reached all four times she got up) each had two base-clearing hits in that inning and the team brought seven girls to the plate and they all eventually scored - before O'Neill even recorded a single out.

The following morning, FC jumped out to a quick 3-0 lead on Albion in the first, as shortstop Chloe Schock hit an RBI single to score leadoff hitter and second baseman Mackenzie Witt. Mc-Neely drove in Schock and then scored herself on an RBI double by Randee Witt. Witt, however, was stranded at third and the Travelers' bats, after Albion tied it at three apiece in the second, suddenly went silent, with the exception of Morehead's. She hit a leadoff double in the third, only to stand stranded at third three batters later. After FC went in order in the fourth, the third baseman hit a two-out single in the fifth, but was caught trying to steal second to end the inning.

FC took control in the fifth. Trailing 4-3, McNeely and Randee Witt each got one-out hits and scored on a deep drive to left by Saturday night's hero, Abbey Balfour. Nadia Klein, a substitute left fielder who last played organized softball in preschool, recorded her first official hit since T-ball, crushing a triple to left, scoring Balfour. Klein then scored on a sac fly by Kirkendall and FC suddenly led 7-4. Mackenzie Witt, Morehead, McNeely and Randee Witt then all came up with offense to produce three insurance runs in the seventh and McNeely recorded a pair of strikeouts in the bottom half to send her team to the title game.

Albion defeated O'Neill to set up a rematch with FC, but they hardly had

New Commitments

Nebraska continued its hot start to the 2016 recruiting cycle, added five new pledges since June 19. From June 24-26 the Huskers added three players and on July 16 added two more.

TE Jack Stoll (6-5/225) of Aurora, CO, was first, followed the next day by LB Greg Simmons (6-2/225) of Fort Pierce, FL, and then LB JoJo Domann (6-1/208) of Colorado Springs. July 16 gave NU CB DiCaprio Bootle (5-11/170) of Miami, and OL Boe Wilson (6-2/277) of Lee's Summit, MO.

Nebraska won a recruiting battle with Texas for Stoll's pledge. He's a versatile prospect, with the size and physicality to block along the line of scrimmage along with the athleticism and hand-eye coordination to catch difficult balls in traffic. Colorado and Colorado State had also offered, and Wisconsin was recruiting hard

Simmons was originally committed to Miami, but after an unofficial visit to Lincoln in early June he reneged on his pledge and opened things up. That didn't last long either, as by late June he was calling Huskers LB coach Trent Bray to commit. Maryland, NC State and Tennessee had also offered. Simmons called NU 'utopia', and also cited the 'family feel' he got from current Huskers De'Mornay Pierson-El, Avery Anderson, and Kieron Williams. He already looks like a college linebacker, but what sets him apart is his intelligence and intensity on the field. Watching his film you see someone who 'plays fast'. He doesn't think – he reacts. That fits with the system the NU defensive coaches have been preaching.

Domann was Colorado's Defensive POY as a junior while playing on the same team as Anderson. Arizona State, Cal, K-State and North Carolina also offered. Like Simmons, Domann mentioned the family aspect in Lincoln among his reasons for choosing NU. A versatile player, Domann projects as a linebacker, safety, or hybrid of both positions. He's a winner as well. After his team started 0-2 his sophomore year, Domann was inserted into the lineup and they have won 25 straight games and two state titles

After being one of the most impressive performers at Nebraska's Miami satellite camp in June, Bootle and his family made the trek to Lincoln for a four-day unofficial visit. At the end of the first day he'd seen enough to end his recruitment. Bootle cited the people that he had met, both at the camp and on campus, as the primary reason for his pledge.

After running a 4.34-second 40-yard dash and competing well in drills at the camp, NU was Bootle's first 'big-school' offer. He also boasts a 10.64-second 100-meter dash and a 4.4 GPA. Illinois, Tennessee, Washington and Wisconsin were all recruiting him, but the opportunity in Lincoln was too much to pass up.

Commitment No. 14 was Wilson, who chose the Huskers over offers from Indiana, Kansas, Louisville and Purdue and interest from Arkansas and Missouri. His final two schools were Nebraska and Louisville. A big reason for his decision was his relationship with offensive line coach Mike Cavanaugh.

"(Cavanaugh) is a great guy and a great coach," Wilson told Husker Online. "He gets me fired up. That was a big reason why I chose Nebraska."

Coming from Lee's Summit West, a perennial state title contender in Missouri's largest class, Wilson projects as an interior offensive lineman. A redshirt year to work on his strength and his pass-blocking skills is expected, but Wilson should be competing for playing time in a couple of years.

Halfway There

With 14 prospects committed, Nebraska is around half done with this class. Adding the recent dismissal of receiver Kevin Gladney to the prior departures of kicker Mauro Bondi, quarterback Johnny Stanton, receivers Glenn Irons and Jariah Tolbert, linebacker David Santos, and safety Leroy Alexander, brings NU's scholarship count down to just 81 of the 85 allowed. Counting graduating seniors and potential early exits for the NFL (i.e. Maliek Collins and Vincent Valentine) and the 2016 recruiting class could reach 26-27 players. Three positions of significant need remain.

At defensive end NU is pursuing Noah Fant (6-5/210) of Omaha South, Mykelle McDaniel (6-4/255) of Loganville, GA, Carlo Kemp (6-3/250) of Boulder, CO, and Amani Bledsoe (6-5/265) of Lawrence, KS.

Fant has pushed back his decision multiple times to take additional visits, and is still considering Cal, Vanderbilt, Iowa and UCLA along with Nebraska. He's planning to decide before his senior year. McDaniel's former teammate, LB Mohamed Barry, has arrived in Lincoln for his freshman season and is actively recruiting McDaniel. It appears that Florida and NU are his top two and South Carolina is still in the mix as well. Alabama, Florida State, Georgia, LSU and USC have also offered. Kemp, Colorado's top-ranked prospect, has yet to narrow his list of 30-plus suitors. He's mentioned visiting NU along with Washington, Oregon, Michigan and UCLA. Having Domann and Stoll committed along with '15 signees Anderson and Eric Lee helps NU, but Kemp has a lot of options.

Bledsoe is the top prospect in Kansas and has schools like Florida State, Ohio State, Oklahoma and Oregon also on his tail. Kansas, Missouri and NU seem to lead, but it's a long way until Signing Day.

The top OT on NU's board is Matt Farniok (6-5/319) of Sioux Falls, SD. Nebraska leads, but Stanford and Iowa remain high on his list and his brothers played at Oklahoma and Iowa State. He won't decide any time soon, but this one feels like Nebraska's to lose.

Alaric Jackson (6-7/285) of Detroit, plans to visit Lincoln unofficially before the end of July after finishing up an AAU basketball tournament in Las Vegas. Last year was Jackson's first year playing high school football after being primarily a basketball player growing up. He's not going to step in and play as a freshman, but his physical potential is impressive enough to list Nebraska, Iowa, Michigan State and Wisconsin among his double-digit offers.

Two other tackle targets are Willie Allen (6-7/300) of River Ridge, LA, and Scott Lashley (6-6/298) of West Point, MS. Pulling either of them out of SEC country will be difficult. Allen has consistently mentioned Nebraska in updates, however, no visit has been scheduled, and he has taken trips to Auburn and Ole Miss with others planned for Georgia, TCU and LSU. Lashley recently listed Nebraska in his top 10, along with names like Alabama, Georgia, Auburn, Wisconsin, Florida and Florida State.

At receiver, Clyde Leflore-Chriss (6-0/170) of New Orleans, Stephen Smothers (5-11/150) of Reisterstown, MD, CJ Riley (6-5/188) of Coconut Creek, FL, and J.D. Spielman (5-8/173) of Eden Prairie, MN, are still in the picture. Chriss lists NU in his top five along with LSU, Ole Miss, Texas A&M and Texas Tech. He also has visits planned to Mississippi State and Troy. Smothers has already scheduled his official visit to Lincoln for the Nov. 7 Michigan State game. He has also scheduled trips to West Virginia and Penn State. West Virginia leads, but if Smothers visits Lincoln things could change considerably. Riley is scheduled to be in Lincoln for an unofficial visit July 20 along with his parents and sister. The stop is part of a long road trip he's taking, visiting Cincinnati, Duke, Kentucky, Pittsburgh and Vanderbilt as well. All of those schools have offered, along with West Virginia. Spielman also holds offers from Iowa, Michigan and Minnesota. He's seen Michigan unofficially, and plans trips to Baylor, UCLA, Nebraska, Iowa, Arkansas, Minnesota and Wisconsin this summer.





Creighton-bound Omaha Marion All-State senior libero Brittany Witt, daughter of Tom (Cindy) Witt,

of Falls City, and Tracy (Bob) Darnell-Kill, of Omaha, last month was named to the All-Tournament Team at the AAU Nationals in Orlando, FL, for the second time in three years.

The 5-7 defensive specialist led the Nebraska Juniors (18s) to a sixth-place finish out of 39 teams in the open division, which is the top of four tiers. There were a total of 205 teams participating.

The senior-to-be accepted a scholarship offer from Creighton before her

How parents can simplify students' transition to college

College is the first taste of true independence many young students experience. Whereas mom and dad were always around to make sure kids were out the door on time and homework was done, that safety blanket is no longer there once kids move into their dorm rooms.

The transition to college life can be exciting. But while students typically welcome that transition with open arms, parents often worry about how their children will handle their suddenly more independent life. Parents who want to help their kids make as smooth a transition to college life as possible can take steps during their children's senior year of high school to help them adjust to their new surroundings and responsibilities more eas-

• Let kids fly solo on school day mornings. New college students have to make many adjustments upon moving into their dorms, and getting themselves out of bed each morning and off to class on time is one such change. Parents worried that their students will sleep in when mom and dad isn't around to remind them to wake up can start letting kids fly solo on school day mornings during their final year of high school. Let kids set their alarms, prepare their own breakfasts and get out the door on time all on their own. By the time their freshman year of college arrives, kids will know how to handle their mornings by themselves.

• Teach kids how to develop budgets. Another problem many firstyear college students encounter is an inability to effectively manage their money. Whether you plan to give kids an allowance while they are in school or intend for them to work part-time for their spending money, use senior year of high school as an opportunity to show kids how to budget their money. If they don't have accounts already, open bank accounts in your youngster's name, and insist that he or she start paying for his or her expenses via these accounts. Resist the urge to give high school kids gas money or money for shopping trips if they have already spent their allowances so they can learn how to effectively manage money between paydays. In addition, teach kids about the right and wrong ways to use credit cards, including the importance of paying balances in full and on time.

• Let kids handle more standard responsibilities. Adults tend to take more mundane responsibilities like making doctor's appointments or grocery shopping for granted. But kids likely have no idea how to handle such tasks. Parents can encourage their high school seniors to make their own medical appointments. In addition, take kids along on grocery shopping trips, explaining how to find sale items and which foods to buy and which to avoid. Nutrition is not always foremost on the minds of college freshmen, but those who understand the importance of healthy diets are more likely to buy nutritious meals than junk food.

• Emphasize time management. Today's high schoolers are busier than ever before, so many may already be prepared for the juggling act that is college life. But college students have more free time than their high school counterparts, so parents can emphasize the importance of managing that free time wisely as opposed to spending it lounging on the couch or napping.

The transition from high school to college can be both exciting and difficult. But parents can get a head start on that transition by encouraging their youngsters to be more independent during their final year of high school.





Bikes lead to helicopters each of past two weekends

Two Falls City residents were injured in a motorcycle accident east of Falls City just after 6 p.m. Sunday, July 19.

Jason Tilton, 36, was driving a Honda Rebel northbound on 655 Avenue, less than one mile south of Hwy. 159, when, according to the Richardson County Sheriff's Office, he lost control of the bike, left the minimum maintenance road and crashed into the east ditch.

Tilton and a passenger, 34-yearold Tara Tackett, were both taken to Community Medical Center by a personal vehicle and treated for injuries. Tilton was later transported by helicopter to another hospital.

The accident came eight days after two Sabetha, KS, men were injured in a two-bike accident that occurred as both were traveling west on Hwy. 8 at about 647 Road (less than three miles east of Salem and just east of the highway's sharp curve to the north).

The 911 call came in at 7:51 p.m. Saturday, July 11, and members of the Sheriff's Office, FC Police and FC Ambulance Squad responded. A saddle bag on the bike of Donald J. Kohake, 55, allegedly fell off his motorcycle and onto the highway, where it may have caused Jeff M. McClafferty, 31, to lose control of his motorcycle and collide into the back of Kohake's bike.

McClafferty was transported to CMC for treatment of his injuries and then taken via Life Flight to another hospital. Just after 9, Kohake was arrested on suspicion of driving under the influence of alcohol.

No tornado last Wednesday, despite warnings

Last Wednesday, July 15, a line of strong storms moved through southeast Nebraska and Richardson County shortly after 9 p.m., prompting the National Weather Service to issue a tornado warning.


Trained storm spotters did not spot a tornado, contrary to popular belief, according to Richardson County Emergency Manager Brian Dixon.

The warning was issued based on what was indicated on the radar. Trained storms spotters in our area did not see any indication of a tornado. Radar, on the other hand, indicated wind rotation at high altitudes that could have possibly produced a tornado.

Residents of Falls City were confused as to why the sirens did not sound in town. Dixon said because of the small area affected, it would not have been a good idea to sound sirens for an event that was not actually taking place.

The storm, located south of Dawson, was moving in a direction that would not directly effect Falls City. Even though radar indications are not as reliable as trained storm spotters, Dixon said there are benefits to the warnings, even if they are not 100 percent sure of a definite tornado.

He said there are times where its better to be safe than sorry.

Dark sarcasm in the classroom

Five of Maze's short films to be shown Thursday at FC Golf Club

Local filmmaker and UNL senior Brent Scott Maze will hold a film fundraiser to help finance his latest, darkest project, Faces and Stones, this Thursday night at the Falls City Country Club.

Five short films - beginning at around dusk - will be shown (for a small donation of \$1 per movie; or whatever you can afford to invest in a local artist) that the Internet, including:

— *Infinite*, where within a series of visits to his psychiatrist, a young man finds his way to the roots of a mysterious recurring dream, but discovers much more than he bargained for;

-The Shed of Our Skin, an exhausted detective turns to a colleague for information in an attempt to finally get one step ahead of a sociopath he has been hunting for years;


—Identity of Another, this heavily stylized, neo-noir, short film examines the frantic, yet suspenseful aftermath of a young criminal's most recent hit. Through a turn of events, he is forced into impersonating the man he just disposed of;

—Ambulance, after being brutally beaten and left for dead, a wealthy playboy finds aid in a passerby with indecipherable motives; and,

—Kale and Marco Witness a Murder, in this short comedy, two young stoners accidentally become witnesses to a brutal murder. However, after being paid off by the killer with a briefcase full of cash, they have a difficult decision ahead of them.

Maze is seeking financial backing for Faces and Stones, which he hopes to start shooting at the end of next month, which happens to be the beginning of the end for him at UNL (he said he hopes to perhaps even graduate a semester early, in December). The production is larger than any of his other projects up to this point. Unlike his other films, Maze is employing others to handle shooting, lighting, etc., while he concentrates on direction.

The story is as strong as anything he's done, as well. The script centers around a young photographer/ small-time weed dealer, played by Falls City native and Ambulance lead Tyler Sells ("he's my go-to guy") who takes a risk at big money in a one-time drug deal (of a hallucinogen called "2CE") that goes a bit awry. In a dark isolated mansion, the character discovers that a long-presumed dead girl is being held captive by a dirty cop and his perverted buddies. Eventually, the scene drops a level to the cellar, where a bizarre human sacrifice/acid trip/pig party is just getting good before the photog saves the day (and the girl). But due to his reputation, nobody — except, in the end, a reporter — believes him.



The latest from Brent Scott Maze will behave yet to be released on gin shooting at locations in and around both Lincoln and Falls City at the end of August.

"Exploring the life, mind and soul of the anti-hero or underdog is something I have always been and will continue to be intrigued by," he said. "I didn't purposefully write it as a horror film, but it's going to be pretty dark and twisted. Really creepy atmosphere."

Employing a crew, renting lenses and lighting gear, feeding an entire crew, costuming, props, hotels, and flying Sells to and fro his new locale in Colorado will up the ante on Faces (well into the thousands of dollars). Maze hoped to perhaps use this project as his senior thesis (and thus utilize otherwise pricey UNL resources), but that idea wasn't so well-received by the upper brass, so Maze, who bristles when discussing the decision-making bureaucrats who generally yield the power in a state university setting, is left to pay the tab himself.

Perhaps adding to a restless impulse to be done with school, Maze spent a week in June at Shreveport, LA, and El Dorado, AR, working on a short film with Alexander Jeffery, a 2011 Nebraska graduate who relocated to (where else?) LA to make films. In '13, Jeffery received the Royal Reel Award at the Canada International Film Festival for his first feature film *One Way*.

Maze now really wants to get out there on his own. Sooner rather than later.

"We are unfortunately 'geographically handicapped' in a way, due to the fact that the film industry tends to be focused around the coasts and not the Midwest," Maze said.

"We need all the help we can get from the communities to bring a much bigger film industry presence to the heart of the country. There are stories here that need to be told. And with the help of investors and donations, we can make it happen," he said.

"I have poured so much of my beliefs and heart into this script that it has become a very substantial story that touches on deep subject matter, such as the impact and power of true love and desire, the exposition of corruption amongst the powerful, and how those who have heart can overcome even the most perilous situations," Maze said.
