# Tragic motorcycle accident claims life of Ohio man

A 64-year-old Ohio man died Friday evening, Aug. 5, from injuries he suffered in an accident approximately two miles south of Falls City on Highway 73.

Sheriff Randy Houser said Edward Packard of Cleves, OH, was northbound on the highway at about 6 p.m. when the motorcycle he was riding collided with another vehicle. The other vehicle was turning onto 703 Loop.

An autopsy has been completed. The accident remains under investigation, Sheriff Houser said, and additional details are not yet available.

# Concussions main discussion at Board meeting Monday

A topic that has swept the nation and been a great cause of concern has hit Falls City, in the head so to speak. The national conversation on head injuries particularly pertaining to young athletes was a local topic at Monday night's Falls City Board of Education meeting.

The B.O.E. approved the final reading on nine policy revisions at the meeting and although the policies cover a wide range from No Child Left Behind policies to homeless children – the most discussed topic was the new concussion policy.

New this year is the implementation of the IMPACT testing, which creates a baseline

An 18-year-old Falls City man was arrested by local police officers on a variety of charges following a Friday evening, Aug. 5, disturbance.

Jake Fritts was taken into custody by officers Travis Mitchell and Clinton Stonebarger, who were called to the area of 10th and Stone at about 7:30 p.m. Friday. Fritts was allegedly agitated and using obscene language in arguments with neighbors and family members.

One family member described Fritts as being "uncontrollable."

While placing Fritts under arrest and trying to place him in the police cruiser, both officers were allegedly spat on and struck by the defendant. The officers were also subjected to obscene language.

DEAR DR. GOTT: I am a 72-year-old female and have been diagnosed with rotoscoliosis. The doctor explained how my back was rotating.

Meltdown...

My doctor sent to me physical therapy. After six weeks they told me they were through. It didn't help me. I have been going to a chiropractor on a regular basis, as well.

When I asked my doctor about rotoscoliosis, he said, "You better hope you are brain dead or in a rest home when it worsens." Needless to say, I didn't want to hear that.

What can you tell me about this? Can anything be done? I have good bones and go in annually for checkups.

DEAR READER: Rotoscoliosis is a term most often used to describe a severe form of scoliosis in which the spine not only curves to the side (as is normal with scoliosis), but the curvature is also associated with a strong degree of rotation.

Treatment involves proactive pain therapy and possible spinal fusion to prevent further curvature and rotation.

I suggest you ask your physician to refer you to a spinal orthopedist or neurosurgeon for examination, testing and treat-

As an aside, I believe your phy-

you. Rotoscoliosis is a painful condition, but there are more compassionate, helpful ways to deliver that news. You are not without hope, and getting help early may be your best chance at preventing future problems and

DEAR DR. GOTT: I desperately need information on how to get a mentally ill relative to seek treatment. He and his family immigrated to the United States in October 2009. I believe he had issues before they came here, but the new environment and pressure of living here finally caused him to buckle. Two months ago he started intensely interrogating his wife about her hundreds of alleged affairs and other non-existent events. Since then it has become a daily ritual of verbal and sometimes physical abuse against his wife.

I live 300 miles away and have tried to talk to him over the phone. He exploded when I mentioned he should see a doc-

I am helplessly watching him destroy his family and himself. I suspect he is schizophrenic, and I have found a couple of clinics in his hometown that accept sliding-scale payments according to household income, but he refuses to admit he's mentally ill. I don't know how to get him

Could you offer some advice? Are there other resources available to them to deal with his problem?

person can be proved to be a direct danger to himself or others, forced commitment isn't possible. The patient has to be ready and will seek out help only when he or she is willing to admit there is a problem.

Unless your relative's wife is willing to press charges, I'm afraid there is little that can be done. She isn't doing herself any favors by staying, especially given your statement that she is enduring daily emotional and sometimes physical abuse. If there are children involved, it is paramount to their well-being, physically, mentally and emotionally, that they not be exposed to this. The families of alcoholics have support groups; I am sure there are similar groups for those with mentally ill or abused parents/spouses.

My advice? Stay in contact. Remain a calm, stable force for both your relative and his wife. Offer your love and support. The clinics you found in his hometown may be able to offer his wife some local sources of support and advice. Suggest that she





Many of you have asked about the status of our Ballpark Improvement Project, and so I will attempt to give you an update.

First, let me tell you that the project is progressing with much having been accomplished since our Community Meeting at the High School Auditorium on April 27. Surprisingly, this was 3 1/2 months ago! Yes, time does fly and it seems to me summer goes by the quickest!

Anyway, the meeting on April 27 was a good meeting in the sense that several excellent suggestions were made . . . and please know that every suggestion was noted and discussed and evaluated by our Steering Committee over the following three months.

One suggestion was that we seek a second opinion from a different consultant . . . and we have done that. Another was that we stay with four diamonds at Dallas Jones Park instead of adding a fifth . . . and we have done that. And, finally, it was clear that cost estimates were viewed as too high . . . and I am pleased to report that our latest estimate is in the range of \$750,000, less than had earlier been reported. In my opinion, all very positive!

Having said these things, on Thursday, Aug. 4, our Steering Committee met with two representatives from a Peoria, IL, firm which specializes in ball fields and has built many throughout the United States. The name of this firm is Turf Solutions Group (TSG) and this was their second trip to Falls City, having spent an afternoon and following morning looking at our ballparks approximately a month ago.

We were given their drawings and suggestions of how they envision our project, as well as their cost estimates. And, as I stated above, we were pleased with both.

While the committee has since done some minor "tweaking," we liked what we saw well enough that a motion was passed unanimously "that we take the position of recommending that we use TSG as our project consultant/developer and that we further recommend acceptance of their concept" subject, of course, to the changes mentioned above, which have now been completed from TSG's review and consideration and, hopefully, a final diagram of the project.

Incidentally, these guys like our Grandview Park facility very much, and we are asking them to give us an additional estimate on an improved playing surface (perhaps called "Dry Turf") for this facility, as well as other needed improvements and updates, including an abundance of new bleachers for this facility.

Okay, what's next?

Well, in addition to showing the final plan in the Journal when it is finished, we want you to mark your calendars because at 7 p.m. on Wednesday, Sept. 14, we are planning a second Community Meeting in the Commons Area at Falls City High School. We plan a slightly different format than the first meeting in the sense that we plan to set up four or five easels with diagrams of the project on display with each manned by a member of our Steering Committee to assist you in your review.

Following, we will give a brief formal presentation and then open the meeting up for your questions and comments. Also, we hope to have a representative of TSG present at this meeting.

Of course, the final order of approvals need to come from our City Council and, in that regard, we are requesting to be on the Council's agenda on Tuesday, Sept. 6, to give the Mayor and Council a progress report and also a personal invitation to the Community Meeting on Sept. 14.

Following the Community Meeting, and assuming all goes well, we plan to ask to be on the Council's agenda again on Sept. 19, at which time we plan to seek their approval to move ahead with the project and, at the same time, ask them for specific items of "in kind" services and/or any financial support we will need from them.

Finally, assuming all of the above, our Fund Raising Campaign with the private sector will begin, and it is, of course, our wish that we can raise the necessary funds (with the hope that some grants can be found) to complete the project.

FYI, while one-time gifts will certainly be welcome, and perhaps even be preferred, we are thinking in terms of pledges to be paid over a five-year (or less) period.

That's it for now, my friends, and again please mark Sept. 14 at 7 p.m. on your calendars. Your presence is very important to us so that you can see the plans and give us your thoughts and opinions on our new revised design, and also, we can answer your questions.





for student-athletes to measure the effects of a head injury. The test will be given to all studentathletes in grades 9 - 12 to determine a baseline, or healthy, reading. When and/or if the athlete receives a head injury a second test is able to determine how severe the trauma to the head is and the coaches will be able to determine if the athlete can participate.

The policy itself covers three areas. The first is training for the coaches in recognizing the symptoms of a concussion or brain injury. Second involves education for the students and parents about the effects of concussions or head injuries. And the third is the response to these

Superintendant Tim Heckenlively said that includes guidelines on when athletes should be removed from competition or practice and whey they should be allowed to return.

The B.O.E. tabled the policy discussion at the last meeting in July to determine what a licensed healthcare professional was defined as. It was determined after discussion with professionals that the meaning of

licensed healthcare professional would be determined by one of three definitions: a physician, a physician assistant, and/or a medical practitioner.

This was done to clarify precisely what would be accepted by the faculty and coaches of the district, in regards to a studentathlete's participation in activities following a head injury.

Also, the district is going to begin requiring all coaches to take a course on concussion awareness and acquire a certificate for documentation. It was not determined Monday night how long the certifications would last, but Supt. Heckenlively suggested to the board that it would be wise to recertify every few years and require all new coaches to obtain the certifica-

A state law requiring schools adopt concussion policies was approved in the last legislative session. The state law goes into effect next year, so the Falls City district policy is a year ahead of the state requirement.

In other discussion, Heckenlively noted that transportation to many school activities would be deterred because of the current flood situation. Sporting

events and other activities, in places such as Hamburg, IA, and Rockport, MO, will be affected by the long bus routes to the contests, which will affect school time missed as well as travel expenses.

"Some decisions are going to have to be made about the feasibility of these contests with all the bridges being out," said Heckenlively.

In other action items:

- The board tabled a decision on purchasing a 2011 International Route Bus, after board member Scott Hollens raised a question about the reliability of the bus' engine. The board is expected to decide on the purchase during a special budget workshop on August 22nd.

- The B.O.E. approved the first reading of a policy pertaining to service animals for blind or handicap students.

- On July 13, the State Board of Education voted to classify the FCPS system for the period of July 1, 2011, through June 30, 2012.

- The board set public hearings for the 2011-12 Budget and tax request for 7:00 p.m. on Monday, September 12th.

# Appalachian **Dulcimer:**

# sweet music'

The Homestead Dulcimer Club will perform for the Cobblestone Vesper Service at 6 p.m. Sunday, Aug. 28, at St. Paul's Lutheran Church, 20th and Towle.

The club is made up of a group of music lovers who have chosen to share that interest with each other via the instrument called the Appalachian Dulcimer. They meet two evenings a month to play for fun and practice new songs, and perform at various functions, nursing homes and senior centers. The 20 members are all from the Beatrice area.

Dulcimer means "sweet music." It is a stringed instrument of the zither family. The instrument typically has three or four stings. The Appalachian Dulcimer was developed by people who settled in the Appalachian Mountains. Settlers in this area were from Ireland, Scotland, Wales and Germany. The instrument was first used in church services.

It is believed that the Appalachian Dulcimer is the first instrument to be fashioned in North America, other than those indigenous to Native Americans.

As part of their presentation, club members will give more details about the dulcimer and even give people "hands on" opportunities.

#### **ASK MR. KNOW-IT-ALL**

How many actors played the role of James Bond? What were their names?

Q: Recently I watched the movie "Lorenzo's Oil." At a young age, Lorenzo developed ALD, a progressive degenerative disorder. What became of Lorenzo? -- M.W., West Peoria, Ill.

A: Lorenzo Odone was born in Washington, D.C., on May 29, 1978, to Michaela and Augusto Odone. At age 6, he was diagnosed with the childhood cerebral form of adrenoleukodystrophy (ALD). Even though his parents had no medical background, they decided to research the disease. They helped develop an oil using olives and rapeseed, which under certain conditions slows the progression of the disease. Lorenzo far outlived his prognosis by surviving to age 30. He died on May 30, 2008, with his father at his side. The 1992 film starred Nick Nolte and Susan Sarandon as the parents.

Q: How many actors played the role of James Bond? What were their names? -- S.F., Terre Haute, Ind.

A: James Bond 007 is a fictional character created by writer Ian Fleming. In the 1950s, EON Productions received the film rights.

EON Productions' films are considered the "official" James Bond movies. Six actors played the role of 007 -- Sean Connery, George Lazenby, Roger Moore, Timothy Dalton, Pierce Brosnan and Daniel Craig.

Q: New Scotland Yard is the headquarters of the Metropolitan Police Service, which is responsible for policing greater London, U.K. Where does New Scotland Yard derive its name? -- J.S., Miami, Fla.

A: Scotland Yard derives its name from the location of the original Metropolitan Police headquarters at 4 Whitehall Place, which had a rear entrance on a street called Great Scotland Yard. This entrance became the public access to the police station. Over time, the street name and the Metropolitan Police became synonymous. When the police department moved in 1890, the name New Scotland Yard was adopted. When this building in turn became inadequate, the name was transferred to the new building in 1967.

# **Need to raise your** debt ceiling? -- Joe Slater

When Peter asked Jesus how many times he should forgive a brother who sinned against him, the Lord responded with the parable of the two debtors (Matthew 18:21-35). One debtor owed the king ten thousand talents. If Jesus meant for us to think of talents of gold, this would be a staggering sum — in the tens of billions of dollars at today's prices!

Even if silver talents were meant, this servant was hopelessly in debt. Despite his protest to the contrary, there was no way he was ever going to pay it off, regardless of how much more time he was given. His creditor had every right to sell him and his entire family into servitude for the rest of their lives. Fortunately for him, the king had compassion. He required not even a partial payment; he simply forgave the entire debt.

This drowning-in-debt servant had loaned a hundred denarii to a fellow-servant (18:28). It was a significant sum, to be sure; a denarius was a day's pay for a common laborer (see Matthew 20:2). However, even a hundred days' pay could not hold a candle to the tens of billions of dollars of debt for which the king had forgiven the first servant.

One might reasonably expect that thankfulness would move the forgiven debtor to exercise the same compassion toward his fellow-servant. Instead, the wretched ingrate had his poor coworker cast into debtor's prison. When the king heard of it, he became so furious that he turned the unforgiving servant over to the torturers until the original debt was paid in full, which, of course, it never could be.

Go back to Peter's initial question: "How often shall my brother sin against me and I forgive him? Up to seven times?" (Matthew 18:21). Jesus corrected Peter as follows: "I do not say to you, up to seven times, but up to seventy times seven" (Matthew 18:22).

Clearly, Peter needed to raise his debt said, "If your brother sins against you, ceiling! Seventy times seven was not intended as a mathematical equation yielding a product of four hundred ninety. The point was simply this: as many times as the brother sins and repents, you forgive.

In the parable, the king represents God Himself. Our sins put us hopelessly in debt to God. No matter how hard we work, we can never pay the price for even one sin. "The wages of sin is death" (Romans 6:23). God has every right to punish us in Hell eternally. Fortunately, Jesus went to the cross and paid our debt. By putting our confident trust in him and obeying the gospel, we receive complete forgiveness. God puts no ceiling on how many sins the blood of Christ will wash away.

Anyone who thinks, "I have sinned so much that not even God can forgive me," simply has a faulty understanding of the grace of God and the blood of Christ. Since God places no debt ceiling on us, how dare we place such on other people? Jesus rebuke him; and if he repents, forgive him" (Luke 17:3). That includes even seven times in a single day (Luke 17:4).

The complete number seven indicates again the indefinite frequency with which we are to forgive. Love keeps no tally sheet of sins committed (1 Corinthians 13:5). That is not to say that God is going soft on sin, or that we should. Continuing in sin that grace may abound is not an option (Romans 6:1).

But where there is repentance, forgiveness must follow. That is the way God operates and are we not grateful that He does? How, then, can we refuse the same compassion to each other? Indeed, we must not! Do you need to raise your debt ceiling?







# The Village Idiot By Jim Mullen

The big rap against homeschooled kids seems to be that they aren't "socialized." I asked a longtime member of a big-city school board about homeschooling, and he shook his head and rolled his eyes.

"Those kids are nothing but problems," he said. "They're not socialized. We had one boy who wanted to go out for football because that's something you really can't do at home, and when he got to the locker room, the other kids found out he didn't even know how to snap a towel or give a wedgie. That's the problem with homeschooling."

Yes, why can't homeschooled children act as if they've been raised by wolves like socialized children? What were their parents thinking?

I can always tell if children are being schooled at home. They call me "Mr. Mullen" instead of "dude," or "yo," or a couple of words that we can't print. Homeschoolers are usually smarter and more talented than I am. Regularly schooled children may be smarter than I am, too, but since they are socialized to be uncomfortable speaking to anyone outside their age group, I will never know.

Many people pooh-pooh the idea of homeschooling on the grounds that it is just a way for controlling parents to be even more controlling -- as if uncontrolled parenting and conventional schools were working out fine and dandy.

Some parents homeschool for religious reasons, some because they think they can do a better job than conventional schools, some because they don't want their kids contaminated by the kinds of brats who are idolized by MTV execs and their teenage viewers. One MTV show, "My Super Sweet 16," is a documentary of how wealthy parents overindulge their children. The show seems to have two main purposes: to give horrid, spoiled children a chance to be on TV without having to learn how to act or dance or be personable, and to make less well-off teens insane with jealousy.

It's a lose-lose program. One scene shows a soon-to-be 16-year-old screaming, "You've wrecked my life!" at her mother as she hands the child the kevs to a \$68,000 Lexus. It seems the girl wanted to get the car the next night, the night of her birthday. What I especially liked about the screaming fit was that the teen was wearing a diamond tiara while she turned blue with outrage. How wonderfully so-

cialized she was.

Yeah, Mom, you have wrecked Little Miss Sunshine's whole life. Not for giving her the car, but for letting her get away with that kind of behavior. The present you may have actually given her is a string of future ex-husbands; years of ineffective, self-indulgent psychotherapy; a nice addiction to some classy prescription drugs; and screaming fits for the next 40 or 50 years about how you wrecked her life. Her children will be even worse. Congratulations, Mom, she couldn't have done it without you.

Homeschooling is, of course, not for everyone. I personally believe in the upper-class English system where the parents have the baby, then bundle it off to boarding school as fast as humanly possible with the loving send-off, "Oh, do come visit us -- when you're 18."

I've just started to hear a new homeschooling word (well, new to me): "unschooling." Most states require that homeschoolers study the same curriculum as conventional schools. Unschooling, however, is the philosophy that children should be unfettered and should learn naturally, jumping from interest to interest as they grow, the hope being that they will learn how to learn as they follow their own non-curricula. They will learn on the job. This strikes both conventional schoolers and most homeschoolers as a bad idea, but how will we know until the experiment bears fruit?

Parents and teachers know that what works well for one child may not work for another. How old were you before you found out what you were meant to do in life -- if you ever have? Was it something you found at school or on your own?

Maybe the best education is a combination of conventional schooling, homeschooling and unschooling -- or something we haven't thought of yet. But what isn't working is socialization.

# **ASBESTOS NOTIFICATION**

Asbestos is an issue we have been dealing with for many years. The Asbestos Hazard Emergency Response Act of 1986 (referred to as AHERA), was enacted recently by Congress. AHERA was enacted to determine the extent of and develop solutions for any problems schools may have with asbestos.

To give you some background, asbestos has been used as a building material for many years. It is a naturally occurring mineral that is mined primarily in Canada, South Africa, and the U.S.S.R. Asbestos properties made it an ideal building material for insulation, sound absorption, decorative plasters, fireproofing and a variety of miscellaneous uses. There have been over 36,000 different products made using asbestos materials. EPA began action to limit uses of asbestos products in 1973 and most uses of asbestos products as building materials were banned in 1978.

We have had our facilities inspected by a certified asbestos inspector, as required by AHERA. The inspector located, sampled and rated the condition and hazard potential of all material in our facilities suspected of containing asbestos. The inspection and laboratory analysis records were turned over to a professional certified firm to develop asbestos management plans.

An asbestos management plan was developed for our facilities which includes: this notification letter, education and training of our employees, a set of plans and procedures designed to minimize the disturbance of the asbestos containing materials (ACM) and plans for regular surveillance

Falls City Public School, complying to this plan, removed all of the friable asbestos from its buildings. Some floor tile containing abestos still remain.

A copy of the asbestos management plan is available for your inspection in our administrative offices during regular office hours. Mike Kafer is our asbestos program coordinator and all inquiries regarding the plan should be

We have implemented the asbestos management plan. We are intent on not only complying with, but exceeding federal, state, and local regulations in this area. We plan on taking whatever steps are necessary to insure your children and our employees have a healthy, safe environment in which to learn and work.

**ORDINANCE NO. 2011-107** AN ORDINANCE TO AMEND SEC-TION 3-1007 OF THE FALLS CITY MUNICIPAL CODE; TO INCREASE THE AMOUNT REQUIRED FOR COST OF PLUMBING WORK TO OBTAIN A PLUMBING PERMIT; TO REPEAL CONFLICTING OR-DINANCES IN SAID SECTION; TO PROVIDE FOR AN EFFECTIVE DATE:

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF FALLS CITY, NEBRASKA;

SECTION 1. That Chapter 3, Article 10, Section 3-1007 of the Falls City Municipal Code be amended to read as follows:

§3-1007 MUNICIPAL BUILDING DEPARTMENT; PLUMBING PER-MIT. In the event that the proposed construction work is strictly of a plumbing nature, the applicant shall apply to the Municipal Clerk for a permit therefor. The clerk shall require in writing such specifications, details, cost estimates, and other information as he or the Plumbing Inspector may deem necessary.

The application, plans and specifications shall be reviewed by the Plumbing Inspector to verify compliance with any applicable laws under this code and other pertinent laws and ordinances. Fees and the procedure for issuance of a plumbing permit shall be the same as for building permits.

No plumbing permit shall be required where the proposed plumbing work is of a minor nature and the total cost of the same is less than five hundred dollars (\$500.00) two hundred fifty dollars (\$250.00). Successful applicants shall comply with all inspection regulations prescribed by the Plumbing Inspector and this code.

SECTION 2. That any other ordinance or section passed and approved prior to the passage, approval, and publication or posting of this ordinance and in conflict with its provisions, is hereby repealed.

SECTION 3. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.

#### 2.0 INFORMATIONAL ITEMS/RE-PORTS:

2.1 Staff/Student Presentation: Mrs. Kristen Poppe was at the meeting representing the Partners in Education (P.I.E.) group. Mrs. Poppe stated that P.I.E. is a group of parents raising funds for North School and South School students and it sponsors various activities for the students. P.I.E. sponsors such activities as: Bring a Friend to Lunch, hot fudge sundae bar, Hoops for Heart, lunch for teachers during Teacher Appreciation Week, purchase of materials for various music programs, and others. P.I.E. raises funds by sponsoring the Little Miss and Mr. Contest, sale of calendars, bake sale, track meet concessions, and others. P.I.E. has purchased 9 IPods for the schools, collected and submitted box tops, provided treats for class competitions, and funded a scholarship to a graduating student going into elementary education. Principal Ernie Valentine expressed his appreciation for what P.I.E. does for the teachers and students and stated that they do an outstanding job for the schools. The Board members also expressed their appreciation to the P.I.E. group as it takes a lot of time and effort by everyone involved.

2.2 Principal Reports: North School Principal Ernie Valentine attended the meeting but no reports were given by the Principals.

2.3 Board President Harris' Report: President Harris reported that he has gone over the evaluation with Superintendent Heckenlively. Board member Scott Hollens stated that it was his understanding that all Board members would be present when the evaluation was discussed and would like to have it done that way in the future. It was the consensus of the Board to have all Board members present in future discussions of the evaluation.

2.4 Superintendent Report:

2.4a Legislative and Organizations Report: Superintendent Heckenlively stated that it is that time of the year to verify the information upon which the NASB Awards of Achievement as well as Outstanding Awards are based and provided each Board member with the NASB record of his or her participation in 2010-2011 board development activities. The information needs reviewed/corrected and returned to Superintendent Heckenlively so that he can submit it to the NASB. The NASB Budget Conference will not be offered via videoconference at ESU 4 in Auburn on July 20. The closest location is Lincoln. Board members are to let Superintendent Heckenlively know if he or she would like to attend so registrations can be sent in.

Just as a reminder, Falls City Public School belongs to the following statewide education organizations: NASB, NRCSA, and GNSA. School administrators belong to NCSA (and to the sub organizations under its umbrella). Teachers belong to the NSEA. All of these organizations lobby on behalf of their members, and at times lobby the same position, sometimes actually join together, and at other points differ on position and/or rationale. Attached in the appendix is a NRCSA information sheet from Dr. Jon Habben.

2.4b Building and Grounds Update: Superintendent Heckenlively reported that various concrete jobs around the district have been completed and include the sidewalk/entrance on the lot south of South School, patchwork in the high school parking lot, and improvements to the sixth grade entrance at middle school. Superintendent Heckenlively stated that he received one bid for the drainage improvement project between the high school and Jug Brown Stadium remains from Metzger Construction in the amount of \$18,875.00 and that work will begin on this project within the week. Additionally, the asphalt portion of the high school parking lot is presently being sealed and will be re-lined for parking.

It was noted that determination will be finalized in August on the purchase of the new International route bus. A proposed 50% will be funded from the 10-11 budget while the remaining 50% will be paid in the fall as part of the 11-12 fiscal budget. This purchase will keep the district on track with the bus rotation. The new bus tire bid came in at \$2,900 and will be purchased this month.

2.4c School Improvement Process: Superintendent Heckenlively stated that a technology advisory committee is being formed to coordinate the district's planning efforts toward instructional technology. The advisory committee will make recommendations to the Board of Education for the purpose of mapping out the future direction of technology enhancements to Falls City Public Schools. At the August Board meeting the Board of Education will need to appoint a member to serve on the technology advisory committee.

2.4e NASB Medicaid Consortium Agreement: The Board was furnished with a copy of the new agreement to participate in the Nebraska Association of School Boards Medicaid Consortium (NASBMC). We are currently a member and receiving assistance in attaining reimbursement from the federal government for administrative costs for Medicaid eligible students. The Board of Education must vote on and approve the interlocal agreement to continue participation in NASBMC. Below is a description of the program.

Program Description: This program was created to help school districts access federal dollars for services they were already providing to Medicaid eligible students. School districts regularly provide certain services that are termed administrative in nature, as well as some transportation services for Medicaid eligible students. These costs for services are reimbursable by federal funds through the state Health and Human Services Agency (HHS). For public school districts to access these funds, state and federal rules and laws must be followed. NASB assisted in the creation of an interlocal agreement called the Nebraska Association of School Boards Medicaid Consortium (NASBMC). The consortium contracts with a third party administrator (TPA) to train member school districts on the proper claiming procedures and to file said claims on behalf of NAS-BMC. Member school districts pay a fee of 9% of their claim to the third party administrator (TPA), plus 3% to the State of Nebraska, HHS, for administration of the program. The TPA collects all consortium data quarterly and submits the information to the State. The State claims this amount from the Federal Government and electronically deposits the total amount claimed by the school districts for the quarter to NASBMC. Once the monies are wired to NASBMC, checks are cut for each member of the consortium for their respective amounts, and to the TPA and NASBMC. The State reclaims their 3% fee electronically from the NASBMC account.

2.4f Preliminary Budget Information: Superintendent Heckenlively informed the Board that the ARRA State Fiscal Stabilization Funds (SFSF) and Education Jobs Funds reports and fund requests will be submitted in July and August for final fund receipts. There is no carry-over of the ARRA funds and this will mark the end to the ARRA Stimulus Funds school districts

received over the past two years. A preliminary budget is being built for expenditures, receipts and transfers. Although preliminary estimates are known, August 20 remains a key date for tax valuation to be certified to see if we can fund the proposed budget. We need to set a budget workshop and process timeline, which takes place after August 20 and before the September 12 regular board meeting. I would recommend Monday, August 22 or Monday, August 29. The date and time of the board workshop for the budget will be an action item on the August 8 Board of Education agenda.

The UNL Extension Educator salary will increase to \$32,000 plus benefits of \$7,197, making the total \$39,197. With that in mind, and our projected budget, a 12% partnership for Falls City Public School would be approximately \$4,703.64 (previous commitment was \$10,000). Falls City Public School will continue our commitment to the UNL Extension Educator Program with a primary focus of entrepreneurship and sciences at the secondary level. Falls City EDGE will also be determining the commitment level of their support for the program. Board member Scott Hollens questioned if the Board wished to continue supporting this project. It was noted that the teachers involved in this feel that it is a worthwhile project and therefore it was the consensus of the Board to support the project again.

# FORMER FC MAN LIVING ROCK & ROLL DREAM

A "chance introduction" four years ago is sowing the seeds for a potential life changing event for a Falls City native and his Aurasing (pronounced R-uhsing) band mates.

Matt Oliver, a 1999 graduate of Falls City High, moved to Omaha six years ago to take a position with the State of Nebraska as a Child Protection and Safety worker. In this short time he married his wife, Ekho, became a father - twice - and helped an up-and-coming band achieve success, with more looming on the horizon.

Oliver and Aurasing are one of several currently local bands competing for an opportunity of a lifetime. Aurasing is currently vying for a chance to be included on the lineup of the Rockstar Uproar Tour, which will make a stop at Omaha's WestFair Amphitheater on Friday, September 23. The tour includes such acclaimed artists as Avenged Sevenfold, 3 Days Grace, Sevendust and more.

The leading vote getter for the Omaha stop will be included on the bill and if they can crack the top two in the national vote, Aurasing will have the opportunity to play the final 13 stops on the national tour.

Simply create a fan account by going to the site and entering your email address, choose a password, then search for Aurasing. You can vote once a day and the voting for the Omaha tour stop will end towards the end of August.

Oliver knows what's at stake. "Winning this competition would be a once in a lifetime

His friend was auditioning for a spot as the second guitar player in the newly formed band. In the meantime, Matt grabbed a bass guitar and started jamming with the guys and according to fellow founding member and lead vocalist, Mike Clark, "Corey immediately noticed that Matt was a really fast study and he remained at the top of Corey's mind."

It didn't work out for Matt's friend, but Matt quickly became the missing ingredient. The problem was they weren't sure how to contact Matt and they also did not want to be disrespectful to Matt's friend who initially auditioned.

"I found Matt's wife through Myspace and contacted her regarding Matt," said Clark. "He immediately responded, came over for his audition and that is how Aurasing came to be."

The band has taken a workman-like approach in the years since. They released their Saddle Creek artists, including Bright Eyes.

They released their first fulllength album, The Intervention, at a near-sold out show in one of Omaha's premier venues, The Waiting Room, in November of last year.

Their ability to play a boisterous live set as well as a keen sense for promotion has earned them a reputation as one of Omaha's most alluring opening acts.

Matt's wife has been behind him since day one. "I would say my wife has been the most supportive," Oliver said. "She sacrifices some of her own things in order for me to be in such a time-consuming band. If she didn't support it I wouldn't have been doing this for four years and I am lucky to have such a self-less wife."

He met his wife, Ekho, in the fall of 2004, while she was attending Nebraska Wesleyan in Lincoln. She eventually

opportunity for Aurasing," he said. "To go from playing in front of 500 people to playing in front of 20,000 people would be quite a jump.

"To share the same stage with Avenged Sevenfold, 3 Days Grace, Sevendust and the others would be a dream come true."

The story of how Oliver came to be a member of the band is coincidental, but if one believes things happen for a reason then this is right up your alley.

Right around the same time he was courting his bride-to-be, Matt, who had jammed with a few different bands around the Lincoln area while a student at Doane, just happened to be over at a friend's house when Corey Wilson, one of the founding members of Aurasing stopped by to watch Matt's friend play guitar.
