


Such was the case last week for Ed and Sandra Hartman, whose lunch at A&G restaurant was interrupted by the parade director.

Capital improvements abound as FCPS kicks off new school year

Falls City Public Schools held its regular monthly meeting last Monday, Aug. 10, at the Central Office in FC Middle School. Prior to the meeting, a meet and greet session was held in the commons for new faculty, board members and administration.

Supt. Tim Heckenlively reported that nearly all projects slated for completion over the summer months had wrapped up in time for Thursday's first day of the 2015-16 school year. The expanded parking areas at North School and the resurfacing and concrete at the high school parking lot are a few of the more noticeable capital improvements. Additionally, the HVAC control system was updated at the high school, sidewalk sections at North school were replaced, the parking lot south of the building at South School was rocked, and two classrooms at South School received new carpet. The BOE also approved an addition to Parent-Child Center at last Monday's meeting.

Furthermore, FCPS was one of thirty Nebraska schools and libraries included in Wave 10 eRate Grants for Funding Year 2015. Wave 10 Funding is providing \$73,697 for installing new Internet cabling and in-

ternal connections at the High School and

Middle School. The project will most likely be completed over Christmas break or during the summer of 2016.

Heckenlively noted that from Oct. 4-7, five AdvancED representatives will visit District 56 and conduct a rigorous, on-site review. The goal of the external team visit is to help the school district identify ways to improve. The external team will visit classrooms and conduct interviews with all stakeholder groups to gain a better understanding of the learning at FCPS.

Several board policies were approved, including suicide prevention training, a new policy required by state law. State statute requires that "all public school nurses, teachers, counselors, school psychologists, administrators, school social workers, and any other appropriate personnel shall receive at least one hour of suicide awareness and prevention training each year." The training is web-based and takes one or two hours to complete.

The budget workshop will be held at 6 p.m. Monday, Aug. 31, in the Central Office. Hearings for the 2015-16 budget and property tax request will be at 7 p.m. Monday, Sept. 14, in the Central Office.



A few weeks ago as I sat in my living room grasping my chest in pain, I began to think of my life. What I was I leaving for my son, friends and family? A few memories, a massive classic movie collection and my stories. Then I began to think about Kathy.

I wasn't really close to Kathy Bartek but I really began to know her in her last years. I so enjoyed that woman and was inspired by how she lived and what she left her family.

The day I met Kathy has always been such a vivid memory of mine because she taught me a life lesson without even knowing it.

In December 2005, I sat on the couch facing the south as the sun beamed into our picture window. It was warm in the house on this cold December day. I could feel my face getting hotter and hotter as we sat and waited. The puppies had been put away and our 3-day-old baby boy was sound asleep. Finally, I stood up in a rage. "I don't understand why we need someone to come to our home and judge us as parents I yelled at Brian.

We were scheduled to have our "Well Baby Visit" Someone would come to our home and check on how we are getting along with our baby.

I was 22, hormonal and terrified by this person who was going to come into my home and probably take my new baby away because the carpet was too dirty or our dogs barked too much. Brian did his best to calm me down. I took long deep breaths and kept telling myself it will be fine.

"Think she will like the Care Bears we painted in the nursery?" I said. "Of course! She will love them!" Brian quickly responded.

Months before my mom, sister and I painted Care Bears all over Alex's bright blue walls. They were amazing and they made his room such a happy place. I always wanted to show them off to people, but nobody ever came to visit so I was hoping this would be the sign this woman needed to tell me that I would be a great mom.

Before I knew it this tall, slender, beautiful woman was knocking on our door. I remember her introducing herself "Kathy Bartek" I didn't know her; Brian had known her since he was a kid. So they chatted and I really can't tell you much else of what the visit consisted of. Maybe she checked Alex; maybe she walked around our living room looking at the hundreds of photos that lined the walls. I really don't know because in my mind, I was still waiting for two things. "Okay, that's it, you can't keep this baby" or "Where is his nursery?" Neither came. As she smiled and gathered her belongings I held back tears. She didn't ask to see his room. She was buttoning her coat up when I sheepishly asked if she wanted to see his nursery. Kathy glanced at the clock on our wall and smiled warmly and said, "I would love to!"

I took her into his room where Brian told her that my mom, sister and I had painted this nursery ourselves. She smiled and told me how wonderful it looked and it was just one of the best nurseries she had ever seen. She stayed an extra 20 minutes as I told her about that day we painted, the night Brian built the crib and broke the light that fell and cut a two-inch gash on the top of his head. She listened, she smiled and she never once brought up the fact that she had many other places to be. She had seen hundreds of nurseries and hundreds of babies, but she made me feel like mine were both special (because they totally were). She told me Alex looked like his dad and he had the most beautiful complexion, like his mom. That moment I knew I adored Kathy Bartek.

That day she taught me that going the extra mile and spending just a few more moments with someone can make a world of difference. Now I try to give others that extra minute when they need it. Smile more, judge less and listen.

A few years later Kathy was diagnosed with ALS. We would often chat on Facebook about. She was one of my biggest cheerleaders on my writing and mothering. She would ask how my day was, what my column would be about or how much she liked a particular column and why. When I was told my column would be put on hold, she told me to keep writing. Books, blogs, columns to publish later, whatever, just keep writing. I laughed, a book? But she was serious, She believed in everyone, even me.

I will never be a 'Kathy Bartek' but I will strive to be like her. Her daughters often tell me when they like a certain column. It makes me think of Kathy every time and reminds me of how much they're like their mom. They are sweet and caring. For anyone to take the time to say "Hey, I really liked what you did," is selfless.

Thinking of Kathy and her story makes me want to live my life in a way that others say 'Wow, she really inspired me to do something." I never got the chance to tell Kathy how she inspired me to keep writing and smiling through some of the hardest times.

If we all gave that extra minute to someone once a day, the world would be a happier place.

Interim study season coming, rural issues look interesting

If it's time for the University of Nebraska-Lincoln football team to start playing home games, it must be time for the Legislature's Interim Study Hearing Schedule to fill up.

Yes, lawmakers like to travel to Lincoln (they get paid for it) to attend interim hearings at the Capitol

on Fridays and then attend home football games on Saturday. It seems it has ever been thus. If that's what it

takes to lure them to town when they aren't in session, so be it.

Now, for the studies themselves. There are hundreds scheduled each year and every committee has some to consider before the next session convenes. Lawmakers explain that is how they get the information they need to formulate new bills or tweak existing

Many of these are not the headline grabbers that topics such as prison or taxation reform might be, but they are still important to the fabric of life in Nebraska. Several being heard by the Urban Affairs Committee and one by Revenue deal with issues of importance to rural Nebraskans.

The first is a study of the Local Option Municipal Economic Development Act, commonly referred to as local tax or LB840 (Laws 1991) funding. Six lawmakers introduced Legislative Resolution 152 to look at the nearly 25-year-old law by reviewing its history, the eligible uses of the funds, the potential new uses for the funds and an examination of the process used to amend an existing LB840 plan and whether or not such a plan requires voter approval.

The September 25 hearing comes one day before the Nebraska vs. Southern Mississippi home game. The current act, which has been modified 13 times since first adopted in 1991, authorizes incorporated cities and villages to collect and appropriate local tax dollars (sales and/or property tax) if approved by the local voters, for economic development purposes. It is being used in 68 communities from Chadron to Falls City and Kimball to South Sioux City and a lot of places in-between.

The Act involves the formulation of a local economic development program plan which forms the foundation for the collection and expenditure of local tax revenues for economic development through: direct loans or grants to qualifying businesses for fixed assets and/or working capital; loan guarantees; grants for public works improvements which are essential for business recruitment or retention; job training; purchase of real estate; salary for city staff or consultants to implement the program; bonding; production of films; grants or loans for the construction or rehabilitation for sale or lease of housing for low to moderate income individuals.

An economic development program may also include grants or loans for the construction or rehabilitation for sale or lease of housing for persons of low to moderate income.

Also up for consideration that same day is LR155 to examine current and potential economic development tools available to Nebraska municipalities. This study includes Tax Increment Financing (TIF) as well as LB840 funds. It will also include a review of potential additional economic development tools, which could be made available, including a review of economic development tools currently available in other states and the legality of of-

fering them in Nebraska based on the uniformity and proportionality provisions of the state Constitution. The committee will meet October

28, the day before the Nebraska vs. Northwestern home football game, to consider Lincoln Sen. Patty Pansing Brooks LR278 which would examine the existing resources and the need for additional tools for municipalities to further encourage revitalization of significant and older historic neighborhoods. The study will consider: the need for financial

incentives to encourage business in-

vestments in declining neighborhoods; the prospect for additional incentives to encourage home ownership of rehabilitated older buildings; the possibility of a collaboration between state and local governments and public and private entities in this endeavor.

No date for a hearing has been set yet, but Omaha Senator Burke Harr has a resolution, LR308, that would examine issues regarding the growth of Nebraska's agricultural related economy to determine what actions can be taken to spur population growth and business expansion in rural communities statewide. The study will consider the delivery and effectiveness of rural economic development programs in Nebraska as well as policies in other states that partner urban and rural areas and promote job creation in rural communities.

These aren't the big issues, by any means. But they are very important issues to all Nebraskans and reflect the work that a citizen legislature needs to

Pushing Back on Washington

One of the greatest barriers to growing Nebraska is the increasingly burdensome regulations coming out of Washington, D.C. As Governor, one of my top priorities is pushing back on these regulations and creating

a business-friendly climate in our state so that hardworking Nebraskans can find the goodpaying jobs that we rely on to keep Nebraska a great place to live, work, and raise a family. Washington bureaucrats, however, have continued to author new rules that seek to regulate many aspects of our lives.

Earlier this summer, the Obama Administration announced the final Waters of the U.S. (WOTUS) rule which appears to give federal authorities the ability to regulate almost any body of water imaginable. Previously, the federal government's regulatory authority was generally limited to "navigable"



bodies of water like rivers or lakes. In fact, the Clean Water Act mentions the phrase "navigable waters" over 80 times. After this final rule, the Environmental Protection Agency now has the authority to regulate ponds, ditches, or even standing water after a rain. This is a massive expansion of their authority, and has potentially costly impacts on farmers, ranchers, and businesses who may be required to seek expensive permits when their activities impact even relatively small bodies of water.


At the beginning of this month, President Obama launched a new initiative which he is calling his "Clean Power Plan." This plan aims to reduce carbon emissions by forcing individual states to develop plans to reduce emissions to a target level mandated by the federal government. For example, Nebraska would be required to reduce emissions by 40% with compliance required by 2022, less than seven years away. While this plan involves state action, compliance by our state was made virtually impossible because of logistical barriers. For instance, it takes longer to plan new power transmission lines and new sources of power, than the Obama Administration gave states for compliance.

The Clean Power Plan will also prove to be costly for our state and consumers. In Nebraska, our public power districts have a statutory obligation to provide low-cost power to their customers. Utility companies are starting to examine the impact of the Clean Power Plan on their ratepayers, and some are already finding that it will force them to move from low-cost sources of power like coal, which means higher utility bills for consumers like you. Recent studies of how the Clean Power Plan would impact Nebraska have found that ratepayers in our state would face 12% to 35% increases in their utility bills.

Additionally, this mandate from the federal government is unnecessary because Nebraska utilities are already working to diversify their energy portfolio. Nebraska has almost 500 wind turbines with a combined capacity of over 800 megawatts of power. In 2014, utility-scale wind energy generated 2.8 billion kilowatthours of electricity. This year, NPPD announced in conjunction with Monolith Materials that Sheldon Station near Hallam would be the first utility-scale hydrogen powered generator in the U.S., and is expected to produce 125 megawatts of clean electricity. Ironically, it is unclear under the new rules whether Nebraska will even be able to count this project toward carbon emission reduction require-

This demonstrates how poorly-written and misguided this new regulation is.

Washington continues to impose a new, unprecedented level of control on states which threatens our state's sovereignty. Because the EPA has overstepped the authority given to them by Congress, we have joined a lawsuit with 28 other states against the EPA over WOTUS. We are also suing the federal government, along with 15 other states, over the Clean Power Plan. The EPA must follow the law, and we cannot let their actions go unchecked. I encourage you to contact your federal representatives and the EPA to let them know what you think about these new rules. four finalists who will participate in public forums and university visits that will provide opportunities for key constituents and members of the public to meet the individuals and offer feedback.

Nebraskans are invited to share their thoughts now on the search by completing a survey at surveymonkey.com/r/UNLchancellor. Public input from the survey will inform the development of a job description and candidate profile for the next chancellor. The appointment of the next chancellor will be made by the president, subject to approval by the Board of Regents.

Steffen, 53, owns a some 2,000acre dairy farm in Richardson County, but also has some history in politics. In 2013, he testified before the Senate Ag Committee in Washington, D.C., on the impacts of drought and wildfire, and about some of the risk management strategies that have helped them survive. He said the Federal Crop Insurance Program covered a portion of the losses he sustained in 2012 and should be maintained. Though a new farm bill eventually passed and did away with direct cash payments to producers, subsidies certainly have not gone away. The Congressional Budget Office projects \$3.37 billion in payments to corn and soybean producers in 2017 from the Ag Risk Coverage alone. That's 38 percent higher than what the sector collected in 2014 under the old system of cash payments.



dation, the Stalder Foundation, Falls City Adjustment Board, and the Richardson County Arts and Humanities Council. Her favorite position, however, has been that of library board member.

"I became active with the library board because of my love of the written word," Sandy said. "That all started when I was a little girl, and had to walk home from school in Bellevue. It was cold sometimes, and the library was about half-way to my house, so I would stop there to warm up. That's where my love of books began."

This summer marks the year that the periodical cicadas, the 17 year cicadas are emerging from the soil. I am sure you have heard their deafening sound as you have driven through southeast Nebraska the past couple of months. I remember 17 years ago (1997) when the cicadas emerged. I was in my first year of Extension in Missouri at the time. I could not believe how loud the sound the ci-

per acre. This phenomenon has been going on the past couple of months here in southeast Nebraska and I have heard from several people telling me that the cicadas have been everywhere. Once they emerge, each adult may live for 5 or 6 weeks. During this time, the males and females have mated and the females have laid the eggs that are the start

be up to a million cicadas emerging

been laid into the small twigs of trees and shrubs. This causes moderate twig dieback and is called ("flagging"). Pin oaks or red oaks are often trees where flagging occurs, but there should be no longterm consequences. The eggs hatch after six to seven weeks and the newly hatched nymphs fall to the

ground, burrow until they find a suitable tree root, and begin the feeding and waiting period that will last until the year 2032.

I have received some calls from people with concern from dieback on their pin and red oak trees. This is just part of the cycle of life for the 17 year cicadas and should not cause any long-term harm to your tree. This is the mark that the cicadas have made on trees in southeast Nebraska in 2015.





Naming new building after Msgr. Roh a fitting gift of gratitude

Msgr. Robert Roh was admittedly uncomfortable with the impending praise and admiration that - we can only assume - comes with having a building named after you. But he long ago learned a valuable lesson about giving and receiving gifts: A person can be both humble and gra-

During a June interview, I asked Msgr. Roh what might go through his mind when the words "Roh Activity Center" are attached to the side of the new multi-million-dollar Home of the Irish. The question might have caught him off guard and the whole idea made him feel uneasy, but this wasn't the first time the idea had bounced around up there. Major donors demanded it and, really, it was pretty obvious. After 27 years and 900 funerals and weddings, he's certainly deserving. He led like few, if any, before him.

The great storyteller immediately went back to his collegiate years at Benedictine College in Atchison, KS. Robert Roh ministered to and befriended an elderly black man,

whom he visited weekly. "He was delighted to have me down and each week I really looked forward to meeting with him," he said. "One day he tried to give me something -I don't know what it was, money, or some kind of gift. I didn't want to take it. Then he raised his voice - it was the only time he ever raised his voice at me and I was shocked.

"When someone wants to give you something, you take it," he told me. "'They're trying to show you that they love you!""

"He teaches; yet not with the presumption of one who imposes his own truth but on the contrary with the humble, glad certainty of someone who has encountered the Truth, who has been grasped and transformed by it, hence cannot but proclaim it."





Corky Towle wins 10th title, Steve Simon grabs a sixer

There weren't too many surprises at the annual FC Golf Club Two-Day Mens and Ladies Tournaments this past weekend, as Corky Towle captured a 10th championship and Steve Simon netted his sixth crown (all since 2000 - see Page 10).

IRS warns taxpayers of widespread scams

Following the emergence of new variations of widespread tax scams, the Internal Revenue Service today issued another warning to taxpayers to remain on high alert and protect themselves against the ever-evolving array of deceitful tactics scammers use to trick people.

These schemes – which can occur over the phone, in e-mails or through letters with authentic looking letterhead - try to trick taxpayers into providing personal financial information or scare people into making a false tax payment that ends up with the crimi-

The Treasury Inspector General for Tax Administration (TIGTA) has received reports of roughly 600,000 contacts since October 2013. TIGTA is also aware of more than 4,000 victims who have collectively reported over \$20 million in financial losses as a result of tax scams.

"We continue to see these aggressive tax scams across the country," IRS Commissioner John Koskinen said. "Scam artists specialize in being deceptive and fooling people. The IRS urges taxpayers to be extra cautious and think twice before answering suspicious phone calls, emails or letters."

Scammers posing as IRS agents first targeted those they viewed as most vulnerable, such as older Americans, newly arrived immigrants and those whose first language is not English. These criminals have expanded their net and are now targeting virtually anyone.

In a new variation, scammers alter what appears on your telephone caller ID to make it seem like they are with the IRS or another agency such as the Department of Motor Vehicles. They use fake names, titles and badge numbers. They use online resources to get your name, address and other details about your life to make the call sound official. They even go as far as copying official IRS letterhead for use in email or regular mail.

Brazen scammers will even provide their victims with directions to the nearest bank or business where the victim can obtain a means of payment such as a debit card. And in another new variation of these scams, con artists may then provide an actual IRS address where the victim can mail a receipt for the payment - all in an attempt to make the scheme look official.

The most common theme with these tricks seems to be fear. Scammers try to scare people into reacting immediately without taking a moment to think through what is actually happening.

These scam artists often angrily threaten police arrest, deportation, license revocation or other similarly unpleasant things. They may also leave "urgent" callback requests, sometimes through "robo-calls," via phone or email. The emails will often contain a fake IRS document with a telephone number or email address for your re-

It is important to remember the official IRS website is IRS.gov. Taxpayers are urged not to be confused or misled by sites claiming to be the IRS but ending in .com, .net, .org or other designations instead of .gov. Taxpayers should never provide personal information, financial or otherwise, to suspicious websites or strangers calling out of the blue.

Below are five things scammers often do that the real IRS would never

The IRS will never:

· Angrily demand immediate payment over the phone, nor will the agency call about taxes owed without first having mailed you a bill.

Threaten to bring in local police or other law-enforcement groups to have you arrested for not paying.

Demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you

· Require you to use a specific payment method for your taxes, such as a prepaid debit card. · Ask for credit or debit card num-

bers over the phone. Here's what you should do if you think you're the target of an IRS im-

personation scam: If you actually do owe taxes, call the IRS at 1-800-829-1040. IRS workers can help you with a payment

If you know you don't owe taxes or do not immediately believe that you do, you can report the incident to the Treasury Inspector General for Tax Administration (TIGTA) at 1-800-

· If you've been targeted by any scam, be sure to contact the Federal Trade Commission and use their FTC Compliant Assistant at FTC.gov. Please add "IRS Telephone Scam" to the comments of your complaint.







Veterans' Cemeteries across Nebraska

On August 13, 2010, the Nebraska Veterans' Cemetery at Alliance was dedicated. It occupies twenty acres once part of the World War II Alliance Army Air Field, which became operational in August 1942. After the war, the government transferred the air field property to the city of Alliance for municipal airport use. The city donated land to the Nebraska Department of Veterans' Affairs for the Nebraska Veterans' Cemetery. The first interment was made on January 21, 2011, and the cemetery has the capacity for some eight thousand burials. While the cemetery at Alliance is Nebraska's state-operated veterans' cemetery, military cemeteries here date to the 1820s.

The first significant such cemetery was created by circumstance. During the winter of 1819-20 nearly eight hundred U.S. soldiers of the Rifle Regiment and the Sixth Infantry garrisoned Cantonment Missouri adjacent to the Missouri River north of today's Omaha. Not only did the troops suffer from harsh winter weather in their primitive log quarters, an outbreak of scurvy decimated the garrison. Scurvy results from a deficiency of Vitamin C, but fruit and vegetables providing this dietary necessity could not be supplied or grown in this remote location during wintertime. By March 1820 some 345 men had fallen sick and 100 had died. The death toll had risen to 160 by April 1. The dead were interred atop the bluff near where Fort Atkinson would be built that spring to replace

Cantonment Missouri. In 1827 the army abandoned Fort Atkinson, but the soldier dead remained, constituting an unofficial and unmarked military cemetery now on private property.

By the 1840s other military posts sprang up in the Nebraska country to protect the overland route to the West Coast, such as Fort Kearny on the Platte and Fort Laramie. More forts came with the organization of Nebraska Territory in 1854 and statehood in 1867: Fort McPherson, Fort Robinson, Fort Hartsuff, Fort Sidney, Fort Omaha, and Fort Niobrara, along with smaller cantonments such as Camp Sheridan. Posts large and small had cemeteries for the burial of deceased soldiers and dependants.

In 1873 the post cemetery at Fort McPherson in Nebraska's central Platte Valley was designated as a twenty-acre national cemetery. Although the army closed the fort in 1880, the national cemetery remained and continues in service today. As other Nebraska army posts and those in adjacent states were closed, the burials in their post cemeteries were relocated to the Fort McPherson National Cemetery. They include twentyeight enlisted men killed by Indians near Fort Laramie in 1854 during the so-called Grattan fight and sixty-three "buffalo soldiers" of the black Ninth and Tenth U.S. Cavalry who served at Fort Robinson. The cemetery includes veterans of the Civil War, the war with Spain, World Wars I and II, Korea, and Vietnam. Four soldiers interred there received the Medal of Honor.

Recently the U.S. Veterans Administration announced that a new National Cemetery will be built in Sarpy County. It will be known as the Omaha National Cemetery and is projected to occupy thirtyfive acres. Its completion will give Nebraska two national cemeteries, along with the Nebraska Veterans' Cemetery at Alliance. Veterans from the Civil War to the present, who chose to be buried in the communities in which they lived, lie in nearly every cemetery across the state.





Former Tiger star changes his mind on college ball after MVP performance at Beatrice All-Star Game

Peru State College Bobcat men's basketball head coach Eric Behrens has announced the signing of nine recruits for the for the 2015-16 campaign, one of whom you should be quite familiar with by now.

Former FC High School guard Weston Witt, the hero of two Tiger District Championship victories, did an "about-face" in regards to playing college basketball after the Southeast Community College All-Star Game in June. Witt led the East boys squad, scoring 18 points in the first half of a 91-82 victory over the West and put his name in the game's history book along the way. Witt finished with 24 and was named the game's MVP on a unanimous vote by coaches and media. It was believed to be the first unanimous vote of the event's 25-year

The 5-10 Witt, a pure shooting guard who is amazingly and deceptively good scoring inside, is one of two freshmen recruits for Behrends' Bobcats - the other is 6-2 Connor Dukes, from Plattsmouth. Dukes is another strong perimeter player on the offensive end.

"Weston is a heady combo guard who handles, passes, and shoots the basketball at a very high level," Behrends said. "He is a young man who will be positive for the culture of our program and we think he has a chance to be very good for us."

Witt averaged 11.3 points per game and led FCHS to back-to-back state tournament appearances with late heroics in both the 2014 and 2015 District Final games. This past winter, his shot in the paint with 1.9 seconds left gave the Tigers a dramatic victory over Boys Town. He led all scorers with 19.

"Weston is going to find a way to compete," Falls City coach Don Hogue said at the time, "the higher the odds, the better he gets."

"Weston does so many things. He can score, he sets up his teammates, he can go inside. He offers a lot offensively and defensively,

as well as how he distributes to his teammates," Hogue said.

Witt broke the school's single-assist record in 2014-15 - a record set in 1978 (Max Milam).

The rest of the new group of recruits consists of five juniors and two sophomores. The new commits will join four seniors and one junior.

A 6-7, 225-pound junior, An-

dre Henley, hails from the south side of Chicago and is the unquestioned catch of the class. The De La Salle High School graduate played at Hutchinson Community College (KS) prior to arriving at Peru State.

"Andre possesses one of the most versatile skill sets for a 6-7 wing as any player in NAIA basketball. He can dribble, pass and shoot, has tremendous court vision and plays the game with great feel. Dre can defend multiple positions and go get the ball of the glass and lead the break as a point forward," Behrends said.

Six years ago, Henley was considered the best player in all of Chicago, a city which produces more Division I basketball players than any other in America. He played for the best AAU team in the state of Illinois, Mac Irvin Fire, which seems to be a revolving door for high school athletes into college. After a tremendous freshman year, former Kentucky Head Coach Billy Gillispie offered Henley a scholarship. As a sophomore, the future looked brighter than ever. From De La Salle, Henley took his talents to Carbondale at Brehm Prep, a powerhouse high school in southern Illinois. Despite his talent and skill at his position, Henley did not make the transition he had hoped, becoming the first or second man off the bench. Some offers continued to roll in from schools like Marquette, Iowa State and Illinois. Once Gillispie was let go as head coach and Callipari was hired, that scholarship was no longer on the table and this once promising player was falling out of the limelight and soon to be forgotten.

Henley transferred back to De La Salle to be apart of one of the best teams in Illinois. This time around, though, he was a bit overshadowed by the play of Mike Shaw, who signed on with Illinois, but after two seasons transferred to Bradley for the 2014-15 season, and stars such as Texas Tech's Alex Foster (6-8, 210) and Illinois standout Jaylon Tate. Despite the accolades of Foster and Shaw, both of whom were immediate contributors at Tech and Illinois, respectively, Henley was widely considered the best player for De La Salle.

"Watching Henley, he seemed effortless going up and down the court making great passes, breaking up passing lanes, and finishing at the rim. Although he is not blessed with explosiveness, his game could lull you to sleep how swiftly he plays the game," a college scout wrote in 2011.

"Henley has the perfect game for a small forward. He's quick on his feet, he can hit the mid-range shot with consistency, he can drive to the basket, and he has long arms the makes him a very good defender. He can dribble as good as anyone at that height and while he won't jump out of the gym, he can finish at the rim with ease. The potential is there for Henley. Could potential be the word that describes the rest of Henley's career, or will we find this young small forward on NBA draft boards in years to come?," the scout wrote.

Other signees are Riak Bol, a 6-10 junior from Omaha Benson High School, Deandre Hollins-Johnson, a 5-10 point guard who followed Behrends from Omaha Central to Peru, 5-8 junior Darwin Ellis, from Brooklyn, N.Y., graduated from Lincoln High before playing at Williston State (N.D.), Karim Diop, a 6-7 junior from Dakar, Senegal, Anthony Richardson, a 5-11 sophomore from Schenectady, N.Y., and JaPree Murry, a 6-3 sophomore from Papillion-LaVista.

Behrens is cautiously optimistic about this group of recruits and looks forward to getting these commitments on campus in a couple of weeks.

"I am pleased with our second recruit class, especially having had a longer time to do so compared to getting a late start last year. We look to build upon the success of last year as our returners, combine with the newcomers, should provide us with more depth."

Peru State will open its season on Nov. 4 with a road contest with Briar Cliff University in Sioux City, IA.
