# One year older, one year wiser

# District provides iPad for each FC High student

Doors flung open at four different Falls City Public School buildings last Thursday and the hundreds of young students passing the threshold embarked on a 2013-14 school year that, using recent history as an indicator, promises to be better than the last one.

The brick and mortar buildings themselves are largely unchanged, but the learning environment inside the classrooms only improves with each passing year. The professional development of faculty never ceases, as teaching strategies and techniques must keep innovative pace with the everadvancing technological tools they and their students utilize. And the proof is in the perceptive pudding: FCPS students in 2012 performed better on state mathematics, science and writing tests than they did in 2011; and, it was announced last week by the Nebraska Dept. of Education, FCPS students in 2013 performed better than in 2012.

"The assessment results prove that FCPS students are continuing to improve their scores in mathematics, science and writing," Supt. Tim Heckenlively said. "Much of this success can be attributed to the district's school-wide goal of focusing on raising student achievement. A highly qualified faculty, improved focus on achievement data, up-to-date technology and curriculum resources, and parental support all contribute to student achievement at FC Public Schools," he said.

Heckenlively, who is entering his fourth year as District 56 Superintendent, addresses patrons of the district and outlines some of FCPS' goals and priorities in a guest editorial published in today's *Journal* (see Page 2).

His term as superintendent, which followed 11 years as North School Principal, has coincided with a prosperous time for FC Public Schools. A suprisingly prosperous time, because when Heckenlively was selected to succeed Dr. Jon Habben in the spring of 2009, the "Cliff Effect" alarm had sounded full-blast in Nebraska schools. Federal stimulus monies had run out and the

state's budgetary woes led the Legislature to cut \$334 million, much of it coming from education. FCPS' certified state aid for 2010-11 was some \$600,000 less than the year before. Dr. Habben, now Executive Director for the Nebraska Rural Community School Association, used terms like "disaster" and "breathtaking" when describing the financial situation his successor was inheriting.

While dwindling state was and continues to be - a concern for FCPS and all rural Nebraska school districts, no "disaster" has yet materialized in Falls City, as tax revenues from skyrocketing property valuations are sufficiently filling the district coffers. And then some - Heckenlively and the District 56 BOE have effectively managed the money and even replenished the case reserves.

"It was tight, but we've been able to stay strong," Heckenlively said. "We've been able to run a steady budget without increases to the general fund," he said. "We continue to lower the levy and we're getting to the point where we don't have to borrow on a short-term basis, as was the case several years back."

Effective management in the boardroom has led to unprecedented accomplishment in the classroom. In Heckenlively's second year, school officials were in Washington, D.C., accepting FC High School's prestigious National Blue Ribbon Award. At the time, FCHS was just the third Nebraska school ever to receive the honor.

"I'm very, very proud of you, Falls City," Nebraska Governor Dave Heinemann said at the time. "This is something all of you should take enormous pride in. Falls City High is being recognized as a Blue Ribbon School – how often has that happened in Nebraska, let alone southeast Nebraska?"

District 56 is a model school district - literally. FCPS is one of 17 school districts working with the Nebraska Dept. of Education to develop model evaluations based on the framework for effective instruction.

"During this pilot year, we're preparing to undertake the challenge to work through the process for implementation. The goal of the new evaluation model is to ultimately improve

# County, union talks continue

Representatives of the Road & Bridge Department Union, Randy Gilsdorf and Jim Olberding, met with the Richardson County Board of Commissioners Tuesday, Aug. 13, to discuss the proposal they presented on July 23.

The proposal includes a two-year contract with a pay increase of 2.5% the first year and 3% the second year, an additional holiday (county fair) or a floating holiday, increasing paid time off to accumulate to 90 days and increasing the medical reimbursement amount from \$650 to \$1,250.

Board members Dave Sickel, Jim Davidson and Jim Standerford presented a counter offer that agreed with a two-year contract, with pay increases of 2.5% the first year and 2.5% the second year, with no other changes to be made from the previous agreement that expired on June 30, 2013.

Ted Buri, contract administrator of the NAPE Local 61 AFSCME, participated in the meeting by teleconference. The board was to meet again with the union representatives at today's



Time was when the State Fair and/or Labor Day was the traditional time for announcing candidacy for statewide office in Nebraska. Said announcements were often "events" designed to get the most spin out of the announcement. With the popularity of social media, such news is now often spread in tweets whenever.

So, if you want to keep up with who's in and who's out in the 2014 races, I suggest you get a large sheet of paper and divide it into grids with a wide column for Governor and one for U.S. Senate. Beside each wide column you should have two narrow columns indicating In and Out. Post the paper in an appropriate place: your garage, your basement, the back of the bathroom

Write in the names of the usual suspects, but do it in pencil. These things change quicker than a columnist can keep track. Under Governor you can list Democrats or Republicans in whatever order suits your voter registration card. Hint: leave more space for Republicans since there are more of them in Nebraska. It's too early to tell you how to prioritize things in the Senate race, which might take a few more months.

Ready? Let's go to Governor/ Republicans. Put these names in chronological or alphabetical order, no matter. State Senator Charlie Janssen of Fremont has been in the race for what already seems to be a long time since he has been issuing news releases on what he perceives to be nearly every topic of dinner table conversation that might occur. You can also add Senator Tom Carlson of Holdrege and Falls City businessman Charles Herbster who owns a large cattle feeding operation and a multi-level marketing business that has apparently made him financially successful. While you're at it, add Omaha businessman Pete Ricketts who is said to be ready to throw a baseball cap into

The unsuccessful 2006 GOP U.S. Senate nominee is currently co-owner of the Chicago Cubs. Nebraska Attorney General Jon Bruning has sent an e-mail to supporters to tell them he'll be running for reelection as Attorney General, not Governor. So don't add him to the

Now go to Governor/Democrats. Former University of Nebraska Regent Chuck Hassebrook should be first on your list. He was brave enough to step out a while ago as the first Democrat in the race. The Lyons resident is also the director of the Center for Rural Affairs. Add the name of State Senator Annette Dubas of Fullerton to the list. She said she'll announce next month, but she's in and hopes to make a race out of the primary and put some of her rural ideas on the line. DO NOT add Omaha State Senator Steve Lathrop to the list. He sent a tweet recently indicating he won't be a candidate, this time, and has opted to finish his lawmaking obligations and take a look at a possible

The hard part is done. Now go to the U.S. Senate column, under Republicans. Former State Trea-

surer and decorated Navy veteran Shane Osborn was the first to put his oar in the water and remains the only one in the race. Get ready to add Midland University President Ben Sasse. The former U.S. Assistant Secretary of Health and Human Services during the last two years of the George W. Bush administration says he'll announce around Labor Day. There is nothing to write in the Democrat column, yet.

The Dubas - Hassebrook contest could pivot on each candidate's stand on abortion. Nebraska Right to Life endorsed Dubas during her last legislative race. Hassebrook was endorsed by Planned Parenthood Voters of Nebraska during his 2006 Regent's race and refused to join other NU regents who tried to restrict stem cell research. He said

he supports current law on abortion in Nebraska, the majority of which was offered by pro-life Democrats in the officially non-partisan Unicameral and signed into law by then Governor Ben Nelson, also a prolife Democrat.

Some observers say that Rickett's entry in the Republican gubernatorial race could make the whole game expensive again. In 2006, he spent about \$12 million of his own cash in a failed attempt to defeat Nelson. You might want to add another column to your chart to track campaign finance reports if such things interest you.

OK, pencils down now. We'll update your lists again during the nine months remaining before the 2014 primary.

# What you need to know about Congress right now

Deeply unpopular and flagrantly unproductive, Congress is on its August recess right now. It won't return until Sept. 9, after a five-week recess, leaving itself just a few days to settle issues like raising the debt ceiling and passing a federal budget. Here are some things you should know about where

it stands at this stage of the game: — Few, if any, Congresses can match this one for futility. It managed to help out some communities in the wake of Hurricane Sandy and to reach a deal on presidential nominations, but mostly it can't get things done — whatever your politics. The repeal of Obamacare, action on climate change, a "grand bargain" on our fiscal problems, education and tax reform, creating jobs, strengthening gun laws... the list of dropped balls is long, although there is still hope for immigration reform, if just barely. A few weeks ago Speaker John Boehner told Americans not to



judge Congress by how many laws it passes, but by how many it repeals. It hasn't succeeded on either count.

— The budget process is a mess. It's been years since Congress put together a budget according to its regular order, but even by its recent low standards this year has been chaotic. None of the appropriations bills needed for the government to continue running after Sept. 30 has been enacted. "It is common for Congress to leave big budget fights until the last minute," the Wall Street Journal's Janet Hook wrote as Congress left town, "but the budgeting process now seems so adrift that even congressional veterans find it hard to see a resolution." Passing a budget is the most basic function of government, and Congress can't manage it.

— Members of Congress do not like to compromise. The parties are more divided ideologically than they've been for many decades, with one side fiercely hostile to government and the other convinced that government can accomplish good things. Neither side can get things done on its own. That's pretty much the definition of when responsible lawmakers step forward to build a consensus. Yet in this Congress, either they don't know how or they're not interested. A glimmer of hope does exist, as more members respond to polls showing Americans believe it's more important for the parties to compromise than to stick to their positions. They may not be able to come to agreement, but some of them are talking about how willing they are to reach across the aisle.

— Even so, it's worth noticing that one of the congressional parties is extraordinarily difficult to lead at the moment. The Republicans are fractured and squabbling over their future direction. This makes me sympathize with the formidable task the Republican leadership confronts.

— Hardly anyone out there thinks Congress is doing a good job — it's consistently below 20 percent approval ratings — and most people think it's too partisan. Yet members aren't very concerned. They've become quite skilled at running against Washington, even though they are Washington. And they count on the fact that few voters hold their own member of Congress responsible for its shortcomings, however unpopular Congress as a whole has become.

— As lobbyists descend in swarms on Capitol Hill, they hold more power than ever. They rain cash, twist arms, and even draft bills — all the things that powerful congressional leaders used to do. The NRA's defeat of legislation strengthening background checks for gun purchases, in the face of overwhelming public sentiment after Newtown, was nothing less than an impressive display of political clout and an example of how influential lobbyists and special interests have become. Perhaps this is why a good number of my former colleagues have made a tidy living for themselves by becoming lobbyists.

— Finally, all of this contributes to the emerging themes for the 2014 congressional campaign. Candidates will clearly run against the mess in Washington, and a good number of them, though not all, will talk regularly about the need to be bipartisan. The big question for 2015 will be whether the successful ones can translate their talk into legislation to help move the country forward.

meeting.

Highway Supt. Scott Huppert briefly reviewed the proposed budget for 2013-14 — a discussion to be continued this week. Andy Snyder of Smith Hayes & Associates updated the board on the current bond rates and information for financing a jail facility with a bond.

—Met with Sheriff Randy Houser to review the proposed fiscal year 2013-14 budgets of the sheriff's department, jail, Humboldt law contract and investigator. A quarterly jail inspection was held and the facility was found to be in good order.

—Reviewed proposed budgets with Pam Vice, County Assessor; Austin Duerfeldt, County Treasurer; Jami Rutt, Cooperative Extension; Doug Merz, County Attorney; and Jim Gerweck, EMA Director.

—Adopted a resolution to set the tax levy allocation for the rural fire districts and the Ag Society for the tax year 2013 at .02 cents. Standerford abstained.

—Moved to advertise for sealed bids for the re-roofing of the Armory building, with bids to be received by 11:30 a.m. Tuesday, Sept. 3.

the instructional process for our entire staff, both teachers and principals, which will result in higher achievement for our students," Heckenlively said.

"All school districts should and need to have a clear, focused plan on improving student learning. FCPS this year will implement the 1:1 iPad Learning Initiative at Falls City High, which provides an iPad for every freshman, sophomore, junior and senior enrolled.

"It's been a district goal since I've been superintendent," Heckenlively said. "We were able to make a three-year lease purchase without increasing our technology budget at all."

The district goal, of course, is to ensure that Falls City students are career and college ready by the time they graduate from high school. And, according to the Nebraska Dept. of Education, FCPS is getting better all the time: Seventy-five percent of FCPS students meet or exceed state reading standards; 70 percent meet or exceed math standards, compared to 67 percent last year; 80 percent meet or exceed state science standards, another three percent increase; and 69 percent meet or exceed state writing assessments, compared to 64 percent last year.

Richarsdson County Sheriff Randy Houser recently recognized Deputy Joshua Nincehelser with a certificate of commendation for exceptional performance of duty in a stressful and dangerous situation, which stemmed from a call Nincehelser responded to on the night of July 28.

"Performance such as this is characteristic of Deputy Nincehelser's grace under pressure and ability to calmly respond to high stress situations, which reflects great credit upon himself, the Richadson County Sheriff's Office and all law enforcement officers," Houser said. His performance under stress is a testament to his character, training and professional orientation.

"It is a great pleasure to recognize Deputy Nincehelser's superior performance of duty. Congratulations for a job well done."

Nincehelser responded to the possible drug overdose call at a residence in rural Richardson County and upon his arrival, he made contact with the subject, who had taken a large quantity of Xanax without a prescription. Several members of the subject's family were present and while ambulance squad personnel and paramedics attempted to assess their patient, the subject's 16-year-old sister approached from inside the residence with

several kitchen knives raised, shouting, "I'll kill you all."

Nincehelser presented the Tazer at a distance of approximately eight feet and calmly issued a warning to the assailant to drop the knives or be tazed. When she complied, Nincehelser placed her in handcuffs, detained her in his patrol vehicle and directed the ambulance squad personnel to retreat to the roadway adjacent to the property due to verbal threats and interference from another mail sibling. Nincehelser radioed for assistance, but it would be another 13 minutes before the next deputy arrived.

Nincehelser placed the other belligerent sibling in handcuffs and seated him in a lawn chair while he contained the chaotic situation. He was able to keep the overdose subject under observation and communicated calmly with the three adult family members who were present, while receiving further verbal abuse from the detained male sibling, until assistance arrived and it was safe for ambulance squad personnel to return and resume patient care.

### Governor, First Lady encourage parental inclusion in education

STEM education opportunities will be located throughout the fair. STEM will also be featured at Nebraska's Largest Classroom, held at the fair on Aug. 26 and Aug. 27.

The Nebraska Community Learning Center Network is a statewide public-private partnership that supports sustainable, high-quality, school-community collaborations that provide youth with what they need to be successful in school and in life. The network is part of the Nebraska Children and Families Foundation, a non-profit that aims to build strong communities that support families so their children can grow up to be thriving, productive adults.

"Parents and teachers working together is an essential element in student learning and academic achievement," said First Lady Sally Ganem, a former elementary school teacher and principal. "Good teachers combined with strong parental involvement leads to good learning. We have seen firsthand the difference it can make in the life of a young Nebraskan."

The Nebraska Community Learning Center Network collaborations provide students access to areas of learning they may never experience, including hands-on STEM activities. Through the process, participants' exhibit increased school attendance, positive behavior and improved academic perfor-

mance. "Parent involvement remains one of the most important factors in helping ensure that all children succeed in school," said Jeff Cole, Vice President for School-Community Partnerships for Nebraska Children and Families Foundation. "We know, however, that the structure and hectic pace of family life today presents many challenges for parents to participate in traditional parent involvement activities at their children's schools. That is why Nebraska Children and Families Foundation believes it is vital for schools to work in collaboration with community groups to develop a new opportunities that enable all parents to get engaged in supporting their students education."







# BEWARE: SOUTHERN RUST

Nebraska corn growers should be scouting their fields for southern rust, especially those fields planted later this spring and in southern Nebraska counties.

Southern rust was confirmed in samples submitted to the University of Nebraska-Lincoln and private laboratories from 11 counties in south central and southeastern Nebraska with more expected, said Tamra Jackson-Ziems, UNL Extension plant pathologist. As of Thursday, there had been confirmed cases in Pawnee County, but not yet Richardson, Nemaha or Johnson.

"These samples were from fields that had low incidence of disease at this time," she said. "Warm temperatures and high humidity may promote development and spread of the disease."

Rust diseases produce large amounts of spores that can be easily moved by wind for long distances. Having a history of southern rust in corn does not have any impact on disease development now, because this pathogen does not overwinter in infected residue, Jackson-Ziems said.

"The spores must be carried into the area from southern or western locations by winds from diseased areas," she said. "At this time, southern rust has not been confirmed in either Kansas or Missouri corn fields. If the disease continues to spread and worsen in Nebraska, those fields planted later are especially at higher risk for disease and potentially severe yield impacts."

Jackson-Ziems said the best way to keep track of southern rust is to monitor reports from local university plant pathologists, diagnostic laboratories and county Extension offices. Crop disease information in Nebraska is updated on CropWatch, UNL Extension's crop production newsletter at cropwatch.unl.edu.

The characteristics used for differentiating between common rust and southern rust are described and illustrated in the NebGuide, Rust Diseases of Corn in Nebraska, available from local UNL Extension offices and online at http://www.ianrpubs.unl.edu/sendIt/g1680.pdf

The simplest and most reliable way to differentiate the diseases without a microscope is to

examine both leaf surfaces for spore production. Southern rust spore production is mostly limited to the upper leaf surface and tends to be tan/orange in color.

The most reliable method for identifying corn rust diseases is based on examination of microscopic spore characteristics. Anyone needing assistance identifying diseases or other plant problems can submit samples to the UNL Plant & Pest Diagnostic Clinic, 448 Plant Science Hall, Lincoln, NE 68583-0722. Other diseases that have been identified across Nebraska include:

- Common rust This rust has been evident across Nebraska for several weeks. Common rust spores are usually brick-red to brown in color; however, the color difference is not a reliable method for identification when both are not available for comparison and because the spore type can change and turn black later in the season for both diseases.
- Goss's bacterial wilt and blight Goss's wilt continues to be confirmed in samples submitted from across the state. Be sure the disease has be identified before making a fungicide application since Goss's wilt and other diseases also are present right now and can't be directly managed with foliar fungicide applications. Goss's wilt will likely increase after the recent severe storms that have damaged crops.
- Physoderma brown spot Another disease that has begun to develop in Nebraska corn fields is physoderma brown spot. This disease is normally not a concern, except in rare cases, such as on susceptible hybrids exposed to wet conditions, but the lesions are sometimes mistaken for southern rust.



# Breath testing units to FC Police Department

LINCOLN — The Falls City Police Department has received three hand-held alcohol breath-testing units through a traffic safety grant award.

The units, valued at \$285 each, were provided by the Nebraska Office of Highway Safety as part of the state's ongoing effort to prevent underage drinking and alcohol-related traffic crashes, injuries and fatalities.

According to Highway Safety Administrator Fred Zwonechek, "The Falls City Police Department was awarded the new instruments to assist their personnel in identifying potential minor in possession, minor .02 driving and driving under the influence violators." The portable units display a digital reading of the blood alcohol level from a suspect's breath sample.

"These instruments provide the latest technology in preliminary breath testing," Zwonechek said.



## Bobcats preseason sixth in HAAC

Defending Heart of America Athletic Conference champion and NAIA Football Championship Series semifinalist Missouri Valley received eight of 10 first place votes to sit atop the 2013 HAAC Preseason Coaches' Poll, released at the annual Media Day festivities at the NAIA national office.

The Vikings took 80 of the possible 81 voting points to finish 10 points ahead of runner-up MidAmerica Nazarene, which received the remaining two first-place votes as well as four second-place tallies. The two teams will meet in Marshall on Sept. 21 in a matchup between the two teams that have won at least a share of five of the past seven conference crowns.

Peru State began the second half of the poll by being voted into sixth position with 40 points while Graceland took 29 points for seventh position. Avila (25 points), Central Methodist (22) and Culver-Stockton (10) finished out the last three positions. Last year the Bobcats were projected to finish eighth in the preseason poll and finished seventh.

Representing Peru State along with Bobcat head coach Steve Schneider were seniors Lance Steffen (Murdock) and Zach Lempka (Sterling). Coach Schneider addressed the loss of the team's top rusher noting that two players, Ethan Bray (Liberal, Mo.) and Adam Neels (Elmwood), handle the duties during spring ball.

Schneider also was questioned about the renovation of the Oak Bowl and its impact on recruiting. He said, "It has had some impact already, but once it is completely done it should have a bigger role as the future recruits and their families will get to see the product. I do want to thank our administration, the system office, and many others in support of the project."

Steffen fielded the first question which was regarding how he plans to step up into a leadership role since he will be a four-year starter. Steffen stated, "On the field, being a four-year starter, people respect that. In addition, both Zach and I have been members of the Student Athlete Advisory Council (SAAC) for the past three years, so we have had leadership roles with the football team during this time. Also, both of us have been Bobcat Elite team leaders which have given us the role of making sure our team members gain accountability skills and leadership qualities."

Lempka's question dealt with how his responsibility would change in leading the defense after the loss of a top leader for the past several years on defense. Lempka noted, "I want to take a lot of things Preston Bruss (two-time HAAC First Team from Bennet) did on and off the field to lead the team, so I plan to emulate a lot of those same qualities."

The 2013 season kicks off on Saturday, Aug. 31, with three HAAC teams opening their respective seasons. Benedictine will host Briar Cliff (Iowa) and Peru State welcomes Dakota State (S.D.) while Culver-Stockton opens with a visit to Lindenwood-Belleville (Ill.). All 10 teams will hit the road for the inaugural HAAC-KCAC Football Series on Saturday, Sept. 14, with each team taking on the KCAC team that finished in the same position in the 2012 standings at the KCAC site.

Five HAAC teams are ranked in the Top 25 in the NAIA Football Coaches' Preseason Top 25 Poll.

All five teams – Missouri Valley College, MidAmerica Nazarene University, Baker, Evangel, and Benedictine – are on the Peru State Bobcats' schedule for the 2013 season

The Bobcats will face Benedictine on Sept. 28 in Auburn, MidAmerica Nazarene at Oct. 12 in Olathe, KS, Missouri Valley on Nov. 2 in the Oak Bowl, Evangel on Nov. 9 in the Oak Bowl, and

will finish the regular season with Baker on Nov. 16 in Baldwin City, KS

Schneider noted that the conference was one of the best in the NAIA.

"We know in the HAAC we will have a tough opponent every time we hit the playing field, whether it is those teams in the preseason rankings, or our other HAAC competitors," Schneider said. "In addition, we know that Dakota State will be improved and that Southwestern will be looking for a win in the HAAC/KCAC crossover game. So, our guys will have to be ready each and every Saturday of the football season."

In addition, Schneider added, "Having three of the five preseason rated teams at home, which includes the Benedictine game in Auburn, should provide for some additional support from our fans. At present, the Nov. 2 game with Missouri Valley is scheduled to be the first game in the "new" Oak Bowl and also Homecoming, so we would anticipate a huge crowd for it. Plus, the game the following week with Evangel will be Senior Day and I know our seniors do not plan to disappoint their families, friends, and the Bobcat nation.

National runner-up Morningside (Iowa) begins the 2013 season as the No. 1-ranked team in the 2013 NAIA Football Coaches' Preseason Top 25 Poll, the national office announced Monday. Morningside, who tallied 280 points despite receiving just four first-place votes, finished the 2012 season with a program-best 13-1 record.

The Mustangs, led by 2012 AFCA Coach of the Year, Steve Ryan, are predicted to win their third-straight Great Plains Athletic Conference title. Wide receivers Kyle Schuck and Travis Hantleman, and the backfield tandem of Josh Gaedke and Joel McCabe, headline a Morningside offense that returns nine starters from a year ago.

Defending national champion Marian (Ind.), who handed Morningside its only loss in the 57th annual Russell Athletic-NAIA Football National Championship, collected eight first-place votes and 267 points to earn a share of the No. 2 position. National semifinalist Missouri Valley shares the No. 2

ranking with Marian after receiving the remaining first-place vote and 267 points. Marian has now been ranked among the top five teams for 26-straight polls, dating back to Poll 1 of the 2011 season.

National semifinalist Saint Xavier (Ill.) and St. Francis (Ind.) round out the Top 5 with 260 and 239 points, respectively.

The HAAC—Missouri Valley, No. 10 MidAmerica Nazarene (Kan.), No. 15 Baker (Kan.), No. 22 Evangel (Mo.), and No. 24 Benedictine (Kan.) has the most teams in the preseason poll with

five teams making the list. The Mid-State Football Association Midwest— Saint Xavier, No. 11 St. Ambrose (Iowa), No. 16 William Penn (Iowa) and No. 19 Grand View (Iowa)boasts four teams

There was significant movement in the poll with No. 12 Carroll (Mont.) making the biggest improvement —a six-spot jump. No. 14 Southern Oregon fell the furthest, dropping nine positions after being ranked No. 5 in the Spring 2013 Poll.

No. 21 Belhaven (Miss.) of the Mid-South Conference West and No. 23 Langston (Okla.) of the Central States Football League were newcomers to the poll, replacing Valley City State (N.D.) and Robert Morris (Ill.) who both dropped out of the top 25. Belhaven was last ranked in Poll 4 of the 2004 season and Langston was last ranked in 2012 Preseason Poll.



### Cottonwood trees threatened

Early settlers and Native Americans in Nebraska used the eastern cottonwood tree for firewood, landmarks and construction materials. Even today, cottonwood is by far the most harvested and processed timber tree species in the state. But that could all change if the tree continues to decline in population, a University of Nebraska-Lincoln extension forester said.

The eastern cottonwood (Populus deltoides) has been Nebraska's state tree since 1972. It is a native, fast-growing, relatively short-lived tree, dependent on bare soil and good soil moisture reproduce. It is most often found in riparian areas along rivers and streams, often in pure, even-aged

Nebraska's cottonwood resource is threatened because of four factors, Nebraska Forest Service/ UNL Extension forester Dennis Adams said. Flood control, land conversion, livestock grazing and herbicide damage are all causing a decrease in cottonwood population.

"Cottonwood requires bare mineral soil to regenerate," Adams said. "It was prolific in the past due to the periodic flooding that occurred along the state's rivers and streams."

Historically, flooding was a common occurrence along the Republican, Platte, Blue, Elkhorn, Missouri and many other rivers and streams in Nebraska. Since the 1950s, extensive stream channelization and numerous flood control structures have affected the natural stream flow in the state's major rivers and smaller tributaries. Occasional flooding still occurs, but not nearly as extensively as in the past, Adams said. While dams and channelization has enabled many additional uses of previously flooded riparian bottomlands, it has reduced the ability of cottonwood to regener-

"There's not much we can do about cottonwood loss due to

flood control because we aren't going to take the dams out," Adams said.

Adams said it is projected that cottonwood will continue to decrease in both area and number of trees in the future.

"Primarily a result of flood control efforts, the average size and age of our cottonwood trees have increased," Adams said. "Recent forest inventory data indicates that our mature cottonwood stands have virtually no cottonwood regeneration, but are being encroached upon and replaced by other tree and shrub species, often undesirable species like eastern red cedar or Russian olive."

Adams said that one way to help bring back the cottonwood population aside from planting new trees is to allow natural regeneration in riparian areas that may now be in marginal crop

Adams also said that farmers should be careful when using herbicides, particularly aerially applied, on adjacent crops and pastures. Herbicide drift can damage cottonwoods, causing leaves to drop or curl, slowing growth and causing dieback of branches. In extreme cases herbicide drift can kill trees.

"If farmers spray when it is too windy or too hot the herbicide can drift or volatize and can cause damage to adjacent forest land," Adams said.

Adams said that the cottonwood provides important habitat for many small mammals and birds, including squirrels, raccoons, bald eagles and great blue

"For cottonwood to continue to be a significant forest resource in the future, intervention by us may be necessary to regenerate this historic forest resource, not only for wood products, but for the important wildlife habitat, watershed protection and other environmental benefits cottonwood forests provide," Adams said.

# Concussion course hits one million mark

One million concussion courses have now been taken by coaches and other individuals since the National Federation of State High School Associations (NFHS) and the Centers for Disease Control and Prevention (CDC) developed the online course in May 2010.

Earlier this week, the millionth "Concussion in Sports What You Need to Know" course was taken through the NFHS Coach Education Program at www.nfhslearn.com. This free online course provides an overview of how a person can recognize signs and symptoms of a concussion and the appropriate action to take. The course includes each state's return-toplay guidelines required for high schools.

"We place great emphasis on concussion recognition and treatment, and the extraordinary success of our online course has been gratifying," said Bob Gardner, NFHS executive director. "The course is 20 minutes long and it's free. We commend everyone who has taken it."

The NFHS and its Sports Medicine Advisory Committee (SMAC) have worked with the CDC on recent updates to the concussion course. Recommendations have been added regarding the prevention of concussions, and the course test has been updated. The tests (pre-test and post-test) now include 11 questions and provide immediate feedback to the user, thereby creating a better learning experi-

Individuals have access to the course's printable resources, including a parent's guide to concussion in sports, a coach's guide, an athlete fact sheet and materials to implement a protocol for concussion treatment.


"In addition to coaches, we are pleased that many contest officials, administrators, parents and students are among the one million individuals who have taken the concussion course," said Tim Flannery, NFHS director of coach education.

The NFHS has been a leader among national sports organizations in establishing guidelines to deal with concussions. In 2008, the SMAC advocated that a concussed athlete must be removed from play and not allowed to play on the same day. For the past four years, all NFHS rules publications have contained guidelines for the management of a student exhibiting signs, symptoms or behaviors consistent with a concussion.

Atotal of 34 online courses are now offered through the NFHS Coach Education Program, including the two core courses - "Fundamentals of Coaching" and "First Aid, Health and Safety for Coaches." The NFHS also offers 14 sport-specific courses and 18 elective courses, including 13 that are free.

### Check pastures and non-cropland for sericea lespedeza, other invasive weeds

While pasture conditions are much better in 2013 compared to 2012 when most of the region was hit with severe drought, pastures still may be affected from last year. It is important to keep a watchful eye out for invasive weeds in your pasture such as Sericea lespedeza or other invasive weeds. The past several years we have had informational meeting about the invasive weed Sericea lespedeza. Now is a time you need to check pastures and non-crop areas to see if it is present. If it is present, it should be treated with a herbicide. If you have harvested hay off CRP or pasture that had Sericea lespedeza, use caution when feeding it. Try to feed hay in a confined lot or on cropland to reduce the spread of seed. If you haul manure from this lot, use the manure on cropland rather than pasture. Sericea lespedeza is much easier to control on cropland than pasture.

People have done an excellent job of identifying and treating it in southeast Nebraska, so we can keep it under control before it gets a foothold and becomes a huge problem here. Even if you have not had a problem with it previously, it may have spread to your farm. Sericea lespedeza spreads as birds and other animals spread the seed. Sericea lespedeza can grow as tall as 4' under good growing conditions. It is a coarse plant with a dense growth of leaves along its stems and branches. In the vegetative stage cattle will eat it, but as it matures it becomes unpalatable to cattle because of high tannin content. It is a very prolific seed

producer as well. It is extremely competitive and it can crowd out desirable grasses and forbs.

If you have a weed growing on your property that you don't know what it is and think it may be Sericea lespedeza, bring it into the Nemaha County Extension office so we can positively identify it. In early summer PastureGard or Remedy, both of which contain the active ingredient triclopyr, are recommended for control. This time of year and in the fall, products that contain the active ingredient metsulfuron are the most effective. For rangeland, the University of Nebraska recommends Cimarron Plus or Escort.

Another weed which seems to be showing up more, especially in non-crop areas is Johnsongrass. I have seen it along roadsides and along the edges of fields and pastures. Johnsongrass is usually easy to control with glyphosate or one of several a grass herbicides. Fall is also a good time to control musk thistle. If you have had problems with this noxious weed in the past, you may want to check these previously infested areas. It is much easier to control musk thistles when they are young seedlings in the rosette stage than in the spring when they start to bolt. The 2013 Guide on Weed Management (UNL Extension publication EC130) provides several options for control of these weeds. If you have questions about these weeds or any weeds you are unfamiliar with, feel free to contact the Extension off in Nemaha County at (402) 274-4755.

### Swine disease affecting bacon prices nationwide

LINCOLN — A devastating swine disease before they go home. new to the United States hasn't shown up in Nebraska yet, but it's already forcing bacon prices nationwide to new highs.

The University of Nebraska-Lincoln's Veterinary Diagnostic Center stands ready to test piglets for the Porcine Epidemic Diarrhea virus, said Dr. Bruce Brodersen, assistant professor in the center and the School of Veterinary Medicine and Biological Sciences.

Porcine Epidemic Diarrhea -- PED for short -- has been around since at least the 1970s but first showed up in the U.S. this summer.

"Since the swine population has never been exposed before to this virus, they're very susceptible," Brodersen said. "The disease outbreaks are very severe because there's no immunity to it at all. So, it's been devastating as far as pig mortality is concerned."

Brodersen said he expects PED to turn up in Nebraska eventually, but swine producers can take steps to avoid it coming to their facilities.

Surveys show PED may be spread when trucks gather anywhere there are common loading and unloading chutes such as buying stations. From those common areas, the virus can be tracked back to individual operations. Brodersen urged producers to be very careful to clean their trailer or truck

"You should always follow very strict biosecurity steps," he said. No vaccine is available in the U.S. yet.

Piglets infected with PED experience diarrhea and vomiting violent enough to kill them. The U.S. Department of Agriculture has confirmed only about 400 cases of the disease in the lab, but its toll has already been estimated in the hundreds of thousands.

As a result, pork price futures have risen to historic levels, with hundredweights of pork going for about \$105 in recent trading at the Chicago Mercantile Exchange. The USDA reports that the same amount of pork went for \$78 in March.

Fox Business News reported that the prices for pork bellies, which are cured into bacon, have risen particularly fast. On Tuesday, the wholesale price of a hundred pounds of fresh pork belly topped \$189, 5 percent more than it was five days earlier and apparently at or near all-time highs.

Retail prices for bacon don't track one-to-one with belly prices, Fox Business News reported, but they also have risen. The Bureau of Labor Statistics estimated the price of a pound of bacon in urban supermarkets at \$4.92 in June -- up 14 percent from June 2012 and another all-time high.





# Husker High School expanding

of University Nebraska President James B. Milliken announced earlier this month that NU is launching a second phase of its highly successful Nebraska Virtual Scholars program. The program, initiated in 2011, will expand access to online courses to more high school students in the state and create opportunities for the university to work with school administrators - particularly those in rural Nebraska – to identify challenges that could be addressed through online educa-

This year the Virtual Scholars program will provide 100 scholarships to Nebraska high schools for students to take courses from the University of Nebraska High School for free. Formerly known as the Independent Study High School, the NU High School is a university-wide initiative that, in line with the goals of the state's P-16 Initiative, is expanding access to education to more students who face barriers with traditional paths to degrees. The high school is especially focused on supplementing the education of Nebraska students by providing STEM, Advanced Placement, foreign language and other courses not offered at their schools.

Schools must apply on behalf of their students in order to be considered for the scholarships. Applications are available here and will be accepted until Sept. 13, with recipients announced in early October. While the program is open to all Nebraska schools, it is especially focused on expanding opportunities for students in rural schools. The NU High School's full catalog of more than 100 core, elective and Advanced Placement courses will be made available.

Milliken said he hopes the scholarships will provide the catalyst for more discussions between the university and school administrators about the needs of Nebraska schools and how on-

line education might meet those needs. In turn, those discussions should yield valuable insight for the university, schools and policymakers, Milliken said.

"The first phase of the Nebraska Virtual Scholars program was a tremendous success, providing opportunities for talented students across the state to enroll in courses that otherwise would not have been available to them," Milliken said. "With this next round of the Virtual Scholars program, we will expand access to education to even more students, working with schools to better prepare them to succeed in college and beyond. The entire state will benefit when our students are more success-

Gov. Dave Heineman, who chairs the Nebraska P-16 Initiative, said: "Education is the great equalizer and that's why it's important for all Nebraska students to have access to a quality, rigorous high school curriculum so that they are prepared to be successful. Establishing a statewide Nebraska Virtual School for our young people and the University of Nebraska's Virtual Scholars program are important steps forward. I hope students and schools will take advantage of this opportunity."

Sen. Kate Sullivan of Cedar Rapids, chair of the Legislature's Education Committee and a cochair of the P-16 Initiative, said: "The Virtual Scholars program is an excellent fit with the mission of our state's P-16 Initiative to increase student success in Nebraska. This is a great opportunity for Nebraska schools and I applaud the University of Nebraska for its commitment to expanding access to education to more students across the state, particularly in rural Nebraska. On behalf of the Education Committee and full Legislature, I look forward to learning more about the unique challenges facing rural Nebraska and discussing how we can work together to solve them."

In the first round of the Virtual Scholars program, 60 high school students around the state got the opportunity to take online courses for free – including, for example, a student in Dixon County who took Advanced Placement calculus, which his school didn't offer: a student in Wheeler County who hopes to start his own business someday and was able to take a business communications course; and a student in Lancaster County who wanted to take French but whose small school offered only Spanish. Many of the applications sought scholarships for STEM (science, technology, engineering and mathematics) courses, confirming that there is a high demand across the state for more programs in these critical areas.

As a result of that initial round of scholarships, the online high school developed a number of new offerings, including career education courses focused on the STEM areas, math placement tests and several science courses.

"Now we have an opportunity to build on the initial success of Nebraska Virtual Scholars by further updating our course program based on what educators tell us they need," said Barbara Wolf Shousha, director of the NU High School. "I'm thrilled to be able to leverage the good work of Nebraska schools to make quality online education available to more students. It's my hope that the Virtual Scholars program will make more Nebraskans aware of the exciting opportunities available to them through online learning."

Currently the NU High School serves more than 2,400 students, 250 of whom are from Nebraska. Scholarships provided through the Virtual Scholars program will cover tuition, fees and course materials. The standard cost for Nebraska residents for University of Nebraska High School courses is \$194 per one-semester course.
