County accepts local bid for Sheriff's vehicles

During their Tuesday, Aug. 23, Courthouse meeting, the Richardson County Commissioners approved the bid from a local dealer on two vehicles for the Sheriff's Department.

Board members Jim Davidson and Jim Standerford (Chairman Dave Sickel was unable to attend the meeting) reviewed with Sheriff Don Pounds both the State of Nebraska contract award and an additional quote from Armbruster Motor Co. of Falls City. The Armbruster quote was accepted. The board voted to purchase two Chevy Silverado 1500 crew cab 4WD vehicles at a cost of \$33,484 each.

Bids for kitchen equipment at the new Jail/Law Enforcement Center were rejected.

Sheriff Pounds said inmates were to be moved to the new Center on Thursday of last week.

Board members held their weekly meeting with Hwy. Supt. Scott Huppert, who showed photos of bridge projects in progress. Crews are working at several sites removing small bridges and placing in culverts.

Later, Huppert reviewed a quote for repairing the north Courthouse entrance sidewalk and stairs. The quote was from Kobush Concrete Inc. of Platte City, MO, to repair and seal cracks (two coats of sealant) at a cost of \$9,187. The board voted to approve the quote as presented.

In other developments, the board:

—Reviewed FY 2016-2017 office budgets as presented by Clerk of the District Court Pam Scott and Extension Educator Kaytlyn Kennedy.

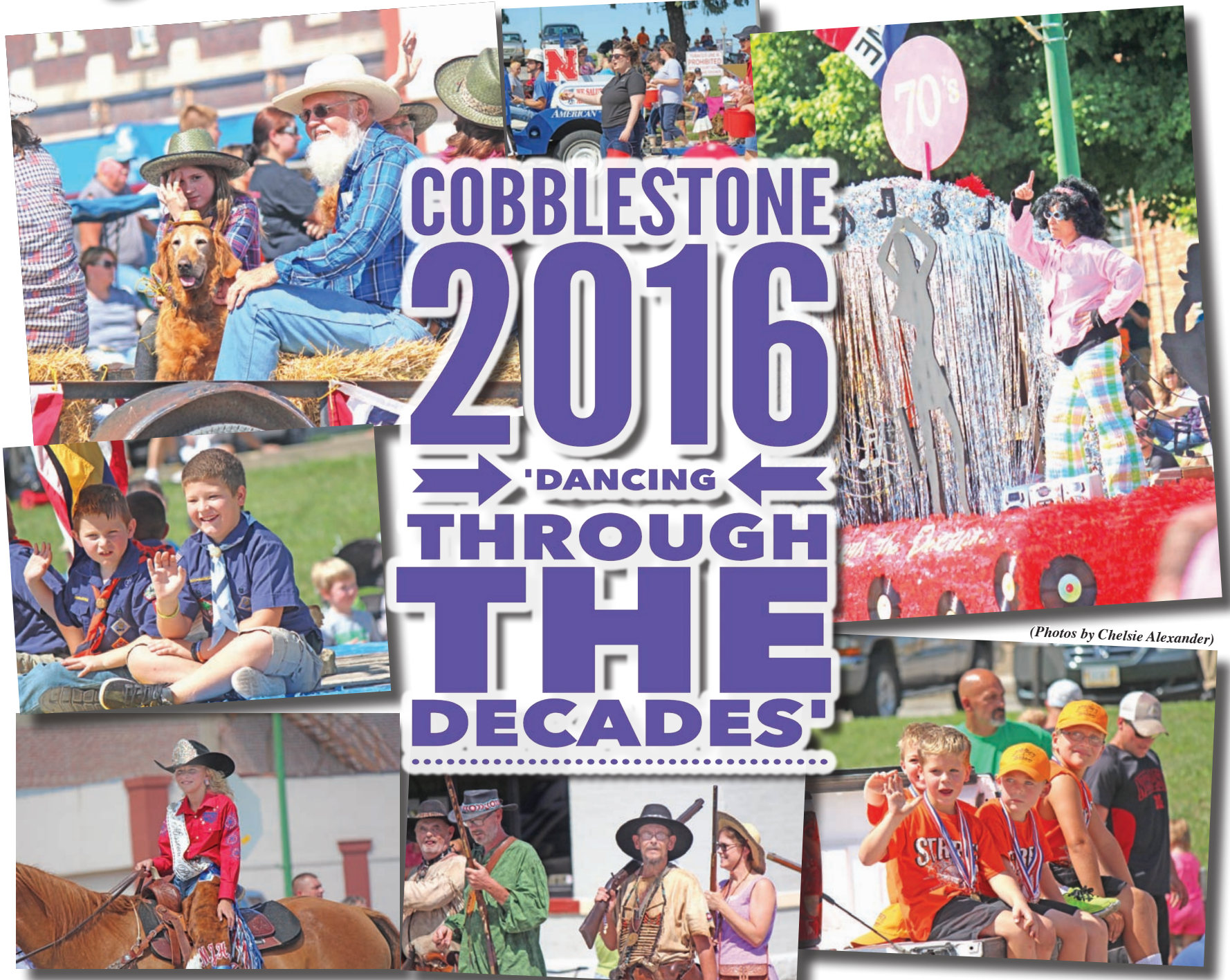

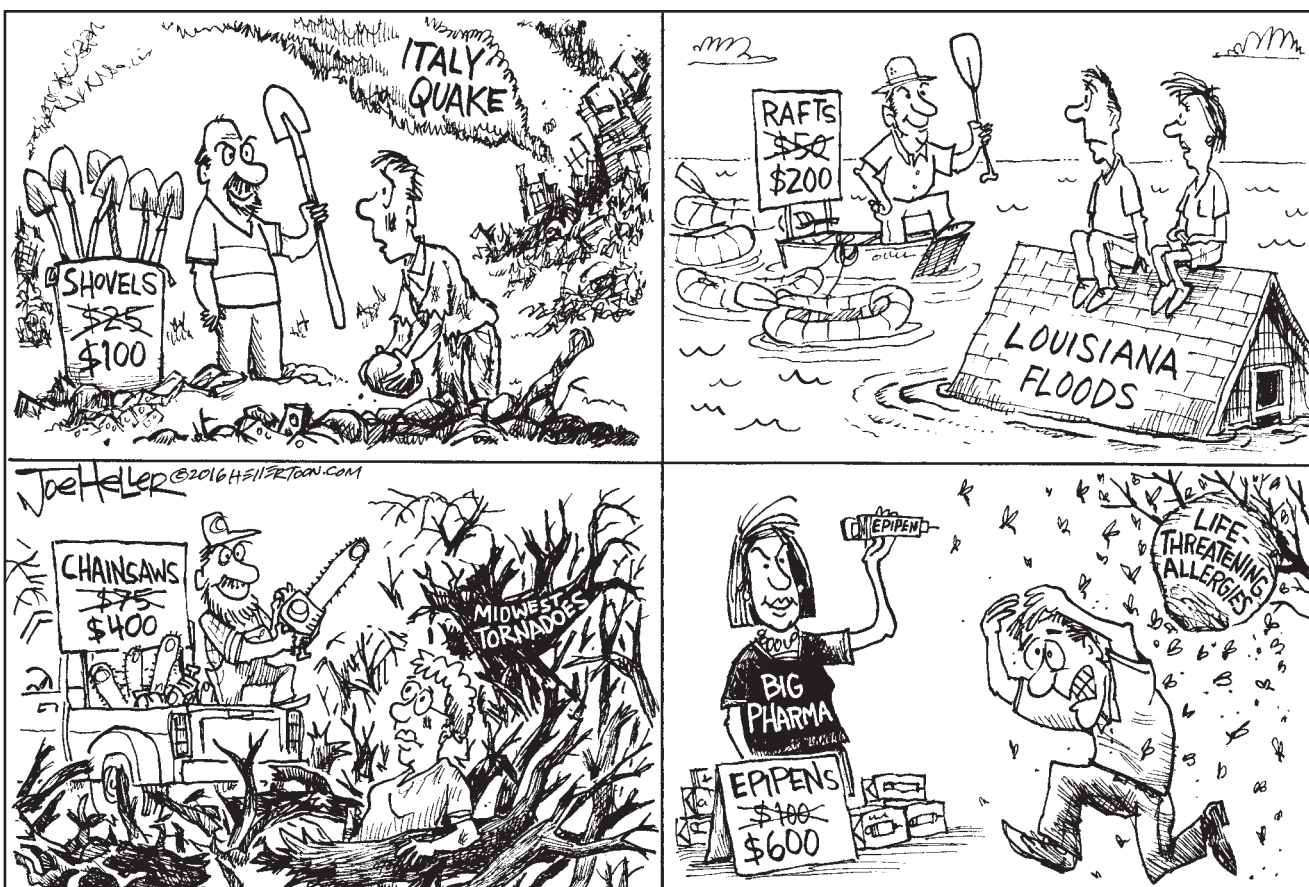

Drug prices keep rising with no end in sight

“Thinking About Health,” is part of the Nebraska Press Association’s partnership with Rural Health News Service, which will provide Nebraskans with unbiased health-related information, designed to help better understand the health issues facing our communities, state and nation.

Recently a tweet from Lauren Sausser, a fine health reporter I know in South Carolina, caught my eye. “Crazy drug prices became personal. My dad will start Keytruda regimen on Friday, \$15,000 per infusion, once every three weeks indefinitely.” The high cost of pharmaceuticals had hit home!

Her 61-year-old father, Jim McCallister, who lives in Spartanburg, S.C., had been diagnosed with a melanoma discovered during a routine skin exam a few weeks earlier. It had spread to his lungs. Doctors recommended the drug, which uses the body’s immune system to attack cancer cells and has showed promise in treating aggressive melanomas.

McCallister’s employer-provided insurance is paying for most of his treatment, and the family is looking into Merck’s co-pay program. In the meantime, McCallister faces several thousand dollars of out-of-pocket costs.

McCallister may be lucky cost-wise. But the fact remains: Somebody is paying for the high cost of Keytruda and other new drugs coming on the market. Sausser said her dad asked if insurance would cover the drug. “The doctor told him they would find some way.”

That’s the nub of the dilemma. For many like McCallister, there may be help, often from the drug companies themselves in the form of patient assistance plans. Remember drug company AstraZeneca’s ads for some of its costly drugs: “AstraZeneca may be able to help”?

Sometimes state or local government programs, private charities, nonprofit agencies, or coupon programs help patients pay for their drugs. Patients who can’t get help from any of those sources often go without.

None of the assistance programs, however, attack the underlying prices for the drugs, which pharmaceutical makers can set according to what the market will bear. They can pretty much do whatever they want with little push back from those who end up paying the bills – governments, insurers and patients. The U.S. has no cost controls, and government doesn’t negotiate drug prices the way many other countries do.

So the price of commonly prescribed drugs like the EpiPen, a shot that stops life-threatening allergic reactions, has risen to more than \$600 for two pens. In 2009 two pens cost \$100. The price for Abilify, an antipsychotic, has risen 113 percent between 2007 and 2014, and the cholesterol-lowering drug Crestor has climbed 103 percent over the same time period, according to The Campaign for Sustainable Rx Pricing, a group of employers, insurers, and unions that are trying to raise public awareness of high drug prices.

That helps explain why Medicare recently reported its spending on prescription drugs increased more than 17 percent in 2014 even though the number of claims from the program’s 38 million beneficiaries rose only 3 percent.

Medicare’s prescription drug law was never meant to pay all a person’s drug expenses. This year once a beneficiary and her drug plan have paid \$3,310 for medicines, she reaches the coverage gap where she must pay the cost of most of her drugs. If she spends, out of her own pocket, another \$4,850 for drugs this calendar year, she qualifies for catastrophic coverage and pays only 5 percent of all her remaining drugs for the year.

The trouble is that with prices so high, it’s easy to end up in the coverage gap paying out-of-pocket. Even protection offered by catastrophic coverage may not be enough. That’s especially true for people taking high-priced specialty drugs.

In 2013, about 3 million people were in this predicament. “Not a lot of people pay above the threshold, but those who do can pay through the nose,” says Tricia Neuman, senior vice president of the Kaiser Family Foundation.

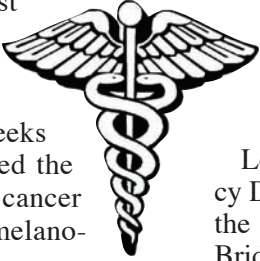
Escalating drug prices affect everyone – even those not taking expensive drugs or not on Medicare. High drug prices affect all insurance premiums sooner or later.

Not long ago I spotted a letter to the editor in USA Today from Heather Block, age 53 who has Stage 4 breast cancer. She was calling for patients to organize and build a network to help craft solutions for the problem of skyrocketing drug prices.

I talked to Block about this. Her zeal and interest in organizing patients reminded me of the early days of the consumer movement in the 1960s when citizens organized to pass legislation to make the marketplace safer and more fair. With drugs, Block says, it’s hard to organize people because of drug assistance programs that take the sting out of prices and make patients less willing to work against the companies, the presence of disease advocacy groups funded by the pharmaceutical industry, and a general reluctance to speak up for fear of jeopardizing their own health and survival.

Crop Cover Field Day scheduled for Sept. 7

A Nebraska Extension/NRCS Sponsored Cover Crop Field Day is scheduled for Wednesday, September 7th at the Trent Bohling Farm in western Nemaha County, one mile west of the Highway 136 & Highway 105 Junction. The field day site is 1/8 of a mile south of Highway 136 on 629 Avenue. Registration is at 9:30 with refreshments; followed by the program beginning at 10:00 a.m. Different cover crop mixes were planted at different planting dates in July and August in wheat stubble and will be available for examination at the field day. Several topics will be covered at this field day. Daren Redfearn, Extension Forage Systems Specialist with Nebraska Extension will discuss planting dates and species selection, Mary Drewnoski, Beef Systems Specialist, Nebraska Extension, will discuss how planting date and species impact forage quality and animal performance and also address using cereal rye in grazing

systems. Jay Parsons, Ag Economist, Nebraska Extension will address a very important question, lease arrangements for grazing cover crops. Humberto Blanco, UNL Soil Scientist will discuss research that is being conducted in Nebraska on the impact of cover crops on soil physical properties. 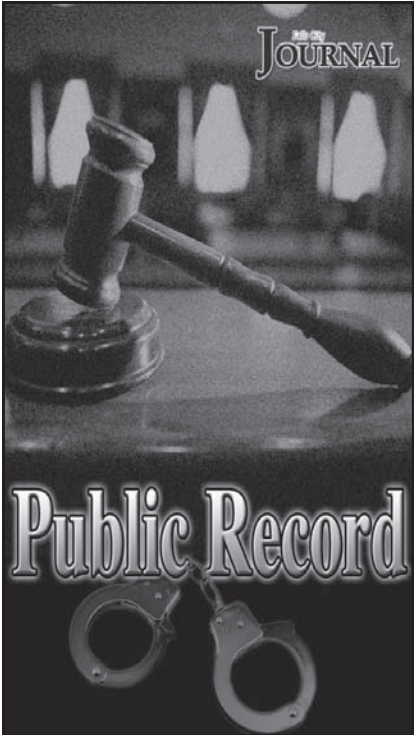

The Falls City Tigers kicked off their 2016 campaign on the road against the Southern Raiders in Wymore on Friday, Aug. 26.

The Tigers scored first and never trailed in the game. They capped off a 10 play, 64-yard

drive with a two yard touchdown run by Edward Fritz. The PAT failed but with 2:45 remaining in the first quarter, the Tigers had a 6-0 lead.

It didn't take long for the Tigers to get on the board again. This time it was an eight play, 64-yard drive, culminated by a 12-yard run by Zane Heckenlively for the touchdown. This time the PAT run by Rudy Vrtiska was good and with 10:09 left in the first half the Tigers had staked a 14-0 lead. This is where the score would remain as the first half came to a close.

The third quarter began with Southern taking the kickoff out to their own 30 yard line, but three plays, and minus seven yards later, the Falls City defense forced a punt. The Tigers didn't fair much better on their next drive as they totaled just five yards on three plays, and also had to punt the ball away.

The two teams traded possessions before the Tigers offense put together a seven play, 51-yard drive that ended with Heckenlively once again scoring, this time from two yards out. The PAT was no good as a Vrtiska to Trevis Keller pass fell incomplete. The Tigers now led by a

score of 20-0.

On their next possession Southern marched down the field in six plays for its first touchdown of the game.

Quarterback Drake Adams hit Trevin Saathoff for a 51-yard touchdown pass just over the head of a Tiger defender. The extra point kick was no good, and with 1:13 left in the third quarter, Falls City continued to lead, 20-6.

The two teams traded possessions once again in the fourth quarter. Falls City turning the ball over on downs, then forcing the Raiders into a three and out. After a Wymore punt, Falls City took the ball over on the opponents 33 yard line. On the following play Edward Fritz broke free for a 33-yard touchdown run. Fritz also tacked on the two-point conversion and the Tiger lead went to 28-6.

Scoring for the Tigers came to an end when Heckenlively carried the ball into the end zone from 18 yards out. The kick by Dalton Kennel was good and the final score went to 35-12.

Heckenlively was the workhorse for the Tigers as he sprinted for 232-yards on 22 carries. Vrtiska and Fritz put up 91 and 72-yards respectively.

On the other side of the ball the Tigers were led by Fritz with eight total tackles including 2.5 sacks.

The Tigers didn't play perfect though as they did commit 13 penalties for 92 yards. When asked about it Coach Fritz said, "We had some guys playing new positions, I think nerves were working on them more then normal." Fritz gave credit to Heckenlively on both sides of the ball. He also singled out the defensive line play of both Ben Bauman and Dalton Kennel.

The Tigers will be at home Friday night as they play host to Ashland-Greenwood with hopes of avenging last years 41-14 loss.

"Ashland will be more than a handful, they are a very gifted team that will be looking to get in the win column this week. We need to have a good week of practice," said Coach Fritz.

The 2016 Irish football season got underway Friday night, Aug. 26, and it didn't disappoint. After raining off and on all day, the clouds moved out and a rainbow was seen over the field soon after kickoff. Maybe it was a sign for what was to happen.

The Irish, playing without 316 pound senior Bryant Jom, were able to stay within striking distance for three quarters before pulling out a last minute dramatic victory over the Nebraska City Lourdes.

The Irish were once down 18-0 early in the second quarter and they trailed 24-8 as they entered half time.

When asked what gave them such trouble the first half Coach Goltz replied, "we made too many mistakes, we were sloppy with some penalties, which helped them keep some drives going."

Everything seemed to change after the first half. Coach Goltz said they made some defensive adjustments that paid off. He also said that the coaches reminded the players that they had and entire half to play, and that's just what they did.

The Irish first possession of the



third quarter looked too much like the two quarters before. Quarterback Drew Bippes was picked off at the Lourdes seven yard line, to end the drive. The defense held, and on the next set of downs Bippes found Junior Noah Keller with a screen pass to the right side of the field. Keller cut against the defense and raced 63 yards for the touchdown with 5:47 remaining in the third quarter. The conversion attempt failed but the Irish had cut the deficit to 24-16. Nebraska City drove the field but was stopped by the Irish defense on the eight yard line after a fourth down pass fell incomplete.

In the fourth quarter, the Irish capped off a 12 play, 72 yard drive when Bippes hit Emerson Keithley for a 13 yard touchdown. With the score 24-22, it looked like the Irish

had the Lourdes on the ropes. However the celebration didn't last long as the Lourdes took the kickoff back 72 yards and scored a touchdown two plays later, making the score 30-22.

The Irish didn't get their heads down though as they promptly drove 65 yards on just six plays which ended with Bippes hitting Christian Harring for a nine yard touchdown pass.

With just 5:47 to go in the game, the Irish trailed the Lourdes by just two points, 30-28.

Nebraska City was moving the ball on their next drive when Brandon Scheitel not only rushed the quarterback, he stripped the ball and returned it 25 yards down the field dragging opponents to the Lourdes nine yard line. With 1:46 to go, on fourth and goal, Bippes found Emerson Keithley again, this time right at the goal line. He was able to stretch over the pylon for the go ahead touchdown. The point after attempt failed but for the first time in the game the Irish had the lead 34-30.

After the kickoff, Nebraska City drove to the 11 yard line of the Irish. On first down, the quarterback ran to the eight yard line. That's when the defense dug in. The next three plays, all pass attempts, fell incomplete. Sacred Heart took the ball over on downs, and took a knee to end the ball game.

"It was a team effort on both sides of the ball. We had some guys cramp up the second half so our depth really helped us," said Coach Doug Goltz.

For the Irish, Bippes led the ground attack with 12 carries for 74 yards. Bippes also led the air attack completing 16 of 23 pass attempts for 243 yards and an outstanding five touchdowns. The receiving corps was led by Emerson Keithley who had, six receptions for 63 yards and two touchdowns. Noah Keller had three catches for 78 yards and a touchdown.

Emerson and Tristan Keithley both came up big on the defensive side of the ball each with 15 total tackles, followed by Austin Ahern who had nine stops of his own, including a quarterback sack.

Sacred Heart (1-0) will be on the road this week as they travel to Weeping Water (0-1) for a 7:00 kickoff.

Signs and symptoms of ADHD

Attention-deficit/hyperactivity disorder, a behavioral condition marked by difficulty sitting still, paying attention and controlling impulsive behavior, is a prevalent problem across the globe. According to the organization Children and Adults with Attention-Deficit/Hyperactivity Disorder, a meta-analysis of 175 studies conducted worldwide estimates that 129 million children have ADHD.

Parents of children who are exhibiting difficulty concentrating in school or controlling their impulsive behavior should not immediately assume their youngsters have ADHD. Nearly everyone, adults and children included, struggles to concentrate from time to time. According to the Diagnostic and Statistical Manual, Fifth Edition (DSM-5), the classification and diagnostic tool used by the American Psychiatric Association for psychiatric diagnosis, several symptoms must be present before a child turns 12 for that child to be diagnosed with ADHD.

Part of the difficulty in diagnosing ADHD can be traced to the impulsivity and inattentiveness typical of children under the age of four. Because of that potential for misdiagnosis, parents should resist the urge to diagnose children without having their youngsters examined by a licensed psychiatrist. Parents who are concerned their child might have ADHD can look for certain symptoms, which can fall under three main categories: inattention, hyperactivity and impulsivity.

Inattention-It can be difficult to notice signs that a child is inattentive until he or she enters school, where kids must focus on classroom lessons and homework. But symptoms of inattention may include: Careless mistakes when performing certain tasks, including schoolwork and chores. Difficulty sustaining attention when playing or performing certain tasks. Difficulty listening when being spoken to directly. Failure to follow instructions. Failure to finish certain tasks, including chores and schoolwork. Difficulty organizing. Unwillingness to engage in activities that require prolonged mental effort.

Hyperactivity - Kids can be easily excited, and parents may mistake that excitement for symptoms of hyperactivity. And while children under the age of four tend to be curious and inattentive, some kids begin to exhibit symptoms of hyperactivity as early as preschool. Excessive fidgeting, Squirming in seats, Leaving seat when remaining seated is required, such as in classroom settings. Difficulty playing quietly, Running or climbing at inappropriate times, Talking excessively, Impulsivity.

Youngsters who act impulsively may do things without thinking about their actions or words beforehand. While this is common in young children and may not indicate ADHD, frequent impulsive behavior should be discussed with a psychiatrist. Frequently provides answers before questions have been completed, Difficulty waiting his or her turn, Frequently interrupts others, Intrudes on others by butting into conversations or games.







Ways to prevent foodborne illness at the store

Foodborne illness can be prevented not only in the home where food is cooked, but at the grocery store where food is bought.

The U.S. Food and Drug Administration has seven tips for preventing foodborne illness while shopping for food:

1. Check for cleanliness. Buying from a retailer who follows proper food handling practices helps ensure food is safe. Check the general impression of the facility to see if the store looks and smells clean.

2. Keep certain foods separated. Separate raw meat, poultry, and seafood from other foods in the grocery shopping cart.

Place these foods in plastic bags to prevent their juices from dripping on other foods. It's also best to separate these foods from other foods at checkout and in grocery bags. Be sure to separate food from cleaning supplies you are also purchasing at the store.

3. Inspect cans and jars. Don't buy food in bulging cans, dented cans, cracked jars, or those with loose or bulging lids. A bulging can may mean the food was under-processed and is contaminated.

A dented can, especially at a seam, may cause an opening in the seam, allowing contamination. This is the same as a crack in a jar. A loose lid means the vacuum has been lost and the product may be contaminated.

4. Inspect frozen food packaging. Don't buy frozen food if the package is damaged. Packages should not be open, torn, or crushed on the edges. Avoid packages above the frost line in the store's freezer. If the

package cover is transparent, look for signs of frost or ice crystals. Frost and large ice crystals could mean that food in the package had either been stored for a long time or thawed and frozen again. In such cases, pick another package.

5. Select frozen foods and perishables last. It's important to keep cold foods cold and hot foods hot.

6. Choose fresh eggs carefully. Open the carton and make sure the eggs are clean and crack free. Buy only refrigerated eggs and follow the "Safe Handling Instructions" on the egg carton.

7. Be mindful of time and temperature. It's important to refrigerate perishable products as soon as possible after shopping.

Food safety experts stress the two hour rule. Because harmful bacteria can multiply in the danger zone, between 40 and 140 degrees Fahrenheit, perishable foods should not be left at room temperature longer than two hours.

Modify that rule to one hour when temperatures are above 90 degrees Fahrenheit, as they often are in cars that have been parked in the sun.

If it will take more than an hour to get groceries home, use an ice chest to keep frozen and perishable foods cold. Also, when the weather is warm and the car's air conditioner is being used, keep groceries in the passenger compartment, not the trunk.

Be aware of late season soybean pests

With the recent rains, there is potential for good soybean yields. Most soybeans are still growing and not physiologically mature yet, so there is still a chance for late-season crop pests to impact crop yields. Earlier this summer, some areas in southeast Nebraska saw high numbers of grasshoppers and subsequent defoliation of corn leaves in some fields. Grasshoppers can clip soybean pods off or feed on pods, significantly impacting soybean yields and even quality of the soybeans. It is important to periodically check around field borders for evidence of high grasshopper populations. Check your fields to see if grasshoppers are moving into your soybean fields. Here is a link to an archived article from CropWatch and treatment recommendations for grasshoppers, <http://cropwatch.unl.edu/monitoring-grasshoppers>.

The bean leaf beetle is another pest that sometimes can cause economic damage to soybeans here in southeast Nebraska. I checked a few fields this week for bean leaf beetle populations in Nemaha County. While some fields had relatively low numbers, one field had a bean leaf beetle population of 2 beetles per sweep. If populations across a field average 3 beetles or more per sweep consider an insecticide treatment. If the bean leaf population is below this level, scout the field five days later. Injury to the soybeans usually occurs when beetles are feeding on the pods. I have not seen or heard of any reports of high populations in southeast Nebraska, but we have had high populations of bean leaf beetles occur during this time of year in the past that have required chemical treatment to prevent economic loss. In 2011, we were invaded by an unusually looking caterpillar that caused some significant crop damage to soybeans late in the summer. The silver spotted skipper caused defoliation of soybeans in a number of fields. A few fields were almost completely defoliated by very high populations of this caterpillar. Some producers treated fields with insecticides, while others decided not to treat. I have not heard of any high numbers causing problems this year yet. The caterpillar has a yellow body, narrow neck and brown head with orange eyespots. It was very unusual looking, almost like some creature from outer space. These caterpillars come from eggs laid by a butterfly that has brownish-black wings with white spots on the underside of the wings. In 2011 we had thousands of these

butterflies in the area with several questions about them.

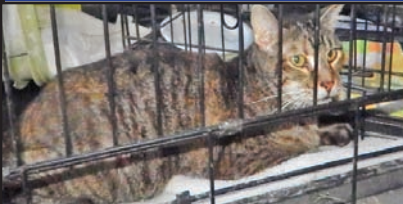
