

# Fire Marshal's Office says arsonist on loose

A lengthy investigation by the Nebraska State Fire Marshal Office into the three structure fires that occurred in the 1200 Block of Lane Street in Falls City between July 25 and 29 have all been determined to be arson, Fire Marshal's Deputy Raymond W. Nance said.

Details of the fires are not being released at this time due to the ongoing investigation.

A 911 call was made at 9:22 p.m. Saturday, July 25, to report a burning garage at 1203 Lane St. Twelve firemen responded and were on the scene into the early hours of the following Sunday. Then later that evening, again at approximately 9 or 9:30 p.m., another house on the block, this one on the opposite corner at 1223 Lane St., was

ablaze, prompting 14 firefighters to respond. Yet again, the following Wednesday, crews rushed back to 1223 Lane, where the home is being remodeled, and spent two hours on the scene. No one was injured during the trio of blazes.

Both homes are owned by 36year-old Joshua M. Darden. Authorities called the fires "suspicious," at the time but continue to refuse comment or clear potential suspects.

The home at 1223 Lane St. was assessed in 2014 at \$16,535.

Darden is a Los Angeles native and accomplished typeface designer who once taught at New York City's Parsons School of Design. He established the Brooklyn-based Darden Studio in 2004, but appears to have moved out of NYC in or sometime around 2010.

# Death penalty, last used in '97, officially repealed

#### Can executioners find work?

Organizers of a referendum petition effort to repeal a stay on Nebraska's death penalty say they have turned almost 167,000 signatures to Secretary of State John Gale. The submission comes just days before a new law repealing the state's death penalty is set to go into effect.

In order to put the issue before voters in the next general election, circulators must have collected verified signatures from five percent of registered voters in 38 counties. To suspend the legislatively-approved repeal, signatures from ten percent of registered voters must be verified, also in 38 counties.

The exact threshold of signatures that organizers must meet will not be known until election officials from all 93 counties verify their voter registration numbers to the Secretary of State's office.

Gale explained that following that process, petitions will be sorted, date stamped and numbered. Then they will be mailed or delivered to the appropriate county election officials for verification.

"Counties have 40 days from the date they receive the petitions to complete their verification. It is possible to approve a 10 day extension, if necessary. However, based on previous experience, the counties do their best to finish verifying within the initial deadline."

Once the counties have completed their verification of signatures and the Secretary of State's office has reviewed and confirmed the results, petition organizers will be notified.

The law repealing the death penalty in Nebraska went into effect Sunday.

The last time a referendum petition appeared on the ballot was in 2006 involving the consolidation of Class I school districts.



## 'I Believe' Fight Against Suicide ride Saturday, Sept. 12

# **Upcoming Blood** Drive to honor Hailey Dorste

Thirteen-year-old Hailey Dorste is a happy, healthy eighth grader who understands the importance of blood donation all too well. This is why her family, the Falls City community and the American Red Cross are teaming up to hold two upcoming blood drives in her name.

Hailey was born with a congenital heart defect. Just weeks after she was born, Hailey underwent open heart surgery and needed blood transfusions. She's been through two more surgeries since, most recently this past January at the age of 12.

The need for blood is constant. Blood donors with all types, particularly O negative, A negative and B negative, are needed to help ensure a steady blood supply for

# Social Innovation Fund Grant to bring \$15 million to rural Nebraska

Nebraska Children and Families Foundation announced that it will receive a grant from the Social Innovation Fund to expand services to unconnected young people in rural Nebraska.

The SIF grant – the first awarded to Nebraska -- comes from the federal Corporation for National and Community Service (CNCS). Nebraska Children will use the funds to customize its successful model for addressing the needs of unconnected youth to rural communities who want to better serve this population. This model – proven effective in the Project Everlast initiatives in Omaha and Lincoln – focuses on young people who have aged out of foster care, are experiencing homelessness, or have been in the juvenile justice system, and prepares them to become independent, contributing adults.

"The unconnected young people served by our older youth systems are faced with notoriously poor life outcomes," said Jennifer Skala, NE Children's Executive Vice President of Community Impact, "Many of them will experience homelessness, develop chronic health problems, struggle with addiction, become parents too early or even become incarcerated as adults. These outcomes are not only negative for the young people experiencing them, but are extremely expensive for Nebraska taxpayers."

"Nebraska Children is one of three grantees the SIF is backing this year to address inequities in rural services," said Damian Thorman, director of the Social Innovation Fund. "The SIF award will help drive resources needed to build effective systems of care in remote areas often overlooked by traditional philanthropy. We are proud to support rural Nebraska's efforts to create supportive communities dedicated to helping struggling teens successfully transition to adulthood."

The SIF grant itself will provide \$1 million per year for both 2015 and 2016, with an anticipated renewal for the following three years. This total \$5 million in federal funding will be augmented by \$5 million already secured from private supporters, plus another \$5 million in cash match from partner communities. The grand total is an anticipated \$15 million to benefit unconnected youth in rural Nebraska.

"Nebraska Children is kicking off a competitive grantee selection process to be a part of this statewide Connected Youth Initiative," Skala said. "We anticipate selecting up to 10 communities in rural Nebraska who want to implement this proven model to serve their unconnected youth."

A Request for Proposal form for applicants will be released Sept. 4. Those currently working in or with older youth systems across the state are invited to Nebraska Children's Older Youth Summit on Sept. 8 to discuss the SIF funding and what implementation will look like. 

Brian asked through a wail of laughter if I said tap shoes. Yes, I said tap shoes. For years I have loved the sound of tap shoes and the people who were talented enough to make it sound so good. What on earth will someone without a lick of rhythm do with tap shoes? Well-I'm going to try as hard as I can to learn at least one routine. Along with my \$18.99 shoes that were so darn cheap I could have bought them years ago, I purchased a DVD on how to dance like Fred and Ginger. I know its laughable to think that I could even for a second do anything that Ginger Rogers did, but darn it I'm going to try.

In my mind, I will pull these shoes out of the box, slip them on my feet and tap like nobody had ever tapped before. I'm a dreamer; obviously. But I don't know if the talent had possibly been assigned and was just waiting all these years for the perfect tap shoes. I know it sounds so goofy that in 2015, a nearly 32 year old woman has declared for one and all that she is going to give tap dancing a try, but its something I have always wanted to do. Even if I am awful, I can still sound amazing walking around my kitchen or maybe even around the Journal office.

I assure you that I do not suffer from Attention Deficit Disorder. It seems as though I'm always declaring some wild new interest. But with age comes the knowledge that time is moving rather quickly. In my twenties I kept telling myself that I'd try it next year. # High School Reunion: maybe you CAN go home again

I set out on the six-hour drive with great expectations. I was going to see friends, catch up on their lives and share tidbits of the past 50 years. It was to be a time of homecoming and celebration. I knew the old hometown would be somewhat familiar, but perhaps a little strange since I hadn't been there for years.

Then thoughts of Thomas Wolfe's epic "You Can't Go Home Again" hit me.

"But why had he always felt so strongly the magnetic pull of home, why had he thought so much about it

and remembered it with such blazing accuracy, if it did not matter, and if this little town, and the immortal hills around it, was not the only home he had on earth? He did not know. All that he knew was that the years flow by like water, and that one day men come home again." - Thomas Wolfe, You Can't Go Home Again

The "immortal hills" were beautiful, the beneficiary of lush spring and summer rain. But the evidence of hail and harsh storms was apparent in some places where corn was stripped to scrawny stalks, if there was any at all. Some fields appeared to be abandoned as if the effort no longer mattered.

"All things belonging to the earth will never change-the leaf, the blade, the flower, the wind that cries and sleeps and wakes again, the trees whose stiff arms clash and tremble in the dark, and the dust of lovers long since buried in the earth-all things proceeding from the earth to seasons, all things that lapse and change and come again upon the earth-these things will always be the same, for they come up from the earth that never changes, they go back into the earth that lasts forever. Only the earth endures, but it endures forever." - Thomas Wolfe, You Can't Go Home Again

I was neither ready for - nor surprised about – the vacant storefronts. The vitality of an aggressive business mix of service and retail was gone from downtown. Moved to the malls and strip malls on the outskirts, perhaps. I pondered just how many antique stores and nail salons the market could bear. I avoided the big box retailers, but know they are the only profitable game in town. The downtown streets were rolled up at

At our age, most of the toiling was done. Classmates who gathered at several venues during the reunion spoke of the jobs they had, the volunteer work they are doing now. Some spoke of part time jobs and a desire to work as long as they were physically able. Many spoke of children and their careers and the number of grandchildren and great grandchildren on whom they dote. Many have stayed in this hometown or moved back in retirement. Most came from other places.

"Perhaps this is our strange and haunting paradox here in America -- that we are fixed and certain only

when we are in movement. At any rate, that is how it seemed to young George Webber, who was never so assured of his purpose as when he was going somewhere on a train. And he never had the sense of home so much as when he felt that he was going there. It was only when he got there that his homelessness began."

to thoughts about the houses in which we were reared. It seems that part of the unspoken curriculum of such reunions is a drive-by of the childhood

home. In my case, gone were lush green lawn the and gigantic Linden trees of my youth. They

replaced by scraggly weeds and dirt and a pickup parked in the front yard for lack of a driveway. One friend said her house was gone, replaced by the Post Office. Another said hers never looked better. Yet another said the new owners of the farmstead were working to preserve the historic property.

My eyes were opened. The history, the memories, the flood of emotions were soothed by the human interaction with other classmates who were obviously experiencing the same thing. We were homeless in that place we once called home. But we were reunited and somehow magically refreshed. And, we'll do it again in a few years.

# Missouri bridges still in bad shape

Just two-and-a-half years after the completion of the most intense bridge program in the state's history, the number of critical-condition bridges in

Missouri is growing again. After the latest round of bridge inspections, the number of bridges in critical need of attention has risen to 641 - 50 more than a year ago. State Bridge Engineer Dennis Heckman says that trend is likely to continue.

"When we completed the Safe & Sound Bridge Improvement Program in 2012, we stemmed the tide for a while," he said. "But we knew that the curve would start going up again. Safe & Sound made a dent, however it did not repair or replace all of the state's bad bridges. Now with a shrinking construction budget, the number of bad bridges is on the rise again."

Missouri has 10,376 bridges on state highways, including 209 that are more than 1,000-feet long. While the Safe & Sound program replaced or repaired more than 800 bridges over four years, 50 to 100 fall into the "critical condition" category each year. Critical condition bridges are the state's worst and with continued deterioration are just one or two steps from being closed.

"To get ahead of the game, we should be replacing more than 100 bridges per year," Heckman said. "Instead, our funding levels are only allowing us to replace about 30. In 10 years, we'll have about 1,500 bridges on the critical condition list."

MoDOT also has about 1,400 bridges that have posted weight limits. Many of those are already on the list of critical condition bridges and many others will soon be added to the list.

Heckman stressed, however, that "critical condition" doesn't mean unsafe. "We aggressively inspect our bridges. When we discover a problem that is a safety issue, we close the bridge," Heckman said.





## Online Voter Registration Day a major advancement

Nebraska's new online voter registration application system is intended to roll out to mark National Voter Registration Day on Sept. 22 says Secretary of State John Gale. The system is in the final stages of testing. Gale said the unveiling will mark one of the biggest technological advancements to the state's voter registration system in several years.

"Creating an online process is one of the greatest leaps toward not only modernizing our state's voter registration system, but also making the process more convenient and accessible to all of our citizens by computer or by mobile device."

To date, more than 20 states have implemented online voter registration. Arizona was the first in 2002. The most recent state to go online was Hawaii this month.

Gale added that these states experienced an initial surge in online voter registrations compared to paper registrations, and having online registration available provided a boost in voter registrations overall.

The planning and creation of Nebraska's online voter registration application system began with the passage of LB 662 in 2014, sponsored by Senator Bob Krist of Omaha. It involved the cooperation and assistance of multiple vendors and state agencies including: the Secretary of State's office, Dept. of Motor Vehicles, Office of the Chief Information Officer, Election Systems and Software and Nebraska Interactive.

Essentially the new system will allow use of the applicant's driver's license signature from the DMV. Instead of a wet signature on a paper form that is mailed in and filed, users will allow the DMV to utilize the signature on file from their driver's license, in order to process their voter registration electronically.

"We'll be very excited to have the system up and running in just a few weeks," said Gale. "Having had the opportunity to observe other states that have already implemented online voter registration, we've been able to create a system that is streamlined, secure and will ultimately enable for more accurate record-keeping in our voter registration database."

In addition to promoting the new online system, Gale is also reminding all qualified Nebraskans to observe National Voter Registration Month by registering or updating their registration in September. "It is essential," Gale said, "to have a strong majority of eligible citizens registered and voting at all times to preserve the sense of a government of the people, by the people and for the people."

Gale explained further that "Voter registration seems to surge during presidential elections and then falls off for the gubernatorial cycles. Eligible citizens registered to vote vary between 80 and 85 percent with each cycle. Presidential election year voting varies from 65 to 72 percent and gubernatorial election year voting varies from 45 to 55 percent. 

# Go ahead, Jump!

While Diamond David Lee Roth may not climb up onto, let alone take flight from, a drum riser these days, there's a record-breaking Falls City High School track and field athlete of similar vintage who is still standing there with his back against the record machine.

And Raph Thompson can still "Get up!"

It was sadly poetic that DLR and the Brothers Van Halen this summer performed the 1984 B-side "Drop Dead Legs" for audiences throughout the United States more than three decades after the pinnacle of the band's popularity. It was likely a vinyl version of a much more vigorous VH that filled the air when Thompson was jumping into the record books 30 years ago, so it's truly inspirational that when the FCHS Class of 1985 met for its 30-year reunion in June, Thompson not only remained agile enough to perform the classics, he even had forthcoming chart move on the horizon.

More than three decades after triple-jumping 46-7 1/2 to put his name — presumably, at this point, for the rest

and a couple months removed from

birthday, Thompson stepped back into the track spikes, counted his steps, practiced his takeoffs and landings and stretched those hip flexors the rest of us misplaced about same the time our 32-inch waists went missing. It's not just flexing hips, either. According to experts, the triple jump utilizes "buttocks" and "torsos" and legs actually "swing" and knees "collapse."

Actually, triple jump by most accounts, puts more stress on an athlete's body than any other field event. It's comprised of the same four phases that get a short guy on a bar stool: Approach, hop, step and jump, but different.

According to Biology of Sport, a journal published by the National Library of Medicine, the triple jump is a precise and demanding athletic move that exposes an ill-conditioned or otherwise untrained athlete to significant risk of injury to muscles, tendons and joints "due to the high impact forces from the ground and powerful muscle/tendon efforts. The triple jump is

— therefore one of the most technically and physically demanding athletic events."

No Tiger athlete has jumped like Thompson, an employee at Falls City Mercantile for many years, and few guys in the U.S. approaching 50 can (or would dare try).

On Aug. 2 at the State Games of America, Thompson at Lincoln High School jumped 33-feet, 8 1/2 inches to grab the Silver in the 45-49 Age Division. Only Eric Hunter Johnson, of Raleigh, N.C., one of the highest ranked jumpers in the country, beat Thompson and it was by fewer than two inches. Two other guys ages 45-49 competed, but neither eclipsed 30 feet, however an Arkansas jumper, Mike Henson, went 34-4 in the 50-54 age group.

More than 1,000 athletes in 800 events competed in the 2015 State

Today, it seems, its popular for pundits to compare athletes from different generations. Suppose because it's popular to argue. There's also a commonly held belief that today's athletes are superior to those who came before them.

In that light, it delights us here at The Journal to report that had Raph Thompson jumped 46-7 1/2 at Omaha Burke High School last May, as he did as a teenage Tiger in 1985, he would've been the 2015 Class B State Champion. In Class A, he would've placed third.

Furthermore, the 47-year-old Raph Thompson who jumped 33-8 1/2 a month ago would've been a state qualifier in Class D at the State Track Meet.

SNL's Sally O'Malley was 50, liked to kick and stretch and it was

#### New Commitments

Athlete **JD Spielman** (5-8/173) of Eden Prairie, MN, is the latest 2016 Husker commitment. The son of Minnesota Vikings GM Rick Spielman and nephew of former NFL linebacker and current college football broadcaster **Chris Spielman**, JD will likely play receiver at Nebraska.

Initially a lacrosse commit to Ohio State, Spielman decided that he couldn't give up football. He told the *Omaha World-Herald*, "...but my first love was really always college football."

Iowa, Michigan and Minnesota also offered, and the Gophers were his second choice. Rivals ranks Spielman as the No. 4 player in Minnesota. His high school coach Mike Grant, the son of legendary Vikings Coach Bud Grant, believes Rivals under-ranked Spielman.

"I would just say this: if he was 6-1 and 205-pounds he would be the top recruit in the country," Coach Grant told HuskerOnline.com. "He's that good.

"People look at him and say 'He's not big enough', but he was the best player in the state last year. I don't know how those people think, I guess. I think a guy is either a player or not a player, and he's a great player. He's got tremendous speed, tremendous quickness, and really outstanding vision. He also has great hands."

#### Official Visitors

Visiting for the opener against BYU will be committed linebacker **Greg Simmons** (6-2/225) of Miami, FL, his teammate, OT **Stewart Reese** (6-6/330), WR **Darian Owens** (5-11/188) of Fresno, CA, and OL **Tremayne Anchrum** (6-3/270) of Powder Springs, GA.

Reese was surprise late addition to the group. Rivals' No. 37 overall player in Florida, he has narrowed his Top 6 to NU, Alabama, Auburn, Florida, Florida State and Georgia. To put his talent in perspective, he has already eliminated LSU, Miami, Michigan State and Notre Dame. Reese is a powerful blocker with quick feet. He's equally adept at pass protection as he is blowing defenders off the ball in the run game. Teams struggle to pull players of his caliber out of the SEC, but with Simmons already pledged, NU's chances increase.

Owens has been committed to UCLA since mid-April, but is still considering other schools and plans to also visit Oregon State, Washington, UCLA and Oklahoma. NU's connection to Owens is that he's a friend and former teammate of NU receivers coach Keith Williams' son, current Fresno State WR Keyan Williams. That relationship with Coach Williams has Owens intrigued by Nebraska.

Anchrum also lists Clemson, Georgia and Virginia Tech among his top schools, and he recently said that the Huskers and Bulldogs were "butting heads" at the top. Again, pulling him out of the south will be a tall order.

In Week 2 against South Alabama, NU will host committed linebacker **Quayshon Alexander** (6-2/235) of Wayne, NJ, along with Mesquite, TX, tight end **Donte Coleman** (6-4/220), LB **Nehemiah Augustus** (6-0/205) of Patterson, LA, and safety **Eric Burrell** (6-0/182), Owings Mill, MD.

Burrell has nearly 20 offers, but named a Top 4 of NU, Wisconsin, Duke and Syracuse. His only scheduled visit thus far is to Lincoln, and he has unofficially visited Boston College, Syracuse, Rutgers, Duke and Virginia. Coleman is committed to Texas Tech and will also visit there, as well as Fresno State, Cal and possibly West Virginia. Arizona State, TCU and Texas are among other schools to offer Coleman. Augustus lists Arizona State along with many smaller schools among his offers. He plans to visit ASU, but NU has a big early lead thanks to LB coach **Trent Bray**.

#### —— Need Positions

Defensive line and offensive tackle remain the two biggest "need" positions in this recruiting class, and NU has lost some targets recently.

Defensive end **Amani Bledsoe** (6-5/265) of Lawrence, KS, released his Top 10, and the Huskers didn't make the cut. Combined with Wichita's **Xavier Kelly** (6-4/257) committing to Clemson, NU missed out on the top two prospects in the Sunflower State.

Omaha South's **Noah Fant** (6-5/210) pledged this past Friday to Iowa. In announcing his commitment on the Sharp & Benning Radio Show on 1620-AM in Omaha, Fant cited Iowa's history of putting tight ends into the NFL, as well as his comfort level with the Hawkeye coaching staff among his reasons for the decision. Nebraska was recruiting Fant at defensive end, but had warmed to the idea of tight end recently also.

**Mykelle McDaniel** (6-4/255) of Loganville, GA, and **Justin Madubuike** (6-3/245) of McKinney, TX, are still available at defensive end, and I would expect to see some junior college targets soon.

At defensive tackle the list is also short, with **Marcel Southall** (6-3/270) of Duncanville, TX, and **Stephon Taylor** (6-5/300), of New Orleans, the top remaining targets.

Southall told Husker Online that he plans to visit Lincoln this fall, but hasn't set a date yet. Coach Bray is recruiting him, and he's aware of **Ndamukong Suh**'s career at NU. Alabama, Florida, Oklahoma and Texas are

also in the mix here.

Taylor boasts nearly 40 offers, including Alabama, Florida State, Miami and LSU. He hasn't set any official visits yet, but Nebraska has been in contact with him and he said early this summer that he wants to visit

Lincoln.

High-level OT targets remaining include the aforementioned **Tremayne Anchrum, Matt Farniok** (6-5/319) of Sioux Falls, SD, and **Alaric Jackson** (6-7/285) of Detroit. Farniok is considered a Husker lean, although he's visited California and Stanford unofficially this summer and is planning official trips to NU, Michigan State, Florida State and possibly Michigan. Jackson hasn't scheduled a trip to NU yet, but mentioned recently that Purdue and Rutgers might get visits. Wisconsin, Michigan State and Iowa have also offered. Jackson had planned to unofficially visit Lincoln before school began, but that trip didn't materialize.

Like at defensive end, I expect to see some junior college prospects emerge as the season progresses.


#### 2017 QB offered



## Proposal would eliminate tuition for some med students

A report published in the July online version of the journal Academic Medicine details a bold proposal that would revolutionize how medical education is funded and even eliminate medical school tuition for some students.

The proposal – authored by leaders at the University of Nebraska Medical Center - would broaden funding for graduate medical education to come from not only federal and state government but also from private insurance companies and other health care payers.

It also suggests that tuition should be paid for medical school students who practice in a rural or urban underserved area after they graduate.

The proposal, which will appear in the September print edition of Academic Medicine, is the first in recent medical literature to break down how to accomplish these goals.

For years, major national and regional organizations have been trying to increase the number of positions for medical residents and shore up funding for all positions, but little progress has been made.

Experts say now is the time to act because of the need to increase physician workforce and the continuing threats to GME funding for training residents. Less money for training residents will mean less physicians and even more maldistribution of physicians in rural communities and urban underserved areas.

"We have actually created a point in time when it's important to rethink quite radically how we do this process," said Kelly Caverzagie, M.D., associate dean for educational strategy in the UNMC College of Medicine.

Residency begins after medical students graduate from medical school. For three to seven years, depending on medical specialty, resident physicians train under the supervision of a faculty member. The resident is the primary caregiver of patients and becomes a specialist through the residency training pro-

The UNMC proposal calls for a comprehensive all-payer system.

"The current system is not the best system with which to fund GME," Dr. Caverzagie said. "Rather than the federal and state governments paying all the costs to train a resident, we believe that everyone who benefits from the health care delivery system should contribute to the cost of training residents since everyone benefits from a well-trained physician."

In addition to Medicare and Medicaid, the UNMC model calls for private insurance companies and all other health care payers to share costs.

The plan also suggests one answer to a long-debated issue about medical school debt, which influences what specialty a physician chooses and where they practice - rural or urban. Debt also impacts the ability of underserved students to attend medical school.

Under the proposal, Dr. Caverzagie said tuition would be waived for certain students who enter into medical school.

"When they graduate from medical school, they would have no monetary debt, but would be required to provide service in a place of need, whether that would be in a rural or urban underserved area," he said.

Dr. Gold said the hope is to begin a meaningful dialogue for changes. He said the fine details would require years of studying and planning.

"We hope that by publishing this

manuscript we engage policy makers, legislators, as well as leadership in medicine, in a conversation that leads to further ideas and hopefully some pilot programs to develop partnerships on how we might reframe medical school funding and residency funding," Dr. Gold said.

The proposed model also would make the costs of training more transparent as well as the training benefits to the health care system, Dr. Caverzagie said.

Though residents salaries are known, it's difficult to measure things such as the time it takes physicians to train and supervise residents. The time invested reduces the potential for the physician's ability to see more patients.

"Right now we get a new workforce every year, but how that funding occurs for the training is really difficult to follow," Dr. Caverzagie said. "This would be a more transparent way and it's important we have transparency because then we can define expectations of training and begin to measure expected out-

## FC man, 19, appears on tampering charge



Brett M. Winters is scheduled to appear back in Court Sept. 21 for a preliminary hearing.

Authorities interviewed and arrested both Winters and 29-year-old John Hall the day after they allege Hernandez fired a bullet into Debella Jr.'s head in the basement of a home at 1418 Morton St. According

to court documents, Winters admitted that he saw Debella lying on the floor in the basement of the home yet did not render aid. He then told police he changed clothes, collected drug paraphernalia and removed it from the home. According to police, Hall heard the gunshot and also removed drug paraphernalia from the scene and threw it outside near the driveway. Hall, of Shubert, has been charged with tampering and possession of a controlled substance, both of which are Class IV Felonies. He is scheduled to appear in County Court Sept. 14. Both Hall and Wnters, according to signed arrest affidavits filed in court, were both on probation at the time and were attempting to avoid further legal troubles, hence didn't contact authorities.

In addition to first degree murder, Hernandez has also been charged with possession of a firearm to commit a felony and possession of a firearm by a prohibited person. He remains in Richardson County Jail on a \$1.5 million bond and is scheduled to return to court for a preliminary hearing Sept. 16.

# Some 35.5 million to hit highway

AAA Travel projects 35.5 million Americans will journey 50 miles or more from home during the Labor Day holiday weekend, the highest volume for the holiday since 2008.

This will mark the fourth consecutive year of overall travel growth for the Labor Day holiday period. The holiday period is defined as Thursday, Sept. 3 through Monday, Sept. 7. Nearly 86 percent of all travelers, or 30.4 million people, will drive to their destination. More than 2.6 million are expected to fly, and 2.4 million will travel by other modes including bus, train and cruise ship. AAA says positive economic factors have helped to spur travel growth. Low fuel prices combined with a strong labor market has helped increase personal wealth providing many families with a higher level of disposable income. Motorists may find the lowest Labor Day gas prices in a decade. Nationally, fuel prices are down 91 cents a gallon compared to a year ago, averaging \$2.53 a gallon on Aug. 27, 2015.



#### **Motorists Urged to Use Caution**

As of Friday, Aug. 28, 150 men, women and children have lost their lives on Nebraska roadways. Fatalities are up 12 percent compared to the average for the previous four years. So far this year, 20 motorcycle riders have died in crashes, which is equal to the total number of lives lost during 2014. AAA reminds all motorists to buckleup, refrain from driving if consuming alcohol, and avoid distractions that take your mind off of the roadway ahead.

High speed roadways, with twoway traffic and no medians protecting the vehicles traveling in opposite directions are especially dangerous. Any distraction may easily cause the driver to drift across the centerline. Passengers in the vehicle need to do their part to avoid creating distractions for the driver

# The United States is running out of oil, 1922

"Petroleum production in the United States has reached its peak." That was the conclusion of Dr. Ralph McKee, a chemical engineering professor at Columbia University in 1922. His comments appeared in a front page article in the February 15, 1922, edition of Lincoln's Nebraska State Journal with the headline, "Must Look to Shale for Supply of Oil." McKee stated that there was "no likelihood of the discovery of new petroleum fields in this country," but he predicted that the nation's future energy needs could be supplied by oil from shale.

The article went on to list the states that had potentially rich reserves of oil-bearing shale: Colorado, Utah and Wyoming led the list, with other large deposits said to be in Nevada, California, Kentucky, Indiana and Ohio. He made no mention of North Dakota.

Two months later on April 16 the *Journal* carried another article featuring Professor McKee's comments about the U.S. petroleum outlook. The country was already importing oil, some 130 million barrels from Mexico in 1920 alone. Consumption was increasing by about 50 million barrels per year. McKee warned, "The number of trucks, farm tractors, and automobiles used must be decreased or we must find another source of motor fuel."

In 1920 Nebraska had some 205,000 registered automobiles and trucks, while petroleum-powered tractors were replacing draft animals as motive power on farms. The use of cars and trucks, as well as the mechanization of agriculture, would only accelerate in the future. By 1941 there were some thirty million cars and trucks in the United States.

After more than a half century of dry holes, in 1940 Nebraska's first commercial oil well was completed in the far southeastern corner of the state. The Pawnee Royalty Co. made the discovery just west of Falls City.

"The first publicized report of oil in Nebraska had been an 1883 newspaper account of a 'vein of petroleum' discovered in the same county," explains a Nebraska historical marker.

"Over the next 57 years the search for oil consumed thousands of dollars, and hundreds of wells were drilled throughout Nebraska," adds the marker placed by the Nebraska Petroleum Council.

"Traces of oil were reported at various locations across the state, but the state didn't have a producing well until 1940."

Eager to become an oil-producing state, the Nebraska legislature had offered a \$15,000 bonus for the first oil well in Nebraska to produce 50 barrels daily for 60 consecutive days.

In 1939 and 1940 the Pawnee Royalty Company had two encouraging but unsuccessful drillings near Falls City. A third well, *Buchholz No. 1*, was begun near the marker on April 22, 1940. On May 29 the well began producing and averaged 169-1/2 barrels daily for the first 60 days.

The discovery easily qualified for the Nebraska Legislature's \$15,000 bonus. Richardson County enjoyed an oil boom for three years.



NEBRASKA FEMA-DR-4225-NE The U.S. Department of Homeland Security's Federal Emergency Management Agency (FEMA) hereby gives notice to the public of its intent to reimburse state and local Nebraska governments and agencies, and eligible private nonprofit organizations for eligible costs incurred to repair and/or replace facilities damaged by: Severe Storms, Tornadoes, Straight-line Winds, and Flooding occurring from May 6-June 17,

This notice applies to the Public Assistance (PA) and Hazard Mitigation Grant (HMGP) programs implemented under the authority of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 USC §§ 5121-5207, as amended.

Under a major disaster declaration for Nebraska (FEMA-4225-DR-NE) signed by the President on June 25, 2015, the following counties in the state of Nebraska have been designated adversely affected by the disaster and are eligible for PA only: Adams, Arthur, Box Butte, Cass, Clay, Dawes, Dundy, Fillmore, Gage, Hamilton, Hayes, Jefferson, Johnson, Lincoln, Lancaster, Morrill, Nemaha, Nuckolls, Otoe, Pawnee, Richardson, Saline, Saunders, Seward, Sioux, Thayer, Wayne and York. All counties in the state of Nebraska are eligible for HMGP. There are no counties declared for Individual As-

This public notice concerns public assistance activities that may affect historic properties, activities that are located in, or affect, wetland areas or the 100-year floodplain (areas determined to have a one percent probability of flooding in any given year) and critical actions within the 500-year floodplain. Such activities may adversely affect the historic property, floodplain or wetland, or may result in continuing vulnerability to flood damage.
Such activities may include restoring facili-

ties located in a floodplain with eligible damage to pre-disaster condition. Examples of such activities include, but are not limited to, the fol-

1. Non-emergency debris removal and disposal;

2. Non-emergency protective measures; 3. Repair/replacement of roads, including streets, culverts, and bridges;

4. Repair/replacement of public dams, reser-

voirs and channels; 5. Repair/replacement of public buildings and related equipment;

6. Repair/replacement of public water control facilities, pipes and distribution systems; 7. Repair/replacement of public utilities, including sewage treatment plants, sewers and electrical power distribution systems; and

8. Repair/replacement of eligible private, non-profit facilities (hospitals, educational centers, emergency and custodial care ser-The President's Executive Order 11988.

Floodplain Management, and Executive Order 11990, Protection of Wetlands, requires that all federal actions in or affecting the 100- year floodplain or wetland areas be reviewed for opportunities to move the facility out of the floodplain or wetland and to reduce the

risk of future damage or loss from flooding and minimize harms to wetlands. However, FEMA has determined that in certain situations, there are no alternatives to restoring an eligible facility located in the floodplain to its pre-disaster condition. These situations meet all of the following criteria:

1. The FEMA estimated cost of repairs is less than 50 percent of the estimated cost to replace the facility and the replacement cost

of the facility is less than \$100,000; 2. The facility is not located in a floodway or coastal high hazard area;

3. The facility has not sustained structural damage in a previous presidentially declared flood disaster or emergency;

4. The facility is not defined as critical (e.g., hospital, generating plant, contains dangerous materials, emergency operation

FEMA will provide assistance to restore the facilities described above to their pre- disaster condition except when measures to mitigate the effects of future flooding may be incorporated into the restoration work. For example, insufficient waterway openings under culverts and bridges may cause water backup to wash out the structures. The water backup could wash out the area. Increasing the size of the waterway opening would mitigate, or lessen, the potential for this damage. Additional examples of mitigation measures include providing erosion protection at bridge abutments or levees, and extending en-

trance tubes on sewage lift stations. Disaster assistance projects to restore facili-ties, which do not meet the criteria listed above, must undergo a detailed review. The review will include a study to determine if the facility can be moved out of the floodplain. The public is invited to participate in the review. The public may identify alternatives for restoring the facility and may participate in analyzing the impact of the alternatives on the facility and the floodplain. An address and phone number for obtaining information about specific assistance projects is provided at the end of this Notice. The final determination regarding the restoration of these facilities in a floodplain will be announced in fu-

ture Public Notices. Due to the urgent need for and/or use of the certain facilities in a floodplain, actions to restore the facility may have started before the federal inspector visits the site. Some of these facilities may meet the criteria for a detailed review to determine if they should be relocated. Generally, facilities may be restored in their original location where at least one of the following condi-

1. The facility, such as a flood control device or bridge, is functionally dependent on its floodplain location;

2. The facility, such as a park or other open-use space, already represent sound floodplain management and, therefore, there is no need to

3. The facility, such as a road or a utility, is an integral part of a larger network that could not be relocated economically. 4. Emergency action is needed to address a

threat to public health and safety.

The effects of not relocating the facilities will be examined. In each case, the examination must show an overriding public need for the facility at its original location that clearly outweighed the requirements in the Executive Order to relocate the facility out of the floodplain. FEMA will also consult state and local officials to make certain that no actions taken will violate either state or local floodplain protection standards. The restoration of these facilities may also incorporate certain measures designed to mitigate the effects of future flooding. This will be the only Notice to the public concerning these facilities.

The National Historic Preservation Act re-

quires federal agencies to take into account the effects of their undertakings on historic properties. Those actions or activities affecting buildings, structures, districts or objects 50 years or older or that affect archeological sites or undisturbed ground will require further review to determine if the property is eligible for listing in the National Register of Historic Places (Register). If the property is determined to be eligible for the Register, and FEMA's undertaking will adversely affect it, FEMA will provide additional Public Notices. For historic properties not adversely affected by FEMA's undertaking, this will be the only Public Notice.

FEMA also intends to provide Hazard Mitigation Grant Program (HMGP) funding under Section 404 of the Stafford Act to the State of Nebraska for the purposes of mitigating future disaster damages. Hazard mitigation projects may involve the construction of a new facility (e.g., retention pond, or debris dam), modification of an existing undamaged facility (e.g., improving waterway openings of bridges or culverts), and the relocation of facilities out of the floodplain. Subsequent Notices will provide more specific information as project proposals are developed.


