Skyrocketing land valuations continue to provide a collective thorn in the sides of local landowners, but on the flip side, the tremendous amount of tax revenue generated makes school budget-makers' jobs quite a bit easier.

Valuation of land in School District 56 last year increased some \$50 million - from \$580 million to \$630 - allowing the School Board to bring its overall levy down 3 1/2 cents per \$100, to \$1.13. That's down significantly from \$1.24 just five years

The total district budget, approved by the Board Sept. 10 during its regular meeting at the Central Office in FC Middle School, of just more than \$10 million is up 1.5 percent, and 84 percent of that will be used for salaries and benefits, according to School Supt. Tim Heckenliv-

"What's happened," Heckenlively said, "is that property taxpayers are paying more and more of the bill, obviously."

Sixty-seven percent of the district revenues come from local property tax, with 25 percent coming from state aid.

The Kean of Queens





Since then, Harry has shipped out to Afghanistan for a tour of duty. He's reportedly targeted by the Taliban and was in very real danger during a recent attack.





Forging Ahead. This time we mean it!

There it was in the Sunday paper. The same edition with the story about the drought continuing to hurt Nebraska agriculture and the assurances that just because the Cornhuskers lost their second game of the season there would NOT be mass firings in the athletic department.

Having reached my limit of bad news, I was looking for a bit of good and was intrigued by the tabloid size and the title: "Forging Nebraska's Future 2012 Progress Report." With my cynical mind now fully engaged, I started looking for the source of the information in this document filled with charts and a rating system of outlines of stars - some completely filled with ink and some with only a bit, as if the printing plates were out of register.

Yikes! There it was, the Nebraska Chamber of Commerce and Industry. Yep. The Chamber. The folks who are paid to breathe positive comments into the sagging economy because that's their Mary Poppins' duty. Wait a minute. Look at those other sponsors. A couple really heavyweight foundations and the Nebraska Legislature – remember we elect those people – and the Nebraska Press Association. You know, the old jokes about not arguing with the people who buy ink by the barrel and paper by the boxcar load.

And the mission statement! "Using a business-like model" to develop long-term strategies to stimulate the economy. OK, this is serious stuff. I was on the verge of thinking anything less of it, but the text seemed to face some hard issues head-on. Yes, we have tremendous water resources (most of the time) but we also generate tons more environment-threatening solid waste than we once did.

Future thinking is NOT new for Nebraskans. Years ago I was invited to sit in on sessions with such a group that would periodically meet for two days to "think" about such things. Turns out they liked to gather in small towns along Nebraska's northern border so they could slip over into South Dakota and hunt waterfowl. Yes, some folks pay big bucks to do that because the hunting is apparently better on the other side of the border. And my neighbor's back yard is always greener than mine!

But, I digress. Bottom line here: This idea of a coalition to "build a better Nebraska for the Next Generation" looks like the real deal. They have staff and supporters and plans to have statewide forums to discuss things like workforce and quality of life. AND, half of the "Advisory Committee" is under the age of 35. So the "good old boys" must all be off hunting.

Or at least half of them are.

The Progress at a Glance confirms some things – so far - that many of us already take for granted. Nebraska gets 4 of 5 stars for quality of life: It costs less to live here; takes less time to get to work; there is less violent crime; health care costs less; heart disease is not as prevalent and there are fewer single parent families than other parts of the country.

It also gives us 4 of 5 stars in development and technology. That covers such things as low unemployment rates, tax incentives, exports, entrepreneurship and the availability of research and development.

But it also addresses serious downsides such as the increasing costs of Medicaid and other public benefit programs, which are growing faster than the cost of living. And the report mentions the high cost of doing business in Nebraska because of business taxes.

The report is a balanced mix of the good and the bad. The promise of a real statewide discussion on the issues and the plans to draft a working document to truly forge the future are promising. No need to concern myself with waterfowl numbers in South Dakota this time.

'Commend officials for doing what they feel is best'

If Paul Revere was a modern day Falls Cityan, he could be heard shouting throughout town "The Japanese are coming! The Japanese are coming!" Just as history has distorted the so-called facts of Revere's proclamation back on "the eighteenth of April, in Seventy-five" ("The Regulars are coming out" were the actual words Revere used to warn of the British troop's movement), so has the buzz around town that the "Japanese are coming."

Unless your subscription to *The Journal* expired in July, you are more than likely aware of the probable addition of a new business in Falls City, a grain elevator owned by Consolidated Grain and Barge (CGB) on the newly annexed land in the "Industrial Corridor" on the south end of town "down by the tracks." And, unless you only check the Journal to see what happened in "Days of Yore" or to see if the prison at Tecumseh has finally hired enough correctional officers or to just look at the pictures in "Sports," you are well aware that the news of a "grain elevator owned by the Japanese" is more than just a friendly topic of conversation over an early morning cup of coffee at One Stop. The topic of CGB seems to have stirred up more controversy than Elvis himself.

So, what is all this chatter about? Who is this CGB? Are the Japanese (or any other foreign country) really going to come in, take over the grain markets, and eventually our entire economy? Will CGB put all of the "local" elevators and truckers out of business? Will they also be opening up a Hibatchi grill in town? (Just kidding, but that would be nice!) To satisfy my own curiosity, I set out on my very own "research frenzy"...

Remember that Holiday Inn you stayed at on vacation? Those Bud Lights (then maybe Budweiser) you drank while watching the Huskers play UCLA? The 100s of jars of Gerber baby food you (attempted) to feed your baby? The Popsicle or Choco Taco your kids ate on those 95 degree days this summer? Those Toll House chocolate chip cookies your mom made? The French's mustard you put on your concession stand hot dog? The Shell gas you filled your truck up with? The Purina dog food Fido eats? The Chrysler Building, a New York landmark? As All-American as baseball and apple pie as these every-day-products sound, they are ALL owned by foreign companies!

Next trivia question... What do all of THESE everyday brands have in common: Slurpie, 7-11 gas station, JVC, Firestone tires, Honda, Dial soap, Jergens lotion, Playstation, Samsung, Sony, Toyota, Pioneer, a Pilot pen...? Yep, you guessed it: These popular brands are all owned by Japanese companies. The point? If we are simply worried about allowing a foreign (Japanese in this case) owned company moving in and taking over, too late! These days it's hard to even get out of bed without coming in contact with some product that was at one time as American as Mickey Mouse but sold out to neighbors across the waters. That warning call is too late. The Japanese (and others) aren't just coming; they are already here!

Therefore, just how "Japanese" is Consolidated Grain and Barge, a company whose headquarters is based in Covington, Louisiana? Based on the information posted on their website, "CGB has been an innovative and progressive leader in the grain and transportation industries since 1970, when it began modestly in a small office in St. Louis, Missouri with three employees. Today, CGB operates a global enterprise in more than 95 locations with over 1500 employees, overseeing a diverse family of businesses." CGB Enterprises, Inc. is privately held by the global companies ITOCHU and ZEN-NOH, which "provide CGB with the international backbone to compete in the global marketplace." While these facts may still raise some eyebrows concerning a "Japanese takeover," a little background information on the "corporate giants" may help ease some worries.

The story of ITOCHU, the parent company of CGB, sounds a lot like an account of the Industrial Revolution right of an American history book. In 1858, at the age of 15, Chubei Itoh, ITOCHU's founder began an itinerant linen trading business (he was a traveling salesman.) During this time, Japan concluded the Treaty of Amity and Commerce with five countries which included United States, opening an era of free trade. The sight of foreigners, battleships, and foreign trading posts astonished Chubei and sparked his curiosity, convincing him of the limitless potential of commerce. Hence, in 1872 Itoh opened a drapery store. Unique to the time, the company's charter set out workers' rights and duties to ensure that all workers, including junior staff, could work to their utmost capabilities. Based on the trust he had in his workers. Itochu favored a democratized form of management where he promoted competent workers in a bold manner and adopted a meetings-based system of management. When Chubei Itoh II took over the family business, he reformed and modernized the management practice while bolstering the product lineup and expanding overseas operations. Today the company's values center around "being visionary, integrity, passion, diversity, and challenge" while setting five "self-tests" for its employees such as "Am I proud to say I am involved in the work." Maybe a company with priorities such as those of ITOCHU/CGB might not be a bad addition to the Falls City community as well as an asset for its citizens after all?

To give the best comparison on the relationship between ITOCHU and CGB, consider that of the Vatican and the local Catholic Church. While the Pope makes all of the "executive decisions" involving the Church,

the local Parish and Diocese call the shots when dealing with the everyday business of the Church. So, if CGB were to make its way to Falls City, "down by the tracks," we would be dealing with normal, everyday country folks (and possibly a few Cajuns?) just like us! Just going out on a limb on this one, but I would guess that a majority of the people hired to work at CGB's Falls City location would be local citizens. In fact, I'd bet that would include some of you reading this paper, whether it be as a secretary, scale opera-

tor, facilities manager, or other employment opportunity the elevator would provide.

It is important to also not that CGB's other locations are scattered across the Midwest in towns similar to Falls City such as Dixon, Illinois; North Bend, Ohio; Cape Girardeau Missouri; Mt. Vernon, Indiana; Uniontown, Kentucky; Catoosa, Oklahoma, Van Buren, Arkansas; and Fayette, Iowa (to name just a few). I wonder if any of the "concerned" parties considered checking with the people of these small, farming communities to see what impact CGB had on their towns? If not, that might be a good place to start to build a stronger case for either side's argument.

Now to the next "controversial" hurdle, which is best put by in words by Alan Jackson: "Now the court square's just a set of streets that people go around but they seldom think 'bout the little man who built this town before the big money shut 'em down and killed the little man; oh the little man." How true it is that we try to "revitalize" the downtown and sell out the "outside-of-town." Nonetheless, the motto used to promote Falls City states we are "Strategically positioned; Building for the Future." Isn't there possibly a way to accommodate both: protect the "little man" while building a stronger, economically sound community that our future generations will want to stay active in and be able to benefit from?

While there is no doubt we all believe in the words "Long live the little man. God bless the little man," how many of us would more properly fit the statement "do as I say, not as I do." I am sure we all want the "little man" to be successful. However, how many of us buy our groceries at Walmart rather than at Sunmart? Order our furniture at Nebraska Furniture Mart instead of from Chaneys? Get a new fridge from Sears instead of from Mary's? Purchase building supplies from Lowes instead of from Home Lumber or Farm and City? I will be the first to admit that I am guilty as charged. However, until you sit down and think about it, you don't really realize how lucky we are to have so many conveniences here in Falls City. Thank you to those "little guys" who truly make Falls City an All-American town. Maybe we will all do a little more "practicing what we preach."

In conclusion, whether you are for the addition of a new multi-million dollar grain business, against it, or really could care less and hoping the topic will soon dissolve so there is more room for Husker football in the paper, you have to commend the city officials and directors for doing what they feel is best for the town of Falls City in the long run. In hindsight, maybe a little more background could have been shared with the people? Maybe things could have moved a little slower to allow for a little more public input? Nonetheless, hopefully now you know a little more of, as Paul Harvey would say, "the rest of the story."

Can Wind Save Our Water?

Nebraska public power entities are currently reviewing their electricity generation portfolios and determining what role – if any – wind and other renewable energy will play. As Nebraska battles through a worsening drought, how Nebraska's current electricity generation affects Nebraska's most precious natural resource – water – should also be considered.

Most people know Nebraska ranks fourth in the United States for wind resource, but Nebraskans should know water use and coal-fired electricity generation facilities are joined at the hip, using thousands of acre-feet of Nebraska's surface and groundwater to cool their plants. Wind, however, uses no water at all to generate electricity.

Wind is Nebraska's second most valuable natural resource behind water. Wind is "mechanical generation" – gears turning a generator. Coal, natural gas and nuclear are "thermal generation" – combustion creating steam to turn a generator.

Nebraska's multiple coal powered generation units use billions of gallons of water every year from the Ogallala Aquifer and Platte River, yet we never hear anyone asking how much that impacts the state's irrigation, industrial and residential water supply. According to recent costs of water, Nebraska's coal-generation water consumption is staggering. It is accurate that a wind turbine operates at full capacity 40-50 percent of the time. But, 70 percent of every BTU in the combustion process of a coal generation unit goes unused due to steam passing out of the stacks or to unused heated water. The 150-degree water discharged at the end of the process takes BTUs to heat even though it's not creating steam at that temperature.

Nebraska currently exchanges local electricity rate payers' dollars for Wyoming coal, but coal is exploiting Nebraska's water. And perhaps even more unsettling is that Nebraska sells about 25 percent of its generated electricity out of state according to the most current U.S. Department of Energy EIA (Energy Information Association) report. That means Nebraska's rate payers and tax payers bear the liability cost of dirty air and water for exported electricity. Nebraska's power generators sell their excess power to Kansas and surrounding states – often at a loss, and then Kansas turns around and sues Nebraska for the water it took to produce, cool and clean the electricity from coal generation. The EPA is requiring the Nebraska Public Power District (NPPD) to spend billions of dollars cleaning up its Gerald Gentleman plant, the state's 1,365 megawatt coal generation unit at Sutherland. That coal generation unit is in the middle of an over appropriated Natural Resources District putting that coal generation unit in conflict with Nebraska's agriculture economy competing for the same water.

Press releases from NPPD claim their cost of power generation is between 3-4 cents per kWh. Lincoln Electric System (LES) bought power from the Petersburg, NE, wind farm for four cents per kWh. Testimony in Legislative committee hearings by wind industry officials stated the generation cost of wind farms in surrounding states were around 3.5 cents per kWh, validating wind can produce power in line with Public Power's cost assumptions from coal and nuclear.


Currently the state has 6,000 megawatts of power generation; studies by the National Renewable Energy Lab (NREL) show Nebraska could build 3,000-4,000 megawatts of wind farms. It is true wind is an inconsistent power source. If the numbers from public power are correct, and wind is at kw/hour parity with coal generation, then simple supply and demand principals would mean if Nebraska brought on line 50 percent more power generation than it currently has, the price would go down. When the wind does blow, the abundant supply of electricity from the wind farms drives the price down. Electricity, regardless of how it's generated, is just a commodity.

What have gone up are public power's overhead costs. Nebraska's consumers have seen a 50 percent increase in rates across the state over the last five years while the price of electricity generated from wind, coal and natural gas has been static.

It's important for us to consider a new way of thinking about energy. One that gives Nebraska a chance to preserve its water supply and keep Nebraska rate payers' money in the state by moving a greater portion of the our power generation away from thermal coal generation to mechanical wind generation. This will preserve Nebraska's most precious natural resource, water, to help meet federal endangered species demands and to fulfill our mandate to return the Platte River to 1997 flow levels as defined in LB 962. New thinking about wind will also meet our interstate water compact legal requirements, provide drinking water for our residents and protect our agriculture economy and the state's 120,000 irrigation wells. Our energy policy is our water policy.

The Lady Tigers defeated Omaha Duchesne Academy and Auburn, but fell to perennial power Wahoo in the semifinals.

PUBLIC NOTICE

ORDINANCE NO. 2012-107

AN ORDINANCE TO MEET STATE AND FEDERAL REQUIRE-MENTS FOR PARTICIPATION IN THE NATIONAL FLOOD INSUR-ANCE PROGRAM.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FALLS CITY, NE-BRASKA:

SECTION 1.0 STATUTORY AUTHORIZATION, FINDINGS OF FACT AND PURPOSES 1.1 STATUTORY AUTHORIZA-

The Legislature of the State of Nebraska has in Sections 31-1001 to 31-1022, R.R.S. 1943 (as amended), assigned the responsibility to local governmental units to adopt floodplain management regulations designed to protect the public health, safety and general welfare. Therefore, the City Council of Falls City, Nebraska ordains as follows:

1.2 FINDINGS OF FACT 1.21 Flood Losses Resulting from Periodic Inundation

The flood hazard areas of Falls City, Nebraska, are subject to inundation which results in loss of life and property, health and safety hazards, disruption of commerce and governmental services, extraordinary public expenditures for flood protection and relief, and impairment of the tax base all of which adversely affect the public health, safety and general welfare.

1.22 General Causes of the Flood Losses

These flood losses are caused by: (1) The cumulative effect of obstructions in floodplainscausing increases in flood heights and velocities, (2) The occupancy of flood hazard areas by uses vulnerable to floods or hazardous to others, which are inadequately elevated or otherwise unprotected from flood damages.

1.3 STATEMENT OF PURPOSE

It is the purpose of this Ordinance to promote the public health, safety, and general welfare and to minimize those losses described in Section 1.21 by applying the provisions of this Ordinance to:

1.31 Restrict or prohibit uses which are dangerous to health, safety, or property in times of flooding or cause undue increases in flood heights or velocities.

1.32 Require that uses vulnerable to floods, including public facilities which serve such uses, be provided with flood protection at the time of initial construction.

1.33 Protect individuals from buying lands which are unsuited for intended purposes because of flood hazard.

1.34 Assure that eligibility is maintained for property owners in the community to purchase flood insurance in the National Flood Insurance Program.

SECTION 2.0 DEFINITIONS

Unless specifically defined below, words or phrases used in this Ordinance shall be interpreted so as to give them the same meaning as they have in common usage and so as to give this Ordinance its most reasonable applica-

'Base Flood" means the flood having one percent chance of being equaled or exceeded in any given year.

"Basement" means any area of the building having its floor subgrade (below ground level) on all sides.

"Development" means any manmade change to improved or unimproved real estate, including but not limited to buildings or other structures, mining, dredging, filling, grading, paving, excavation or drilling operations or storage of equipment or materials.

"Existing Manufactured Home Park or Subdivision means a manufactured home park or subdivision for which the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including, at a minimum, the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads) is complete before the effective date of the floodplain management regulations adopted by a community.

"Expansion of Existing Manu-<u>factured Home Park or Subdivision"</u> means the preparation of additional sites by the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads).

"Flood" means a general and temporary condition of partial or complete inundation of normally dry land areas from: (1) The overflow of inland or tidal waters. (2) The unusual and rapid accumulation of runoff of surface waters from any source.

"Flood Insurance Rate Map (FIRM) means an official map of a community, on which the Administrator has delineated both the special flood hazard areas and the risk premium applicable to the community.

"Floodplain" means any land area susceptible to being inundated by water from any source (see definition of "flooding").

Floodproofing" means any combination of structural and non-structural additions, changes or adjustments to structures which reduce or eliminate flood damage to real estate or improved real property, water and sanitary facili-

ties, structures and their contents. "Floodway" means the channel of the river or other watercourse and the adjacent land areas that must be reserved in order to discharge the base flood without cumulatively increasing the water surface elevation more than a designated height.

"Historic Structure" means any structure that is: (a) Listed individually in the National Register of Historic Places (a listing maintained by the Department of Interior) or preliminarily determined by the Secretary of the Interior as meeting the requirements for individual listing on the National Register; (b) Certified or preliminarily determined by the Secretary of the Interior as contributing to the historical significance of a registered historic district or a district preliminarily determined by the Secretary to qualify as a registered historic district; (c) Individually listed on a state inventory of historic places in states with historic preservation programs which have been approved by the Secretary of the Interior; or (d) Individually listed on a local inventory of historic places in communities with historic preservation programs that have been certified either: (1) By an approved state program as determined by the Secretary of the Interior or (2) Directly by the Secretary of the Interior in states without approved programs.

"Lowest floor" means the lowest floor of the lowest enclosed area (including basement). An unfinished or flood-resistant enclosure, usable solely for parking of vehicles, building access or storage, in an area other than a basement area, is not considered a building's lowest floor, provided that such enclosure is not built so as to render the structure in violation of the applicable non-elevation design requirements of this Ordinance. ZNEZ

"Manufactured Home" means a structure, transportable in one or more sections, which is built on a permanent chassis and is designed for use with or without a permanent foundation when

attached to the required utilities. The

term "manufactured home" does not

include a "recreational vehicle" <u>"Manufactured Home Park or</u> <u>Subdivision</u> means a parcel (or contiguous parcels) of land divided into two or more manufactured home lots for rent or sale.

"New Construction" For floodplain management purposes, "new construction" means structures for which the "start of construction commenced on or after the effective date of the floodplain management regulation adopted by a community and includes any subsequent improvements to such structures.

<u>"New Manufactured Home Park</u> or Subdivision " means a manufactured home park or subdivision for which the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including at a minimum the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads) is completed on or after the effective date of floodplain management regulations adopted by a commu-

'100-Year Flood" means the condition of flooding having a one percent chance of annual occurrence.

"Principally Above Ground" means that at least 51 percent of the actual cash value of the structure is above ground.

"Recreational Vehicle" means a vehicle which is (i) built on a single chassis; (ii) 400 square feet or less when measured at the largest horizontal projection; (iii) designed to be self-propelled or permanently towable by a light duty truck; and (iv) designed primarily not for use as a permanent dwelling but as temporary living quarters for recreational, camping, travel, or seasonal use.

"Regulatory Flood Elevation" means the water surface elevation of the 100-year flood.

Special Flood Hazard Area" is the land in the floodplain within a community subject to one percent or greater chance of flooding in any given

"Start of Construction" [for other than new construction or substantial improvements under the coastal Barrier Resources Act (Pub. L. 97-348)] includes substantial improvement, and means the date the building permit was issued, provided the actual start of construction, repair, reconstruction, rehabilitation, addition, placement, or other improvement was within 180 days of the permit date. The actual start means the first placement of permanent construction of a structure on a site, such as the pouring of slab or footings, the installation of piles, the construction of columns, or any work beyond the stage of excavation; or the placement of a manufactured home on a foundation. Permanent construction does not include land preparation, such as clearing, grading and filling; nor does it include the installation of streets and/ or walkways; nor does it include excavation for a basement, footings, piers, or foundations or the erection of temporary forms; nor does it include the installation on the property of accessory buildings, such as garages or sheds not occupied as dwelling units or not part of the main structure. For a substantial improvement, the actual start of construction means the first alteration of any wall, ceiling, floor, or other structural part of a building, whether or not the alteration affects the external dimensions of the building.

"Structure" means a walled and roofed building that is principally above ground, as well as a manufactured home, and a gas or liquid storage tank that is principally above ground.

"Substantial Damage" means damage of any origin sustained by a structure whereby the cost of restoring the structure to its before-damaged condition would equal or exceed 50 percent of the market value of the structure before the damage occurred.

"Substantial Improvement"

means any reconstruction, rehabilitation, addition, or other improvement of a structure, the cost of which equals or exceeds 50 percent of the market value of the structure before "start of construction" of the improvement. This includes structures which have incurred "substantial damage," regardless of the actual repair work performed. The term does not, however, include either (1) any project for improvement of a structure to correct existing violations of state or local health, sanitary, or safety code specifications which have been identified by the local code enforcement official and which are the minimum necessary to assure safe living conditions, or (2) any alteration of a "historic structure," provided that the alteration will not preclude the structure's continued designation as a "historic structure."

"Variance" means a grant of relief to a person from the terms of a floodplain management Ordinance.

"Violation" means the failure of a structure or other development to be fully compliant with the community's floodplain management regulations.

SECTION 3.0 LOCAL <u>ADMINISTRATOR</u> **RESPONSIBILITIES**

The City Clerk hereby has these added responsibilities and is authorized and directed to enforce all of the provisions of this Ordinance and all other Ordinances of the City of Falls City now in force or hereafter adopted, related to zoning, subdivision or building codes.

SECTION 4.0 LOCAL ADMINISTRATOR ADDITIONAL RESPONSIBILITIES

The City Clerk shall be appointed to these additional responsibilities by resolution of the Governing Body and his appointment shall continue during good behavior and satisfactory service. During temporary absence or disability of the City Clerk, the Governing Body of the City shall designate an acting administrator.

SECTION 5.0 DESIGNATION OF CURRENT FHBM/FIRM

The Governing Body of the City of Falls City hereby designates the current Flood Hazard Boundary Map/ Flood Insurance Rate Map for unincorporated areas of Richardson County dated May 1, 1990, as the official map to be used in determining those areas of special flood hazard.

SECTION 6.0 PERMITS REOUIRED

Permits Required: No person, firm or corporation shall initiate any floodplain development or substantial improvement or cause the same to be done without first obtaining a separate permit for development as defined in this Ordinance.

A. Within special flood hazard areas on the official map, separate floodplain development permits are required for all new construction, substantial improvements and other developments, including the placement of manufactured homes.

B. Application: To obtain a floodplain development permit, the applicant shall first file an application therefore in writing on a form furnished for that purpose. Every such application shall:

(1) Identify and describe the development to be covered by the floodplain development permit for which application is made.

(2) Describe the land on which the proposed development is to be done by lot, block, tract and house and street address, or similar description that will readily identify and definitely locate the proposed building or development.

(3) Indicate the use or occupancy for which the proposed development is intended.

(4) Be accompanied by plans and specifications for proposed construc-

(5) Be signed by the permittee or his authorized agent who may be required to submit evidence to indicate such authority.

(6) Within designated floodplain areas, be accompanied by elevations of the lowest floor, including basement, or in the case of floodproofed non-residential structures, the elevation to which it shall be floodproofed. Documentation or certification of such elevations will be maintained by the

(7) Give such other information as reasonably may be required by the City Clerk (i.e., require a statement from the applicant that they are aware that elevating or floodproofing structures above the minimum levels will result in premium reduction, especially in the case of non- residential floodproofing when a minus one foot (-1') penalty is assessed at the time of rating the structure for the policy premium.)

SECTION 7.0 DEVELOPMENT PERMIT APPLICATIONS **REVIEW**

The City Clerk shall review all development permit applications to determine if the site of the proposed development is reasonably safe from flooding and that all necessary permits have been received as required by Federal or State Law.

SECTION 8.0 ALL APPLICA-TIONS REVIEW (See Section 21)

The City Clerk, in reviewing all applications for new construction, substantial improvements, prefabricated buildings, placement of manufactured homes and other development(s) (as defined in Section 21 of this Ordinance) will:

A. Obtain, review and reasonably utilize, if available, any regulatory flood elevation data and floodway data available from Federal, State or other sources, until such other data is provided by the Federal Insurance Administration in a Flood Insurance Study; and require within special flood hazard areas on the official map that the fol-

(1) That until a floodway has been designated - No development or substantial improvement may be permitted within the identified floodplain unless the applicant has demonstrated that the proposed development or substantial improvement, when combined with all other existing and reasonably anticipated developments or substantial im-

lowing performance standards be met:

(2) Residential Construction - New construction or substantial improvement of any residential structure shall have the lowest floor, including basement, elevated at least one foot above the base flood elevation.

more than one (1) foot at any location.

(3) Non-residential Construction - New construction or substantial improvement of any commercial, industrial or other non-residential structure shall either have the lowest floor, including basement, elevated at least one foot above the base flood elevation or, together with attendant utility and sanitary facilities, be floodproofed so that below such a level the structure is watertight with walls substantially impermeable to the passage of water and with structural components having the capability of resisting hydrostatic and hydrodynamic loadsand effects of buoyancy. A registered professional engineer or architect shall certify that the standards of this subsection are satisfied. Such certification shall be pro-

vided to the local administrator.

(4) Require for all new construction and substantial improvements - That fully enclosed areas below the lowest floor that are usable solely for parking of vehicles, building access or storage in an area other than a basement and which are subject to flooding shall be designed to automatically equalize hydrostatic flood forces on exterior walls by allowing for the entry and exit of floodwaters. Designs for meeting this requirement must either be certified by a registered professional engineer or architect or meet or exceed the following minimum criteria: A minimum of two openings having a total net area of not less than one square inch for every square foot of enclosed area subject to flooding shall be provided. The bottom of all openings shall be no higher than one foot above grade. Openings may be equipped with screens, louvers, valves, or other coverings or devices provided that they permit the automatic entry and exit of floodwaters.

B. Require the use of construction materials that are resistant to flood damage.

C. Require the use of construction methods and practices that will minimize flood damage.

D. Require that new structures be designed (or modified) and adequately anchored to prevent flotation, collapse, or lateral movement of the structure resulting from hydrodynamic and hydrostatic loads, including the effects of

E. New structures be constructed with electrical, heating, ventilation, plumbing, and air conditioning equipment and other service facilities that are designed and/or located so as to prevent water from entering or accumulating within the components during conditions of flooding.

F. Assure that all manufactured homes shall be anchored to resist flotation, collapse, or lateral movement. Manufactured homes must be anchored in accordance with State laws, local building codes and FEMA guidelines. In the event that over-the-top frame ties to ground anchors are used, the following specific requirements (or

their equivalent) shall be met: (1) Over-the-top ties be provided at each of the four corners of the manufactured home with two additional ties per side at the intermediate locations and manufactured homes less than 50 feet long requiring one additional tie per side.

(2) Frame ties be provided at each corner of the home with five additional ties per side at intermediate points and manufactured homes less than 50 feet long requiring four additional ties per side. ZNEZ

(3) All components of the anchoring system be capable of carrying a force of 4,800 pounds.

(4) Any additions to manufactured homes be similarly anchored.

G. Assure that all manufactured homes that are placed or substantially improved within special flood hazard areas on the community's official map on sites:

(1) Outside of a manufactured home park or subdivision;

(2) In a new manufactured home

park or subdivision; (3) In an expansion to an existing

manufactured home park or subdivi-

(4) In an existing manufactured home park or subdivision on which a manufactured home has incurred "substantial damage" as the result of a flood, be elevated on a permanent foundation such that the lowest floor of the manufactured home is elevated at least one foot above the base flood elevation and be securely anchored to an adequately anchored foundation system in accordance with the provisions of Section

H. Assure that manufactured homes to be placed or substantially improved on sites in an existing manufactured home park or subdivision within special flood hazard areas on the community's official map that are not subject to the provisions of Section 8.G. be elevated so that either:

(1) The lowest floor of the manufactured home is at least one foot above the base flood elevation, or

(2) The manufactured home chassis is supported by reinforced piers or other foundation elements of at least equivalent strength that are no less

than 36 inches in height above grade and be securely anchored to an adequately anchored foundation system in accordance with the provisions of

Section 8.F. I. Require that recreational vehicles placed on sites within the identified special flood hazard areas on the community's official map either (i) be on the site for fewer than 180 consecutive days, (ii) be fully licensed and ready for highway use, or (iii) meet the permit requirements and the elevation and anchoring requirements for "manufactured homes" of this Ordinance. A recreational vehicle is ready for highway use if it is on its wheels or jacking system is attached to the site only by quick disconnect type utilities and security devices, and has no permanently attached additions.

SECTION 9.0 SUBDIVISION APPLICATIONS

The Governing Body of the City shall review all subdivision applications and other proposed new developments (including manufactured home parks or subdivisions) and shall make findings of fact and assure that:

A. All such proposed developments are consistent with the need to minimize flood damage.

B. Subdivision proposals and other proposed new developments (including proposals for manufactured home parks and subdivisions), greater than five (5) acres or fifty (50) lots, whichever is lesser, include within such proposals regulatory flood elevation data in special flood hazard areas.

C. Adequate drainage is provided so as to reduce exposure to flood haz-

D. All public utilities and facilities are located so as to minimize or eliminate flood damage.

SECTION 10.0 WATER AND SEWAGE SYSTEMS

New and replacement water and sewage systems shall be constructed to eliminate or minimize infiltration by, or discharge into floodwaters. Moreover, on-site waste disposal systems will be designed to avoid impairment or contamination during flooding.

SECTION 11.0 STORAGE OF MATERIAL AND EQUIPMENT

The storage or processing of materials that are in time of flooding buoyant, flammable, explosive, or could be injurious to human, animal or plant life is prohibited. Storage of other material or equipment may be allowed if not subject to major damage by floods and firmly anchored to prevent flotation or if readily removable from the area within the time available after flood warning.

SECTION 12.0 FLOOD-CARRYING CAPACITY WITHIN ANY WATERCOURSE

The Governing Body of the City will ensure that the flood-carrying capacity within the altered or relocated portion of any watercourse is maintained. The City will notify, in riverine situations, adjacent communities and the State Coordinating Office (Nebraska Department of Natural Resources) prior to any alteration or relocation of a watercourse, and submit copies of such notifications to the Federal Emergency Management Agency. Moreover, the City will work with appropriate State and Federal agencies in every way possible in complying with the National Flood Insurance Program in accordance with the National Disaster Protection Act of 1973.

SECTION 13.0 VARIANCE PROCEDURES

13.1 The Board of Adjustment as established by the City Council shall hear and decide appeals and requests for variances from the requirements of this Ordinance.

13.2 The Board of Adjustment shall hear and decide appeals when it is alleged that there is an error in any requirement, decision, or determination made by the City Clerk in the enforcement or administration of this Ordinance.

13.3 Any person aggrieved by the decision of the Board of Adjustment or any taxpayer may appeal such decision to the District Court as provided in; 19-912, R.R.S. 1943.

13.4 In passing upon such applications, the Board of Adjustment shall consider all technical evaluation, all relevant factors, standards specified in other sections of this Ordinance, and; 13.41 the danger that materials

may be swept onto other lands to the injury of others; 13.42 the danger to life and property due to flooding or erosion dam-

age; 13.43 the susceptibility of proposed facility and its contents to flood damage and the effect of such damage

on the individual owner; 13.44 the importance of the services provided by the proposed facility

to the community; 13.45 the necessity to the facility of a waterfront location, where appli-

13.46 the availability of alternative locations, not subject to flooding or erosion damage, for the proposed

13.47 the compatibility of the proposed use with existing and anticipated development;

13.48 the relationship of the proposed use to the comprehensive plan and floodplain management program

13.49 the safety of access to the property in times of flood for ordinary and emergency vehicles.

13.5 Conditions for Variances

13.51 Generally variances may be issued for new construction and substantial improvements to be erected on a lot of one-half acre or less in size contiguous to and surrounded by lots with existing structures constructed below the base flood level, providing items (13.52-13.55 below) have been fully considered. As the lot size increases beyond the one-half acre, the technical justification required for issuing the variance increases.

13.52 Variances may be issued for the repair or rehabilitation of historic structures upon a determination that the proposed repair or rehabilitation will not preclude the structure's continued designation as a historic structure and the variance is the minimum necessary to preserve the historic character and design of the structure.

13.53 Variances shall only be issued upon a determination that the variance is the minimum necessary, considering the flood hazard, to afford relief.

13.54 Variances shall only be issued upon (i) a showing of good and sufficient cause, (ii) a determination that failure to grant the variance would result in exceptional hardship to the applicant, and (iii) a determination that the granting of a variance will not result in increased flood heights, additional threats to public safety, extraordinary public expense, create nuisances, cause fraud on or victimization of the public, or conflict with existing local laws or Ordinances.

13.55 The applicant shall be given a written notice over the signature of a community official that (1) the issuance of a variance to construct a structure below base flood level will result in increased premium rates for flood insurance up to amounts as high as \$25.00 for \$100.00 of insurance coverage and (2) such construction below the base flood level increases risks to life and property. Such notification shall be maintained with the record of all variance actions as required by this Ordinance.

SECTION 14.0 **NON-CONFORMING USE**

14.1 A structure or the use of a structure or premises which was lawful before the passage or amendment of the Ordinance, but which is not in conformity with the provisions of this Ordinance may be continued subject to the following conditions:

14.11 If such use is discontinued, any future use of the building premises shall conform to this Ordinance. The Utility Department shall notify the City Clerk in writing of instances of nonconforming uses where utility services have been discontinued.

14.12 Uses or adjuncts thereof which are or become nuisances shall not be entitled to continue as noncon-

forming uses. 14.2 If any nonconforming use or structure is destroyed by any means, including flood, it shall not be reconstructed if the cost is more than 50 percent of the market value of the structure before the damage occurred except that if it is reconstructed in conformity with the provisions of this Ordinance. This limitation does not include the cost of any alteration to comply with existing state or local health, sanitary, building, or safety codes or regulations or the cost of any alteration of a structure listed on the National Register of Historic Places or a State Inventory of Historic Places.

SECTION 15.0 PENALTIES FOR VIOLATION

Violation of the provisions of this Ordinance or failure to comply with any of its requirements (including violations of conditions and safeguards established in connection with grants of variances or special exceptions) shall constitute a misdemeanor. Any person who violates this Ordinance or fails to comply with any of its requirements shall upon conviction thereof be fined not more than \$500.00, and in addition, shall pay all costs and expenses involved in the case. Each day such violation continues shall be considered a separate offense.

Nothing herein contained shall prevent the City of Falls City or other appropriate authority from taking such other lawful action as is necessary to prevent or remedy any violation.

SECTION 16.0 ABROGATION

AND GREATER RESTRICTIONS It is not intended by this Ordinance to repeal, abrogate or impair any existent easements, covenants, or deed restrictions. However, where this Ordinance imposes greater restrictions, the provision of this Ordinance shall prevail. All other Ordinances inconsistent with this Ordinance are hereby repealed to the extent of the inconsistency only.

SECTION 17.0 **INTERPRETATION**

In their interpretation and application, the provisions of this Ordinance shall be held to be minimum requirements and shall be liberally construed in favor of the governing body and shall not be deemed a limitation or repeal, of any other powers granted by state statutes. SECTION 18.0 WARNING AND

DISCLAIMER OF LIABILITY

The degree of flood protection required by this Ordinance is considered reasonable for regulatory purposes and is based on engineering and scientific methods of study. Larger floods may

occur on rare occasions or the flood height may be increased by man-made or natural causes, such as ice jams and bridge openings restricted by debris. This Ordinance does not imply that areas outside floodplain district boundaries or land uses permitted within such districts will be free from flooding or flood damage. This Ordinance shall not create liability on the part of the City of Falls City or any officer or employee thereof for any flood damages that may result from reliance on this Ordinance or any administrative decision lawfully made thereunder.

SECTION 19.0 SEVERABILITY

If any section, clause, provision or portion of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

SECTION 20.0 APPEAL

Where a request for a permit to develop or a variance is denied by the Building Inspector the applicant may apply for such permit or variance directly to the Board of Adjustment.

SECTION 21.0

CONFLICTING ORDINANCES This Ordinance shall take precedence over conflicting Ordinances or parts of Ordinances. The Governing Body of the City of Falls City, Nebraska may, from time to time, amend this Ordinance to reflect any and all changes in the National Flood Disaster Protection Act of 1973. The regulations of this Ordinance are in compliance with the National Flood Insurance Program Regulations as published in Title 44 of the Code of Federal Regulations and the 1983 Nebraska Floodplain Man-

SECTION 22.0 EFFECTIVE DATE This Ordinance shall be in full force and effect from and after its passage, approved and publication or postings as required by law.

AN ORDINANCE TO AMEND SECTION 2-201 OF THE FALLS CITY MUNICIPAL CODE; TO AMEND THE GENERAL POWERS AND DUTIES OF THE LIBRARY BOARD; TO ADD A PROVISION PROHIBITING DISCRIMINATION; TO REPEAL CONFLICTING OR-DINANCES IN SAID SECTION; TO PROVIDE FOR AN EFFECTIVE

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF FALLS CITY, NEBRAS-

SECTION 1. That Chapter 2, Article 2, Section 2-201 of the Falls City Municipal Code be amended to read as

§2-201 LIBRARY BOARD. LI-BRARY BOARD. The Library Board shall consist of five (5) appointed members who shall be residents of the Municipality and who shall serve terms of five (5) years. The Governing Body shall appoint the members of the Library Board by a majority vote. Neither the Mayor nor any member of the Governing Body shall be a member of the Library Board. The terms of members serving on the effective date of change in the number of members shall not be shortened, and any successors to those members shall be appointed as the terms of those members expire. In case of any vacancy by resignation, removal, or otherwise, the Governing Body shall fill the vacancy for the unexpired term.

No member shall receive any pay or compensation for any services rendered as a member of the Library Board. The Governing Body may require the members of the Library to give a bond in a sum set by resolution of the Governing Body and conditioned upon the faithful performance of their duties.

At the time of the Boards first (1st) meeting in June of each year, the Board shall organize by selecting from their number a Chairperson and Secretary. No member of the Library Board shall serve in the capacity of both the Chairperson and Secretary of the Board. It shall be the duty of the Secretary to keep the full and correct minutes and records of all meetings, and to file the same with the Municipal Clerk where they shall be available for public inspection at any reasonable

A majority of the Board members shall constitute a quorum for the transaction of business. The Board shall meet at such times as the Governing Body may designate. Special meetings may be held upon the call of the Chairperson, or a majority of the members of the Board.

The Library Board may erect, lease, or occupy an appropriate building for the use of a library, appoint a suitable librarian and assistants, fix the compensation of such appointees, and to remove such appointees at the pleasure of the Board. The Governing Body shall approve any personnel administrative or compensation policy or procedure before implementation of such policy or procedure by the Board. The Library Board shall have the authority to appoint a Librarian and all other employees. The Board shall have supervisory authority over all employees of the Library including the Librarian.

The Library Board may establish rules and regulations for the government of the Municipal Library as may be deemed necessary for its preservation and to maintain its usefulness and efficiency. The Board may fix and impose, by general rules, penalties and forfeitures for trespasses upon or injury to the Municipal Library grounds, rooms, books, or other property, for failure to return any book, or for violation of any bylaw, rule, or regulation and fix and impose reasonable fees, not to exceed the Municipal Library's actual cost, for nonbasic services. The Board shall have and exercise such power as may be necessary to carry out the spirit and intent of Neb. Rev. Stat. sections 51-201 to 51-219 in establishing and maintaining a public library and reading room. The Library Board shall have general charge of the Municipal Library and shall establish appropriate rules and regulations for the management, operation, and use of the Library. All actions of the Board shall be subject to the review and supervision of the Governing Body. The Board shall be responsible for making such reports and performing such additional duties as the Governing Body may designate <u>from</u> form time to time.

The Municipal Library shall make its basic services available without charge to all residents of the political subdivision which supplies its tax support.

No service shall be denied to any person because of race, sex, religion, age, color, national origin, ancestry, physical handicap, or marital status. (Ref. 51-202 through 51-219 RS Neb.)

SECTION 2. That any other ordinance or section passed and approved prior to the passage, approval, and publication or posting of this ordinance and in conflict with its provisions, is hereby repealed.

ŠECTION 3. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.

NOTICE IS HEREBY GIVEN THIS 13TH DAY OF SEPTEMBER, 2012. Pursuant to the Noxious Weed Control Act, Section 2-955, subsection 1 (a), to every person who owns or controls land in Richardson County, Nebraska, that noxious weeds being or growing on such land shall be controlled at such frequency as to prevent establishment, provide eradication, or reduce further propagation or dissemination of such weeds. Upon failure to observe this notice, the county weed superintendent is required to:

- 1. Proceed pursuant to the law and issue legal notice to the landowner of property infested with noxious weeds giving such landowner 15 days to control the noxious weed infestation. Conviction for noncompliance may result in a \$100.00 per day fine to the landowner with a maximum fine of \$1,500.00; or
- 2. Should more immediate control be required, proceed pursuant to the law and have the weeds controlled by such method as he/she finds necessary, the expense of which shall constitute a lien and be entered as a tax against the land, and be collected as other real estate taxes are collected, or by other means as provided by law.

THE PUBLIC is also hereby notified that noxious weed seed and propagative parts may be disseminated through the movement of machinery and equipment, trucks, grain and seed, hay, straw, nursery stock, fencing materials, sod, manure, and soil as well as articles of similar nature. Methods of treatment have been prescribed by the Director of Agriculture and may be obtained from the county weed control authority.



In other news:

— Board President Scott Huppert will receive the Level IV Award for board development at the first NASB meeting of the 2012-13 school year on Oct. 10 in Beatrice.

— Heckenlively reported that a heat pump system at the high school failed earlier in August, and has been replaced with a new unit. The new unit replacement cost will be covered by insurance, minus the deductible.

— NeSA Assessment results for Nebraska students were publicly released Aug. 21 by the Nebraska Dept. of Education. New test results show FCPS students scored higher on their 2012 state reading and mathematics tests, higher than in previous years.

The results for students at grades 1-8, and 11 are based on a new, more rigorous testing process that also measured the new standards focused on college and career readiness.

Seventy-eight percent of FCPS students are meeting or exceeding the state reading standards, compared to 65.81% in 2010. The new mathematics test results show 68% of FCPS students tested proficient, compared to 64.52% in 2011. The state writing scores for grades 4, 8 and 11, which were initially released last May, indicate an average of 76% of FCPS students met or exceeded the state writing assessment, as compared to a state average of 72%.

Seventy-seven percent of FCPS students met or exceeded the state science standards, compared to a state average of 67%. Science standards as well as the state's science test have been revised, increasing the rigor of the standards and the tests with the goal of ensuring Nebraska students are career and college ready by the time they graduate from high school.

The FCHS project, titled "Technology and Agriculture Keep Expanding Student Ability and Interest in Math" (TAKES AIM), will use iPads and GPS's in math classes to provide an enriched curriculum of agriculture-based lessons.

More information on the presentation of the grant is still to come from Monsanto.

— The Nebraska Dept. of Roads Traffic Engineering Division recently completed a study of safety and operations along US Highway 159 between Fulton and Morton Streets. With the information from the traffic study, NDOR identified several signs that could be added, moved or removed.

Some of the notable changes include the addition of a school crossing assembly at the Morton Street and Fulton Street crosswalks. In addition, each of the school-related signs within the corridor will be updated to the more current fluorescent yellow-green color.
