



Early voting for General Election

Early Voting in person begins for the General Election on Tuesday, Oct. 11, 2016, and will be available at the office of the Richardson County Clerk, Room 203, Courthouse, in Falls City.

Anyone who is unable to go to their regular polling place for any reason can request an "Early Voting Ballot." These ballots can be mailed to voters upon the receipt of an application or a written request signed by the voter or their agent and delivered to the Office of the County Clerk. "Early Voting Ballots" can also be picked up in person and voted at the Office of the County Clerk beginning Oct. 11, 2016 through Nov. 7, 2016 during regular business hours.

Application forms for "Early Voting Ballots" will be published in the *Falls City Journal* and *Humboldt Standard* over the next few weeks and the form is also available on the Richardson County website www.co.richardson.ne.us home page.

The deadline for those persons who would like to vote in the Nov. 8, 2016, General Election and who have not previously registered to vote in Richardson County is Friday, Oct. 28, 2016. Voter registration is done at the Office of the County Clerk during regular business hours, and on Friday, Oct. 28 the office will remain open until 6 p.m.

Registrations will also be accepted at the Humboldt City Clerk's Office during regular business hours. Voters can also register at <http://ne.gov/go/NEreg2vote>. The deadline for any voter registration form other than in person is Friday, October 21.

Voters may check their registration at <https://www.votercheck.necvr.ne.gov> or by contacting the Richardson County Clerk's Office at 402-245-2911.

Address changes and name changes due to marriage are encouraged to be changed before Nov. 8, however, these changes can be made at the polls on Election Day by voting a "Provisional Ballot."

Farm Bureau opposes \$369 million SCC bond proposal

The Nebraska Farm Bureau announced today its opposition to the Southeast Community College \$369 million bond proposal that seeks to secure funds for projects across the Southeast Community College system, including construction of a new campus in downtown Lincoln. If passed, the measure would equate to a massive property tax increase on farmers, businesses, and homeowners across the 15 county SCC District, said Nebraska Farm Bureau President Steve Nelson.

"Educational opportunities are vitally important to Nebraskans. We understand the important role community colleges play in preparing Nebraskans for jobs, both inside and out of agriculture. With that said, this SCC proposal fails to meet the needs of the other partners in the educational process; the individual tax payers who will have to take real money out of their pockets and family budgets to pay for the \$369 million measure, plus interest," said Nelson.

Nelson said the decision to oppose the measure stems from numerous factors, starting with the concern expressed by members of the organization who reside and pay taxes in the district.

"The message we've heard from members has been clear. This SCC proposal is too big, too expensive, and too risky," said Nelson. "Lumping together numerous projects in a single bond with a price tag that we estimate could

top half-a-billion dollars in new property taxes, when all is said and done, is unacceptable. Relief from skyrocketing property tax bills is the number one concern we hear from members. This proposal doesn't provide the level of detail or certainty about how dollars will

be spent for a request of this magnitude. Raising property taxes by \$369 million (\$369,000,000) without definitive plans about how and when the money will be spent is simply irresponsible."

Nelson noted that SCC would benefit from a different approach to

addressing renovation and facility needs.

"What voters need to understand is that SCC has room under their existing taxing authority to raise additional funds for these types of projects – authority which

Tragedy avoided during FC car-motorcycle crash

There really is no such thing as a "minor fender bender" when it comes to motorcycles, as powerful iron horses thrust vulnerable throttle jockeys through thin air, with only cautious driving, good instincts and better luck preventing a road trip from becoming road rash (or far worse).

So motoring mates Brad and Jennifer Campbell were grateful to be home from work all last week nursing only aching, but intact, bodies after a collision with a mid-sized sedan abruptly ended a leisurely Sunday morning bike ride.

The Sept. 18 crash in front of the Falls City Post Office and Sapp Bros. 66 flung husband and wife off their 2016 Harley-Davidson and onto the Harlan Street pavement, into an ambulance and, ultimately, hospital beds. They were initially treated at Community Medical Center but transferred via ambulance to Bryan West in Lincoln. Brad, 50, who was driving his new Ultra Classic Electra, injured a shoulder and was released that night, while Jennifer, who celebrated her 50th birthday just yesterday, suffered injuries to her back, neck and leg and was held overnight. The full extent of their injuries has yet to be determined, as doctors wait for swelling to diminish before conducting additional tests.

The Campbells were exiting the Sapps parking lot south onto Harlan Street at the precise time Margaret Jones, 83, who coincidentally shares a birthday with Mrs. Campbell, pulled her 1999 Chevy Lumina away from the post office and made a U-turn south on Harlan

when the vehicles "sideswiped" one another. The Campbells were transported to CMC by Troy and Donna Lovenburg, who were accompanying their friends on the ride.

"Luckily, our speed wasn't high. We'd just gotten started," Brad, who has extensive experience perched atop a motor scooter, said. The former Falls City councilman and longtime Executive Director of the Iowa Tribe Housing Authority in White Cloud, KS, said the bike suffered only minor cosmetic damage, estimated at \$1,800 by investigating officer Zach Ractliffe of the FCPD. Jones' Lumina suffered about \$800 damage and Ractliffe didn't issue any citations.

Also fortunately, the parents of two grown children and grandparents of four little ones will soon ride again. Statistics show that though motorcyclists on average are more cautious drivers than those steering four wheels, injuries to those not protected by an enclosed environment such as a car frame are much more severe when accidents do occur. And though just three percent of registered vehicles are motorcycles and they account for less than one percent of total vehicle miles traveled in the U.S., motorcycle riders make up 13 percent of all road fatalities.

Sabetha motorcyclist killed Sunday

A 51-year-old Sabetha man was killed Sunday afternoon, Sept. 25, when his motorcycle collided head-on with a pickup on Highway 75 in Brown County. Timothy Sparks was pronounced dead at the scene after a truck driven by 33-year-old Jody Guidry Jr., of Opelousas, LA, crossed the center line and struck Sparks' Harley-Davidson. Guidry was not hurt.

Though there is no motorcycle helmet law in Kansas, Sparks was wearing one.

More violence against staff at State Penitentiary in Lincoln

A Nebraska Department of Correctional Services staff member was assaulted at the State Penitentiary in Lincoln on Sunday, Sept. 25.

The inmate struck the staff member by punching him in the head. Chemical agents and physical force were used to subdue the inmate. The staff member was transported to a local medical facility for treatment of non-life-threatening injuries and released.

The names of the staff member and inmate will not be released, according to a statement released Monday.

Just last month, nine staffers were assaulted by inmates refusing to return to their cells at the Lincoln prison. All nine were hospitalized. And three days prior to that incident, an inmate wrapped his arms around a staffer's neck at the same prison, causing injury.

The facility for adult males was operating at nearly twice its design capacity in June. Sunday's violence is the latest in a series of incidents at Nebraska prisons since a riot erupted at the Tecumseh State Correctional Institution in May 2015, leaving two inmates dead.

Growing trade with Japan

Trade has helped grow Nebraska for decades. Whether you are a rancher who exports beef to Japan or a center pivot manufacturer who has expanded your operations to China, trade has been critical to growing our Nebraska farms, ranches, and businesses. Just look at the numbers: In 2014, Nebraska exported a total of \$10.66



billion worth of goods, of which \$6.59 billion worth was ag-based. Whatever pessimism we hear about trade from politicians these days, it is critical that we remember how key our trade relationships are to growing opportunities for the next generation of Nebraskans.

To see how trade has benefitted our state, there’s no better example than our relationship with Japan. Since Kawasaki first put down roots in Lincoln in 1974, Nebraska’s trade relationship with Japan has been helping create jobs and growing our economy. Our long-standing relationship with Japan has made the country the state’s number one direct foreign investor and third largest trading partner.

This relationship has flourished because of a long-term commitment by numerous Nebraska diplomats including previous governors and business leaders. My administration has continued this tradition. In 2015, I led my first trade mission to Asia during which I met with executives from Japanese companies to thank them for their investment in Nebraska and to talk about how we could support future expansions.

The trade mission has borne fruit. Over the past year, Kawasaki announced it would establish its first North American aerostructures line in Lincoln with a multi-million dollar investment. Morio Denki, one of Kawasaki’s suppliers that produces electrical components for rail cars, also announced their expansion in Nebraska. In addition to these expansions, we have also seen recent investments from other Japanese companies including Marubeni, Kewpie, Itochu, and NTT.

Continuing to cultivate relationships with Japanese companies can help encourage additional investment and build Nebraska’s reputation as a great place to do business. Last week, I traveled to St. Louis to attend the 48th Annual Midwest U.S.-Japan Conference. At the event, I addressed the conference and met with Japanese business executives as well as the country’s ambassador to the United States. During my address, I announced that Nebraska would host the association in Omaha for its 50th annual conference in 2018. The event will be a once-in-a-generation opportunity for Nebraska to showcase our state as a great place to do business for Japanese business executives and leaders looking for opportunities to invest and grow their businesses.

While relationship building through trade missions is key to expanding trade opportunities for Nebraska, we must also work to break down trade barriers that are limiting growth in markets for our products. Right now, Congress is considering the Trans-Pacific Partnership (TPP), a trade deal that would help expand markets for Nebraska’s commodities along the Pacific Rim with countries like Japan, Malaysia, Singapore, and Australia among others. The deal would reduce trade barriers, such as tariffs on our commodities like beef, making our products much more attractive to millions of consumers. For example, it would take Japan’s 38 percent tariff on our beef down to nine percent, and in Vietnam it would go from 20 percent to zero!

Trade deals like TPP are good for growing Nebraska and our relationship with key trade partners like Japan. Prison inmates and staff, more than just numbers

CAUTION: Some of you aren’t going to like what you read. You may NOT agree with what I am about to say, but all I ask is that you think about these things, which are, in large part, based on personal experience over time.

Prison reform. It’s more than just numbers and dollars and party politics. It’s about people and lives and livelihoods.

The word prison conjures up an Arlo Guthrie vision from “Alice’s Restaurant”:

“and there was all kinds of mean nasty ugly looking people on the bench there. Mother rapers. Father stabbers. Father rapers!”

That image has been drilled into our heads through TV shows and movies, maybe even novels. There is some ugliness, but this is also a way of life for 5,150 inmates in the Nebraska Department of Corrections. It is important to remember that these inmates are also people. People who have made bad choices and have found themselves incarcerated under the watchful eye of guards and caseworkers and administrators. Those folks are people too.

The inmates who can’t leave at the end of the day are living in space that is crowded to the point of 160 percent of what it was designed to hold. Try putting 60 percent more flour in the mixing bowl, or 60 percent more liquid. But then, remember that these are people.

Now think about the people who work in the correction’s facilities. At any given point, the workforce can be 200 short. Have you ever had to cover the phones or pick up the slack for a sick or missing co-worker? Remember how that felt? Now, consider having to operate with multiple vacancies.

In order to do that, people are forced to work overtime. Think about yourself. At some point you start to run out of gas and become tired and irritable. And we wonder what causes conflict between inmates and the people in charge. The inmates are living in cramped spaces and may just be a little irritable as well.

I can hear what you’re thinking. These are bad people and they don’t deserve to live in luxury. I’d cut you some slack on that thought. But, these are people – not all of them are as bad as Arlo Guthrie’s characterizations – and they shouldn’t be treated like animals in confinement.

Sitting in a prison visiting room on a Sunday afternoon gives one a new perspective. These are people who have wives and children and families. These are people who have parents and grandparents and aunts and uncles and siblings. These are people you’d find at a family gathering elsewhere if the circumstances were different.

Same for the folks who are running the gathering. They have badges and radios and handcuffs and pepper spray and various other objects of control. But they are people too and they are trying to do their jobs. There are just not enough

of them.

So, I see two approaches here. First, let’s reduce the number of people we are putting behind bars and look for alternative sentencing that would more aptly fit the crime. What does it benefit an alcoholic or addict to be behind bars for several years when treatment might make more sense. Does it make sense to pull someone out of a productive job -- where they are making money that could be used to pay for restitution or treatment or getting ahead in life – and warehouse them just because the law says we can?

The second step toward a solution: let’s pay enough money to hire enough people to do the

work. Pay them well, treat them well, and don’t overwork them. These are dangerous jobs. The people who do them deserve to be compensated fairly

Let’s support the corrections director so he asks the Legislature for the right amount of money to pay for the staff he truly needs. Give him the courage to stand up to the governor and those lawmakers who want him to save money so it can be spent on property tax relief. If it takes \$12 million, let it be \$12 million, not half that.

Remember, we are dealing with people. Let’s treat them like people, not numbers.

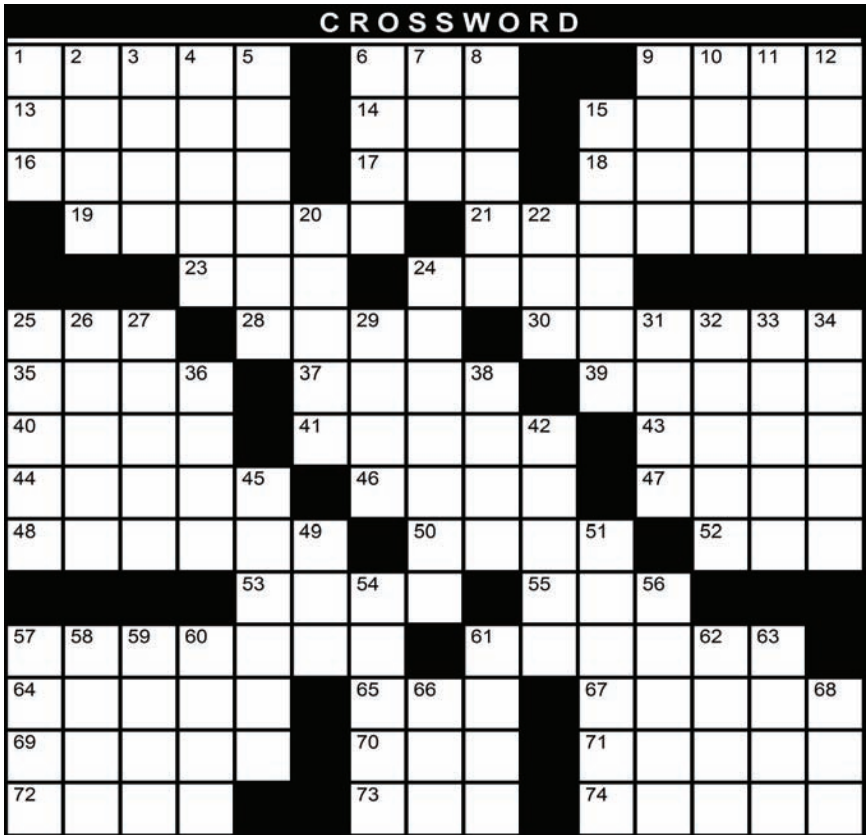

Year end tax planning - right around the corner

Do you like paying more taxes than you need to? Although there is certainly truth when it comes to the saying regarding “Death and Taxes”, you may be able to reduce the latter by taking a little time to review your situation. In the financial planning world, I often find tax discussions and planning are just as important as retirement accumulation when building net worth. The higher your household income gets, the more important it becomes! Let me give you an example. Let’s say you are married filing jointly, in the 25% federal income tax bracket and you are eligible to fully deduct your contribution to a traditional IRA. Putting \$2,000 into a traditional IRA will likely save you \$500 in taxes! (\$2,000 *25%). You just increased your net worth and lowered your tax liability by shifting \$2,000 from your checking/savings account to your retirement account. Please keep in mind that deductions vary according to your modified adjusted gross income and whether or not you’re covered by a retirement plan at work. Whether or not your contribution is tax-deductible shouldn’t be the only consideration in choosing an IRA. Before deciding, you should also weigh in on factors like required minimum distributions and taxes on withdrawals. Here are just a few tips that you may find worth your time when trying to keep more of your hard earned money.

(1) Plan –Take 30 minutes to review your income, withholdings and other pertinent financial data. You probably spent 10x that amount of time prepping for the family vacation. If you have a CPA, accountant or financial planner, setting up time with them is recommended. If you are self-employed or a small business owner, this is really important to do in Oct/Nov., while there is still time to make moves before the end of the year.

(2) Accelerate - If you itemize deductions, making payments for deductible expenses such as medical expenses, making January’s mortgage payment in advance, or pre-paying your 2017 charitable contributions may benefit you. If you are self-employed, making a purchase of needed equipment, vehicles or supplies for next year is usually worth considering. With that said, don’t buy it, if you don’t need it!

(3) Maximize- Add to your retirement savings. If you have the flexibility, max out or increase your contributions. This may lower your tax liability and help you save for retirement at the same time.

(4) Review RMDs – If you are age 70½, you generally must start taking required minimum distributions (RMDs) from traditional IRAs and employer-sponsored retirement plans (there are exceptions). If you fail to do so, the penalty is HUGE! ...roughly 50% of the amount you should have taken.

(5) Tax Loss Harvesting - No, you don’t have to be a farmer to do this and tax considerations shouldn’t drive your investment decisions. However, this fancy financial term is simply the practice of selling a security that has experienced a loss. By realizing, or “harvesting” a loss, investors are able to offset taxes on both gains and income. The sold security is generally replaced by a similar one, maintaining a suitable asset allocation. However, if you need to reallocate anyway or want to diversify your holdings differently, this may be a situation to reduce taxes and make the needed changes to your holdings at the same time. Usually, any losses over and above the amount of your gains can be used to offset up to \$3,000 of ordinary income.

remains even if the bond passes. We are asking SCC to slow down and consider Nebraska’s taxpayers who already pay the 7th highest property taxes in the country,” said Nelson. “SCC would be better suited to look at their existing taxing authority and prioritize projects in smaller, more targeted requests, if warranted,” said Nelson.


The decision to oppose the measure was not taken lightly. Representatives from Farm Bureau, including individual members who will be directly impacted by the measure, have met with SCC officials to both discuss and ask questions about the Bond measure.

“SCC and our state’s other community colleges provide an important service to Nebraskans and our labor force. Farm Bureau even has a presence at SCC through our Collegiate Farm Bureau. This isn’t a question of whether there is value in SCC. It’s a question of whether this is a good proposal,” said Nelson. “This specific proposal fails to provide enough detail or accountability and asks too much of taxpayers and their children who will be paying for this measure for the next

25 years. Taxpayers in the District should vote NO on this measure and let SCC know they must better articulate the need and provide detailed accounting when taking money out of the pockets of homeowners, farmers, and businesses in the form of new tax dollars.”

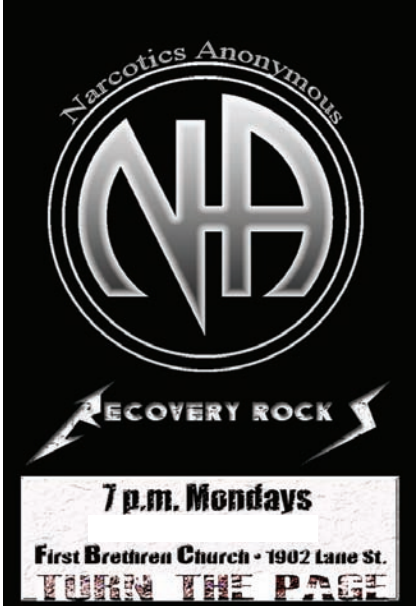
How to protect yourself from theft

Many people have no qualms about posting personal data via social networking sites, even though they aren't taking the precautions necessary to keep that information safe. Always keep your privacy settings at the highest level, and never share sensitive personal information such as your birth date, address or financial information.
Invest in security software
Invest in or upgrade your spyware and security applications. In addition, install any security updates authorized by your operating system or the apps you use.
Create strong passwords
Skip those easy passwords that just about anyone who knows a little about you can guess. Instead, choose complex passwords that feature a combination of letters, numbers and symbols. Many passwords are case sensitive, so use a combination of uppercase and lowercase letters as well.

Use only secured wi-fi networks
Avoid sharing personal information when using unsecured networks, such as those available at restaurants or coffee shops. It's easy for someone to hack into your accounts when they don't have to go through firewalls and other security features.
Exercise caution with email
Opening emails or clicking on attachments and links could initiate spyware, and doing so may even infect your computer with a virus. Also, don't be fooled by emails requesting personal information. Such messages are typically sent by fraudulent people masquerading as legitimate businesses, such as credit card companies looking to "verify" account information.
Keep personal belongings out of sight
Be mindful of personal items and information at all times. Shred mail that contains account numbers, and store checks and bank account paperwork and files where they can't

be seen. Avoid logging on to personal accounts in public and when your sensitive information might be visible to others.
Theft can be scary, and anytime personal belongings or information is stolen, it can make a person feel violated. Start taking steps to better safeguard your personal data.

The Falls City Tigers were back at the friendly confines of Jug Brown Stadium Friday night to take on the Bulldogs from Auburn. The Tigers were looking to get back into the win column after a disappointing loss last week to Lincoln Christian. A huge Homecoming crowd was on hand to cheer on the Tigers, and no one would be going home early on this night.

With 1:20 to go in the ball game and Falls City facing fourth down on the Bulldog 15 yard line the Tigers would call on Zane Heckenlively to try to keep their hopes alive. The Tigers split three receivers right and one left trying to keep Auburn guessing on what play would be coming. On the snap Heckenlively rolled to his left and cut it up field and was met right at the first down marker by an Auburn defender. It was too close to call, the referees took a time out to measure and both crowds fell silent. Just like that the air went out of the Tigers and their fans like a punch to the gut. Heckenlively was short of the mark by nearly two inches.

The Tigers didn't hang their heads though, instead they dug in and played defense. On first down FC stopped the Auburn running back for a one yard loss and took a time out with 1:10 to go. Then on second down Ben Bauman made another stop behind the line and FC took their final time-out with 1:04 to go in the game. On third down the Tigers brought down the running back in the back field for yet another loss but they couldn't stop the clock. With 18 seconds to go Auburn was forced to punt the ball away. The Tigers brought the heat and just missed a blocked punt. However a late penalty flag came out for a roughing the kicker penalty and Auburn would retain possession and run out the clock.

There were so many instances where just an inch or two could have changed the outcome of the game. There were four measurements for first downs. Heckenlively's first touchdown of the game barely got over the pylon. Auburn's touchdown up the middle. Falls City turning the ball over on its final drive, just missing the block punt, and to finish the first half the Tigers just missed a safety by an inch or two. In a game that's measured by yards it often comes down to inches.

Auburn took the opening kickoff and put together a 12 play 70 yard

drive. But the Tiger defense would bend but not break as they forced and incomplete pass and held Auburn out of the end zone. Falls City would take over on their 15 yard line with 5:50 to go in the opening quarter. The Tigers put together an impressive 16 play 85 yard drive that ate up 7:24 and it ended with a score. On second down Heckenlively kept the ball to the left and stretched the ball over the pylon for the touchdown. The extra point kick was wide right and FC led 6-0.

Falls City would force a three-and-out on Auburn's next possession and get the ball back with 7:38 to go in the half. The Tigers couldn't get any traction on offense and would be forced to give the ball right back. Trevis Keller came in to punt and he got away a good one. The Tigers downed the ball on the four yard line after a 56 yard kick. After a couple of plays Auburn had the ball on the 16 yard line for a third down attempt. The quarterback pitched the ball back to the running back, who fumbled it but got back on top of it on the one inch line. It very easily could have been called a safety but instead Auburn retained control with a fourth down coming up. With no time outs and only 39 seconds left in the half FC had the ball on the Bulldog 40 yard line. A heave to the end zone by Heckenlively was picked off as time expired with FC leading 6-0.

The third quarter began with FC getting the ball at their 44 yard line. After moving the ball 28 yards down field the Tigers would turn the ball over on downs after a costly chop block penalty. Auburn took over on their 28 yard line and would march 72 yards for a touchdown with 4:18 left in the third quarter. The two-point conversion was good and Auburn now led 8-6. Not to be outdone the Tigers came charging back going 64 yards on seven plays. Heckenlively again was the workhorse on the drive.

Following great blocking up front by his line, Heckenlively ran right and reached the ball across the goal line. The two point attempt by Heckenlively was good and with 1:08 left in the third quarter FC led 14-8.

Auburn once again put together a long, clock eating drive that would end in a score. The Bulldogs methodically marched 66 yards on 16 plays for the game tying score. On fourth and one, Auburn ran the ball up the middle for the touchdown. The PAT kick was good and Auburn led 15-14 with 5:11 to go.

Falls City, behind nice runs by Heckenlively and Rudy Vrtiska moved the ball down field before turning it over on 4th down at the Bulldog 10 line.

Fundamentally FC played a much better game. After eight turnovers a week ago the Tigers only had one this week. Also Falls City

had fewer penalties called against them. When asked about the tough loss Coach Fritz said, "we just have to keep working, keep focusing on the fundamentals. If we play with emotion like we have at times this year for four quarters we'll be a much better team."

Heckenlively led the ground attack for FC with 202 yards on 34 carries. Also on the night he became Falls City's all time leading rusher, overtaking Cord Huettnier. Zanye now has 2,547 career rushing yards. "It's a tremendous achievement for Zayne and his offensive line. Dalton Kennel, Ben Bauman, Koner Hogue Trevis Keller, Brian Sickel, Jesse Dean, Ed Fritz, Parker Thompson and Emmet Kirkendall. It would have been a lot better with a win but still a great accomplishment," said Coach Fritz. Dalton Kennel led the defense with 13 total stops. Ed Fritz added and another

10 tackles. Both the offensive and defensive line stepped up against the Bulldogs.

The Tigers will get the week off to rest. They will be in action again on October 7, against Conestoga.

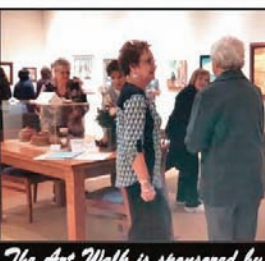

Every car/truck dealer in the county advertised new models in the *Journal*, which reciprocated with photos and descriptions of the new vehicles.

"A Patch of Blue," starring Sidney Portier, was to open at the Rivoli. Verdon was to receive \$69,680 in federal funding for a new sewer system.

An exhibit of art works by F.E. Morehouse of Rulo was to open Oct. 4 at the local library. Mr. Morehouse was a WWI veteran whose work included oil paintings, lead pencil sketches, pen and ink drawings and charcoal drawings.

"How The West Was Won," starring Henry Fonda, Gregory Peck, Debbie Reynolds, James Stewart, John Wayne and Richard Widmark, was to be on the big screen at Breezy Hill Drive-In.

Former President Dwight D. Eisenhower said he would not "automatically preclude anything," including the use of nuclear weapons, to bring the Vietnam War "to an early end." (UPI) Meanwhile, the County Selective Service was calling for two new inductees.

The 3-0 Falls City Sacred Heart Irish traveled to Mead on Friday evening to take on the 2-1 Raiders. The undefeated and third ranked team in class D-2 according to the *Lincoln Journal Star* wasted little time setting the tone of the game.

On the first possession of the game Mead was unable to get anything going offensively and the Irish forced its opponent into a three and out and a punt. Henry Arnold took the punt back 12 yards and the Irish started their first possession at midfield. SH didn't take too long as they pushed the ball down the field in five plays, capping off the drive with a five yard touchdown run by Christian Harring. The two point run by Harring was also good and with 8:03 remaining in quarter number one the Irish led 8-0.

The Raiders were able to move the ball on their next set of downs against the stingy Irish defense. However the Irish defense dug in and forced Mead into a 29 yard field goal which was no good. On the Irish next drive the duo of receiver Emerson Keithley and quarterback Drew Bippes teamed up for a 39 yard touchdown pass. The two-point run by Austin Ahern was good and the Irish jumped out to a 16-0 lead with 3:02 remaining in the first quarter.

After giving up some yards on the last drive, the Irish defense stood strong and forced Mead into yet another three and out. After a punt with no return the Irish had the ball at their own 25 yard line to begin the drive. On the second play Bippes again found Emerson

Keithley down the field for a 46 yard touchdown pass. A pass from Bippes to Harring for two points made the score 24-0 as time ran out on the first quarter.

After another three and out, Arnold took the Raider punt back 27 yards to the Mead 29 yard line. Then on the second play of the drive Arnold took the ball and rambled 20 yards for the score. A run by Bippes for the conversion made the score 32-0 with 8:51 to go in the half.

SH forced a fumble on the Raiders next set of downs and Brandon Scheitel pounced on the ball at the Mead 30 yard line. The celebration didn't last long though as Bippes was picked off and Mead returned the ball 28 yards to the Irish 36 yard line. Keeping their heads up Sacred Heart turned around and Emerson Keithley stepped in front of a pass and returned it down the field 51 yards.

The turnover bug struck again for the Irish this time on a muffed option play at the Mead 14 yard line. Once again Mead was able to move the ball, this time down to the Irish 21. Then on fourth down Michael Keithley batted down a pass attempt and the Irish would take over first and ten. Turnover issues continued to plague the Irish as Harring was stripped after a long run and Mead fell on it at their 18 yard line. The Raiders were unable to capitalize and time ran out on the first half.

The Irish came charging out in the second half and with 10:34 to go Bippes did the damage with his legs, running 56 yards for the score. A pass from Bippes to Noah Keller made the score 40-0. The Mead Raiders just couldn't get going on offense and turned the ball over on downs at their own 35 yard line. This time it was Harring doing the hard work on the ground going 28 yards for the score. The PAT kick failed but SH led 46-0.

Meads next set of downs went the way many had before, three-and-out. This time Michael Keithley busted through the line and blocked the punt. SH took over on the Mead 35 yard line. Six plays later Freshman Jake Hoy went into the end-zone from seven yards out. The PAT attempt failed and the score went to 52-0. Neither Hoy nor the Irish were done as he scampered 13

yards on the Irish next possession for SH's final score of the game. An Austin Sells run made the score 60-0.

Mead would not go quietly as they took the kickoff back 77 yards for their first and only touchdown with 19 seconds to go in the game. The two point attempt was good and the final score would end up 60-8 in favor of the Irish.

Senior Bryant Jorn saw his first action of the season after recovering from a severe ankle sprain. Coach Goltz said Jorn played about half of the first two quarters. "He played well at times but still needs to get into game shape," said Goltz. When asked about the running game Goltz said, "we decided to run the ball and we blocked well and ran well. Our first unit offense though had three turnovers in the second quarter-two fumbles and one interception. We need to clean that up."

With the big lead the Irish have been able to rest the starters lately which can be both good and bad. "We haven't played a four quarter game since Lourdes so conditioning for a full game is a concern. On the other hand, we are getting lots of reps for the younger kids which helps for the future," said Coach Goltz.

County Board opens sealed bids for projects

Sealed bids were opened by the Richardson County Commissioners during their regular Tuesday, Sept. 20, Courthouse meeting.

All three board members, Dave Sickel, Jim Davidson and Jim Standerford, were in attendance. All sealed bids were accepted for review purposes only.

One bid was received for the bridge project at the mouth of the Nemaha River. The bid, at \$594,129, came from Simon Construction, Inc., of North Platte. The County Engineer will review this bid.

Two bids were opened for the 2016 armor coat project. Topkote, Inc., of Yankton, SD, bid \$153,271.20 and Sta-Bilt Construction Co., Harlan, IA, bid \$219,240. These bids were to be submitted for review to the Highway Supt. and Engineer.

The board held public hearings on the proposed budget and tax request levy for 2016-17. Only one individual, Larry Rexroth of Humboldt, attended the budget hearing and stated opposition to the county's funding of private economic

development corporations. Specifically, Rexroth pointed to Falls City EDGE.

Following the hearing, the board acted unanimously to adopt a resolution to adopt the 2016-17 budget.

No visitors attended the hearing on the the tax levy request, at a different rate from the previous year. After closing the hearing, the Commissioners set the new tax levy at .344051. All voted "aye."


Jeremy Behrends introduced himself to the board as the Chief Probation Officer in District 1. He had assumed his duties on Sept. 1. Mike Pemberton, probation officer serving Richardson and Nemaha Counties, also attended this portion of the meeting.

The local Probation Office is requesting that its location on the first floor of the Courthouse be relocated to the previous Sheriff's Office on the second floor of the Courthouse. Board members said they would consider the request and respond within the next month.

Highway Supt. Scott Huppert provided his weekly update on road and bridge maintenance. He informed the board that motor grader operator Ben Sailors intended to resign his position effective Sept. 30. Huppert said the bridge crew was working on a project south of Rulo and would be moving to a bridge site northwest of Humboldt. The board moved to approve the addendum to the contract with Nemaha County for a bridge replacement project on a county line road.



Sheriff Don Pounds reported on activity in the Sheriff's Office and County Jail during the past week. A few matters with the jail were reviewed and have been forwarded to the architect for correction.

In other developments, the Commissioners: Approved a subdivision for the Clara E. Coonce Trust and adopted the corresponding resolution. Approved all claims that had been submitted.

How to keep children of all ages safe

New and experienced parents alike must keep many things in mind when welcoming a child into their homes. Babies do not come with instruction manuals, but kids of all ages need their parents to perform various functions, including keeping them safe.

The Centers for Disease Control and Prevention says unintentional injuries, or those that result from burns, falls, poisoning, road traffic, and drowning, are the leading cause of morbidity and mortality among children in the United States. But even injuries that do not result in fatalities can still be serious. An estimated 9.2 million children per year visit hospital emergency rooms for unintentional injuries. For children 12 months old and younger, falls account for more than half of the nonfatal injuries.

Child safety is not an issue to take lightly, and parents and other caregivers must remain up-to-date on the latest guidelines regarding safeguarding children. The following are some safety tips and areas of concern parents may want to pay particular attention to.

Falls - As children learn to move around their world, stumbles are to be expected. However, there are steps parents can take to minimize injuries.

Keep babies and young kids strapped and secured when using infant seats, swings, car seats, and strollers. Always keep the devices close to the ground, and not placed on top of a table or other furniture.

Install safety gates at the top and bottom of all staircases.

Install window guards to prevent window falls.

Visit only those playgrounds that have installed shock-absorbing surfaces beneath the play equipment.

Water accidents - A child can drown in mere inches of water. As a result, parents must be extremely diligent to prevent accidents.

Never leave a child unattended around any source of water, even for just a few seconds.

Empty all tubs, containers, and kiddie pools of water immediately after use.

Use locks to seal toilet lids, and keep doors to bathrooms closed.

Install fences around home pools. Gates should be self-closing and self-latching.

Always test the temperature of bath water to ensure it is comfortable and will not scald a child.

Toys are a part of a child's life, and they should bring joy, not danger.

Keep a child's age in mind when purchasing a toy or game.

Small toy parts can pose as choking hazards for young children, so inspect toys frequently for chips.

Each year in the United States, more than 2,800 kids are treated in emergency rooms after swallowing button batteries. Keep the following away from young children: remote controls, singing greeting cards, digital scales, watches, hearing aids, thermometers, children's toys, calculators, key fobs, t-light candles, and flashing holiday jewelry or decorations.

Risks for older kids - As children age, the ways to protect them change. The National Children's Advocacy Center suggests these guidelines.

Parents should learn all they can about their children's activities and friends.

Teach children to refuse anything from strangers.

The buddy system is a good idea when walking home from school or other events.

Make sure kids know that strangers can be found online, too. Teach kids to avoid sharing personal information with individuals they meet on social media.

Develop a family safety plan for meeting up when outside of the home.

Tiger Softball now 14-10 on the season

The Falls City High School softball team has had its share of ups and downs this season, and this past week was no exception. The Tigers, who are now 14-10 on the season, hosted a triangular Monday night, and faced off against two very good class B teams. Falls City lost to Crete 0-1, and to Beatrice 5-11.

The orange-and-black then came back on Thursday night and pounded its district competitor, Freeman High School, 11-1. "The girls battled hard against all three teams," head coach Joe Dunn said. "We hit the ball very well, but Crete and Beatrice fielded us well. We lost to two solid softball teams."

In the Crete game, senior pitcher Tayten O'Brien led the way defensively, giving up just three singles, and smoking the ball past five batters for strike-outs. On the rest of the hits, the Falls City field backed up its pitcher, teaming up for six fielded fly balls, and eight grounded outs to Erin Brewer at first. Crete's lone score came in the fifth inning when the Cardinals' first batter got on base on an error, and was advanced to second by a grounder. The fourth batter hit a single to the outfield, which allowed the runner to score.

Falls City hit equally well, but just couldn't get all the way around the bases. Rylee Scholl and Morgan Bletscher had the sole singles in the game. Bletscher was advanced to third on sacrifice grounders by Erin Brewer and Bailey Gilkerson, but was unable to get across the plate. The Cardinals ended up winning the game with just one run.

In the Beatrice game, the Tigers fielded well, but the Orangemen's bats were hot. Beatrice tallied 17 singles in the game, against the solid pitching of senior Bailey Armbruster, and junior Meredith Poppe. The Lady Orangemen also

had two doubles, a triple, and a home run, and racked up 11 runs to Falls City's five.

Defensively, third baseman Morgan Bletscher led the way as she fielded four grounders for outs at first, and caught two fly balls. Center fielder Meredith Poppe and left-fielder Regan Deckinger each caught a fly ball as well. Offensively, the Tigers hit the ball, but struggled to keep it on the ground. They hit eight fly balls that were caught for outs.

Catcher Molly Brown hit an over-the-fence homer in the bottom of the fourth inning, scoring designated player, Hannah Clary, who had gotten on base with a single. The Tigers already had three runs on the board at the time, having scored one in the bottom of the second inning when Bletscher hit a single, and was advanced around the bases on walks. Rylee Scholl and Meredith Poppe then pounded out doubles in the bottom of the third and were knocked in on singles by Armbruster, Bletscher, and Deckinger.

On Thursday night, a very solid Tiger team showed up at Hartman Field, and added an exclamation point to their 11-1 win over the visiting Falcons from Freeman. Starting pitcher Tayten O'Brien faced just fifteen batters in the four innings. She struck one out in the first inning, two in the fourth, and gave up just two singles and a triple. One of those singles was a fly ball to short center field, and shortstop Rylee Scholl nearly caught it, but it was just out of her reach. Scholl did, however, catch one fly ball and fielded two grounders for outs to Brewer at first. The other outs came on grounders to Brewer, and O'Brien.

When the Tigers were at the plate, singles were inked by seven of the first eight batters, driving in three runs in the bottom of the first inning. Meredith Poppe and Rylee

Scholl then hit doubles in the second inning, and Morgan Bletscher socked a triple after Bailey Armbruster walked. Bletscher drove her in, and the score was six to nothing in the top of the third.

Freeman scored its sole run then on a walk and a three-bagger, but the Tigers answered with a single by Bailey Gilkerson, then doubles by Deckinger and Brown. Rylee Scholl then drove Brown in with an out-of-the-park homer. Morgan Bletscher hit one in the bottom of the fourth, to end the game by the ten run rule.

Falls City also played at home last night, and will play its final home game on Thursday, against Syracuse. The JV game starts at 5:00, and the varsity at 6:30.
