CANCER BAGS DONATED IN HONOR OF TAMI FEEK

In 2015, family members of Tami (Weaver) Feek, rallied together in search of donations. It was a goal of Amanda (Weaver) Crowley's to organize the event in hopes that they could help others going through the same struggles that Tami did. Mid-February 2014, Tami was diagnosed with inflammatory breast cancer, a rare form of breast cancer. She underwent two rounds of chemotherapy, surgery, and radiation. In December, it was discovered that cancer had spread to her vertebrae. Feek went through another round of radiation, with no success, so she started chemo again. She was frequently traveling to Bellevue for her treatments, as well as seeking care at MD Anderson Cancer Center in Houston, TX. Feek sadly passed away on October 29, 2015.

A Facebook event was created to help spread the word. Crowley's goal was set to donate at least ten bags in memory of her aunt Tami. A donation of \$26.00 was asked to purchase the bags from her Thirty-One business. She would then fill the bags using her commission. There were so many family members, friends, and friends-of-friends that donated to the cause, breaking Crowley's goal of 10 bags. Pam Scott had even applied for \$250.00 from Thrivent for Lutherans Action Team. After all of the donations stopped coming in, Amanda was able to purchase 60 bags. These bags were filled with items such as hand sanitizer, lotion, Biotene mouthwash,

hard candy, socks, crossword puzzles, pens/pencils, Kleenexes, chapstick, blankets, and a notebook with an inspirational

quote that was handwritten on the inside. There were also bag tags with Tami's picture on it. (Continued on Page 4)

The City of Falls City has announced that on Thursday, January 9, 2020, there will be a large planned electrical outage in Falls City to make permanent repairs to damaged cables.

The outage will affect anyone who lost power on December 19, 2019, during the electrical outage. The city will have a contractor on-site with expertise in this technical type of work so we can replace and terminate the cables.

The outage will begin at approximately 7:30 am. Repairs will be completed as soon as possible but could take up to eight hours or longer to complete.

St. Paul's Church at 20th and Towle Street is serving as a "warming/electrical station" on Thursday, January 9, during the planned power outage. They're encouraging people to come in to keep warm, bring a lunch and use their facilities. The church is handicap accessible.

GROWING NEBRASKA IN 2019

The vision of my administration is to grow Nebraska, and we've worked hard throughout 2019 to make that vision a reality. This has been a tough year because of historic floods, but Nebraska has been resilient. We've experienced tremendous growth in 2019 by building on four pillars of prosperity: developing our people, cutting red tape, delivering tax relief, and expanding trade opportunities.

In 2019, Nebraska created jobs for working families in industries ranging from manufacturing to technology. Nebraska's manufacturing employment surpassed 100,000 for the first time since the Great Recession of 2007-2009. I saw the resurgence of Nebraska manufacturing firsthand in October during a tour of our state's builders and makers. Aulick Industries in Scottsbluff, Allmand in Holdrege, and Becton Dickinson in Columbus are just a few examples of growing manufacturing companies here in Nebraska.

Despite challenges in agriculture over the past year, we have helped to grow major opportunities for our farmers and ranchers. In October, Costco celebrated the grand opening of its poultry operation in Fremont. Costco has partnered with around 100 farm families to build new chicken barns in Nebraska. In addition, corn and soybean growers are supplying the equivalent of 2,000 acres of corn and 2,000 acres of soybeans to Costco's plant every week.

The incredible tech growth our state experienced in 2019 has reinforced our reputation as the Silicon Prairie. In January, LinkedIn announced a major expansion in Nebraska. In 2007, LinkedIn opened its first office in Omaha with fewer than 10 people. By the time it finishes its current expansion in 2021, the company expects to employ 1,000 people in Omaha.

This year was also a banner year for data centers in Nebraska. In June, Facebook opened a data center campus in Papillion that will exceed \$1 billion of investment by the time it's completed. In August, Compute North broke ground on a new data center in Kearney's Tech ONE Crossing. In October, Google also broke ground on a major data center—just down the road from Facebook's location in Sarpy County. In September, Lincoln's City Council approved initial plans for yet another large data center at a site northwest of the 56th Street exit of Interstate 80.

To equip Nebraskans for these great jobs, we grew our Developing Youth Talent Initiative (DYTI) to introduce more Nebraska middle school students to careers in IT, value-added agriculture, and manufacturing. Career academies expanded at high schools from Sandy Creek to Scottsbluff to provide high school students with the opportunity to get college credit while gaining practical workplace skills. At the college level, we've increased the number of Registered Apprenticeships 44 percent since 2016 so that students can "earn while they learn" at a local business. Together, these initiatives are creating a talent pipeline of skilled young professionals to grow Nebraska.

Just a few days ago, I met with President Trump and fellow Governors at the White House to share the ways we've cut needless, burdensome regulations in order to grow Nebraska. In 2019, we merged the Departments of Environment and Energy to generate efficiencies. We made it easier for Nebraskans to obtain licenses to work in occupations such as appraisers. Our Center of Operational Excellence also worked with state agencies to reduce waste and save time for State teammates and customers.

In addition to cutting red tape, we've controlled spending so we can cut taxes to help Nebraskans grow their businesses, create jobs, and invest in their communities. In March, I worked with the Legislature on my third budget, which covers the next two fiscal years. Since I took office, we have reduced the annual growth in state spending from 6.5 percent to less than 2.4 percent over the last three budgets. This allowed us to increase the Property Tax Credit Relief Fund from \$140 million, which is where it started when I became Governor, to nearly double at \$275 million annually. When Nebraskans receive their property tax statement this month, they will see that the State Tax Credit has gone up by 20 percent year-over-year.

Meanwhile, the Bureau of Economic Analysis reports that Nebraska has enjoyed economic growth well above the national average in 2019. State revenues reflect this growth. In October, the state's forecasting board raised its revenue projection by \$266 million, combined, for the current and upcoming fiscal year. With the extra revenues, we're poised to deliver additional tax relief in 2020.

Finally, I led three trade missions this year to open up new markets for Nebraska products. In February, I led a delegation to Mexico as we pushed for approval of the U.S.-Mexico-Canada Agreement. Then in September, I visited Vietnam and Japan. Vietnam increased its beef exports 127 percent year-over-year, and our visit helped secure approvals for pending biotech applications for soybean imports. Earlier this month, Japan approved tariff reductions for American beef and pork imports, which is a big win for Nebraska. Finally, our trade mission to Germany in November promoted Nebraska's ag technology and allowed us to thank German companies investing in Nebraska.

Nebraska's economy is on an upward trajectory. We have plentiful jobs for graduates and abundant opportunities for businesses to get started and grow in our state. They're Back! 106th Legislature Second Session Begins.

They're back! The 106th Nebraska Legislature Second Session has begun at the State Capitol. This Legislature looks like the same one that bailed early on the 90-day session in 2019 without definitively addressing property tax reform, a new statewide business incentive plan or medical marijuana.

Scheduling is clearly the Speaker of the Legislature's prerogative and Speaker Jim Scheer of Norfolk realized that things were at a standstill. It might be different this year since Scheer is term-limited at the end of this session and he might want to make it count. The calendar currently calls for final adjournment, Day 60, on April 23.

Let's look at this session as it unfolds by the numbers. There are 30 Republicans, 18 Democrats and one Independent (Ernie Chambers) in the officially non-partisan body. Yes, there's only one Ernie Chambers and he, too, is term-limited after this year.

The first 10 days of the session are open for the introduction of new bills. They will be scheduled for public hearings while Senators dive into morning floor debate to work on the backlog of 481 carry-over bills and 11 Legislative Resolutions. There are 13 senator priority bills, four committee priority bills and two Speaker priority bills, which should take precedent. They are at various stages of floor debate.

You might ask why it takes longer than 60 days for the 60-day session. There are 15 recess days and two holidays built into the next four months. The two holidays come in January for Martin Luther King Day and President's Day. There are four recess days in February, five in March and six in April. Legislative debate will tentatively stop on April 16th and then lawmakers — intent on overriding any possible gubernatorial vetoes — will come back April 23rd for one final day.

That allows plenty of time for the incumbents to get home to campaign for the May primary election. Given that nearly half of the Senators face re-election, the things they say and do on the floor may be limited. Nobody wants to make a fool of themselves. There are a few term-limited senators who might be expected to throw caution to the wind. Either way, the looming election will definitely color what happens.

Pending ballot initiatives will likely have an impact on floor activity. Major proposals on property taxes and marijuana will definitely be worth watching. Pressure from the Executive Branch to pass an economic development proposal will also be in play. Senator Mark Kolterman of Seward is carrying LB720, the Imagine Nebraska Act, which stalled on Select File (second round debate) last year as rural senators held it hostage in an attempt to get property tax reform

passed. Neither happened.

Lincoln Senator Anna Wishart is carrying LB110, the Medical Marijuana Act, which is stuck on General File (first round). Education Committee Chairman Senator Mike Groene of North Platte has an Education Committee priority bill (LB147) to allow teachers and administrators to use physical restraint to regain control of a disruptive classroom situation. Both measures are hot button issues as is Senator Chambers LB44 to repeal the death penalty, his 26th attempt to do so. He was successful a couple years ago and lawmakers overrode a gubernatorial veto. But the governor heavily funded a ballot issue, which allowed Nebraskans to vote to keep the death penalty.

Senator Tom Briese of Albion and Senator Steve Erdman of Bayard have lingering property tax proposals. Briese's LB183 is on Select File and Erdman's LB483 is on General File. Both deal with ag land valuation and their application to school funding. Both may be used as vehicles for or abandoned in favor of a property tax proposal expected from the Revenue Committee which met regularly during the interim to fashion a solution that would prevent the ballot issue.

Count on this being one of the more exciting short sessions in recent memory.

Falls City Federal Golden Eagle passbook accounts earned interest as high as five percent.

A meeting was scheduled to outline a conservation plan for the Winnebago-Bean watershed.

The Falls City school district was seeking bids for sale of the Grandview school building.

Orders were being received for evergreen and broadleaf trees and shrubs for farm windbreaks at just \$8.20 per hundred.

Both Falls City and Humboldt had submitted entries in a National Clean-up contest.

Falls City High wrestlers lost a dual they hosted with Wymore Southern 35-8. Tom Prichard and Norm Olson got the only Tiger victories.

The Order of the Eastern Star of Rulo installed Mrs. Lester Baker as its worth matron.

Walt Disney's "Peter Pan", Gregory Peck in "The Chairman" and "Run Wild, Run Free" were being shown at the Rivoli.

Susan Fleskoski and Stacy William Hoy, III were winners of the Elks Leadership Contest.

Margaret Elaine Mason, 23, Ottumwa, IA, the alleged driver of a getaway car in a robbery at the Bank of Salem, had her probation revoked and was sentenced to 15 months in prison.

In boys' basketball: Wymore Southern 96 Falls City 75, Hiawatha 79 Falls City 67, Ralston 67 Falls City 47, Sacred Heart 61 Bern 46, Bern 62 Dawson-Verdon 58, Sterling 75 Southeast 65.

Feb. 15 was the deadline for freeholders to petition for transfer land into a K-12 School District.

Free immunizations to prevent red measles were available for injection by physicians.

While most Americans were spending the holidays with their families, Air Force Sg. Melvin O. Marmet, Falls City was hundreds of feet underground with NORAD in northern Canada.

Pawnee City eliminated Sacred Heart 73-52 and Humboldt outscored Lourdes 51-37 to advance to the semifinals of the Southeast Border conference basketball tournament.

The state manager of the Nebraska Dairy Assn., Shubert native J. Sam Lewis, was the speaker for the annual meeting of the Federal Land Bank Assn.

Don Coupe was elected president of the Falls City Chamber of Commerce. Sheriff Camblin filed for re-election as a Republican.

Commissioners approved applications of both Rulo and Salem to combine their municipalities elections with the May county primary.

Among neighborhood grocery stores with *Journal* ads were Pickard's Market, Shaffer's, Kenny's Food Center, and Fleskoski's Food Basket.

Safeway was seeking to attract customers with discounted prices on porcelain china and Hinky Dinky with attractive pricing of EKCO cookware.

Commissioners discuss Rulo road resurfacing and 911 dispatch

The routine maintenance being done on county roads and bridges during the previous week and on planning for the resurfacing of the road south of Rulo. County bridge match submitted 2 proposals for review and approval. Engineers are preparing estimates for the overlay on the hard surfaced road south of Rulo. Darveau informed the Board that there have been quite a few areas where field terraces are being made which is diverting water into the County Road right-of-way ditches. Future bridge replacement projects were also briefly reviewed. Sheriff Hardesty and Chief Deputy Roland Merwin reviewed with the Board the routine business within the Law Enforcement Center. The Sheriff and Chief Deputy also discussed with Commissioners the planned statewide radio system and Regional 911 Dispatch for Southeast Nebraska. During his portion of the meeting, Brian Kirkendall, EMA Director, presented to the Board quotes he had obtained for the replacement of his department's radio equipment. Mr. Kirkendall explained that it is likely that Richardson County would join the statewide radio system in the near future and his department will delay any purchase of radio equipment at this time.

Kirkendall also presented quotes received for the purchase of a generator system capable of powering the entire Courthouse. The quotes received thus far were: Generators for Sale, Omaha, 70kw for \$34,300; IAO Electric of Hiawatha, KS for a used 150kw with 123 hours for \$47,000. Both quotes included installation and any wiring updates. Additional quotes will be sought and this matter will be discussed further at a later meeting.

Commissioners voted to go into an executive session with Kirkendall to discuss personnel matters at 9:45 a.m. Following their discussion with the Emergency Management Agency Director, the Board voted to close the executive session and return to its regular meeting agenda at 9:55 a.m.

Radon Action Month and free radon testing

Radon can enter homes through cracks in concrete floors or walls, sump pits, or drinking water from private wells. In Nebraska, over half of

all homes tested contain high radon levels. The high incidence of radon in Nebraska underlines the need for continued testing to identify households in need of radon mitigation, a process to reduce radon accumulation within a home.

The Southeast District Health Department is offering free radon test kits. The do-it-yourself test is a simple way to identify if your home needs radon mitigation services to reduce the risk of radon-associated lung cancer. NPPD releases emergency planning information

In case of an emergency at the Cooper Nuclear Plant, how would I be notified/what should I do? Should a major emergency occur at Cooper Nuclear Station, sirens will sound a steady tone for three to five minutes which will alert you to turn on your radio or television set for information. Rural residents will be alerted when your NOAA/EAS radios automatically turn on.

If an emergency occurs at Cooper Nuclear Station, the station will immediately notify state, federal and county officials.

Local and state officials will use an alert and notification system to inform residents within a 10-mile radius of Cooper Nuclear Station that an emergency exists.

The alert and notification system is made up of sirens located in populated areas, and National Oceanic and Atmospheric Administration (NOAA) Emergency Alert System (EAS) radios, located in rural residences which are outside the effective

hearing range of the sirens. Information will be broadcast over the local radio and television stations which form the Emergency Alert System (EAS) in this area.

The siren system is silent tested four times a month (usually on Tuesdays). The NOAA/EAS radios are tested weekly (usually Wednesday mornings at 11:15) whenever the local NOAA Weather Radio Transmitter sends a test message.

The emergency classification levels are as follows: There are four levels or classifications of nuclear power plant emergencies:

1. NOTIFICATION OF UNUSUAL EVENT- An Unusual Event is the lowest level of emergency classifications established by the Nuclear Regulatory Commission for nuclear power plants. It means a small problem has occurred inside the plant. Federal, state, and county officials will be told right away. Residents, businesses, farmers, or visitors to the area will not

have to do anything.

2. ALERT - An Alert is a minor problem inside the plant that may result in a lowering of the level of safety at the plant. Federal, state, and county officials will be told and they will stand by, ready to take safety precautions if necessary. Residents, business, farmers, or visitors should not have to do anything.

3. SITE AREA EMERGENCY - A Site Area Emergency is an indication of a more serious problem. There is potential for small amounts of radiation to be released into the area around the plant. If deemed necessary, state and county officials will take actions to ensure public safety. Sirens will sound and EAS tone-activated radios will turn on. Listen to your local radio and television stations for information and be prepared follow any instructions provided.

4. GENERAL EMERGENCY - A General Emergency is the most serious level of emergency classifications established by the Nuclear Regulatory Commission for nuclear power plants. It means an incident has occurred which could result in the release of radiation outside of the plant area. While we are concerned with latent consequences within the 50-Mile EPZ, the potential for public-health-risks is a much higher and immediate concern

for people within the 10-Mile EPZ. Sirens will sound and EAS tone-activated radios will turn on. Listen for information on local radio and television stations be prepared follow any instructions provided by state and county officials. Instructions may include taking shelter in your home or evacuation from the area.

Who would be affected? Emergency preparedness efforts are divided between Cooper Nuclear Station, private organizations and governmental agencies. The purpose is to protect the health and safety of the public and Cooper Nuclear Station employees in the event of an emergency.

Federal regulations and the Cooper Nuclear Station emergency plan directs that special attention should be given to people within a 10-mile radius of the plant. This 10-mile radius is called the Emergency Planning Zone (EPZ). Cooper Nuclear Station's EPZ includes portions of Nemaha and Richardson Counties in Nebraska, and portions of Atchison County in Missouri.

If an emergency occurred at Cooper Nuclear Station, it is unlikely that everyone in the 10-mile radius would be affected. It would depend on the type of accident and on weather conditions, such as wind direction and speed. Because of this, it is important that you locate where you live on the enclosed map (page 9) AND pay close attention to information broadcast over your EAS network station. You will be instructed to take protective actions ONLY if it is necessary for your safety.

What should I do if the sirens sound? Remember, the sirens and NOAA EAS Radios are only to alert you to tune in to your local emergency alert system radio or television station for information and instructions. This station will give you information about what to do.

Check on your friends and neighbors who might need assistance.

Share this information with them.

If emergency actions for the public are required, your local Emergency Alert Station (EAS) is your best source for information. For additional information, a public information hotline for use by residents in the 10-mile EPZ will be made available by calling 1-877-275-6773.

Sign Up to Receive Emergency Alerts. Nemaha, Otoe, and Richardson Counties Cooper Nuclear Station participates in the Southeast Nebraska Emergency Notification System...Serving Nemaha, Otoe, and Richardson Counties. This system service is provided by Everbridge. You may sign up to receive emergency alerts delivered directly to your home or business telephones, and/or E-mail, text messaging, SMS, and mobile phone devices and pagers.

To sign up for this service and start receiving emergency alerts, Visit: <http://www.nemahacounty.ne.gov/> and click on the Citizen Alert button below and then follow the instructions. If you need assistance signing up contact the Nemaha County Emergency Management Agency at 402-274-2552.

Reception centers locally in Nebraska should an evacuation be directed for all or any part of the 10-mile emergency planning zone in Nebraska, you would evacuate to either Falls City or Nebraska City. Specific information will be broadcast over local EAS radio and television stations. Evacuation routes are shown on the map and listed in the accompanying protective action area information.

Irish boys improve to 9-0

After a six-day layoff, the undefeated Irish boys' basketball was back on the hardwood as they traveled to Dewitt to take on the 4-3 Tri-County Trojans. SH showed a little rust from the time off shooting just 6/14 from the floor to open the game but held a 15-9 lead after the initial eight minutes. The Irish came on strong in the second quarter, pulling ahead to a 36-14 lead at intermission. The Irish again struggled out of the gate in the second half, making just 3/11 shots, but increasing their lead to 45-21. The Irish doubled up the Trojans 12-6 in the fourth period to take the 57-27 win.

For the game, Sacred Heart hit 7/16 from beyond the arc and 23/50 shots overall while limiting Tri-County to just 10/32 from the floor. SH also made good on 4/5 shots from the charity stripe. The Irish owned the glass, holding a 32-18 advantage, including a 10-2 lead on the offensive end.

Tyler Witt led the way for Sacred Heart with a double/double, scoring 17 points and pulling down 15 rebounds and adding four assists. Jakob Jordan added 15 points, making 5/7 from behind the three-point line, and added two steals. Jake Hoy also cracked double digits, making five of seven shot attempts for 13

points to go along with five rebounds and three steals. Lucas Weise led Tri-County with 11 points while Cole Siems added nine. The Trojans were limited to just four made field goals in the second half.

Scoring vs. Tri-County, Jordan 15, Stice two, Hoy 13, Witt 17, Bauman two, Simon four, Fiegenger four.

On Saturday, the Irish traveled to St. Joseph for a matchup against Bishop LeBlond in the Steve Vertin Classic. The Irish controlled the game out of the gate, racing to a 14-2 lead after the opening eight minutes. The Irish defense forced LeBlond into 0-7 shooting, allowing just a pair of free throws in the first quarter. Sacred Heart grew their lead in the second quarter to double up the Eagles 30-15 at the half. SH kept their foot on the gas pedal in the second half, outscoring LeBlond 38-25 in the final two quarters to pick up the 68-40 win.

SH finished the contest making 25/49 shot attempts (51%) while holding LeBlond to 10/33 (30.3%). The Irish absolutely owned the glass, outrebounding the Eagles 43-8. The Eagles did

commit fewer turnovers than the Irish (16-10); however, SH finished with 14 assists while the Eagles had just six. Both teams shot well from the foul line with the Irish making 15/21 while the Eagles hit 15/24.

Tyler Witt again put up a double/double, hitting for 19 points and pulling down 14 rebounds. Witt also added four assists and two steals. Jarrod Simon hit five of eight shots from the field to add 13 points, and Jack Fiegenger added 11 points, three rebounds, and two steals. Jeffrey Johnston led Bishop LeBlond with 12 points, and Isaac Ferguson added nine.

Scoring vs. LeBlond, Jordan six, Stice three, Hoy nine, Witt 19, Simon 13, Fiegenger 11.

With the win, the Irish improved to 9-0 for the season, outscoring opponents 67.1-26.3 for the year. At this point in the season, Witt is the Irish's leading scorer averaging 16.9 ppg and 8.4 rpg.

The Irish now set their sights on Sidney on Thursday, January 9, in FC, and then hit the road for a matchup vs. Diller-Odell. The Irish will later play in the MUDECAS Tournament in Beatrice from January 13-18.
