

**TWO ARRESTED IN HUMBOLDT WARRANT SEARCH**

On September 11, 2020, Richardson County Deputies, with the assistance of the Brown County Kansas Sheriff's Office K-9 Unit, executed a search warrant at 819 4th Street in Humboldt. During the search, deputies located methamphetamine, suspected psilocybin mushrooms, marijuana, several types of drug paraphernalia, drug distribution materials and five firearms.

The following people were arrested at the scene on the following charges: Paige Gutzmer, Possession of Methamphetamine with Intent to Distribute within 1,000 Feet of a Playground a Class 1D Felony; Possession of Marijuana Less than one ounce an infraction; Possession of Drug Paraphernalia X 2 an infraction. Gary Wittrock, Possession of a Controlled Substance (Methamphetamine) a Class 4 Felony; Possession of Drug Paraphernalia an Infraction.

The investigation is on-going regarding the psilocybin mushrooms and firearms. Both subjects were booked into the Richardson County Jail. All subjects are innocent until proven guilty.

**FCPS EXTENDS FREE SUMMER FOOD PROGRAM**

Superintendent of Falls City Public School, Tim Heckenlively announced late last week that FCPS was notified by the Nebraska Department of Education that the U.S. Department of Agriculture (USDA) would extend the Summer Food Service Program through as late as December 31, 2020.

This will allow the school to serve free meals to all children into the fall months, or until available funding runs out.

FCPS initiated the Summer Food Service Program on Monday, September 14, and will credit the full pay and reduced student meal accounts retroactive to September 1, 2020.

Under current guidelines, this program will not be in place for the second semester.

If the funding runs out meals will revert back to full pay, reduced, or free as determined under current guidelines.

Eligible individuals are only students enrolled in and attending FCPS District 56 on those days when school is in session.

All families are encouraged to complete and turn in the free and reduced meal applications for the 2020-2021 school year.

**2020 RICHARDSON COUNTY FAIR, UNLIKE ANY YOU'VE SEEN BEFORE**

Unlike many other fairs around the country, the annual Richardson County Free Fair has decided to forge on through the current pandemic, but with some significant changes.

The September 19, "Our 2020 Vision," themed fair will begin

**NEW CITY BUDGET TO REQUIRE ONE PERCENT LESS IN PROPERTY TAXES**

During its Wed. Sept. 9 meeting, the Falls City's City Council voted 7-0 with Councilmember Amber Holle absent to approve a \$28,837,114 2020-21 City Budget that will require a tax levy of \$0.442747 per \$100 of assessed valuation, one percent less than that required for the 2019-2020 spending plan. That is a budget of \$2,892,554 less than the 2019-20 spending plan, a reduction of eight percent and will require \$712,594 in local property taxes, an increase of one percent, more than offset by an increase of more than two percent in property valuations. The only comment received during a public hearing on the spending plan was made by City Administrator Gary Jorn, who stated that a new regulation taking effect in November 2020 would require that the budget hearing be held at a date and time different from a regular city council meeting.

Following a brief discussion, the Council voted to open for public use the restrooms at Stanton Lake, Grandview Park, and Dallas Jones Park.

The Council approved by a 7-0 vote the appointment of Juan Ramirez and Kaleb Gilkerson to the Falls City Police Department. The two were administered the oath of office by Mayor Shawna Bindle. A story will be published on the two officers in an upcoming issue of the Falls City Journal.

Following a public hearing during which no public comment was received, the Council voted to approve the police

department's application for a \$59,837.50 USDA Rural Development Grant to fund the purchase of new patrol car cameras and officer cameras to replace outdated cameras Chief Duane Armbruster described as being near the end of their useful life.

During her public comments at the beginning of the meeting, Mayor Shawna Bindle thanked the 79 volunteers who serve on 17 city board and commissions and, in particular, two who are completing 34 years of service on the Board of Adjustments, Gary Nelson and Sandra Hartman, who she said would be receiving plaques of appreciation from the City. The Council approved her appointment of a long time, now retired, city employee Alan Romine to fill one of the vacancies.

A public hearing on an application for a Community Development Grant of \$445,000 requiring a \$100,000 match by the City and private property owners drew no public response and the Council voted 7-0 to authorize Mayor Bindle to submit the application. The grant is for sidewalk and curb and gutter improvements in the south portion of the downtown business district, along with facade improvements to buildings in that area.

No public comment was received on an application for a Community Development Block Grant application for \$305,000 to assist Falls City Foods in adding new cold storage equipment at its plant that will result in the hiring of 10 additional workers,

and the Mayor was authorized to submit that application.

Two Insurance bid proposals were approved as presented. A premium of \$190,358 was approved with Berkshire and Travelers Insurance Companies for property coverage, liability coverage, inland marine, automobile, workman's compensation, an umbrella policy, errors and omissions, airport ground operations, law enforcement, and crime. Also approved was a premium of \$122,205 for coverage by the Cincinnati Insurance for the Board of Public Works for property, liability, boiler & machinery, and an umbrella policy.

No action was taken on a bid of \$30,545 submitted by Ray Martin Mechanical Contractors of Omaha for installation of new air conditioning compressors, contactors, auxiliary switches, crankcase heaters, refrigerator oil, filter drivers, and inspection of the air conditioning condensing unit at Pritchard Auditorium. Councilman Derrick Leyden recommended the project to be submitted for competitive bidding and Councilmember Mitch Merz suggested the cost of equipment replacement be considered as well as repairs.

The Council reviewed, but no action was taken on recommendations from computer technology consultant Brad Griffin. Griffin recommended improvements to the City's document management system at a cost of approximately \$16,000, a centralized camera system and li-

**COVID CASES STILL RISING IN RICHARDSON COUNTY**

The Southeast District Health Department (SEDHD) report a new total of 48 cases in Richardson County as of Friday, September 11, 2020. Last week Richardson County showed a total of 40.

According to the Southeast District Health Department COVID-19 Dashboard, 55.5 per-

cent of cases by exposure are community; 36.8 percent are direct contact and 7.7 percent are travel.

Three point eight percent of cases are hospitalized and 96.2 are not hospitalized.

Confirmed cases by age group are .09 percent in the 0-9 age group; 16.4 percent in the 10-19 age group; 24.9 percent in the 20-29 age group; 11 percent in the 30-39 age group; 9.2 percent in the 40-49 age group; 18.3 percent in the 50-59 age group; 9.5 percent in the 60-69 age group; 5.1 percent in the 70-79 age group and 4.7 percent in the 80+ age group.

# GROWING OPPORTUNITIES FOR THE GOOD LIFE

America is known as the Land of Opportunity and nowhere is that more true than here in Nebraska. Even as we grapple with the challenge of the pandemic, we've been hard at work to create and attract great-paying jobs to the Good Life. These jobs help families send their kids to school, own their own home and car, or go on that family vacation. They make it appealing for young Nebraskans to stay in our state after graduation. These jobs also provide the dignity and enjoyment of rewarding work.

As we continue to return to a more normal life, businesses are creating great-paying jobs here in the Good Life. Last week, I attended the ribbon-cutting ceremony for Scoular's new Petsource facility in Seward. It's a great example of how value-added agriculture is growing Nebraska. The \$50-million facility is bringing about 100 jobs to Seward, and it will be sourced with Nebraska beef. So it's not only creating great job opportunities in manufacturing, but also increasing opportunities for our livestock producers.

Last month, I joined the groundbreaking for Vireo, a company investing in Plattsmouth to produce an immune support supplement. The project is projected to bring \$15 million of investment in Nebraska and will bring up to 200 new jobs to the area. It's one of the largest investments in the Plattsmouth area in recent memory and great news for Cass County.

These are just a couple of recent examples of jobs being created across the state as we get Nebraska growing. Throughout my administration, we've been focused on creating a climate favorable to job growth, and we're maintaining that focus as pandemic restrictions loosen. Our state routinely ranks atop lists of the best states in America for business. We're...least state debt (Moody's), labor force participation, and employment-to population ratio (Bureau of Labor Statistics) best regulatory environment (Forbes), lowest unemployment (Bureau of Labor Statistics) most new economic development projects per capita (Site Selection) children's economic well-being (Casey Foundation) lowest costs of doing business (CNBC) and most diverse economy (Bloomberg).

These strong rankings demonstrate that Nebraska is a great place for growth. Even so, no company invests in a generic place called Nebraska. They choose to do business with specific leaders whom they respect and trust. And they select communities where they've experienced friendliness and hospitality. From Seward to Sidney and everywhere in between, Nebraska has hundreds of welcoming, well-led communities that are experiencing growth.

In my time in office, we've built on four pillars to grow Nebraska: 1) developing our people, 2) being easy to do business with, 3) controlling spending to deliver tax relief, and 4) promoting Nebraska domestically and internationally. This four-part strategy has been very successful.

According to the most recent numbers from the Bureau of Labor Statistics, Nebraska has the second-lowest unemployment in the country at 4.8%. Our metro areas in Lincoln, Omaha, and Sioux City are all outperforming regional peers in providing employment. Each has an unemployment rate under 6%, which is significantly lower than in other Midwestern cities: Kansas City (7.6%), Denver (7.8%), Minneapolis (8.2%), and Chicago (12.0%).

Nebraska ranks number one in the nation in employment rate among adults (ages 16 and older). We're the only state where more than two-thirds of adults are actively working. Compared to the 67% of adults employed in Nebraska, only 52% of adults work in Arkansas and in New York.

While we're doing comparatively well, there are still many Nebraskans who have lost work or seen their business, farm, or ranch endure financial hardship. The State put \$85 million of the federal assistance we received from the Coronavirus Relief Act into critical services such as food security, shelter, and behavioral health care. We allocated \$330 million of additional funds to help businesses and livestock producers impacted by the pandemic. We also shored up our Unemployment Insurance Trust Fund to ensure our ability to provide benefits to Nebraskans who are out of work.

Last week, the Nebraska Department of Labor (NDOL) announced that the State is applying for Lost Wage Assistance Funds from the Federal Emergency Management Agency. This will allow NDOL to pay an additional \$300 in weekly unemployment benefits to Nebraskans whose livelihood has been affected by the coronavirus. Qualified claimants will receive the benefits for the weeks ending August 1st, August 8th, and August 15th.

NDOL's job centers are open to anyone, whether unemployed, underemployed, or simply looking to take the next career step. State teammates stand ready to connect Nebraskans to tens of thousands of employment openings. Additionally, NDOL partners with the Department of Health and Human Services to offer innovative reemployment services to Nebraskans who rely on food stamps. The program, SNAP Next Step, provides families with services such as writing a resume, preparing for interviews, and gaining job skills. On average, participants who complete SNAP Next Step increase their income by about \$1,700 a month or over \$20,000 per year! NO SPECIAL SESSION, BUT PLENTY TO DISCUSS NEXT YEAR

As predicted, there will be no special session of the Nebraska Legislature to introduce bills and set policies to address systemic racism.

At the urging of a number of social justice groups in the aftermath of demonstrations – some of them not so peaceful – in Lincoln and Omaha, a group of 11 urban lawmakers signed a petition for said special session. After Secretary of State Bob Evnen polled all 49 senators, only 14 said they wanted the session.

Proponents told a group of eight senators participating in listening sessions in the wake of the George Floyd death in Minneapolis that they didn't want to have to wait until next year. The senators and many of the rest of us sincerely believe the law needs to value every citizen so they know their life is respected, regardless of color, age, economic background or legal standing.

The 35 who said "no" to a special session had a variety of reasons for not returning to Lincoln. For some it's probably a belief that it's strictly an urban problem. Others might have been concerned about the coronavirus danger meter being in the orange in Lincoln, its highest mark since the pandemic began. Still others didn't want a repeat of the rancor that marred the end of the regular session last month. With a statewide election looming, some probably didn't want to give their opponents ammunition if they disagreed with the incumbent's comments.

I am NOT surprised that the session was a no-go. But six Democrats in the officially nonpartisan Unicameral have introduced study resolutions that could be the fodder for bills when lawmakers meet again in January. Such resolutions are designed to gather information on problems and look at solutions.

The recent death of Lincoln Police Detective Mario Herrera – the first active duty death of a Lincoln Police officer in 52 years – could change the debate. But it's quite possible that Omaha Sen. Justin Wayne's bill to create police standards boards in cities and villages with full-time police officers will be introduced again. The late entry died at the end of the 2020 session.

Wayne is promoting two of the six study resolutions. His LR146 would examine the feasibility of a prosecutor-transparency act to collect data and establish a process to report on city and county prosecutors. Such information would include numbers of people incarcerated and racial disparities that may exist.

As chairman of the Legislature's Urban Affairs Committee, Wayne is sponsoring LR374 to look at the history of redlining -- the practice of banks, mortgage lenders, Realtors and others restricting services to certain areas of a community, often based on race. The study would look at negative impacts of redlining on racial and socioeconomic segregation and the role of government in promoting the practice, as well as potential policy solutions to reverse the negative impacts.

Lincoln Sen. Patty Pansing Brooks' LR377 would consider reforming policing through inde-

pendent government oversight of law enforcement agencies requiring more transparency in matters of internal affairs, restraint tactics and staffing and hiring practices.

Lincoln Sen. Matt Hansen's LR417 would focus on policies on the use of force by law enforcement, including the components of the policies, national best practices and their use by agencies and barriers to adopting effective use-of-force policies.

Omaha Sens. Steve Lathrop and Sara Howard are sponsoring LR421 to study the racial and ethnic disproportionality in Nebraska's foster care and juvenile justice systems, specifically for those committed to the Youth Rehabilitation and Treatment Centers. The study would include an action plan for reducing those disparities with

input from Nebraska's four federally recognized Native tribes and others who have been affected.

Omaha Sen. Tony Vargas' LR449 would examine systemic and institutional racism in Nebraska and offer recommendations to make things equitable for those who are biracial, interracial and people of color.

That's quite a load of concepts on a single topic. I can see the results of several resolutions being combined to create some viable legislation. Let's hope that those who yearn for change can be patient while lawmakers, with a revived sense of purpose, work it out.

## Commissioners reject Roads Depart. Labor union contract proposal and vote to sell former Humboldt Legion building

Sept. 8 meeting the Richardson County Board of Supervisors reviewed the latest county proposal from the Road Department Union and responded with an ultimatum aimed at reaching agreement on a new union contract. The County Board rejected the union's latest proposal and informed the Union that the County's final offer presented to them on August 25, 2020 will be withdrawn if not accepted by the Union membership by close of business on September 15, 2020. The Union represents 15 roads department employees.

A motion was made by Commissioner Terry Frank that pursuant to NE State Statute 23-107.01 to set a date of sale for Tuesday, September 29, 2020 at 11:00 a.m. for a tax sale of the two story building and land on the west side of the town square in Humboldt that had previously been owned by Harvey Mann American Legion Post #269. The legal description of the property is the South one half (S1/2) of Lot Number Two (2), Block Number Six (6), City of Humboldt, Richardson County, Nebraska. The adjacent one story addition to that building continues to be listed by the County Assessor's website as owned by the Post and is not included in the tax sale. The motion was seconded by Sichel and approved by unanimous vote.

Highway Superintendent, Steve Darveau, Jr. met with the Board to update them on the routine maintenance being done this week on County roads and bridges.  
 Sheriff Hardesty and Roland Merwin, Chief Deputy Sheriff updated the Board on the routine business within the Law Enforcement Center this past week.

### WORKFORCE HOUSING IN RURAL NEBRASKA

As we work to continually improve the quality of living and the viability of our communities in our corner of Southeast Nebraska, a constant problem is the availability of housing for our workforce. To keep our rural communities thriving, we must have jobs. So, we work to recruit businesses. But businesses won't come if there aren't workers and workers won't come if there's not affordable housing.

As an 8-year member of the Nebraska Economic Development Commission and as a Nebraska Realtor for the past 30 years, I've seen this problem first hand. Just this past May, Nebraska had the lowest unemployment rate in the nation. That's great news, but it comes with a problem: Businesses need more workers in order to expand and grow their businesses. Because of our low unemployment rate, employers typically pay more and we have a better quality of life than our competitors in surrounding states, but we lack housing for a workforce. Lack of housing leads to a labor shortage which means communities are unable to land an employer with good paying jobs moving into their community or moving into an abandoned building in their town. We want workers living in our local communities, enrolling their children in our local schools and paying local taxes. We don't want them to have to commute because of a lack of local housing.

Our neighbors in Iowa, Missouri and Kansas are having similar housing issues and trying to be creative. Some are taking out millions in local bonds to fix rundown housing and spur local development as well as streamlining housing permits.

I commend the great work being done by the Rural Workforce Housing Fund, the Nebraska Affordable Housing Trust Fund and regional entities like the Southeast Nebraska Development District (SEDD) and Southeast Nebraska Community Action (SENCA). We need smart people working to tackle this ever-present problem.

The challenges are legion - availability of land for housing vs. important agriculture uses and corresponding land prices, federal HUD standards, a myriad of issues with short-term mobile housing, availability of adequate financing, as well as the number of older rural homes that are in need of extensive repair (most homes in Southeast Nebraska were built in the 1960's or earlier) - just to name a few of the knots that have to be untangled.

One significant new tool will be the ability of "Land Banks" for rural communities to help develop vacant and tax-delinquent properties. Land Banks help rural communities deal with blighted properties. But we must be constantly on the lookout for other tools as well - housing incentives, zoning laws, neighborhood revitalization efforts as well as engaging with businesses to help fund affordable housing initiatives. I look forward to being an advocate for workforce housing in Southeast Nebraska in the Legislature.

The same results ended with that boy never speaking to me again. I vowed that I'd never ride another carnival ride that spun me around and I've stuck to that promise. While their cute faces will never be able to sway me into riding anything that spins, I'll always climb the steps to go down the slide and drive them around in the bumper cars, no matter the consequences. We sit on a wood board that will always give us splinters as kids run across it shaking us as we try to balance our food on our laps. We see friends we haven't seen since the year before. I can always count on seeing my friend Jeff who I've known since I was a couple of years old and his growing family. I know that I'll get my chili served to me by Mr. Eickhoff, a man whose blood pressure I may have raised more than two hundred times in High School when he was the principal at Dawson-Verdon. I'll see my former next-door neighbor and longtime friend, Josh and his growing kids. The faces are always the same, faces of so many people I love and have known my entire life. After the parade, lunch and free-act, we'll all retreat for a few hours-usually to catch a Husker football game in the afternoon. Then we'll all meet up again for dinner, more chili and the free act. After that, we'll play bingo until they kick us out.

This year I don't know what to expect; it's a whole new ballgame. Brian and Alex will be staying home and I'll probably sneak in and cover the coronation for the paper and grab some food, but it won't be the same. Spending time walking around the square and riding bumper cars with the kiddos is another casualty of 2020. I asked my sister this past weekend if she thought her youngest would remember things like wearing a mask, now as I type this, I'm sad he's missing making the memories that Alex as of riding bumper cars with his older cousins, Hannah and Rex. Those are memories we talk about each year when we go to the fair. Each year matters, each year is unique and they pass by so quickly.

Here's hoping next year at this time we're all celebrating the success of Cobblestone and The Richardson County fair and you'll find me pouring gallons of chili down my mouth right before I take a spin on those bumper cars with Olive and Lucy; or a ride down that slide with Henry.

## Irish fall from ranks of unbeaten

On Friday night at Jug Brown Stadium, two Class D2 powerhouses met on the football field. Top-ranked, 2-0, Sacred Heart hosted the second-ranked BDS Eagles. Things looked to be going the Irish's way early, as the Eagles fumbled on the first offensive play, and Jake Froeschel of the Irish recovered at the BDS 20-yard line. Six plays later, Del Casteel took a sweep to the right, untouched for the four-yard TD run. The PAT run was no good, and the Irish led 6-0 with 9:40 to play in the first.

BDS came roaring back on its second drive. Facing a fourth and 11 at the Irish 20, the Eagles completed a 20-yard TD pass to tie the contest. The PAT run gave the Eagles an 8-6 lead with 7:56 to play in the opening quarter.

On the ensuing drive, the Irish fought right back. After an excellent kick return by Evan Keithley, the Irish covered the 33 yards in ten plays, ending with Casteel's second TD run of the game, an eight-yard pass from QB Jakob Jordan on fourth and goal. SH again failed to make the PAT and led 12-8 with 2:34 left in the first.

After a punt by BDS, the Irish took over at their 23-yard line. On second down, Jordan faked an option left and found Jack Fiegener under the sideline for the 52-yard TD strike to make it 18-8 with :23 left in the quarter.

With 4:46 remaining in the first half, Casteel capped off a seven-play, 45-yard drive, with a four-yard TD run to put the Irish up 24-8. SH was 0-4 in two-point conversion attempts in the first half.

A three and out by the Irish defense set the Irish up to close the door on the Eagles before the half. However, a fumbled punt was recovered by BDS and returned 31 yards for the TD to make it 24-14 with 3:07 to play in the half. The Eagles weren't done yet as they forced a three and out and got the ball back one last time before

the half. Momentum had shifted, and the Eagles were on the attack. With :23 remaining, BDS got on the board again, this time from four yards out. SH was clinging to a 24-20 lead at the half.

The third quarter began well for the Irish. Sacred Heart drove to the Eagle eight-yard line, but a fourth-down pass fell incomplete, and BDS took over on downs. BDS then took the ball down the field against the Irish defense, 72 yards in five plays to take the lead 28-24 with 5:34 to play in the third.

Punts on back to back drives by the Irish offense and scores by BDS on consecutive drives saw the Irish down 42-24 with 7:45 left in the game. Not out of it yet, Jordan found Fiegener on the next Irish drive for a 45-yard TD pass to give SH hope, trailing 42-30 with 7:24 to go. The excitement was short-lived, though, as BDS marched again down the field for one final score to make the final 50-30. After leading 24-8, the Irish were outscored 42-6 as they lost for the first time this season.

BDS outgained the Irish 289-156 on the ground, but the Irish finished with 177 yards passing to the Eagles 77. Casteel led the ground attack for SH with 62 yards on 19 carries and two TDs. Jordan completed 10-18 pass attempts for 177 yards and three scores. Fiegener caught four passes for 121 yards and two TDs. Defensively, Brogan Nachtigal was in on 12 stops, Casteel had 14, and Fiegener had 11.

"We didn't handle adversity very well vs. BDS," said Coach Doug Goltz. "After the fumbled punt recovery TD, we really struggled to be tough enough to win a game like this. When we had them on their heels, they fought back, and when they had us on our heels, we didn't fight back enough."

The Irish will hit the road this week to take on Mead on Friday, September 18. The Raiders enter the contest 0-3.

# Tigers bounce back with road win

Just as they did in their season-opening win, the Falls City Tiger football team played almost error-free football Friday night, September 11, in Malcolm, Ne. The Tigers had zero turnovers and disposed of the Clippers 30-6 to improve to 2-1 for the season. Falls City led 7-0 after the opening twelve minutes and increased their lead to 10-0 by the half. The Tigers took a 30-0 lead late in the game before Malcolm scored a late TD to finally get on the board.

The Tigers took the ball on their first drive of the contest and pounded the Clipper defense with run after run, covering 86 yards on nine plays. Drake Butler supplied the drive's big run, a 47-yard run that helped set up the Tiger's first TD. On second down at the Malcolm 19, Leighton Vice took the ball up the middle, breaking tackles on his way to the endzone. A Lukas Aldana kick gave FC a 7-0 lead with 3:32 to play in the first quarter. On the next drive, facing a second and ten at their 38, the Malcolm QB had his pass intercepted by Jace Heckenlively. Heckenlively returned the INT 36 yards to the Clipper 14-yard line. Facing a fourth down, FC called upon Aldana, who booted the 20-yard field goal to give FC a 10-0 lead with 11:15 to play in the first half.

On third and eight at the 46 on their next drive, the Malcolm QB was chased out of the pocket and threw a pass up for grabs. Rayce Farmer was in the right spot at the right time, catching the tipped ball for the second interception of the game for FC. The Tigers, unable to put a drive together, were forced to punt the ball away.

Malcolm attacked the Tiger defense, getting all the way down to the Tiger 10-yard line. Facing a fourth and four, the Clippers attempted a 20-yard FG right before the half. The kick was no good, and FC maintained a 10-0 lead at the half.

On their second possession of the third quarter, FC covered

65 yards in 13 plays, ending on a three-yard TD run by Butler. Using second and third effort, Butler put the Tigers ahead 17-0 with 3:17 to play in the third.

The Tiger defense stepped up on the next drive, forcing a turnover on downs, giving FC the ball back at their 45-yard line. Nine plays later, Vice scored his second TD of the game from four yards out to give FC a 23-0 lead with 9:21 to play in the game.

FC again flexed its defensive muscle, forcing another turnover on downs. The Tigers began the next drive at the Clipper 21-yard line. Six plays later, Vice followed his blockers to paydirt for the score. The Aldana kick made it 30-0 with 5:40 to play. Malcolm tacked on a late score to make the final score 30-6.

Each team had 48 offensive plays, with FC racking up 287 yards of offense, and Malcolm finished with 222 yards. FC finished with 267 yards rushing and converted 6-10 third-down opportunities.

Carson Simon was 1-3 passing for 20 yards. Butler rushed 13 times for 117 yards and a TD. Vice added 86 yards and three TDs on 15 attempts. Stephen Acton caught one pass for 20 yards.

Defensively, Jaden Nolte finished with eight stops, including a sack. Vice was in on nine tackles, Jaxyn Lunsford also had nine tackles, and Heckenlively added five stops and an interception.

"Louisville's coming in with a record of two and one as well," said Coach Fritz. "We will have to be extremely disciplined on the defensive side of the ball and maintain our run fits. Offensively, we need to be really aggressive and build upon the good night we had against Malcolm. Overall, we need to continue to play with great effort and focus on good fundamental football."

The Tigers will host Louisville on Friday, September 17, at 7:00 p.m. at Jug Brown Stadium for homecoming. Both teams enter the contest at 2-1.



-brary equipment updates at a cost of \$23,000, and updates to the City's wifi system at 10 different locations at the cost of \$4,000 for additional equipment. The Council approved a building permit requested by Bob Campbell for a 40 by 60-foot metal building to be erected on property he owns at 721 Fulton Street. Approved on second reading was an ordinance allowing issuance of a provisional dog license for puppies receiving obedience training of breeds not currently eligible for licensing as adults. The Council received but took no action on a report from Richard Newland, 1005 Harlan Street, on Harlan Street on intersections that were not upgraded to make them handicap-accessible when the state recently made

improvements to U.S. 73 in Falls City. And, the Council took action to authorize the destruction of outdated bank statements, utility records, time cards, and other miscellaneous records not requiring preservation. City Administrator Gary Jorn reported that Omaha Public Power District would be making power distribution system upgrades and would not be supplying power to the City Utility from Sept. 21 to Sept. 25. During that time, the City would be supplied by power from its own generators. Jorn reported the Aquatic Park was open for 61 days with an average daily attendance of 113 and a revenue of approximately \$10,000. He reported Chase Street's resurfacing scheduled for later this month might be

pushed back to next Spring due to delays caused by COVID-19. He reported the Electrical Utility has replaced 48 poles, the Gas Department has replaced eight blocks of main, the Street Department is patching east-west streets, the Building Inspector has measured the height of tree limbs above streets and provided residents door hangers describing trees requiring trimming, and the Park Department has painted Skate Park equipment, resurfaced Grandview Tennis Courts, and part-time summer employees have painted Lane Street light posts, swings and slides at Grandview Park, caulked seams and painted steps and the bridge at the Aquatic Park and the restroom at Dallas Jones Park.
