### Council passes insurance package

The City Council held a special meeting on Monday, September 23, 2024, in the Council Chambers at City Hall. The meeting was called for the board to address a discussion and action for a resolution authorizing the execution of documents required for the USDA Rural Development Assistance Grant and a discussion and action for insurance renewal for the fiscal year 2024/2025. Councilpersons Buckminster and Leyden were absent.

Only four percent of Scouts have earned the rank since the inception of the Eagle Scout award in 1911. Requirements for the award include earning a minimum of 21 merit badges, of which 14 are mandatory to receive the rank. The Scout must also complete an extensive project that the Scout plans, leads, organizes and manages.

Caudle, the son of Penelope and Christopher Caudle, began Cub Scouts in first or second grade. Around sixth grade, Cade entered Boy Scouts and has been working through the ranks ever since.

Back in the early days, Cade's

### Fall invading insects

Fall is my favorite season of the year. The weather is much more enjoyable, the trees turn fantastic colors, and football begins again. With all the fun of fall, however, comes the not so enjoyable entry of insects into our homes. Many household pests that we see most often in the fall coming into our homes for warmth and food are boxelder bugs, Asian multicolored ladybeetles, and spiders. Occasionally, we also find crickets, centipedes, millipedes, and some stink bugs.

Boxelder bugs are a common nuisance pest to enter homes in the fall and they are often seen leaving the home in the spring. These are the insects that are black with a reddish-orange X on their backs. They are a type of a true bug that is found feeding on many trees but they prefer boxelders, ash, and maples. Boxelder bugs will not cause any damage to your homes and they do not bite. The only problem with these insects being in your homes is that they can come in swarms.

Asian multicolored ladybeetles are a nuisance pest as well, that we often see in the fall. These are the ladybugs that we find in our homes in the fall. These ladybugs can bite and it can cause pain, but they don't cause any medical issues. The biggest problem with these ladybeetles is that they get in the house and are found all over your home. They are just trying to find a place to hide out for the winter.

Spiders are also problematic in the fall, especially wolf spiders. These are one of the largest species of spiders that we will find in Nebraska. They are quite hairy and often will have 2 white or lighter brown colored stripes down the back of the spider. There are some wolf spiders that can be the size of a half dollar or more, legs and all. These spiders are not venomous, but they can bite. Most often, wolf spiders don't bite us, but if they do the reaction is minor.

Most people are concerned with brown recluse spiders. They are about the size of a quarter, legs and all and are brown with a darker brown fiddle shape on their back. They can cause a bad reaction in some people, but not all people are as sensitive to the bites as others. If you have brown recluse spiders in your home or office, just take the time to look around things that have been stored before you move them. These spiders are reclusive, so they want to stay away from you.

Management: None of these pests are very damaging to us or our homes and they rarely warrant control by a pesticide. However, if you don't want them in your home there are things to do to reduce their population. Sticky traps are always a good choice, these will catch the insects and then they die. Be sure to place these where pets and children cannot get to them because they are extremely sticky. Home barrier sprays can be used around the foundation of your home and around doors and windows. Be sure to follow label instructions with any pesticide. If you see a few wandering around, use your vacuum to get rid of them. Be sure to empty the canister or switch out the bag often as they may not die when vacuumed. #### All things Nebraska Nebraska's 'blue dot' captures national headlines, lastminute push to erase it

By Paul Hammel, Retired Senior Reporter for Nebraska Examiner Nebraska doesn't get many national headlines about politics, but a recent, last-minute push by major Republicans to get the state to ditch its unique system of awarding electoral votes for president did just that.

Former President Donald Trump and leading GOP Sen. Lindsey Graham were among those applying the pressure recently to return to a "winner-take-all" system.

Only Nebraska and Maine don't give all of its electoral votes to the statewide winner of the popular vote for president.

Instead, Nebraska's five electoral votes are divided up - two for the overall winner, and one each to the top vote-getter in the state's three congressional districts.

It's been the system since 1992, as the result of a bill sponsored by State Sen. Di-Anna Schimek of Lincoln. She reasoned that local voters would have more of a voice in presidential elections if some electoral votes were awarded by congressional district.

Twice since then, the state's electoral votes have been divided - in 2020 President Joe Biden won a single electoral vote in Omaha's 2nd Congressional District, and in 2008 Barack Obama grabbed the blue dot on his way to becoming president.

Then, as now, the unique system brought more national publicity and campaigning to Nebraska, which would be a political fly-over state otherwise.

Heck, last week saw U.S. Rep. Mike Flood interviewed on CNN, and Jane Kleeb, the head of the Nebraska Democrats on MSNBC.

This year, the blue dot could decide what is expected to be a very close election.

Under one scenario, if Vice President Kamala Harris wins the so-called "blue wall" battleground states of Wisconsin, Michigan and Pennsylvania, and then Trump wins the tour southern battleground states of North Carolina, Georgia, Arizona and Nevada, Harris would have 269 electoral votes and Trump 268. It takes 270 to win, thus the race could come down to the blue dot of Nebraska. Hundreds of blue dot signs have sprung up in the Omaha area this year, punctuating the area's potential significance. Of course, Republicans would like to return to a winner-take-all system because Trump – and frankly any Republican – is a sure bet to win in bright-red Nebraska and then get all its electoral votes. (By the way, if there is a tie in the electoral college votes of 269-269, the choice of president falls to the newly elected members of the House of Representatives, with each state's contingent getting one vote. The U.S. Senate would choose the vice president.) This spring, despite some personal lobbying by Trump, according to a story in the Nebraska Examiner, the State Legislature didn't take up a bill to scrap the blue dot. There just weren't the 33 votes needed to fend off a filibuster and pass a bill to return to winner take all. Gov. Jim Pillen recognized that, and declined to call a special session to take up winner-take-all legislation. If you don't have the votes, holding a special session is a waste of time (as we saw, for the most part, with the special session this summer on property taxes). But Republicans mounted another effort to eliminate the blue dot recently, only about six weeks before the November election. The state's all-Republican congressional delegation urged state senators to scrap it so that Nebraska could 'speak with a united voice in presidential elections." Graham visited the state and met with Pillen and a group



of GOP state senators. And Trump got on the phone to Nebraska once again.

But after the 11th hour push, Pillen admitted that 33 votes are still lacking.

Omaha State Sen. Mike McDonnell, who switched parties earlier this year from Democrat to Republican, was viewed as possibly ready to flip his vote on winner-takeall from "no" to "yes."

But McDonnell, who wants to run for mayor in Omaha, confirmed recently that he remains opposed to switching.

Allowing the blue dot in Omaha, he said, "brings tremendous national attention, is impactful on our local economy and forces Presidential candidates to make their case to all Nebraskans, instead of just flying over and disregarding us.'

It's hard to argue with that. Yes, the blue dot might decide this year's presidential race.

But wouldn't we Nebraskans feel better if some level-headed Cornhuskers helped decide who sits in the White House rather than sitting on the sidelines and letting others decide?

#### 75 Years Ago, October 2, 1949 to October 8, 1949

A strike of 514,000 CIO steel workers for welfare benefits cut 95% of the nation's steel production. Government mediators admitted they had little hope that a settlement could be reached soon.

Nearly 450 Missouri Pacific employees living in or working out of Falls City received their last paycheck. The checks issued were for the first nine days of September before the strike began.

The Tiger football team had scoring drives of 70, 45, 53 and 57 yards as they steamrolled Pawnee City 27-0. FC ended the contest with 312 yards of offense from scrimmage.

Coach Jug Brown's Sacred Heart Irish defeated Verdon 14-0 in six-man football action. Chico Marx scored both touchdowns for the Irish.

According to weather observer Miss Kate Kloepfel, Falls City received just 2.22 inches of rain in September, below the average of 4.69 inches for the month.

A small son of Mrs. Fern Rowell of Rulo fainted in front of the Oil City Theater and later told persons at the doctor's office that the sight of blood in the movie had made him sick.

Henry Majerus of Rulo sold 30 hogs, averaging 220 pounds, in St. Joseph for \$19.75 per hundredweight.

A tropical hurricane struck Galveston and Houston, driving 50,000 people from their homes. The storm hit near Freeport, west of Galveston, around midnight, then roared towards Houston.

Father Lawrence Obrist of Lincoln was the new pastor at Sts. Peter and Paul Catholic Church. Obrist filled the position after the death of Father Joseph Murphy.

A partial solution to the infamous Stone Street snarls was undertaken by the city council when they purchased four traffic lights to be installed at the intersection at 17th and Stone.

Glenn, Roberts & Philpot, an accounting firm, took Ernie Prosser in as a fourth partner in the business.

Officials announced the fourth infantile paralysis victim of the year in Richardson County. The victim was 13 years old and lived in the Humboldt area.

Warden William E. Snyder announced that the inmates at Sing Sing prison in New York would be allowed to hear an amplified broadcast of the World Series involving the New York Yankees and the Brooklyn Dodgers.

Nebraska Attorney General James Anderson approved a petition calling for a popular vote on repealing Nebraska's prohibition on gambling. To force a vote, 47,634 voters would need to sign the petition by July 6, 1950.

Seventeen "green hands" were initiated into the Falls City chapter of the Future Farmers of America. New members included Leonard Crawley, Charles Ebel, Darrell Eickhoff, Vernal Faller, Raymond Finck, Dale Huettner, Leon Keithley, John Knobbe, Billy Miller, Gerald Nolte, Edward O'Grady, Billy Portrey, Richard Reschke, Max Rolland, Dallas Runyan, Clarence Scott and Edwin Vollmer.

#### 50 Years Ago, October 2, 1974 to October 8, 1974

Soybean harvest was underway in Richardson County. An estimated 80,000 acres of soybeans were planted in the county in 1974.

George Brett, a rosy-cheeked rookie for Kansas City, was batting .289 with 129 hits, 20 doubles, five triples and two home runs since his call-up on May 3.

The Sacred Heart reserve football team down Humboldt 28-0 in action on the gridiron. Dan Hill scored two rushing TDs, Scott Kreifels caught a TD pass from Bob Aitken, and Mike Sells had a pick six to complete the scoring for the Irish.

Caudle said it was tough finding where people have been buried over the years but was hopeful people would come forward and contact them if they know Eagle Scouts from Richardson County who have passed away.

Through his rigorous research, Cade was able to find six former Eagle Scouts who were buried in the area. He secured ten metal plaques on stakes to be placed at their gravesites. He raised the money for the plaques through donations and delivered one to the John Falter Museum because John Falter, a former Eagle Scout, does not have a burial site.

"The Tuesday before Memorial weekend, we'll go out and place flags for the veterans as a Boy Scout Troop," said Caudle. "We figured we would put them out there, and they would be up for the weekend. If the family asks, we would prob-

ably give it to them and they can put it out."

With any luck, Caudle hopes to have his achievement in hand by next year. He's done the hard part, now he just needs to fill out the paperwork.

Caudle is one of many, including his brother Brock, who is working towards the honor.

"It shows that you can do something, you can actually help your community. The Eagle Scout project shows that a lot," said Caudle when asked about the importance of scouting.

He ended the conversation by stating he could not have done it alone.

"My mom and dad helped me a lot through this," said Cade. "And Dave (Young) and Bill (Harkendorff) helped me a lot. The whole Troop and parents helped; they keep pushing you through."

He also thanked all the individuals and businesses that donated towards his Eagle Scout project,

used to purchase router equipment and a firewall for the Falls City Police Department. The resolution passed 6-0. The insurance renewal packet for 2024-2025 was approved.

The Council voted in favor of the League Association of Risk Management's (LARM) quote of \$267,953 per year to cover the government side. The Council agreed to a three-year commitment with LARM, which gives the City a 5% discount. The Council also voted in favor of a bid from Cincinnati Insurance for \$317,769 to cover the Public Works side. The two packages total \$585,722.

# Commissioners agree on contract with EagleView for flyovers in 2024, 2026 and 2028

The Richardson County Board of Commissioners met for its regular meeting on Wednesday, September 25, 2024. Roll call was answered by Commissioners Sickel, Karas and Caverzagie.

Highway Superintendent Steve Darveau, Jr., updated the Board on road and bridge maintenance being done. Darveau advised the Board that he would have quotes for a new semi the following week. Darveau said he was soliciting bids for a Western Star semi and a Mack. Darveau stated the trucks are nearly identical, with 505 horsepower and automatic transmissions. He also informed the Commissioners that

he had ran the "Road Groomer" on county roads after the recent rains and was able to cover nearly 21 miles.

Darveau stated multiple farmers stopped and asked questions and were pleased with the results.

"I got several phone calls, texts and compliments on the 21 miles that I did run," said Darveau.

Darveau said that with the added moisture, the equipment worked much better. The Board also acknowledged a thank you note from Vicki Jacobitz for the grading and rock on the roads near their properties.

County Jail Supervisor Kristen Morehead met

with the Commissioners and presented a purchase order for a medical cart and restraint chair. Sickel made a motion to approve the purchase of the restraint chair from Safety Restraint Chair, Inc. of Omaha for \$2,900.00. Caverzagie seconded the motion, and it passed. Caverzagie made a motion to approve the purchase of a medical cart for \$4,122.06 from Universal Medical of Oldsmar, FL. The medical cart will have a keypad entry system, allowing each worker to have an individual code so each transaction can be tracked and logged more proficiently.

"Anytime somebody gets in it, we can check the code individually and see who accessed it and who gave this med to this person. It's more of a safety and security," said Morehead.

The Board also reported that the notice was received from Falls City that the Memorandum of Understanding from July 8, 2024, was terminated due to an action at a Council meeting on August 14, 2024. The notice included a revised call procedures document that outlines how dispatching law enforcement personnel for the Richardson County Sheriff's Department will be handled moving forward with 911 calls outside the city limits of Falls City. The revised procedures ensure that EMD-certified (Emergency Medical Dispatch) telecommunicators are available to assess 911 calls in their entirety and respond accordingleView to provide services for 2025 through 2030 at \$39,972.20 per year. The Commissioners voted to terminate the current contract with Pictometry International Corporation, dba EagleView and enter into a Master Service Agreement with Pictometry International Corp., dba EagleView for the years 2025 through 2029. Ryan Poot with EagleView advised the Board that now they will capture overhead images every other year instead of every three years.


According to EagleView, they provide sharp, current images of the county, using topdown and side-angle imagery combined with accurate property data, allowing the county to plan wisely and manage critical programs and infrastructure.

EMA Director Brian Kirkendall asked the Board for approval to advertise the sale of a cell phone that was deemed surplus. Sickel made a motion to approve the advertisement on social media, Caverzagie seconded it and the motion carried. A motion was made by Commissioner Karas and seconded by Sickel to approve a sub-division for Janet Warrick McMullen, Trustee of Janet Warrick McMullen Trust, located in S16, T3, R15 and to adopt Resolution 2024-2025-15. The motion carried.

Commissioner Caverzagie made a motion to enter into an interlocal agreement with Nemaha Natural Resources District and Johnson, Nemaha, Otoe and Pawnee Counties to match funds for a grant received by the NRD from FEMA for updating the All-Hazards Multi-Jurisdictional Mitigation Plan for Southeast Nebraska. The cost to Richardson County is \$7,717.00. Karas seconded, and the motion carried. A quote was also received from El Camino Electric to complete the installation of light poles around the Courthouse and to repair the existing outdoor lighting. The Board plans to advertise for sealed bids to comply with the County Purchasing Act. A motion was made by Sickel and seconded by Karas to pay all claims that were submitted. The motion carried. With no further items on the agenda, Commissioner Caverzagie made a motion to adjourn the meeting at 10:49 a.m.

## Menopause

By: Kelly Evans Hullinger MD Menopause is one of those things that, let's face it, will ultimately affect everyone with previously functional ovaries. Unfortunately we don't talk about it enough, which makes it a topic riddled with misinformation. So... what is menopause?



Menopause is defined by the permanent cessation of menstrual bleeding for 12 months. This occurs naturally when the ovaries stop reproductive activity and a marked decrease in ovarian hormones (estrogen and progesterone) occurs. Symptoms of menopause are a result of these hormonal changes.

Most women enter menopause "naturally," or just due to aging. The average age of menopause in North America is 51 years, but that can vary by up to 8-10 years on either side. However, menopause can also occur when the ovaries are surgically removed or if a patient needs to take a medication that affects ovarian hormone secretion, for example certain therapies for breast cancer. Perimenopause refers to the phase, often lasting 1-2 years, before complete cessation of menses in which a person is likely to experience irregularities in menstrual periods (shorter or longer intervals, lighter or heavier bleeding) and sometimes the start of menopausal symptoms like hot flushes. Some patients will experience problematic or heavy perimenopausal bleeding that warrants medical or surgical treatment.

It is worth noting that laboratory testing is not recommended to diagnose menopause in a patient of typical age range with expected menopausal symptoms. In some cases, especially if a patient is younger than expected, limited testing is warranted to rule out other conditions including pregnancy and thyroid disorders.

Some fortunate women experience no significant symptoms of menopause, but the majority will. The most common symptoms of menopause are the infamous vasomotor symptoms (hot flashes and night sweats) and urogenital symptoms (vaginal dryness and sexual dysfunction). The average duration of vasomotor symptoms after menopause is about 7 years, but approximately 10% of women have symptoms lasting more than 10 years.

Decisions around various options for treatment for these symptoms is highly individualized and depends on how symptoms are affecting a given patient's quality of life. Treatment, if warranted, can involve hormonal therapy (replacing estrogen is the most effective way to reduce hot flashes) or various non-hormonal options. This choice necessitates a conversation about an individual's symptom severity and that patient's risk of hormonal therapy, including breast cancer, blood clots, and cardiovascular events.

In summary, menopause is indeed a part of life. field.



The Stalder Gallery inside the Falls City Library and Arts Center will host an exhibition of Native American art by members of the Iowa Tribe of Kansas and Nebraska. Sponsored by the Richardson County Arts and Humanities Council, the exhibit will open on October 11 and will be available for public viewing until November 20 during the hours that the library is open. The art on display includes items of historical significance as well as contemporary paintings and sculpture by member of the Iowa tribe.

A reception in the gallery at 2 pm on Sunday, October 20, will feature a presentation by tribal members to address the nearly forgotten history of the Native Americans in the this area, including how the group of indigenous people who gave the state of Iowa its name now instead has Kansas and Nebraska in its legal identification.

To accompany the art exhibit, there will be a screening of Fourth Wall Films' award-winning documentary Lost Nation: The Ioway in the Stalder Gallery at 5 pm on Friday, October 18. This film further explores the tumultuous history of the Iowa tribe, including how an 1870's disagreement between two brothers regarding the assimilation of Natives into white culture led to a troubling split in the native group and resulted in a separate Iowa tribe in what is now Oklahoma.

The Arts and Humanities Council is proud to be making this display of indigenous art and history available to the people of Richardson County and the surrounding area. The exhibit is made possible through the cooperation of the Iowa Tribe of Kansas and Nebraska, and the loan of art from the Iowa and Sac & Fox Mission Museum of Highland Kansas, which is located in the former Presbyterian Mission boarding school which housed native children between 1845 and 1863.
