## Two likely killed by fellow inmates during riot

A prison riot at the Tecumseh State Correctional Institution Sunday afternoon left two inmates dead and two others hospitalized.

At approximately 2:30 p.m. Sunday, May 10, staff members of the prison noticed a large gathering in the yard of the prison, in front of a housing unit. As members of the staff reported to the area in hopes of breaking up the gathering, two staff members were assaulted and one inmate was injured. Other incidents followed, resulting in heavy damage to the property, as well as several fires, including a bonfire made of plastic furniture.

As the sun set late Sunday evening, smoke continued to rise from the northwest corner of the prison, creating a hazy dome that covered the grounds. The Johnson County Sheriff's Department blocked the entrance to the prison, as well as a gravel road running west along the north edge of the prison grounds. It would be another four hours before

staff would gain control of the facility, according to State Corrections Director Scott Frakes, who was recently appointed in January.

In a press release, Corrections Spokesman James Foster said the next-of-kin have been notified regarding the deaths of the two 46-year-old inmates, Donald Peacock and Shon Collins. The Nebraska State Patrol is currently

investigating the deaths. Official cause of death has not been released, though sources inside the prison said authorities believe they were killed by other inmates.

Both men were serving lengthy sentences for sexual assaults on children. Peacock was one year into a 40- to 50-year term from Dodge County for 1st degree sexual assault on a child and visual depiction of sexually explicit content. Collins was nearly five years into a 66- to 80-year term from Box Butte County for 1st degree sexual assault of a child and visual depiction of sexually explicit content.

During the three and a half minute press conference Franks said a third inmate was shot in the leg by a tower guard, and a rubber projectile injured a fourth.

"We wanted to ensure we didn't have staff injuries, so it was necessary, and there were pockets of

## SADD brings scare tactics to FC High

Falls City High School students were either enjoying a serene lunch under the sunny spring sky in Jug Brown Stadium or publicly demonstrating their disapproval of an ousted educator last Tuesday when all hell broke loose in the parking lot.

Students certainly had something to say to their superiors regarding the dismissal of long-time educator Roger Windle, but were simultaneously the unwitting target audience of an important message themselves, delivered dramatically with shocking visuals. Students Against Destructive Decisions, or SADD, conducted a mock crash simulation in an effort to illustrate the dangers of impaired driving and

drove that message home with chilling detail. Police, fire and rescue, accompanied by wailing sirens, were on the scene as blood-stained driver Libby Bauman was given a sobriety test and hauled away in handcuffs. Injured students Haley Liberty and Chessanie Blakley were the lucky ones, removed from the mangled cars, placed on gurneys and treated in the ambulance. For the not-so fortunate, the coroner was there, black body bags in tow. Luke Gifford was dead, so he couldn't speak, of course; police had to break the news to his mother, Katy, who would now wait forever for her son to come home.

SADD, acting in concert with FCHS administrators, faculty, students and parents, the FC

## Speaker Galen Hadley proposes scheduling system in home stretch

Good for you, Speaker of the Legislature Galen Hadley.

The Senator from Kearney has announced that he'll alter the daily schedule for lawmakers in the waning days of the 2015 session in an effort to avoid late night debate. It's a unique approach given the number of big-ticket items left for discussion before the June 5 adjournment. But it just might work.

Gone will be the 90-minute lunch breaks that are prime time for lobbyists and special interest groups to entertain, feed and try to persuade senators. Some have chartered buses to take large numbers of senators to lunch. Omaha Senator Ernie Chambers, who never participates in that activity, chides his colleagues saying they "have been taken to the trough" by the lobbyists.

Are the long lunch breaks helpful? Do senators need the time to rejuvenate? Or do they just break the momentum of the day's activity?

The Capitol has no active cafeteria anymore. Senators either have to bring their lunches or go out to eat. Hadley says there will be food served at the Capitol to facilitate the shorter lunch break. In the past, lobbyists have often paid for dinner to be catered to the Senator's Lounge to accommodate lawmakers working through the dinner hour.

But even that act caused the daily sessions to often linger to a 10 p.m. or later adjournment. Depending on the topic of debate, those late hours used to lose senators to card games or televised sporting events. They wouldn't check out or leave the building and would be "on call" if votes were needed. The Sergeants-at-Arms were pretty astute at knowing which lounge or offices were hosting said activity.


It's hard to say how much attention is being paid to a bill by a senator who is counting cards or cheering baskets. Does that affect their vote? I think so.

Hadley told The Associated Press he thinks "people run out of gas when we go late." He added that he is "always suspicious of the quality of legislation passed at 10 or 11 at night."

So what's so important on the agenda? The budget has to be passed by Day 80. That's the top priority at this point. But there are plenty of others: legalization of medical marijuana; repeal of the death penalty; driver's licenses for the children of undocumented aliens; a 6-cent increase in the fuel tax over the next four years; freezing the minimum wage at \$8 an hour for high school students; protections for gay and lesbian employees; changes in the Department of Corrections that deal with mandatory minimum sentences and the use of solitary confinement; and many others.

Remember that Hadley has promised that every priority bill

that has advanced from committee to the first round of debate will be heard. Each senator designates one bill, committees get two each and the Speaker has 25. That's a lot of talk ahead in a limited number of hours.



Hadley and the 104th Legislature are also honoring a final adjournment tradition popularized during the speakership of former Senator

Mike Flood of Norfolk by postponing sine die for one week after the final day of debate. That means that Day 89 of the 90-day session will be May 29. The final day will be June 5 and senators will focus on overriding gubernatorial vetoes, if any, from bills passed the last week of May.

In the past, bills passed on those last days could be vetoed after final adjournment and the Legislature would have no recourse.

Good for you 104th Legislature First Session. Let's hope things work out for the benefit of all Nebraskans.

**SCC needs to focus more attention on southeast corner of Nebraska**

Residents of Southeast Nebraska:

Southeast Community College is in the process of developing its 2015-2019 Strategic Plan. As a part of this process, the College has been seeking community input from all 15 counties within SCC's service area. Our EDGE "Tri-State Labor Basin Study Committee" has urged SCC to develop an Outreach Program to improve its delivery of workforce training to residents of the southeast corner of the district. However, we need letters from persons like you...students, parents, workers, employers, educators, public officials, school boards, city councils, and county governments and organizations ... to demonstrate the need for such an Outreach Program.

Our committee has found a need for development of community-based education to provide the skills required of its workforce by many of our local employers. SCC campuses are located 70, 90, and 120 miles from Falls City and 50, 70, and 90 miles from Auburn making it impractical for those already employed to commute to classes. Many of those who become enrolled as full-time students at these and other campuses never return to the local area following completion of their programs resulting in a net outmigration of good trained workers from our communities. Recently, of the 1,770 who graduated from SCC, only eight took jobs in Richardson County, nine in Nemaha County, five in Johnson County, and one in Pawnee County.

We have a number of manufacturers in the southeast-most counties in Nebraska, including some who desire to expand, who continue to need good, trained workers despite offering attractive wage and benefit packages. Healthcare professionals wishing to upgrade their skills find it difficult to do so without giving up their present employment and being away from their families for extended periods of time to take classes and clinical practicums far removed from their homes.

These are not problems without solutions. Training in the needed work skills are already offered by SCC which receives \$2.8 million in property taxes from the four counties in Southeast Nebraska. It is time for the College to shift its course from centralization of all its resources in the north and western parts of the District to add community-based Outreach Programs at one or more centers within easy commuting distance of students from rural communities like our own.

You don't have to look far to discover how other states are using education as a means to build rural economies. Highland Community College, Highland, KS, just 32 short miles from Falls City, has enrollment centers offering classes, besides at Highland, at Atchison, Baileyville, Holton, Perry and Wamego.

**Animal Clinic Thursday evening**

The Falls City Fire and Police Departments will come together to provide the Animal Clinic from 6-7 p.m. Thursday, May 14, at the fire station, 1820 Towle St.

The clinic allows residents to get their animals' shots and licenses both at the same location. Animal Health Center staff members will give shots and FCPD staff will issue licenses.

City ordinance requires all dogs and cats within city limits and six months of age or older be licensed. Male and spayed female licenses are \$6 and unspayed females, \$11. Delinquent licenses (they expire in May of each year) double in price. Owners must present a current rabies vaccination certificate. The cost for the rabies vaccination is \$15 and the animal must be five months of age. Other vaccinations may also be available.

For owners of American Pit Bull Terrier, American Staffordshire Terrier, Staffordshire Bull Terrier, Rottweiler, Bull Mastiff, Cane Corso, Canis Panthers, Presna Canario, or any mix of these breeds, must present written documentation the animal has been spayed or neutered when applying for a license.

You must currently carry a minimum of \$100,000 in liability insurance with premium payment sufficient to cover a minimum of one year of coverage.

inmates in a variety of locations, and so, we needed to move very thoughtfully, methodically and carefully. We didn't know if the inmates may have acquired weapons during this time. In some cases they had destroyed or covered the cameras, so we didn't have any good sense on what was on the other side of the door until we opened it, so that it was contributed to the time frames," Frakes said.

Corrections spokesman James Foster said that two of the prison's general population housing units were involved in the riot. He said the death row unit was not involved.

Two to three housing units sustained smoke and water damage, as well as broken cameras and windows. Because of the damage to the housing units, prisoners who were kept outside set plastic chairs on fire as it got cold throughout the night.

The Lincoln Journal Star reported receiving a phone call from inmate Jeffrey Frank just before 11 p.m.

"We've pretty much taken the whole prison," Frank said. "The ceilings are fallen. There's dry-wall on fire. There's cameras torn down."

In his phone call to the Journal Star, Frank said no prison employees were in the housing unit.

"I'm looking out a window; there are maybe 60 or 70 blue suits in riot gear and automatic weapons. Maybe National Guard. Some are wearing camo."

Tecumseh prison public information officer Jessica Houseman said Sunday that one inmate was shot on the yard early in the altercation and the other in the evening.

Frank said three, not two, inmates were shot from a prison guard tower. "There was a lot of blood," he said.

As of Monday afternoon, the prison was reportedly under the control of staff, though Frakes described the environment as "tense."

"It is still in the what-do-we-need-to-take-care-of-next phase," Frakes said, emphasizing the prison's response to the riot will be examined, but he is satisfied with the current status.

"I'm very happy that no staff were injured in retaking the facility and restoring order. I'm happy that there was one injury to an offender that was a result of a use of force and that offender charged at staff, so they took appropriate action and the offender is okay. From that perspective, I'm very pleased," he said.

The riot comes only days after Omaha's KETV news reported the turnover rate at Tecumseh jumped from 22 percent in 2010 to 39 percent last year.

Rowan, of Falls City, is the first ordained priest to graduate from Sacred Heart School since Fr. Thomas McGuire in 1981, but he's the first Falls City native since Fr. Nicholas Baker in 1963. Fr. Baker is officially retired, but still active at St. Joseph Parish in Alma. Fr. McGuire is Resident Priest at St. Joseph Catholic Church and School in Beatrice and is also Assistant Spiritual Advisor for the Lincoln Diocesan Council of Catholic Women.

Two more recent FC Sacred Heart graduates - Robert Froeschl and Lane Barnhill - are current seminarians at St. Gregory the Great Seminary at Seward.

After studying philosophy and political science at Northwest Missouri State University in Maryville, MO, for four years, Rev. Rowan said he, too, "felt God's calling in that direction" and headed for St. Gregory the Great.

"There were times in high school and at Maryville when I thought about it," the 28-year-old said.

"And there were a few times in the seminary when I thought maybe it wasn't the right thing for me to do. But there are going to be bad days with anything you do. I realized it was the only way I was going to have peace in my life - peace with God," Rev. Rowan said.

After two years in Seward, he moved to St. Charles Seminary in Philadelphia, where he spent the past four years.

"That was a big change, coming from Falls City," he said. "There are a lot more people in Philadelphia," he joked. "But overall it was a great experience."

Rev. Rowan returned to Nebraska last week and upon his ordination will be assigned to serve as an assistant priest and teach at one of the six high schools of the Lincoln Diocese (David City Aquinas, Wahoo Bishop Neumann, Hastings St. Cecilia, Lincoln Pius X, Ne-

braska City Lourdes Central and, of course, Sacred Heart). Make that five: Rowan said the chances of his assignment being in Falls City are slim to none.

Rev. Rowan's ordination to priest puts him in the most elite company. Though the Catholic population has nearly doubled the past 45 years to include some 1.2 billion people worldwide, the number of Catholic priests in the United States has dropped some 33 percent, to fewer than 40,000, since 1981. Six or seven Catholic priests are ordained each year per million practicing Catholics.

"We're doing OK in the Lincoln Diocese," Rev. Rowan said, noting there will be eight ordinations on the 23<sup>rd</sup> for 95,000 members of the Diocese.

"But on the east coast, there are seven being ordained for 1 1/2 million people."

Rev. Rowan studied with 130 or so seminarians in Philadelphia and is one of 16 graduating this spring.

The ordination will be at 11 a.m. Saturday, May 23, at the Cathedral of the Risen Christ, which is located at 3500 Sheridan Blvd., in Lincoln. He will offer a Mass of Thanksgiving at Sts. Peter and Paul Catholic Church at 4 p.m. Sunday, May 24.

**Lack of commodities, funds jeopardizes free summer lunch program**

The Free Summer Lunch Program, will begin its 11<sup>th</sup> year in Falls City on June 1. This program is designed to give children ages 2-18 a nutritious lunch every weekday during June and July.

It is partially funded by the U.S. Dept. of Ag, with that funding and oversight administered by the State Board of Education under their Summer Food Service Program.

The Falls City Area Ministerial Association sponsors the program, using St. Paul's Evangelical Lutheran Church, 20<sup>th</sup> & Towle Sts., as the meal site. Meals are served from noon until 12:45 p.m.

The lunches served by the Falls City program are not "brown bag" meals, but meals which usually consist of a hot entrée balanced by fruits and vegetables and served on a plate. The program is one of the few in the state which is not operated by a school system or similar entity. The meals at St. Paul's site are planned and prepared with variety and with an eye towards serving healthy items that would be possible for children to choose anywhere.

The program is mostly staffed by volunteers from the community with a paid site manager and head cook to organize and supervise meal preparation and provide leadership in designing educational activities that promote healthy eating and lifestyles for the children who attend. Site Director Cathy Judd, who is beginning her third year, "does an excellent job of doing this, and makes these activities for the children fun and interesting as well," Fr. Larry Parrish, on behalf of the Ministerial Association, said.

"Last summer, we served a record 1,455 meals and want to meet or exceed that this summer."

That said, the program needs the help of the community to survive.

Each year it takes approximately \$5,000 more than the government funds we receive to maintain this program in Falls City at its traditional standards," Fr. Parrish said.

"In the past we have had grants, or money left over from grants, to make up this shortfall, but we do not have any grant money this year," he said. "In addition, we have been informed that we will be receiving almost no commodities this year. We are appealing to the churches, businesses and citizens of our area to help us have another successful year providing free lunches to the children of our community during the coming summer. We have already received a number of gener-

ous donations from organizations, churches, and individuals in our community, but we are still about \$2,000 short."

The free lunch program needs help preparing or serving meals, and assisting in other ways during the meal time. A volunteer for meal preparation will serve for two or three hours, most jobs take an hour or less and volunteers choose their days. Many help one day a week. A one-hour orientation is required for all volunteers and those dates are Wednesday, May 13 and Monday, May 18, both at 6 p.m. Volunteers can be 7<sup>th</sup> graders or up.

"We haven't had any centenarians as volunteers, but we have had at least one octogenarian!," Fr. Parrish said.

For more info, call the St. Paul's office at 402-245-3828 on weekday mornings.

"Please get the word out to those families who could make use of this excellent program. There is no cost or eligibility requirements, though pre-school children need to be accompanied by an adult," he said.



## Mock Crash

Police Dept., the Nebraska State Patrol and the FC Volunteer Ambulance and Fire Squads, combined efforts to create a successful and emotional dramatization of the potential consequences of impaired driving.

The demonstration is divided into two distinct segments: 1) the crash and rescue and 2) comments from the people who performed the emergency services.

Student volunteers were crucial to getting the message across last week at FC High School.

"Students either take it as a huge joke or it has an impact on them," FC Volunteer Ambulance Treasurer and Fundraising & Awareness Committee Chair Rachel Aitken said.

"These students went all out with it and did a great job.

"If it impacts one person, it was worth it," Aitken said.

Someone was obviously impacted by what transpired at FCHS last week. Friday afternoon, School Supt. Tim Heckenlively announced that Windle would return to his teaching position for the 2015-16 school year.

Windle has been on administrative leave for the last couple weeks for a disciplinary incident involving a student on April 21. A video of the incident was taken from another student's phone and that video eventually made it's way to Heckenlively's desk.

Windle's release - which was presumed by many to extend beyond the current school year - caused a firestorm among a large and loud contingent of the student body. Tuesday, well more than 100 students dressed in "Team Windle" T-Shirts in protest of the teacher's suspension. Students created two different Facebook pages, one of which, a petition to "bring Windle back," received about 1,100 "Likes." The students' reaction caught the attention of state media organizations and WOWT 6 News out of Omaha filmed a segment Wednesday for its nightly news. Additionally, many students voiced plans to attend Monday's regular meeting of the Falls City District 56 School Board.

Windle said he is "appreciative of the support shown by the administration, specifically Heckenlively and Principal Gale Dunkhas, as well as the community, parents and students since April 21."


Windle "has reached an agreement to resolve the issues related to the incident with the administration," the statement from Heckenlively reads. "The agreement enables Mr. Windle to focus on improvement of skills in areas deemed appropriate by the administration. As part of such agreement, Windle, will remain on administrative leave the remainder of the school year."

"The school district, administration and Roger and his wife, Susan, are all looking forward to continuing to provide Falls City students with the best education possible," Heckenlively said.

Windle was the Tiger Head Wrestling Coach for 20 years, but in April 2013 was not asked to coach a 21st season. After just one season away, however, Coach Windle returned to assist new coach Nick Kraft last winter.



# 'We were just doing things the Sacred Heart way'

"We were just doing things the Sacred Heart way," Doug Goltz, principal at Falls City Sacred Heart, said in a recent interview.

Goltz, who also serves as the head coach of the football and boys' basketball programs, had just received an official certificate recognizing the school as a nominee for the Spirit of Sport award, sponsored by the National Federation of State High School Associations. He and the school had been nominated for the award by Ken Swanson, athletic director and head football coach at Emerson-Hubbard schools. The nomination was based on the outpouring of generosity that the Sacred Heart community had shown to one of E-M's students after an incident that took place during a football game in Falls City last fall.

The day of the incident was a warm day, even for October. The sun was shining, and there was very little breeze. Sacred Heart and E-M were playing in Jug Brown Stadium in their first state playoff game of the season in Class D2. Sacred Heart was leading 36-3 when E-H's kicker lined up to kick a seemingly impossible field goal—57 yards.

The Pirate blockers set in motion. The kicker sent the ball flying, right through the uprights, and broke the D2 state record. Celebration ensued.

Irish players even congratulated the kicker.

Behind the line of scrimmage, E-H blocker Tanner Haberman lay on the ground, writhing in pain. His screams could be heard over the cheers and high-fives. Haberman had fallen backwards, over a player who had gone to the ground, and his leg had snapped into two pieces.

At the femur (the bone in the thigh is the largest in the body, and is not easily broken).

Tanner screamed as if his leg had been cut off. His excruciating pain was gut-wrenching. Coaches Goltz and Swanson ran out onto the field. They observed that the break was clean, meaning that Tanner's skin was the only thing holding his leg together. Goltz knew then that something was terribly wrong.

"It takes a large amount of force to break the femur," Goltz said.

"And there was no way that Tanner had been hit hard enough on that play to break that bone."

Long story short—Tanner was stabilized by the medics at the game, then rushed to Community Medical

Center. School Supt. Msgr. Robert Roh went out to the emergency room,

the family is in a strange place, and their relatives are sometimes far

away," Msgr. Roh said during a telephone interview. "I've discovered that people feel better—especially people of the Catholic faith—if I just stand around with a collar on, and shut up. It's not the collar, per se, that brings peace and serenity, but the position of the priest. That position seems to bring hope."

By "showing up and shutting up" (as Msgr. Roh said), he learned that Tanner was the oldest of nine children, and that his dad, Troy, was a teacher and the head girls' basketball coach at Emerson-Hubbard. Troy was also one of the bus drivers, and had driven the spirit bus to the game that night. He'd had no choice but to leave to drive the student body home.

Tanner's injury was so significant that he was scheduled to be transported to Lincoln by helicopter. Joan Magdanz, a Sacred Heart parent and CMC nurse, offered to stay with him so Tanner's mom,

Janelle, could get on the road. Janelle headed out so she could meet the chopper on the other side, and left her son in the arms of Falls City. The Sacred Heart troops rallied. After the game, several players and parents showed up at the hospital, wondering what they could do to help.

Their presence buoyed the injured player, so they stuck around just to provide moral support. They offered prayers and encouragement, food, lodging and anything else that the family needed.

When Tanner was taken by helicopter, the kids and their parents continued to pray. In Lincoln, doctors performed emergency surgery to place a rod in Tanner's leg. However, the rod went into the bone way too easily, so biopsies were conducted, and Tanner's parents heard some of the worst news that any parent can hear: Their 18-year-old son had Osteosarcoma. Cancer.

Goltz called Swanson, his colleague and long-time friend, the next day to check on Tanner and was taken aback by the news. He disconnected the call, then sent a message to his teachers, who relayed the message to their students. And suddenly, neither football games nor much else seemed to matter. A child—someone their age—had cancer. And everyone wanted to do something to help.

While Goltz kept in contact with Swanson and gave daily updates, the Sacred Heart community mobilized. The students sold T-shirts that read, "Teaming Up to Tackle Cancer."

They sent shirts to Emerson-Hubbard, and the Pirates bought them, too. The FCSH Pep Club, sponsored by Barb Froeschl, organized a "Sweatpants Day," where students donated money to wear sweatpants and sweatshirts for a day.

"The kids just felt moved to do something," Froeschl, who also serves as the Guided Learning teacher, said. "They offered prayers, said The Rosary and sent cards, in addition to raising money. The support for Tanner, who came into our lives only by chance, was overwhelming."

The Helping Hands Club and the Irish alumni also got involved. And soon, the entire Falls City community did, too. People donated gas cards, others gave food certificates, and many gave money. Dickey's BBQ held a fundraiser and gave half the proceeds to the family.

Msgr. Roh was one of the priests who hand-delivered many of the cards and donations.

"We knew that our donations would be a spit in the bucket compared to the expenses that the family would incur," he said, "but we had to do something."

That something was much more than anyone on this side realized. Swanson was so impressed and overwhelmed that he contacted the Nebraska Schools Activities Association, and nominated Goltz for Coach of the Year. Upon receiving the nomination, the NSAA's Ron Higdon called Swanson and told him that Sacred Heart's response to another family's plight deserved even more recognition. So Swanson nominated Goltz and the school for the national Spirit of Sport award, sponsored by the NFHS.

"The things that Doug Goltz and the Sacred Heart community did for Tanner and his family were way above and beyond the call," Swanson said in a telephone interview.

"And because of their generosity and kindness, the two schools have formed a special bond. The relationship has been strengthened, and I think the whole thing has made us all much more aware of others."

FCSH senior Abby Magdanz echoed that thought.

"Being a part of Tanner's plight has humbled us a lot, and made us realize that, even at 18, life can change in an instant."

Tanner's life certainly did. After his initial surgery, to replace his hip socket, femur bone, and part of the knee, he was doing fairly well. He even played in the last 20 seconds of the Pirate's final basketball game.

"His brother threw him the ball," Tanner's dad, Troy, said. "The other team knew what was going on, so they broke away and let Tanner score a lay-up. Both teams and their fans went wild. It was one of the most moving moments of my life."

The news after that, however, wasn't good. Tanner developed a staph infection, and ultimately had to make the decision to save his leg or risk his life. He made the decision himself to have his leg amputated. Two weeks later, he showed up at the Sacred Heart girls' opening-round game in the state tournament. He also attended the Irish boys' opening round game.

He wanted to show support for the people who have given so much. (He continues to fight his battle with cancer, and his family continues to remain hopeful.)

Regarding the Spirit of Sport Award, Sacred Heart didn't win. The award went to a Connecticut student who continued to excel in three sports after receiving a liver transplant. But this was one award where it truly was enough just to be nominated.

Troy Haberman, father of five other boys and three girls, summed it up perfectly.

"There's no award that anyone could receive that would do the school or the town justice. From the onset of the injury all the way through to this day, Doug Goltz, Msgr. Roh, Joan Magdanz, and people from both schools in Falls City have sent financial support and prayers. Kids in the grade schools have written letters. Many people continue to send cards. We were strangers to your town, but Sacred Heart, and the entire community just really adopted us and took us in. There are no words to describe it."

Well, there really are. Like Coach Goltz said, Sacred Heart was just doing things the Sacred Heart way, and that way can be summed up with two words. **Sacred.** And **Heart.**

*'I saw the sign and it opened my eyes'*

Above is an artistic rendering of a digital sign that will measure 23 feet in width and 15 feet in height that from the United Methodist Church parking lot at 1700 Harlan Street will, hopefully before winter, according to Falls City Chamber/Main Street Director David Branch, beckon the masses to Falls City's downtown business district with dazzling lights advertising everything from the Cobblestone Festival to Sunday's church worship services.

Behind the "Falls City" lettering adorning the sign will be an image of waterfalls, coinciding with the theme of "bringing the falls back to Falls City," Branch said.

The total cost of the sign is \$77,000; the digital display, which will come from St. Joe (MO) Sign Co., accounts for \$21,000 of the cost. The scrolling letters will be easily decipherable, as the digital portion of the structure will be 10-feet wide and two-feet tall. Endicott bricks - 1,800 of them - will encompass the sign and the Chamber is giving everyone a chance at a small (or large) piece of ownership, selling each brick for \$20 (and the purchase is tax-deductible). That will generate \$36,000, while the Richardson County Visitor's Committee has pledged \$10,000 and a \$25,000 state jobs grant is expected to push the project across the goal line. The City of Falls City will provide the electrical line and juice to run the sign and the State, Branch said, approved the project based on the Chamber/City collaboration. The United Methodist Church agreed to lease the property.

No individual businesses will be permitted to advertise on the new sign, but general "Stone Street" sales will be promoted. Branch also said plans to advertise Sunday church times for 24 consecutive hours, beginning on Saturday mornings.

"I'd like to have it ordered by the end of the summer," Branch said, noting citizens are welcome to buy one brick or "all 1,800 - we won't stop ya," he said. "If we get the grant money by then, it'd be nice to have it up before winter hits."


