'God Bless the people of Joplin'

Very few experiences in my life have left me speechless, the moment my son was born, witnessing my nieces' birth and now seeing the devastation in Joplin, Mo. Thousands of volunteers spent their holiday weekend helping those affected by the recent tornado while witnessing the strength and the indomitable will of its residents.

May 22nd, my family and I were driving back from Texas when we heard that Joplin, Mo. had been hit by a tornado. We could see the storms to our east but hadn't known their intensity until that moment.

Over the next few days we watched the horror unfold in Joplin. Many residents of Falls City pulled together to help. Robin Cooper raised money and set up a donation station at Total Entertainment Video and an amazing group of women from Community Medical Center drove down to help survivors sort through their things. That group included Laura Pagnano, Tonya Dean, Erin Anderson, Sarah Issacs, Kelli Dean and Alysia Schawang.

My husband, Brian, and I had discussed going to Joplin that week. We came to the conclusion that our holiday weekend could be spent lying around watching TV or we could drive down and help out. We could make a difference.

Friday night we packed as many donations as we could fit in our car from Robin Cooper's donation drive, and left at 5:30 Saturday morning. Laura Pagnano who had just gotten back told me to prepare myself, and I really thought I had. The moment we pulled into Joplin my hands started to shake. The traffic was bumper to bumper with many out of state vehicles. Stacks of water bottles lined every corner, sirens rang out constantly and volunteer tents were set up everywhere. North Joplin looked like a busy

bustling little city. If you hadn't heard about the tornado you wouldn't have known anything was devastated. With cell service down we stopped at the Ignite Church and dropped off the donations collected from Falls City and surrounding communities. We stopped at the gas station next door to get a drink and overheard a conversation between the clerk and another woman. They were discussing her friend, and co-worker at that station who was still missing. That made it very real for us at that point.

We arrived at Missouri Southern State University and was amazed at how organized everything was less than a week after the tornado. We went inside to sign our waivers and get our instructions. Within minutes we were given 24 packs of bottled water, and respirators and were shown to our bus with about 40 other people. There was some small talk between volunteers until the bus driver asked us if we had been to ground zero yet. Not one of us on the bus had. The driver then changed his tone and told us to prepare ourselves. We were heading up a hill full of trees and homes where nothing looked out of place — and then we topped the hill. There it was. Forty adults on a bus went dead silent and pale at the same time. I started to quietly sob, wondering if I could really do this. As we drove in front of the demolished Home Depot, all you could hear throughout the bus was sobbing and sirens. Nobody spoke a word as we drove through the heart of the devastation.

We made it to our drop off point in the parking lot of a bank where a few days earlier Anderson Cooper had taken shelter from severe weather. We unloaded and were greeted by Joplin city employees. They gathered us around and told us that we would be walking a mile and a half through a residential neighborhood completely leveled by the tornado to get to the lot

Flooding delays bridge project

With all the recent rain, construction on the new bridge on Highway 159 in Rulo has slowed.

Mike Habegger, the manager of the bridge project stated that flooding has slowed the progression and as of Tuesday, is at a standstill.

"We just haven't been able to

work in the high water."

Rulo has received almost five inches of rain in the last two weeks. This has caused some minor flooding and by Tuesday, the flood stage reached 17 feet. Moderate flooding is still forecast.

How long will the flooding delay the construction? As of now, Habegger says, it is "up in

the air" because it all depends on what the weather does in the next couple weeks. He also said that the Main Span contractor has been waiting for almost four weeks to begin work because of the rain.

The workers have been able to make a little progress in re-

Off the Cuff

It was 1965 and some of us were doing what came naturally — driving around town, mostly up and down Stone Street, listening to the radio and swapping tale tales. At the time, none of us had an FM radio, so we were listening to KTNC and our classmate-DJ, David Davies.

This was a time of innovation in the world of popular music. The Beatles were cranking out one hit after another. So were the Stones. New groups were forming at an unprecedented pace, some of them one-hit wonders. On the American side, the Beach Boys were riding the Wilson wave and creating some very classic music.

Then our friend David announced a tune by a guy he called Bob D(eye)lan. Never mind the pronunciation (although we did). The song was “Like a Rolling Stone” and things changed forever.

Bob Dylan celebrated his 70th birthday a week or so ago. That means that those of us who grew up listening to what he had to offer are at least pushing that landmark. I doubt any of us who were tuned in at the time will forget. This wasn’t the typical “I Wanna Hold Your Hand” fare; it was a scolding. A severe put-down of an unidentified girl. It was new, unlike anything we or anyone else had heard.

The previous issue of Rolling Stone magazine included a lengthy tribute to Dylan and his music, with reviews of his 70 best songs as regarded by music experts. After Jason shared a couple of Rolling Stone issues with me, I subscribed, not because I’m plugged into today’s music scene. I’m not. I now read the magazine mostly because of the writing, which is groundbreaking, investigative journalism.

Not surprisingly, the selection for Dylan’s best song was that snarling early rage against what was supposedly a former girlfriend. The lyrics are devastating. The music is timeless and trend setting.

*“Once upon a time you dressed so fine
You threw the bums a dime in your prime,
didn’t you?”*

A comedown was on the way but she laughed it off.

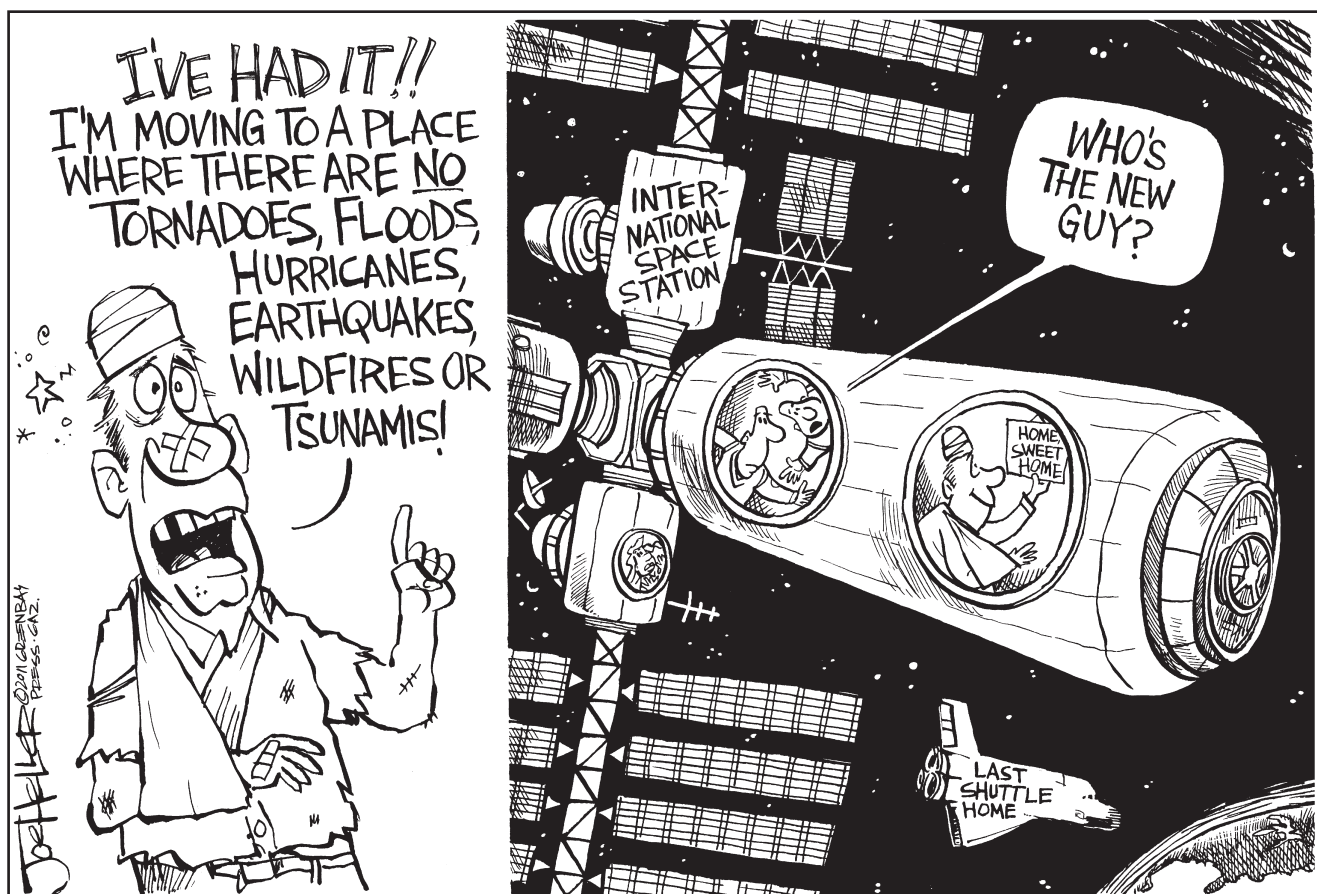
*“Now you don’t talk so loud
Now you don’t seem so proud*

About having to be scrounging for your next meal,” the poet-writer hissed.

*“How does it feel
How does it feel
To be on your own
With no direction home
Like a complete unknown
Like a rolling stone?”*

The song was copyrighted in 1965 by Warner Bros. Inc.; renewed in 1993 by Special Rider Music.

I haven’t done the song justice here and won’t try with any of the hundreds of others the man has written. Songs like “Don’t Think Twice, It’s All Right,” “Blowin’ In The Wind,” “All Along the Watchtower.” Other musicians made some famous, but the message was clearly Dylan’s. He’s still writing and performing and reshaping himself as he goes. Our generation was very, very lucky to have grown up with him. When we can’t find anything to listen to, we can always revisit Highway 61.



Can anxiety drug be addictive?

DEAR DR. GOTT: My mother is 74 years old and has been taking lorazepam 0.5 milligrams nightly to help her sleep for almost two months. She

would like to continue taking it but is concerned about the side effects. She prefers this medication over the other brand-name sleeping pills.

Should she try to go without for a few days to see if she has become dependent? She doesn’t want to skip it for fear she won’t be able to sleep. Please advise, and thank you in advance.

DEAR READER: Lorazepam is one in a group of drugs known as benzodiazepines and is commonly taken to treat anxiety and symptoms of depression. As with most drugs, it can also be used for other conditions, such as sleeplessness, as determined by a personal physician.

Side effects are linked with dosing used but can include drowsiness, headache, weakness, unsteadiness and dizziness. Less common effects can include allergic reactions including hives and rash, difficulty breathing, memory loss and mental changes. Paradoxical reactions can include sleep disturbances, insomnia, hallucinations, hypotension and a great deal more. When paradoxical reactions occur, use of the drug should cease.

The strength of each tablet is between 0.5 milligrams and 2 milligrams. Studies performed on healthy volunteers reveal single high doses have a tranquilizing effect on the central nervous system, with no appreciable effect on either the cardiovascular or respiratory systems. Long-term use of more than four months has not been assessed by

clinical studies, but it is known that continued use of benzodiazepines may lead to physical and psychological dependence. The potential for dependence is greatly reduced, however, with short-term treatment (between two to four weeks). Long-term use of this product is not recommended. Therefore, re-evaluation by a physician is necessary. Withdrawal has been known to present following cessation of recommended doses following as little as seven days of therapy. For people on an extended therapy plan, dosage tapering is recommended, not abrupt discontinuation.

Lorazepam should be used cautiously in patients with such conditions as COPD, sleep apnea, or renal and hepatic impairment.

In summary, your mother is on the lowest possible dose; however, the potential for long-term effects such as dependence must be considered. I recommend that you accompany her (with her permission and approval, of course) to her next doctor’s appointment so you can determine whether she has remained on the drug for too long without a break. Perhaps a switch to melatonin or another over-the-counter might be appropriate for a short trial. Her physician is the best judge in this case.

DEAR DR. GOTT: I recently had an MRI done on my brain, and there were five or six white spots. The doctors are telling me this is nothing to worry about, but I worry. What do you think this is? What could the spots mean?

DEAR READER: White spots can appear as a part of the natural process of aging. It could also be the beginning of hardening of the small arteries within the brain from hypertension or a neurological disorder.

I believe you have to rely on your physician(s) who told you not to worry; however, were I the one involved, I would seek a second opinion with another neurologist for the (hopeful) peace of mind to follow.

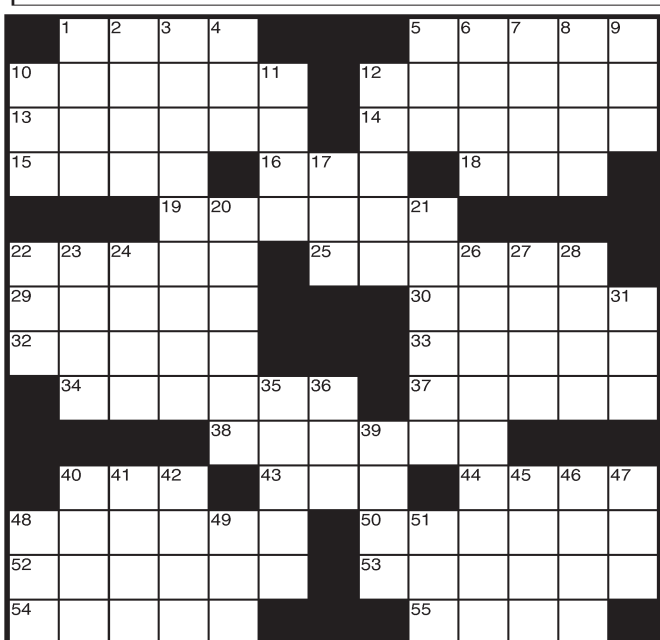

When Robin Cooper, of Falls City, heard how a tornado had devastated Joplin, she knew she had to do something to help. Robin called the Red Cross to see if she could donate clothes to the relief effort, but was told they didn't need clothes at the time. She was soon contacted by Q-Country 92.7 FM with a list of items that were needed for the effort. Robin posted the list on Facebook and within 10 minutes, she was receiving calls and messages from people wanting to help the devastated city. Residents from Falls City, Stella, Auburn and other surrounding communities donated diapers, toiletries, monetary donations and other items. Donations like these were also made from Heritage

Falls, Pamida, Community Medical Center, and Cedar Hollow.

Residents of Eastview Apartments, Pioneer Plaza, and Falls City Care Center donated baked goods for a sale that was hosted at Total Entertainment Video. By Thursday afternoon, the sale had raised over \$1,100. Katie Crofford, Josie Crofford, Kirsten Herling, Eli Kuker, and Shelby Kuker helped organize and run the sale.

On Tuesday Terry and Cathy Crawford got into contact with Robin about driving all of the donations to Joplin. Terry and Cathy drove the goods to Joplin on Friday where their son lives. Fortunately, he is okay.

assigned to. They asked us not to enter any home even if we were asked by the owners, not to go on anyone else's property unless we were asked to do so, and under no circumstances were we to take any photos. They explained that the residents of this area had hit their boiling point of people taking photos of their heartbreak. We were asked to take any personal items that we thought were salvageable and give them to our team leader. They then prepared us of the possibility that we may find human remains. This made my heart sink. The woman next to me started crying uncontrollably. They asked us to clear the area and try not to make a scene if we came across any of the 156 people who were still missing.

Our group of 40 started walking one of the longest walks any of us had ever taken. What we witnessed on our walk was utter devastation. Homes were spray painted with messages of where the residents were, or messages that said, "Thank you Jesus," "God Bless Joplin" and my favorite, "Loot and I'll Shoot."

We made it to our assigned home. Everyone jumped right in, separating the piles into Electronics, Large Appliances, Hazardous Waste, Vegetative Debris, Construction Debris and Household garbage. The first thing I found was a personal photo of a young girl celebrating her birthday. I started stuffing these into my boots until I found our team leader. Brian and a group of other men started cutting up a large tree that had fallen over in the front yard and putting it into a pile. As the day wore on I met so many wonderful people. A woman in her 50s who had driven from southern Texas with her sister worked herself sick; a group of college kids from Kansas City didn't stop once. None of us wore our respirator mask, because of the near 90-degree temperature. Besides the haunting visions all around us of homes lost, the smell was the most disturbing part. The smell of rot and earth filled the air and is something that will haunt me for the rest of my life. Our team leader returned to check on us and immediately took a man to get a free tetanus shot after a nail went through his foot. The owners showed up soon after that and I took them the photos I had found. I knew these were probably not theirs but, if there was any hope even one was, I wanted them to have it. The woman thanked me for finding them and helping clean up. She shook my hand and apologized saying she would hug me, but I was too filthy. She also told me the pink boots I had bought at Farm & City Supply the day be-

fore made her smile. She said they gave her some hope and it was great to see some color in the otherwise drab mess. Those boots were hot but, I had multiple nails stuck in them and never had one go into my foot.

Our group was amazing. We all summoned courage and strength we didn't know we had. We worked through the heat, pain and emotions that should have crippled us. After 4 and 1/2 hours of back breaking work I was about to collapse. Brian and I were covered from head to toe in dirt, fiberglass, sweat, and cuts. We sat down and silently took it all in for a while. Our last bus was about to leave so we started our mile and a half walk back. The curfew was about to take effect and residents

were heading back to the places they were staying. At this time some of us discreetly snapped some photos of the homes that were barren.

When we made it back to our starting point we were emotionally and physically drained. I had fiberglass all over my face and was red from itching. I also had a dark mark under my eye from getting hit with a shingle on accident. Brian's arms were covered in dirt and red from the fiberglass, all of us volunteers looked like we had fought a tough battle and lost. As we loaded our bus I noticed the faces of these volunteers who gave so much and asked for nothing. They were tired, sweaty and very emotional. Some started sharing their stories of why they came and from

where. It was interesting to listen to everyone tell their stories.

When as we got off the bus the Missouri Cattleman's Association had hamburgers, hot dogs, drinks and other snacks for all the volunteers. It was exactly what we wanted and needed! We were tired, and very hungry and they offered us as much food as we could eat and asked for nothing in return. All of us sat in the grass of the MSSU campus and quietly ate. Then we made our way back to our vehicles and went to rest for the next day.

Brian and I drove to Parsons, Kan., an hour away to the closest hotel that could accommodate us. We discussed what we had just seen. Brian told me the vision that stuck with him was a home we passed where there was a bookshelf filled with books next to a TV on the fireplace; that stood alone, undisturbed, in a pile of debris. Personally, I will always remember seeing the remnants of the Home Depot lying under an American flag, and a fire still burning in the distance.

Sunday ended up being a mess of media, people and protests. Volunteer hours were cut short due to Memorial Services and the President's visit. We decided to get out of town before it got completely out of control.

I would encourage anyone reading this to consider taking the drive down. The city of Joplin will need volunteers for a long time. They were so grateful, sweet and strong. They shared their stories, food and water even when they had little of it to give. It was the hardest work we had ever done also, the most rewarding. And we will continue to go back and help out until they ask us to stop. God Bless the 2,500 volunteers who showed up when we were there, and God Bless the people of Joplin.

Evelyn Burns: 36 years of service to ACS

In 1974, Evelyn Burns was diagnosed with breast cancer. At that time, a breast cancer diagnosis meant something different than it does today. Fewer women were surviving the disease and the treatments were more extreme so emotional support was greatly needed. Following her diagnosis and subsequent radical mastectomy, Evelyn was visited by a Reach to Recovery volunteer, a program from the American Cancer Society that matches newly diagnosed breast cancer patients with trained survivors to offer one on one support.

"I was so impressed with the Reach to Recovery volunteer that came to visit me that I wanted to help others." And that's exactly what the 86-year-old has done for the past 36 years as an American Cancer Society Reach to Recovery volunteer.

Burns notes that the women she's visited over the years have all been very receptive and happy to receive the one on one support. They especially appreciate the volunteer's ability to help direct them to receive breast prosthesis as well as their emotional support.

"You have gone through a very similar experience to what these newly diagnosed patients are going through now," said Burns about her Reach visits. "You're apparently healthy and going strong and they can see that in their future when the volunteer comes to see you. Cancer kind of seems like a death sentence in a way until you get into treatment and find out there is life ahead of cancer."

Burns, a retired nurse, has visited newly diagnosed patients both young and old in communities all over Southeast Nebraska. For most of her 36 years, she was the only Reach to Recovery volunteer in the area, making her services even more important.

"Evelyn has shown a true dedication to helping others battle cancer," commented Dawn Vosteen, community manager for health initiatives for the American Cancer Society. "All

of our volunteers are outstanding here in Nebraska but being able to commit to helping others for 36 years takes a very special person. We truly appreciate everything Evelyn has done for the patients she's helped and for her willingness to help the American Cancer Society save lives."

When asked what her 36 years of service has meant to her, Burns replied simply, "It meant something to me that I was able to give other women some encouragement."

In Nebraska, there are currently more than 115 Reach to Recovery volunteers visiting newly diagnosed breast cancer patients and offering support and comfort during this difficult time in their lives. This is just one of the many support programs offered by the American Cancer Society. 4-H part of NASA-funded effort to boost science, math education

Nebraska 4-H will be a partner in a statewide NASA-funded effort to boost science and mathematics education for students in more than 100 schools.

NASA is providing \$750,000 to the Nebraska Department of Education, which will use it to fund programs in Nebraska schools with 21st Century Community Learning Centers.

The 21st Century Community Learning Centers are before- and after-school and summer programs in more than 100 schools across the state. Those schools have a diverse student enrollment and a high level of poverty with at least 40 percent of the students qualifying for free and reduced priced meals, according to the education department.

The program takes flight this summer, introducing teachers of fourth- through eighth-graders to NASA and the Nebraska 4-H Robotics curriculum by providing professional development in hands-on activities on four topics: robotics, rocketry, aviation and near and outer space.

Nebraska 4-H will provide professional development in the robotics area. "We will train teachers to run the robotics program," said Bradley Barker, 4-H science and technology specialist.

"This is a great opportunity. NASA brings lots of resources. We now have access to engineers and scientists from NASA, which we didn't have access to before," Barker said. He also noted it's a welcome opportunity to partner with the state's education department.

The state's program is known as Nebraska Blast. Nebraska was one of 36 applicants and one of only nine to receive a NASA grant.

"We are pleased that we have yet another opportunity to help students who are considered at risk academically," said Nebraska Education Commissioner Roger Breed.

The NASA curriculum will be introduced to teachers through regional workshops offered in Omaha, Lincoln, Columbus, Kearney and the Panhandle.

Forty hours of professional development will be provided each year in collaboration with the 21st Century Community Learning Centers, NASA Nebraska Space Grant Consortium and 4-H, part of University of Nebraska-Lincoln Extension.

The goal is to increase the number of future scientists, mathematicians and engineers by expanding participation to low-income and minority students.

"I am delighted that we have such a broad and diverse group of partner organizations ready to implement this year's Summer of Innovation program," said Leland Melvin, NASA associate administrator for education. "We look forward to building on the momentum that began last year, so we can engage and inspire even more middle school students to reach higher and pursue STEM career opportunities."

STEM is a national initiative focusing on science, technology, engineering and mathematics education.

Flood Recovery Procedures

Recent and current flooding in the District's counties has prompted the Southeast District Health Department to provide guidelines for recovery from flooding.

"It is important to remember that an area that has been flooded may be contaminated with mold or sewage which can cause health risks for your family," cautioned Kay Oestmann, Director of Southeast District Health Department.

After a flood the physical devastation to an area is obvious. Health risks can persist long after the immediate danger from floodwaters has passed. Floodwaters can contaminate food and water supplies, create hazardous electrical shorts, gas leaks, cause dangerous structural damage, and potentially cause health problems.

If you suspect your water supply was contaminated, drink only commercially bottled water or treated water until your supply is tested and found safe. Public and rural water supplies are tested by qualified operators. If you have a private well, observe color,

odor and clarity. It is better to test your water than risk drinking contaminated water. Test kits for private wells for information on how to access these call the Southeast District Health Department. 1-877-777-0424.

Discard any food that may have come into contact with floodwaters. Undamaged, commercially canned foods may be saved. Contact the Health Department for guidelines. You may be able to salvage food in refrigerators or freezers that were not exposed to floodwaters. Check carefully for signs of spoilage, do not refreeze any thawed meat, poultry or shellfish. Oestmann said a good rule of thumb is "When In Doubt—Throw It Out."

At no time should anyone use the floodwaters for recreational swimming. Not only does this present the opportunity for drowning, but skin infections and tetanus have been associated with contact with these waters. Observe the signs posted by law enforcement and Emergency Management and comply with their expertise.

Standing waters compound the threat of West Nile Virus. Spray with insect repellent containing DEET before you go outside. Follow guidelines available through the Southeast District Health Department.

If you are involved in flood recovery or assistance, think about the last time you had a tetanus vaccination. Tetanus organisms are found in the soil and intestinal tracts of animals and humans. Transmission occurs primarily by contaminated wounds that are major or minor. If you have not had a shot in the last 5 to 10 years, or if you have injured yourself while working in the water or mud, you should consult your physician. If you have questions about tetanus and about whether you need to be immunized, call the Health Department.

Bagworms still could be problem

Although last year we seemed to get a reprieve from a bagworm infestation, it is doubtful that they have left the area. The harsh winter of 2009-2010 may have reduced winter survival of bagworms last spring, which contributed to lower numbers and fewer problems with bagworms in 2010. In 2011 it will still be important to be ready for the hatching of bagworms to prevent them from reaching the high infestations we had in previous years. In years prior to 2010, we had a major infestation of bagworms in the area. In previous years, the larvae emerged over several weeks during the summer. We had some late hatches and bagworms were causing problems in July. It will be important to keep an eye on your evergreen trees this year and watch for infestations of bagworms. If you haven't removed the bagworm bags from your trees this winter or earlier this spring, it may be a little late because they already may be starting to hatch. If they haven't hatched yet, pick them off, crush them or discard them in a sealed garbage bag in the trash. Bagworm eggs usually begin to hatch in late-May to mid-June. Check your evergreens, for infestations of these young larvae. They will begin to form a new bag over their bodies. They start out very small with a 1/8" bag around their bodies this time of year, but grow in size and construct a bag 2" long by mid-August. Bagworm larvae damage the tree by feeding on leaves or needles, causing defoliation. It is best to spray when you see the larvae, which will usually be from early June until July. If you do see them, there are several types of sprays that can be used for control of the bagworm this time of year. If you want to use something natural, BT is effective in controlling bagworms and can be purchased as Dipel from most garden centers. The small larvae can be controlled chemically by Sevin, Eight, DeltaGard, Orthene or Malathion, among other things. If you wait until August and the larvae are 2" long and inside their bags, chemical control will be very poor. 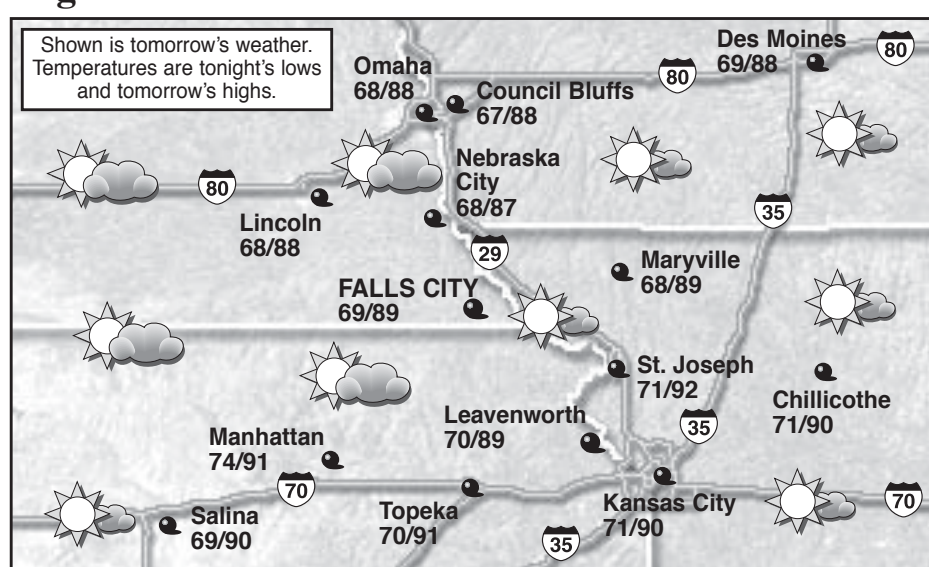

Being "in Christ"

The concept of being "in Christ" is one of the most powerful in all of Scripture. It will answer many questions about salvation, sanctification and unity. We will have a greater, more complete understanding of God's plan of salvation if we understand what it means to be "in Christ." Let us see what the Bible says about being "in Christ."

Jesus is God, Creator and possesses all authority (John 1:1-5, 14; Matthew 28:18). His Word will judge us in the last day (John 12:48). Jesus is the reason for our salvation (John 3:16). Humanity was awash in hopelessness prior to Christ going to the cross. "For when we were still without strength, in due time Christ died for the ungodly" (Romans 5:6).

Through Christ we can have hope. "But if we walk in the light as He is in the light, we have fellowship with one another, and the blood of Jesus Christ His Son cleanses us from all sin" (1 John 1:7).

It is Jesus' blood that allowed us to come back to God after our sins separated us from the Father (Isaiah 59:1-2; Hebrews 9:12-14). We are completely dependent on Christ for salvation (Ephesians 2:8-9).

The blood of Jesus provides the only possible avenue to salvation. "And for this reason He is the Mediator of the new covenant, by means of death, for the redemption of the transgressions under the first covenant, that those who are called may receive the promise of the eternal inheritance" (Hebrews 9:15).

Being "in Christ" we are at peace with God. "Much more then, having now been justified by His blood, we shall be saved from wrath through Him" (Romans 5:9). Faith in Christ, as man's Savior, is a requirement (Hebrews 11:6). "Therefore, having been justified by faith, we have peace with God through our Lord Jesus Christ" (Romans 5:1).

Since our salvation depends on Christ, and we must approach him in our freewill to be saved, entering Christ is the only way to enter his family (Ephesians 2:19).

In Acts 2, the gospel was preached in Jerusalem and 3,000 souls were immersed for the remission of their sins (2:38, 41). When they were baptized, they were added to Christ's church. "And the Lord added to the church daily those who were being saved" (Acts 2:47). The church was built by Jesus (Matthew 16:18) and He is the "head over all things to the church, which is His body" (Ephesians 1:22-23).

Immersion is the only way we can "put on Christ." This is how we get into Christ... into the Lord's body: His church. "Do you not know that as many of us as were baptized into Christ Jesus were baptized into His death? Therefore we were buried with Him through baptism into death, that just as Christ was raised from the dead by the glory of the Father, even so we also should walk in newness of life" (Romans 6:3-4). "For by One Spirit we were all baptized into one body" (1 Corinthians 12:13). "For as many of you as were baptized into Christ have put on Christ" (Galatians 3:27).

Never do we find that we can get into the body (church) of Christ any way other than baptism for the remission of sins. Yet, many people believe that you can get into Christ simply by praying, despite the absence of Biblical evidence. What matters, is what God says. So, "Why are you waiting? Arise and be baptized, and wash away your sins, calling on the name of the Lord" (Acts 22:16). We cannot get into Christ or have our sins washed away without baptism. Accordingly, if someone has not done this, they cannot be in Christ and cannot be in the Lord's Church (His body).

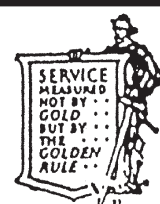

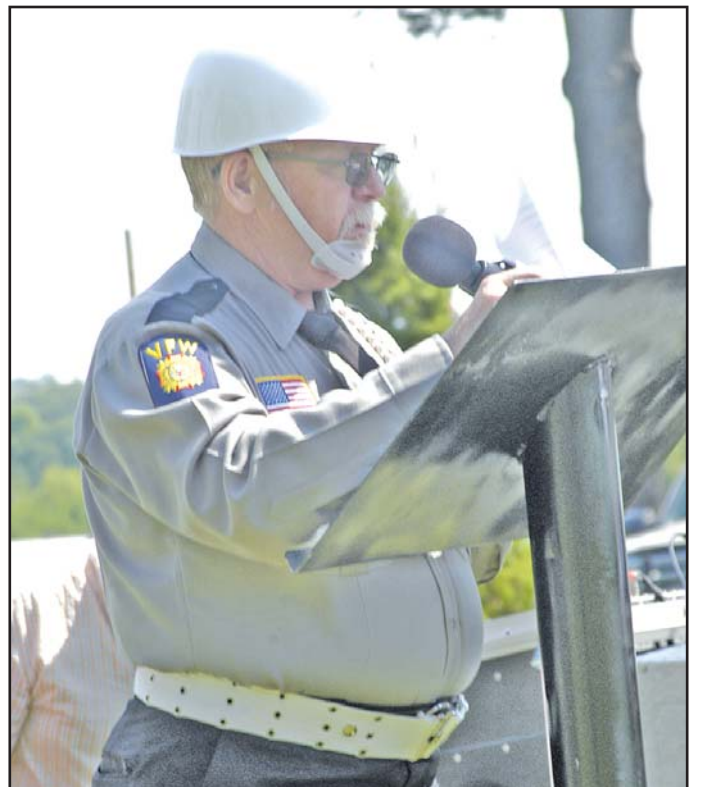

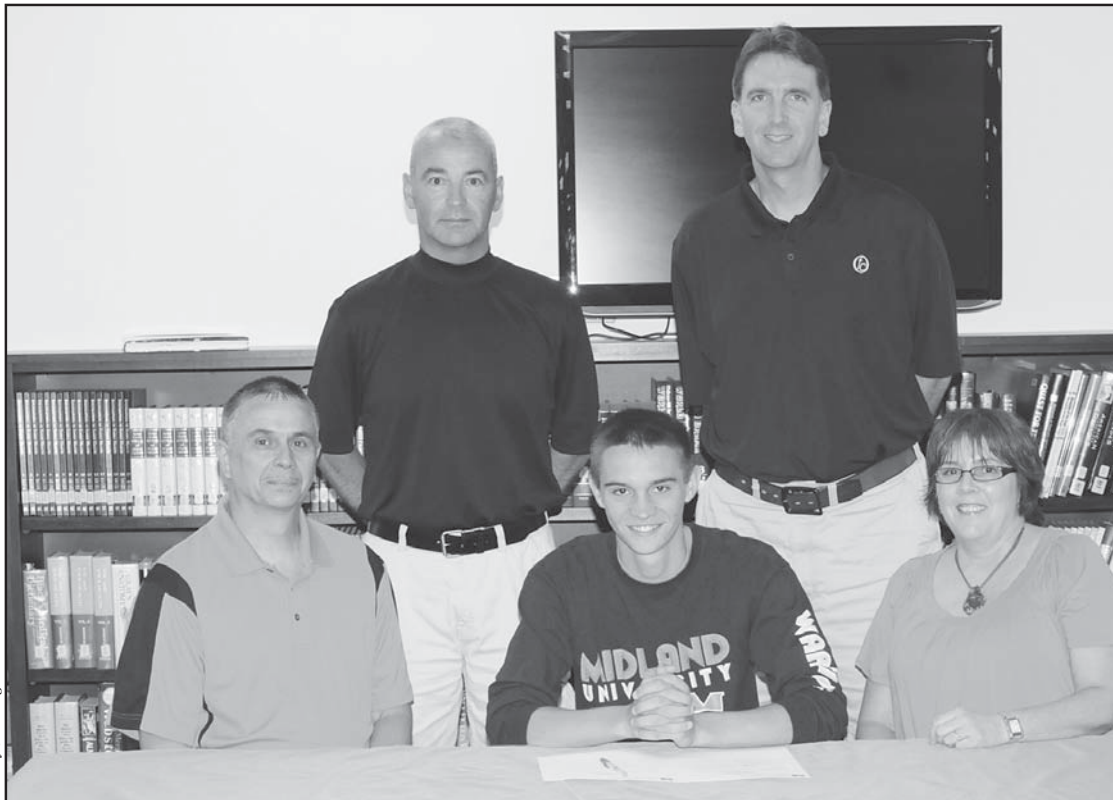

All she had to do was send a \$1,000 check to a "Michael Bradford" in Florida and they would send them their winnings. The man, claiming to be from Publisher's Clearing House, also wanted her to go to Wal-Mart and make a copy of her driver's license. "Why they wanted me to go to Wal-Mart, I

don't know," Jean said.

Jean was very suspicious and noticed the man couldn't speak English very well. When asked where he was from, the man "got real quiet" and said he was from Florida. "I knew that wasn't right because I have caller I.D." After the call, along with the help of her daughter, Jean was able to trace the call to Kingston, Jamaica.

Finally, Jean had heard enough and told the man to send an attorney and they will talk it over then. The call was ended shortly after, and Jean has yet to hear back from the man or an attorney.

She was obviously angry that someone had tried to take her money, but Jean was also concerned that others might fall for the same trap. She warned that people should not give out that sort of information, especially to strangers over the phone. "People need to know what they're doing," Jean said, "If it sounds too good to be true, and it's not in black and white, it usually is."

Q: Many years ago, I had a brief layover in Turkey. In one of the cafes, I ordered a hot drink I was told was a customary beverage during the winter months. White and thick, it had the look and consistency of eggnog. It had an incredible aroma as well as taste. I would love to have it again and share it with friends and family. Is this enough information for you to tell me what it was and how to make it? -- C.L., Bakersfield, Calif.

A: I'm thinking you may have had a cup of salep (there are other spellings of the word). Salep is made from the roots of several species of orchids. The roots are dried and then ground into a flour. The flour is heated with milk, sugar and cinnamon. Some recipes call for a splash of rose water. I am told that Turkey has severely curtailed exports of salep, making it difficult to find the real thing. There are artificial drink mixes available that are good, but not the real thing.

Did you know ... Jodie Foster won the role of Clarice Starling in movie "The Silence of the Lambs" (1991) after Michelle Pfeiffer turned down the part? Foster garnered an Academy Award for Best Actress for her role.

On Memorial Day, hundreds of workers gathered to march toward the Republic Steel mill. The Chicago police blocked their way, an argument broke out, and someone threw a tree branch at police. Police opened fire, killing 10 and injuring dozens.

cent weeks. According to Habegger, they have completed five out of the six shafts for the Nebraska-side of the bridge. Right

now, though, they are moving the equipment out of the mud and floodwaters.

A relatively mild winter had allowed general contractor Cramer & Associates of Grimes, Iowa, to stay on track for the Rulo Bridge's targeted September 2012 completion date,

though that now seems unlikely. "River elevation dictates everything down there," Habegger said previously.

In March, the five piers on the Missouri side were finished and work started on the Nebraska side, just south of the Bridge Cafe.
